

TO THE DESCENDANTS OF DEACON JAMES TROWBRIDGE.

HAVIN' collected the following statistics of the families descended from our venerated ancestor, the author respectfully tenders it to the numerous families bearing the name, trusting it will be found a matter of some interest, at least to such, (as well as to all,) who are in any degree related to the Trowbridge Family.

Doubtless many errors and omissions will be discovered. It is not pretended that it is perfect even as far as it goes, and probably many entire families of some of the branches are omitted. "But such as I have" give I unto you. It is the best I have been able, under the circumstances, to do.

Hoping it may fall into the hands of some one who will find the means and disposition to arrange and publish a more extended history of the entire family, embracing the three branches, Thomas, William, and James, sons of Thomas, of Taunton, England, he herewith submits this imperfect sketch of the latter of said branches for the benefit of all concerned, and to aid in some degree the accomplishment of such a work. Should errors or omissions be discovered, or should any one have in their possession any interesting facts or incidents relating to any of the members of the family, they are desired to communicate with the subscriber by mail.

EXPLANATIONS, &C.

The number, in parenthesis, prefixed to the family, denotes the No. of the family.

The Roman figures prefixed to the name of the head of the family, denotes the No. of the Generation, beginning with Thomas of Taunton, England.

The figures following the name of the head of the family: first the family where he or she originated; and second, the relative position in that family. For example, see page 12, V Generation, Thaddeus, (6, 12) denotes that he belongs to the 6th family and the 12th child of that family.

The figures prefixed to the children's names, denotes the No. and order in which they were born.

The figures on the extreme right of the page, and in a line with the children's names, denotes the No. of the family of which that child became the head. For example, on page 12—Edmund, 2nd child of Thaddeus, afterwards becomes the head of family No. 19. A little examination will enable each one to trace his own line of ancestry with ease.

S. denotes settled in ----, d. died, dr. daughter, m. married.

When the surname is not given, it is understood in all cases to be Trowbridge.

TROWBRIDGE FAMILY.

The name of Trowbridge is of high antiquity in England, as persons bearing this name are found to have lived during the reign of William the Conqueror. The first of the name are found in Trowbridge, a market town and parish in Wiltshire Co., England, which town received its name from that of one of the family, being their residence for many centuries, and the property of one of the name in the reign of Edward I.

The name of Trowbridge first appears in Doomsday Book.

Trowbridge formerly had a Castle, but no traces of it now remain. It was besieged by Stephen about A. D. 1135.

A younger branch of the Devonshire family of Trowbridge seems to have settled in Somersetshire, as early as 1541. They resided at Taunton, in that County. From this branch sprang the Trowbridges of America. That the Taunton family descended from that of Devonshire, is sufficiently proved, by their arms being precisely the same, as those seen in the stained glass window in the chancel of St. James Church, Devonshire.

Thomas Trowbridge, the progenitor, probably, of all the name in America, emigrated from Taunton, Somersetshire Co., England, to this country, He brought with him two sons, viz., Thomas and William, about 1636. and settled in Dorchester, Mass., where another son, James, was born, same Thence he removed with his family in 1641 to New Haven, Conn., where he purchased lands, built houses, was a merchant, and engaged in the Barbadoes trade; and after a few years (in 1645,) returned to England, leaving his "three sons, houses, goods, lots, estates and chattels, in trust with his steward, or servant, Henry Gibbons, but this man shamefully neglected them, and proved dishonest and false to his trust, and a friend, Sergt., Thomas Jeffries, took these three sons to educate and bring up, in the fear of the Lord, and when Mr. Trowbridge comes back, will leave it with the Court to determine what is equal for it." Mr. Trowbridge did not return, but wrote often to his sons, and the authorities of New Haven, to bring Gibbons to account for his breach of trust. He executed a power of Attorney, Jan'y 19, 1662, to his sons, "Thomas and William

of New Haven, and James of Dorchester, Mass., (James having returned to Dorchester and settled there,) to receive of all persons, claims, houses, &c., and to bring to account and punish Gibbons."

This instrument was brought to the Governor and Court, and proved. Gibbons was also brought before them, when he said "he had rendered the account as well as he could, but it was many years since." The Secretary was ordered to examine records, &c. In a short time Gibbons died, but made over by will to Thomas, the eldest son, all his possessions. Mr. Trowbridge died at Taunton, England, about 7th Feb'y, 1672. His sons, as soon as they attained their majority, became men of influence, and possessed large estates.

Thomas (the eldest son,) remained at New Haven, was a merchant. He was born in 1632, m. Sarah, dr. of Mr. Henry Rutherford, of New Haven, where many of his descendants are still found. He died in 1702, leaving a large estate. His son, Thomas, b. in 1663, d. 1711, m. Mary, dr. of Mr. John Winston, and had Daniel, b. 1703, d. 1752, graduated at Yale College; m. Mabel, dr. of Mr. Francis Brown, and had Rutherford, b. 1744, m. Dorcas, dr. of Mr. Amos Hitchcock, and had Henry—b. July 30, 1781 m. Harriet, dr. of Mr. Ezekiel Hayes, and d. 7th Oct., 1849.

He was a shipping merchant, and founded the house of Henry Trowbridge & Sons. Since his decease the business is continued by his sons, Thomas R., Henry, Ezekiel H., and Winston J., under the firm of "Henry Trowbridge's Sons." They are more extensively engaged in the West India Trade than any other house in the State. Of these, three reside at New Haven. The last-named, Winston J., resides at Barbadoes. Thomas R. has made quite extensive researches for information referring to the family, both in this country and England, and has procured very many valuable facts during his investigation.

As will be seen by the foregoing sketch, the last-named Thomas R. is a direct descendant of Thomas, the eldest son of the Thomas who came from Taunton, in the line of Henry, Rutherford, Daniel, Thomas, Thomas and Thomas of Taunton, England. For the foregoing sketch I am indebted to Philo M. Trowbridge, Esq., of Woodbury, Conn., a direct descendant of William, the 2nd son of Thomas the elder, and who has also made extensive and labored researches into the genealogy of the family. I now proceed to give a genealogy of the family of James, the 3d son of Thomas, who was born in Dorchester in 1636.

SECOND GENERATION.

II. James Trowbridge, (1, 3) 3rd son of Thomas of Taunton, England, was born in Dorchester in 1636, and baptized in 1638. In 1641 his father removed with his family to New Haven, Conn. James, however, when near his majority, returned to Dorchester, where he married Margaret, the dr. of Maj. Gen. Humphrey Atherton, 30th Dec., 1659; being about 23 years of age, and had 3 children in Dorchester, when in 1664 he removed with his family to Cambridge Village, (now Newton.)

The Dorchester Church record states, "that the wife of Thos. Wiswall the wife of Goodman Kinwright, and Margaret, the wife of James Trowbridge, were dismissed to the church gathered at Cambridge Village, 11th July, 1664."

After the death of Dea. John Jackson, he (James) was chosen Deacon of the church.

In 1675 he purchased of Deputy Gov. Danforth, 85 acres of land, with a dwelling house and outbuildings thereon, which he (the Gov.) had occupied for some years—bounded with the highways W. and S., the narrow lane N., his own land E.—the dividing line being straight through the swamp.

He was chosen one of the first Board of Selectmen at the organization of the Town, 27th Aug., 1679, and continued in that office 9 years. He was clerk of the Writs 1692 and 1693, Lieut. and Representative to the General Court 1700 and 1703. He had by wife, Margaret Atherton,

He left a will dated 1709, with a codicil dated 1715,—proved June, 1717. Inventory personal estate, £240 0 7. By his will, he bequeathed what right of lands he had in Dorchester, which came by his own father, Thomas, to all his children equally; and all the right to lands in Dorchester, which came by his father-in-law Atherton, to the children of his first wife equally.

His will, dated 1744, gives "£5 to the church, to be loaned out so as not to depreciate, the interest thereof to be given to such poor widows as the Deacons judge proper." To son James, £200; Huldah and Mary, £100 each; Margaret, £200; Thaddeus, £50; children of dr., Mary Coolidge, £325; wife, Sarah, £50; and the residue of his estate to Lieut. Joseph Fuller, Lieut. William Hyde, Dea. John Stone, and Thos. Greenwood, in trust for his wife Sarah, during her life. At her decease $\frac{2}{3}$ of his real estate and $\frac{1}{4}$ part of grist mill to son Thaddeus, and he to pay son James $\frac{1}{4}$ part of its value.

Underneath this stone lies the body of the Rev. Caleb Trowbridge, late Pastor of the Church of Christ, in Groton—born of respectable parents, in the town of Newton; educated at Harvard College, in Cambridge, New England, of such natural and acquired endowments as rendered him an ornament and blessing in the several relations which he sustained.

He was a good steward over the House of God, and discharged the duties of his Pastoral relation with prudence and impartiality, diligence and fidelity.

He was a tender and loving husband, affectionate and kind parent, an agreeable and faithful friend, and useful member of society.

He was much beloved and respected while he lived, and died greatly lamented, the 9th day of Sept., A. D. 1760, in the 69th year of his age and 46th of his ministry, and is, we trust, enjoying the reward of his labors in the kingdom of his Lord. And in honor to his memory his loving people have erected this monument over his grave.

"Blessed are the dead that die in the Lord, for they rest from their labors and their works do follow them."
