# TRACY FAMILY

## INTRODUCTION.

The compiler of this Tracy lineage has not tried to write a genealogy, but only to arrange in as compact form as possible, one line of the Tracy family, with notes of inter-marrying families—for private circulation.

Much of the data will be interesting to families not in this direct line, but who descend from the same ancestors. The left hand page is intended for corrections, as there are always some to be made in records of this kind; and the blank leaves at the back of the pamphlet are left to enable any one to complete his individual line from any ancestor mentioned here.

The data has been obtained from "Burke's Peerage."

"Americans of Royal Descent" by Browning "Hyde Genealogy." Caulkin's "History of Norwich" and from family records.

A Tracy chart was arranged first, but it was impossible to put on the chart the names of all the lineal ancestors of Howard Van Sinderen Tracy that we were able to find, as it would have made the chart too large, but *all* the names appear in this pamphlet, and the line is given complete from EGBERT, FIRST KING OF ENGLAND, down to Howard Van Sinderen Tracy.

The chart is not a necessary adjunct of the pamphlet as the latter forms a complete record by itself.

The first ancestor mentioned is Dreux, and his wife was in the eighth generation from Egbert, King of all England. Counting from Dreux we have here given thirty-one generations.

In a book being published by Lieut. C. S. Ripley, U. S. N., called "The Ancestors of Lieut. Thomas Tracy, of Norwich," genealogies are given showing that the Tracys descended from the

Vikings, Britons, and West Saxons, Saxon Kings, Pepin, Charlemagne, Hugh Capet, Emperors of Constantinople and of Russia.

In several instances different birth dates are given by different authorities for the same individual. In these cases the dates that have the preponderance of evidence are given here.

Dreux is in the eighth generation, but he is numbered No. 1, as we did not have his line complete back seven generations when the chart was made.

#### EIGHTH GENERATION.

Dreux, Count of Vexin, called by English historians 1 Walter De Mante, Count of Mantes. He was great grandson of Waleran, who succeeded Hugh the Great, Duke of France, father of Hugh Capet, as Count of Vexin in 956, and is said to be descended from Emperor Charlemagne and Hildegarde of Swabia, his wife. Dreux died in Bythinia in 1035. He married Princess Goda, eighth in line of descent from King Egbert. She was youngest daughter of King Ethelred II. by his last wife, Ethelred II. was son of Edgar, who was the Emma. son of Edmund I., who was the son of Edward, who was the son of Alfred the Great, who was the son of Athelwulf, who was the son of Egbert I., King of all England. Emma, wife of King Ethelred II., was daughter of Richard I., Duke of Normandy. She held lands in the reign of her brother, King Edward, the Confessor, which lands remain in the hands of some of her descendants at this time (1864).

#### NINTH GENERATION.

2 Rudolph or Ralph De Mantes, second son of No. 1, was lord of the Manor of Sudeley and of Toddington. He inherited this from his mother; he was made Earl of Hereford by his uncle, Edward the Confessor, of which earldom his son was deprived during the reign of William the Conqueror. Rudolph married Gethe She held lands in her own right in Buckinghamshire and she is called in "Dooms Day Book" Gethe, wife of Earl Rudolph. Rudolph died December 21, 1057; was buried at Petersborough.

#### TENTH GENERATION.

3. Harold de Mantes, only son of No 2, married Matilda, daughter of Hugh Lupus (the first earl of Cheshire), and Ermitude, his wite. Hugh was son of Richardgoz Viscount d Auveranche, and his wife, Margaret, a half sister of William the Conqueror.

#### ELEVENTH GENERATION.

4 John De Mantes, eldest son of No. 3, inherited lands from his father in Gloucestershire and then became John DeSudeley, Lord of Sudeley and Toddington. A. D. 1140, he married Lady Grace Tracy, (the ancestor of Grace was Le Sire de Tracy, who came over with William the Conqueror and fought at the battle of Hastings) daughter and heiress of Henry de Tracy, or Traci, Feudal Lord of Barnstable, in Devonshire. The barony was given to him by King Stephen of Normandy, as Henri de Traci was an excellent soldier and the only person in the County of Devon who stood firm to the King, "and he did the King considerable service in those Western parts." John and Grace had two sons, Ralph, the heir of his father, and William de Sudeley, the heir of his mother, Lady Grace, and he, (William), assumed the name of Tracy instead of keeping his father's name, de Sudeley.

#### TWELFTH GENERATION.

5 Sir William Tracy was second son of No. 4. He was Knight of Gloucestershire, also held lands in Toddington to the extent of one Knight's fee from his brother, Ralph de Sudeley. Sir William died in Devonshire and was buried in the Church of Marthoe.

#### THIRTEENTH GENERATION.

6 Sir Oliver Tracy, eldest son and heir of No. 5, was a Knight of Gloucestershire during the reign of King John; was in possession of the estates of Barnstable.

#### FOURTEENTH GENERATION.

7 William Tracy, son of No. 6, was in arms against King John in 1215 and his property was confiscated, but it was restored to him by Henry III. about 1217. William married Hawis De Born, and he died about 1224 in Toddington.

#### FIFTEENTH GENERATION.

8 Henry Tracy, son and heir of No. 7, lived in Toddington; died about 1246. He had two sons and one daughter.

#### SIXTEENTH GENERATION.

**9 Henry Tracy**, eldest son and heir of No. 8, was presented to the Church of Marthoe in Devonshire in 1275.

#### SEVENTEENTH GENERATION.

10 Sir William Tracy, son and heir of No. 9, was a Knight of Gloucestershire in 1290 and had command in the Scottish wars.

#### EIGHTEENTH GENERATION.

11 William Tracy, of Toddington, son of No. 10, was a ward of Laurence Tresham in 1300. He was a Knight and Sheriff for five years, from 1324 to 1329; was elected to Parliament in 1313 and 1321. The office of Sheriff in those days was a very dignified and important position.

#### NINETEENTH GENERATION.

12 William Tracy, son and heir of No. 11, had a mandate to raise troops for the King during the reign of Edward III.

#### TWENTIETH GENERATION.

13 Sir John Tracy, son and heir of No. 12, was in Parliament as one of the Knights of Gloucestershire in 1357; was Sheriff in 1368–1369.

#### TWENTY-FIRST GENERATION.

14 Sir John Tracy, son of No. 13, was a member of Parliament, also Sheriff of Gloucestershire in 1378. Died in 1379.

#### TWENTY-SECOND GENERATION.

15 William Tracy, of Toddington, son and heir of No. 14, was Sheriff in 1395. Died in 1399.

#### TWENTY-THIRD GENERATION.

16 William Tracy, of Toddington, son and heir of No. 15, was Sheriff in 1418 and 1431. He was called to the Privy Council of Henry the VI. He married Alice, the widow of William Gifford. She was daughter and heiress of Sir Guy de la Spine, Lord of the Manor of Coughton in Warwickshire. (See Lodge's Peerage of Ireland, 1754.)

#### TWENTY-FOURTH GENERATION.

17 William Tracy, of Toddington, eldest son and heir of No. 16, was Sheriff in 1443, 1444 and 1450. He married Margaret Pauncefort. She was daughter of Sir John Pauncefort and Margaret Beauchamp, his first wife.

#### TWENTY-FIFTH GENERATION.

18 Henry Tracy, Esq., of Toddington, was son and heir of No. 17. He married Alice Baldington. She was daughter and co-heiress of Thomas Baldington, Esq., of Alderly. Henry died about 1506.

#### TWENTY-SIXTH GENERATION.

19 Sir William Tracy, of Toddington, eldest son and heir of No. 18, was Sheriff in 1513. He married Margaret Throckmorton, daughter of Sir Thomas Throckmorton and Margaret Ordney, his wife. This Sir Thomas was son of Sir John and Eleanor Throckmorton. Eleanor was daughter and co-heiress of Sir Guy de la Spine, Lord of the Manor of Coughton in Warwickshire. Sir William died about 1531. He was one of the first who embraced the reform religion during the reign of Henry VIII.

#### TWENTY-SEVENTH GENERATION.

20 Richard Tracy, second son of No. 19, was Sheriff in He obtained grants of lands from the Crown at 1559. Stanway and Beckford. He was well educated and before the death of Edward VI. wrote several treatises in defence of his father's faith. He married Barbara Lucy, pupil of Fox, the Martyrologist. (See Miscellaneous Notes.) She was daughter of Thomas Lucy, of Charlecote in Warwickshire, and it was her nephew on whom Shakespeare took revenge by writing of him in one of his plays as "Justice Shallow," as it was before Sir Thomas L 1cy that Shakespeare was arraigned for deer Richard was Sheriff in 1560. stealing. Barbara was a descendant in the sixteenth generation from Hugh de Mountfort, son of Gilbert de Gamet (or Gaunt) and Alice Mountfort, his wife, and great grandson of Baldwin V., Count of Flanders, who married Alice, daughter of Robert II. of France. Through her ancestress Judith, wife of Baldwin I., Count of Flanders, Barbara Jescended from the Emperor Charlemagne, and through his ancestress Alfritha, wife of Baldwin II., Count of Flanders, she descended from Alfred the Great.

#### TWENTY-EIGHTH GENERATION.

21 Nathaniel Tracy, second son of No. 20, received lands from his father at Tewksbury.

#### TWENTY-NINTH GENERATION.

22 Lieut. Thomas Tracy, son of No. 21, was born about 1610 at Tewksbury. He came to Salem, Mass., in 1636, lived there until 1637. Land was granted to him there. He came over to America in the interest of his friends,

Lord Say and Lord Brook. He removed to Connecticut in 1640; married in 1641 at Wethersfield, Mrs. Mason. She was widow of Edw. Mason. They moved to Saybrook, Conn., before 1639, which town was named after his two friends. He married for a second wife the widow of John Bradford (son of Gov. Bradford). Lieut. Thomas was a talented and active man; was much interested in ship building. He moved to Norwich in 1659; was one of the thirty-five original proprietors; he was representative of Norwich to the Legislature twentyseven sessions. He died about 1685. In 1645, he and Thomas Leffingwell, with others, relieved Uncas, the Sachem of The Mohegans, when he was besieged. Uncas afterward gave 400 acres of land to Thomas Tracy and Thomas Tracy was Lieutenant of Thomas Leffingwell. the New London County Dragoons, enlisting to fight the Dutch and Indians. In King Philip's war, in 1675, he, with John Bradford, was appointed Commissary and Quartermaster. He owned considerable real estate (more than 5,000 acres). Lieut. Thomas died Nov. 7, 1685. Buried in Norwich.

#### THIRTIETH GENERATION.

23 Capt. John Tracy, born in 1642, was eldest son of No. 22; he was one of the original proprietors of Norwich, Conn., and Justice of the Peace and representative from Norwich for six sessions. He married Mary Winslow in 1670. She was born in 1646. He died Aug. 16, 1702, at Norwich. She died July 31, 1721. Mary was daughter of Josiah Winslow, of Marshfield, Mass., (who was born in 1606 at Droitwich, England) and Martha (Bourn) Winslow, and she was niece of Gov. Edward Winslow, of the "May Flower." See Notes.

#### THIRTY-FIRST GENERATION.

24 John Tracy, eldest son of No. 23, was born in 1673; married Elizabeth Leffingwell. She was daughter of Thomas Leffingwell, who married Mary Bushnell, eldest daughter of Richard and Mary (Marvin) Bushnell, of Saybrook.

#### THIRTY-SECOND GENERATION.

John Tracy, son of No. 24, was born at Norwich in 1702. 25 He married January 21, 1724, Margaret Hyde. He died She was born at Norwich, Aug. 16, Aug. 20, 1786. 1702; was second daughter of John Hyde and Experience John Hyde was son of Samuel and Jane (Lee) Abel. Hyde of Norwich. Samuel was son of William Hyde. Experience Abel was daughter of Caleb and Margaret Margaret Post was daughter of John and (Post) Abel. Hester Hyde was daughter of  $\hat{\boldsymbol{\omega}}$ Hester (Hyde) Post. William Hyde. Margaret (Hyde) Tracy died at Franklin, Feb. 6, 1789. Jane Lee, wife of Samuel Hyde, was daughter of Thomas Lee and — (Brown) Lee. This Thomas Lee came from England about 1641; died on the passage over. His family went to Saybrook.

#### THIRTY-THIRD GENERATION.

26 Josiah Tracy, third son of No. 25, was born at Norwich, April 17, 1730; he died January 24, 1806. Married Dec. 15, 1757, Margaret Pettis. She was born March 4, 1740; was daughter of Peter and Abigail (Failes) Pettis, of Norwich. Peter was son of Charles Pettis. He was a farmer, lived in West Farm, now called Franklin. Margaret died Sept. 6, 1821.

#### THIRTY-FOURTH GENERATION.

Josiah Tracy, third son of No. 26, was born at Norwich, 27 Married January 20, 1795, Mary Birchard. May 7, 1772. She was born July 25, 1773, at Norwich; was daughter of Jesse Birchard and Lydia (Waterman), his wife, of Iosiah Tracy was a mechanic, lived at Frank-Bozrah. lin; removed to Columbus, N. Y., where his wife, Mary, died Sept. 10, 1840. Josiah died at Honesdale, Pa., April 3, 1844. Lydia Waterman was daughter of William Waterman (who was born in 1710) and Margaret (Tracy) Waterman. This William was son of John and Judith (Woodward) Waterman. John was born in 1672; was son of Ensign Thomas Waterman and Miriam Tracy, his wife. Miriam was only daughter of Lieut. Thomas Tracy and his first wife. She was born in 1648. So Mary (Birchard) Tracy descends from the only daughter of Lieut. Thomas Tracy, and Josiah Tracy, her husband, descends from the eldest son of Lieut. Thomas Tracy. Names of all the children of Josiah and his wife Mary are given in this pamphlet.

#### THIRTY-FIFTH GENERATION.

28 Judge Josiah Tracy, eldest son of No. 27, was born at Franklin, Conn., Oct. 1, 1796; he married, Aug. 18, 1824, Diantha Lathrop. She was born about 1802; was a daughter of Eleazor Lathrop, of Connecticut. He was one of the early settlers of Sherbourne, N. Y. Josiah settled at Painesville, O.; was engaged in the mercantile business with his brother; was a Colonel of militia. In 1832 he moved to Vermillion, O.; was superintendent of the Huron Iron Works. About 1835 moved to Huron, O.; was in the commission business; was also Mayor, Justice of the Peace, State Senator and one of the Judges of Erie County. Diantha, his wife, died at Huron, April 22, 1840. He moved to Mansfield, O., in 1847, and died there Jan. 11, 1857; was buried at his request at Huron, O., by his wife, Diantha. Names of all their children are given in this pamphlet.

#### THIRTY-SIXTH GENERATION.

29

Frederick E. Tracy, third child of No. 28, was born at Painesville, Ohio, May 6, 1831; he married May 10, 1855, Anna Tracy Lord of Honesdale, Pa.; he resided at Zanesville, O., in 1853; he was teller in the bank there moved to Mansfield, O., in 1858. He went into the wholesale grocery business; has been senior partner in the firm of Tracy & Avery since 1860, and still resides in Mansfield, O. (See "Lord Record" in this pamphlet for the lineage of Anna Tracy Lord, who married Frederick E. Tracy, No. 29).

#### THIRTY-SEVENTH GENERATION.

30 Howard Tracy, eldest son of No. 29, was born at Putnam, O., February 16, 1856; was educated at Oberlin, O., graduated at Amherst College 1876. He married Bessie Lindsley at Nashville, Tenn., May 5, 1886. They reside at Louisville, Ky. Howard is President and Manager of the Hull Coal & Coke Company T Bessie Lindsley is the daughter of Adrian Van Sinderen and Eliza (Trimble) Lindsley. Eliza was daughter of Judge James Trimble and ----- Alexander, his wife. Adrian Lindsley was son of Philip, who was President of Princeton College and of the University of Nashville, Philip Lindsley was son of Isaac and Phebe Tenn. (Cordit) Lindsley; Isaac was son of Philip, who was son of John, who was son of John, who was son of Sir

Francis Lindsley, of Lindsley, Leicestershire, England, in 1685, who settled in New England, then removed to Morris County, N. J. His descendants still reside there.

Phebe Condit was daughter of Ebenezer and Huldah (Byram) Condit. Huldah Byram was daughter of Ebenezer and Abigail (Alden) Byram. Abigail Alden was the daughter of Ebenezer Alden, who was son of Isaac Alden, who was son of Jozeph Alden, who was son of John and Priscilla (Mullen) Alden. This shows that Bessie Lindsley Tracy was ninth in descent from John and Priscilla Alden, whose story is too well known to need repetition here.

Ebenezer Alden married Ann Keeth.

Isaac Alden married Mehitabel Allen.

Joseph Alden married Mary Simmons.

Philip Lindsley married Margaret Laurence. She was the daughter of Lieut. Nathaniel Laurence and Elizabeth, (Berrien) his wife, who was daughter of Judge John Berrien, of New Jersey.

Lieut. Nathaniel Laurence was the son of Thomas and Elizabeth (Fish) Laurence and was born in 1761. He left Princeton College at the age of 16, and was appointed Lieutenant in the Revolutionary Army; afterwards he was Attorney General of New York and Member of the Legislature. He was given a large tract of land in Tennessee for his services in the Revolution. Some of his descendants still live on this land.

#### THIRTY-EIGHTH GENERATION.

31 Howard Van Sinderen Tracy, eldest child of No. 30, was born at Louisville, Ky., October 8, 1887.

#### THE SUDELEY ARMS.

The field of the escutcheon is gold and divided into four parts. The first and fourth have each in the chief point an escallop shell black, between two narrow red bands, all of which stand for Tracy—the shell denotes that an ancestor went on a pilgrimage or crusade. The second and third parts are divided by a plain green band with engrailed edge (um) and narrow black border for Hanbury.

#### CREST.

On an ermine cap turned up an escallop shell, black between two wings of gold for Tracy. Out of the sable mural crown a golden demi-lion rampant holding in the paws a black battle-ax with helm of gold for Hanbury. Supporters—On either side a purple falcon with wings extended and beaks and bills of gold. Motto--Memoria pii aeterna. The memory of the just is eternal.

## LORD, GARRETT, AND RUSSELL FAMILIES.

- **Solomon Lord**, the first ancestor of that name of which anything is known definitely, settled in Lyme, Conn. He was in the leather and shoe business. Sometime afterwards he started for England to see about some property, and neither he nor the ship was ever heard from. He left a wife and large family in Lyme and they resided in this vicinity for awhile, then separated and went to different places. This Solomon was probably a descendant of Wm. Lord, a son of Thomas and Dorothy Lord, who came from Braintree, England, about 1635. They had five sons and three daughters. One son, Thomas, settled in Hartford, Conn. Anna married Gen. Thomas Stanton of Hartford. William, third son of Dorothy, settled in Saybrook and his sons settled in Lyme; descendants lived in Lyme and that vicinity.
- **Solomon**, son of the first Solomon, lived in Windham, Conn. The impression of some of his descendants is that his name was Solomon Z., but in all official records found, he is called only Solomon and he signs himself so on a bond which is owned by Russell F. Lord. This bond is dated March 20, 1817, and describes a sale of a lot of land in Rome, N. Y., for \$250.00 by Solomon Lord and Eli Root to John Driggs.

Solomon lived in Rome, N. Y., a short time before he went to Oriskany, N. Y. He married Meriam or Marion Coleman of Coventry, in Windham, Conn., April 3, 1766. They had:

BETSEY, born at Coventry, May 16, 1769.

ZELOTIS, born at Windham, Aug. 24, 1771.

CHARLOTTE, born at Windham, Dec. 2, 1772.

NATHAN, born at Windham, March 9, 1774.

(See Windham, Conn., Town Records.

Solomon enlisted from Windham during the Revolutionary War in the 4th Regiment, Connecticut Line, under Col. John Durkee. This regiment was a part of the first Connecticut Brigade, which Brigade was at one time part of the wing of the army commanded by Lafayette. (See "Official Records of Connecticut;" also "History of Windham."

Solomon died about 1820 at the home of his daughter Betsey (Lord) Root, wife of Eli Root, of Oriskany, N. Y. He was 88 years old when he died. A descendant of Betsey Root has a picture of Solomon and his wife, Meriam.

There is a letter extant which Eli Root wrote to his father-in-law, Solomon Lord, in 1792, giving him a description of his new home in Oriskany.

The house built by Eli Root in 1835 and where he and his wife, Betsey (Lord) Root, lived, is still extant. Three generations of the descendants of Solomon Lord have been born in this house.

Meriam was daughter of Gershom and Mercy (Allis) Coleman, who were married Jan. 3, 1745. It is likely that Gershom descended from Thomas Coleman and Susanna, his wife, who came to America in 1635.

As we have stated, Betsey Lord, daughter of Solomon, married Eli Root. Charlotte Lord, her sister, married Daniel Babcock about 1795. We have a copy of a letter written by this Charlotte to her sister, Betsey Root, dated Windham, June 4, 1849. She tells of her health and of her family; says: "Our uncles and aunts are all dead; we have no friends left in Coventry. Have not heard from our brother Zelotis for several years. Uncle Jenning's family have all left Windham and gone west, except Nathan and he is in New York." These Jennings descended from the Coleman family of Coventry. Betsey and Charlotte Lord had a brother Nathan who died in infancy and a brother Zelotis.

This Zelotis (third in descent from the first Solomon Lord) was born at Windham, Conn., Aug. 24, 1771. He married Sarah or Sallie Farnham at Hebron, Feb. 14, 1798. Sallie Farnham was born Nov. 27, 1774. Proof cannot be found of where she was born; the impression is that it was at Norwich, although no record can be found of it. Her daughter, Sarah L. Hull, said that Sallie was daugh-Sallie's parents were from Norwich. ter of Capt. John and Elizabeth (Chapman) Farnham, was related to or descended from the Russell family of New Haven. Her sister, Elizabeth (so her descendants state), came from that part of Norwich called "Bean On R. F. Lord's monument, where Sallie is Hill." buried, it is inscribed that she was born at Hebron, Conn. Many Town Clerks have been corresponded with, but no birth-place can be found for Sallie, but dates of her marriage and children are recorded, and it is known that she was living with her sister Elizabeth when she married Zelotis Lord. The sisters were orphans at this time. She married Zelotis Feb. 14, 1798. They lived in Hebron, Conn., about a year, and their first child, Solomon Z., was born there March 16, 1799. In 1800 they moved to Rome, N. Y.; resided there until 1840; then moved to Honesdale, Pa., and lived with their son, Russel F. Lord. Zelotis died here July 8, 1850.

Then Sallie went to live with her son, Solomon Z. Lord, and died there Jan. 4, 1859.

Children of Zelotis and Sallie Farnham Lord were:

- Solomon Z., born at Hebron, Conn., March 16, 1799; died June 29, 1890. Married, 1st, Adeline Garrett (See Notes of Garrett family); they had four children. He married, 2nd, Sarah Jessup; they had seven children.
- Russel F. Lord, second son of Zelotis and Sallie Lord, was born Aug. 17, 1802, at Rome, N. Y.; married, 1st,

Mary Ann Garrett, Jan. 4, 1832. She was a sister of his brother Solomon's first wife. Russel F. was a Civil Engineer. was employed by the Delaware & Hudson Canal Co. in 1826. In 1831 he was made Chief Engineer at Honesdale, Pa., and held this responsible position until 1864, when he resigned on account of age and ill health, but was retained as Consulting Engineer until his death, July 7, 1867, at Honesdale.

His wife, **Mary Ann Garrett**, was born at Trenton, N. Y., Sept. 24, 1809. She died at Honesdale, July 26, 1847. She was daughter of Samuel and Irene (Russell) Garrett. who moved from Connecticut to Oneida County, N. Y., and settled in the town of Remsen. They both died in 1816 when Mary Ann was only 7 years old. She had two sisters and three brothers, as follows:

The eldest sister, Emily, was born at Utica, N. Y., Feb. 9, 1801. Married Gerrit Van Frank, April 15, 1824. Died Nov. 14, 1854.

Adeline, born July 4, 1803; married Solomon Z. Lord, April 4, 1826.

Wyllys Russell, born Feb. 16, 1808; died June 10, 1816.

James Carnahan, born Nov. 19, 1812. Married Nellie Veghte Gambling, Dec. 20, 1834. Died June 21, 1893.

Henry Dwight, born Sept. 5, 1814; died 1837.

Mary Ann was brought up in the family of Hon. Andrew Billings, of Remsen. **Samuel Garrett** was born at Branford, Conn., April 10, 1773; died at Utica, N. Y., Jan. 16, 1816. He married Irene Russell in 1800. He was a son of **John Garrett** and Hannah Barker, his wife. John was born in London, Eng., Aug. 14, 1728. He married Hannah in 1767 in New Haven. She was born in 1735; was related to the Maltbys and Russels, of New Haven. The Maltbys came from Maltby, Yorkshire, Eng., which was in possession of the family over 800 years. This John was left an orphan; was adopted by an uncle who was a sea captain. He accompanied his uncle on many voyages; then settled in New Haven.

He was in the War of the Revolution. He had two half brothers. One settled at or near where Cleveland, O., now is, and the other brother, Peter Garrett, settled where Cincinnati now stands. Irene Russell was born at Branford, Conn., in 1781; died at Utica, N. Y., Jan. 4, 1816. She was daughter of John and Hannah (Plant) Russell, who married in 1778. This John Russell was son of Col. Edward and Mary (Barker) Russell. Col. Edward was son of John Russell and Mary (Trowbridge) Russell. Col. Edward was in the War of the Revolution. (See Official Records of Connecticut.)

John Russell who married Mary Trowbridge, was son of John Russell and Sarah (Maltby) Russell. This John was son of **Rev. Samuel Russell** and Abigail (Whiting) Russell. **Rev. Samuel** was son of John Russell, the Emigrant, who came to Cambridge, Mass., in the ship Globe about 1634. His ancestors were of English origin to the time of William, the Conqueror. Then in France, the family can be easily traced, perfect in every link, to the year 500 A. D.

The following is from "Lower's Essays on English Surnames," and from "Bardsley's English Names," second edition:

The names Garrett, Jarrett and Jarrard are all corruptions of the name of the old Norman Saint Girard, who was held in high repute previous to the eleventh century.

The surname Russell is undoubtedly derived from le Russe, which latter is only one form of the endless corruptions of le Rouse, a sobriquet given on account of a light or red complexion and very familiar to all who have spent any time over mediæval registers, as Peter le Russe, Martin le Ruse, William le Rus, Willecocus Russel. These names all appear on the "Hundred Rolls."

**Russel F.** and Mary Ann (Garrett) Lord had seven children, but four died in infancy. Anna Tracy Lord, the eldest child, was born at Honesdale, Pa., Nov. 1, 1832. She married Frederick E. Tracy, May 10, 1855. He is in the thirty sixth generation from King Egbert (see Tracy Record). Names of all their children are given in this pamphlet.

Russell F. Lord, Jr., eldest son of Russel F. and Mary Ann (Garrett) Lord, was born Oct. 1, r837, at Honesdale, Pa. He married Mary Jane Farnham, of Port Jervis, N. Y., May 19, 1860. He is now in Ecuador, South America; is superintendent and manager of the mine called "The Plaza del Oro."

They had seven children:

She died and he married, Nov. 19, 1872, Fannie T. Eaton. They have one child, Mira E. Lord, born May 10, 1874; married June 6, 1894, Lieut. John Lewis Hayden, First U. S Artillery. They have one child, James Lord Hayden, born March 15, 1895, at Seattle.

Major James H. Lord graduated from Military Academy, West Point, June 17, 1862; promoted brevet Second Lieutenant of Second Artillery same day; July 24th, same year, was promoted Second Lieutenant of the same regiment, served in the Army of the Potomac during the War of the Rebellion in Northern Virginia campaign in 1862; was engaged at the battles of Malvern Hill, Second Bull Run, Chantilly and several skirmishes; participated in Maryland campaign; engaged in the battles of South Mountain, Antietam; took part in the march back to the Rappahannock River; engaged in the battle of Fredericksburg, Va.; transferred to the Western Army; took part in the movements of the Ninth Army Corps; participated in Vicksburg campaign; promoted to First Lieutenant in 1864; took command of his battery in 1865; engaged in the battles of Dinwiddie Court House, Five Forks, Lisbon Centre, High Bridge, Farmville, Appomattox Court House and at the surrender of Lee; brevetted First Lieutenant July 1, 1862, for gallant and meritorious conduct at the battle of Malvern Hill; brevetted Captain Sept. 17, 1862, for gallant and meritorious conduct at the battle of Antietam, and brevetted Major April 9, 1865, for gallant and meritorious service in action at Appomattox Court House, Va. Lieut. Lord was at Headquarters of Second Division, Cavalry Corps, as Aide to Gen. Crook. Having been appointed Captain of the Volunteer Staff; afterwards took command of Fort McHenry, Md.; transferred to the Pacific Coast; served Presidio, San Diego, and in garrison at Presidio, San Francisco; stationed at Governor's Island, New York Harbor, for several years; promoted Major Oct. 4,

1889. and ordered to San Francisco as Depot Quartermaster, which position he served in until he retired on account of poor health in 1892 or 1893. He is still living in San Francisco at this date, 1895, and still an invalid.

Mary Ann (Garrett) Lord died at Honesdale, Pa., July 26, 1847, and Russel F. married 2d, Jan. 29, 1849, Lizzie M. Scott, of Mt. Pleasant, O., daughter of John W. Scott, Professor of Miami College, and his wife Mary daughter of John Neal.

Russel F. and his second wife had three children; Walter Scott Lord, born Feb. 27, 1851, was a civil engineer, deceased. Lizzie Lord, born Dec. 23, 1852 married Lieut. John Parker, U. S. N. Mary Scott Lord, born April 30, 1858, married Walter Dimmick. He only lived a few months.

Mrs. Lizzie Lord died in Washington, D. C., at the White house, Dec. 10, 1889. She was a sister of Mrs. Caroline Harrison, wife of President Benjamin Harrison. Alfred Chapman Lord, third son of Zelotis and Sallie Lord, and brother of Russel F., was born Oct. 17, 1805, at Rome, N. Y. He married Laura P. Blossom in 1836. They had eleven children.

Sarah Lord, only daughter of Zelotis and Sallie Lord, was born at Rome, N. Y., Sept. 28, 1808, married Sept. 9, 1830, Rev. Leverett Hull, of Bethlehem, Conn. (See Records of Descendants of Richard Hull, of New Haven, compiled by Puella F. (Hull) Mason.) Leverett and Sarah had five children. Rev. Leverett died Sept. 3, 1852, at Sandusky, O. Sarah died March 3, 1891, at Maryville, Tenn.

Sallie Farnham Lord had four brothers, John, James, Russell and Charles, and a sister, Elizabeth.

Mrs. Sarah Lord Hull always stated that Capt. John Farnham and his wife came from Norwich, Conn., but as yet no official record has been found, but Sallie was living with her sister Elizabeth when she married Zelotis Lord. This Elizabeth married, 1st, Daniel Caulkins. They had one child, Nancy. Among her descendants are James O. Way, Mrs. W. S. Ellis, of Gilead, Conn., Mrs. Clara E. Hanmer, of Wethersfield, Conn., John L. Way, of St. Louis. This data is given, as some day it may be a clue to finding something about Sallie's and Elizabeth's ancestors.

Elizabeth (Farnham) Caulkins, only sister of Sallie (Farnham) Lord married, 2d, John T. Peters, of Hebron He was later judge of supreme court of Hartford, Conn. They had a large family. Among them was, 1st, Mary O, who died unmarried; 2d, Hugh who graduated at Yale, was admitted to the bar in Cincinnati, O.; He was accidentally drowned; 3rd, Abigail who married Rev. B. Treat, a lawyer, afterwards a minister. He was settled at Newark, N. J., then was appointed secretary of the A. B. F. M., held this position till he died. He resided in Boston. Only one of their children is living, Rev. Chas. Treat. Rector of St. Stephen's Church, New York City.

Several of Elizabeth (Farnham) Peters descendants have been corresponded with, but knew nothing more of the Farnham family than we have given.

Elder John Strong, the ancestor of Rev. Sydney D. Strong, sailed from Plymouth, England, for America March 20, 1630, in company with 140 others. Among this number were Rev. John Warham, Roger Clapp and John Mason. The name of the ship was "Mary and John." They landed at Nantasket, Mass. After searching for a few days they settled and called the name of the place Dorchester.

Mary Winslow, who married Capt. John Tracy, No. 23, was daughter of Josiah and Margaret (Bourn) Winslow, of Marshfield. Gov. Edward, this Josiah and Kenelm Winslow, were all brothers, sons of Edward Winslow and Magdalin, his wife, of Droitwich, Eng., all born there. Gov. Edward came to America in the "May Flower'' in 1620, and Josiah and Kenelm came in 1629, in the "May Flower" (its second or third trip). Josiah was born Feb. 11, 1605. He was Representative at Plymouth, Town Clerk for thirty years; died in 1674. These three brothers were grandsons of Kenelm and his second wife, great grandsons of John and Agnes (Throgmorton) Winslow of England. (See N. E. Register, Vol. 21, page 210). Louise M. and Waldo Tracy Winslow, descend from Josiah Winslow, and Dr. C. E. and Fayette D. Winslow, their husbands, descend from Kenelm Winslow, brother of Josiah and Gov. Edward Winslow.

Many who will read this pamphlet, knew Mrs. Sarah Lord Hull. She was an acknowledged authority on family relationship. She often said that in the year 1830 or 1832, she visited Mr. John Lord, of Lyme, and that he and her father Zelotis Lord were cousins. She used to talk with Rev. C. B. Lord, of Maryville, Tenn., about this visit at the home of his father. Rev. C. B. was about 14 years old at the time.

This John Lord mentioned above was a lineal descendant of Thomas and Dorothy Lord, who came to America with seven children in the ship "Elizabeth and Ann" in 1635. They went to Newton, afterwards Cambridge to join their eldest son, Richard, who had come to America in 1632.

John Lord, father of the John Lord whom Mrs. Hull visited, had a brother Samuel, so the "Salisbury Records" state. These records also state that letters "were sent to Lyme to obtain news of this Samuel, but were returned unopened." Taking these facts in connection with the fact that one of Zelotis Lord's ancestors sailed for England from Lyme and was lost at sea and that he left a large family in Lyme, which family scattered soon after their father was lost, it seems very likely that this Samuel was an ancestor of Zelotis and explains why no official records are found back of Solomon Lord, father of Zelotis. If this is so, the John Lord that Mrs. Hull visited was a cousin of her father, just as she stated. It is possible either that Zelotis' grandfather was named Samuel or that the Samuel of the Records has been misread and should be Solomon. This latter could be very easily the case, especially if the name is abbreviated on the Record, as Solm. might readily be taken to be Saml. -

The writer has in her possession a letter written by Zelotis Lord dated Hebron, Sept. 12, 1797, to his parents in Rome, N. Y., in which he tells them of his intention to move from Hebron, where he had been about two years, to Rome, and also writes that he has recently met a young lady whom he wished to marry, and wishes to have the approbation of his parents. He also says that it is possible that he will visit them before he goes to Rome to live, and that he is in perfect health.
