THROOP GENEALOGY

WILLIAM THROOPE, b. 1637, d. Dec. 4, 1704; a Puritan in religion; was of Barnstable, Mass., having been one of the "inhabitants admitted after 1660 and before 1700;" was surveyor of highways for Barnstable in 1677 and 1683; a grandjuryman in 1680; removed to Bristol. R.I., in 1680, taking his family overland in an ox-cart, and was one of the original settlers there; took a prominent part in the public affairs of that place,-was a selectman in 1689, a grand-juryman in 1690, and representative in the Rhode Island Assembly in 1691; was a friend and neighbour of John Walley who was the lieutenant of Sir Wm. Phips in the Quebec expedition of 1690; his Will, dated June 12, 1704, began "In the name and fear of God, I, William Throope, in ye County of Bristol, yeoman, Amen. in the sixty-seventh year of my age and being under some indisposition of body," and in it bequests are made to each member of his family, "his loving and well-beloved wife Mary" was made sole executrix, and he mentioned "the remaining service of two Indian boys which may be unexpired at my decease;" on May 14, 1666, m. Mary Chapman, b. Oct. 31, 1643, d. June, 1732, daughter of Ralph Chapman of Marshfield who came in the ship Elizabeth from London, in 1635, aged 20. described as "shipcarpenter from Southwark in Surrey," who had m. Lydia Willis or Wells on Nov. 23, 1642. Children: Mary, b. April 6, 1667, who m. John Barney; Dan, b. 1670, see further; Elizabeth, b. 1672, who m. Jonsthan Peck; John, b. 1676, d. 1772, deacon of Bristol, among whose descendants were Rev. Amos Throope, b. 1702, d. 1735, of Woodstock, Ct., whose grandson Dr. Amos Throope was an eminent physician and president of the Medical Society of Rhode Island in 1812-14, and Hon. John Throope, b. 1733, of the state of Vermont; Thomas, b. 1681, d. 1756, deacon of Bristol, ancestor of Captain Billings Throope, b. 1735, of Bristol, Thomas Billings Throope, b. 1771, of Middleburg and Hamover, N.Y., and Algonquin, Ill., Col. Wm. Throope, b. 1771, of Bristol, Capt.

George Throope, b. 1774, of Fort Ann. Clintonville and Willsborough, N.Y.; Mercy, living unm. in 1704; Lydia, b. 1686; Capt. William Throope, b. 1678-79, d. 1737, of Bristol and Lebanon, held many positions of honour and reputation, ancestor of many, including the following: Capt. William Throope, b. 1699, d. at the siege of Louisburg under Sir Wm. Pepperrell, Cape Breton Expedition, 1745-46; Rev. William Throope, b. 1720, minister at Southold, L.I., N.Y.; Rev. George Throope, b. 1723-24, minister at Johnstown, N.Y., and tutor of the children of Sir Wm. Johnson; Col. Josiah Throope, b. 1727, of Halifax and Cumberland, N.S., Canada, returned to the United States; Enos Thomson Throop, b. 1784, d. 1874, lawyer, Governor of New York State, 1831-33, and charge-d'affaires to the Kingdom of the Two Sicilies, 1838-41; Hon. George Bliss Throop, b. 1793, lawyer and politician in Auburn, N.Y., and Detroit, Mich.; Hon. Montgomery Hunt Throop, b. 1827, of Utica, N.Y., and New York City, lawyer and legal author; George Enos Throop, the advertising expert, now of Chicago, III.; Rev. Benjamin Throope, b. 1712, d. 1785, pastor of the church he organized at Borzah, Ct., from 1738 to 1785, a graduate of Yale and a very able minister of the Congregational church, was chaplain of the Crown Point expedition in 1755; Octavia Throope, b. 1754, who m. Rev. Enoc Hale, grandfather of the Rev. Dr. Edward Everett Hale; General Dyer Throope, b. 1738, officer in the Revolutionary war; Col. Benjamin Throope, b. 1744, d. 1822, prominent in the war of the Revolution; Major Dan Throope, b. 1768, at Borzah, removed to Oxford, N.Y.; Capt. Simon Gager Throope, b. 1790, lawyer at Oxford, N.Y.; Dr. Benjamin Henry Throope, b. 1811, d. 1889. practised at Scranton, Pa.; Benjamin Throop, millionaire coal operator, now resident in Scranton, Pa.; probably, Professor Willard L. Throop of Amherst College, at present; probably, George Reeves Throop, Ph.D., LL.D., now Chancellor of Washington University; probably, Lt. Col. George H. Throop, military engineer, of Mamaroneck, N.Y.; Arthur W. Throop, b. Dec. 3, 1851, retired Civil Servant, Ottawa, Canada, son of Robert H. Throop, b. 1812, of Cobourg, Ont., Canada, grandson of Benjamin Throop, b. Oct. 19, 1778, of Cobourg, greatgrandson of Col. Benjamin Throop, b. 1744, great-great-grandson of Rev. Benjamin Throope, b. 1712, great-great-great grandson of William Throope, b. 1678-9, and great-great-greatgreat grandson of William Throope, b. 1637, the first settler firmly for generations by many branches of the family, William Throope, b. 1637, d. 1704, was a son or near relative of Colonel Adrian Scrope, Scroop or Scroope, and fled to America, probably by way of Leyden, Holland, and assumed the name of William Throope because of the further protection it afforded him in the then British colony. It is recorded in the "Hartford Book of Possessions," p. 585, that an Adrian Scroop signed as witness to the execution of deeds of land in 1665 and 1667, and nothing more is known of him, but it has been believed he removed to Barnstable and was the man who adopted the alias William Throope.----Colonel Adrian Scroop, b. 1601, of the great House of Scroop, which could trace their lineage back to the Conquest, if not to Edward the Confessor, was an indirect descendant of the noble family of Scroop. He was a direct descendant of the family barons of Bolton. in Buckinghamshire, the head of which was ennobled. He himself occupied the Scroop mansion at Wormsley, Oxford-Scroop was prominent under Cromwell in shire. England. the Great Rebellion; fought at Edgehill and other battles, was Governor of Bristol Castle, a Commissioner to Scotland, and was appointed one of the High Court of Justice which condemned Charles the First to be beheaded. He attended that Court with exemplary regularity, sat close to Bradshaw, the President, was 37th to sign the death warrant on Jan. 27, 1648. During the political revolutions of 1659-60, he apparently remained neutral and had some prospect of escape at the Restoration of Charles the Second. He surrendered himself in obedience to the King's proclamation; the House of Commons voted he should have the benefit of the Act of Indemnity on payment of one year's rent, but the House of Lords ordered all of the King's judges to be arrested and excepted Scroop absolutely from pardon. Later, the Commons reiterated their vote in Scroop's favour, but the Lords remained firm. Taken altogether, this was an inexcusable breach of faith, as Scroop had surrendered in reliance upon the King's proclamation. At his Trial, held at Old Bailey, Oct. 12, 1660, Scroop defended himself with dignity and moderation. He admitted, reluctantly, that he had signed the death warrant of Charles the First. Pleaded that "he was not in the parliament, and that which was done in the high court of justice, it was done by a commission from the parliament, and it was that authority that was then accounted the supreme authority of the nation." Answering this plea, the presiding judge gave an exposition of the British Constitution, showed that the socalled Parliament which had appointed the High Court of Justice was not only unconstitutional but unrepresentative, for "there was but forty-six sat, whereas there were above two hundred and forty excluded," and said: "When men shall assume an authority never heard of before. if men will countenance their acts by obeying them, it is an aggravation." Scroop then pleaded: "If I have been misled, I am not a single person that has been misled, for I see a great many faces that were misled at that time as well as myself," and "I hope that an error of the judgment shall not be accounted an error of the will, for I never went to the work with a malicious heart," to which Lord Chief Barron relied: "If a man do an act of this nature, that may be some kind of excuse to God, but towards man you are to look to the fact." Scroop then reminded the Court that he had surrendered himself on the King's proclamation, but Richard Browne, lord mayor elect of London, in whom "there was great meanness, if not worse," certainly a renegade, for he had been formerly a major-general in the parliamentary army and a kind of a friend of Scroop's, now anxious to prove his loyalty to the new regime, swore that since the restoration of Charles the Second. Scroop had used words apparently justifying the late King's execution and had not pronounced it murder, saying "some are of one opinion, and some of another," and this evidence, which also led to the abandonment of Scroop by the Commons, sealed his fate and he was executed at Charing Cross on Oct. 17, 1660. The Chief Justice, who treated Scroop with great civility and was as just as could be expected at the time, stated: "Mr. Scroop to give him his due is not such a person as some of the rest, but he was unhappily engaged in this bloody business." Noble in his "Lives of the Regicides," states: "It was a thousand pities that if so many were to die as public examples, some of the others who were equally guilty of the King's death, and whose lives were a disgrace to any cause, were not substituted in his stead." Ludlow, a contemporary, said: "His port and mean were noble, and the endowments of his mind every way answerable," and an account of his behaviour in prison and at the gallows describes him as "a comely ancient gentleman," and dwells on his cheerfulness and courage. The night preceding his death, a nephew came to him in his dungeon and requested him to repent of the part he had acted in the King's death, and submit to the present King's mercy, to which he replied, "avoid satan," and this same night he composed himself and "slept so sound he snored." At the gallows he referred to "him through whose means I was brought here to suffer, I say no more, the Lord forgive him, I shall not name him," and in his last prayer, he asked for "strength to stand and endure the present hour of temptation," after which the executioner performed his bloody office.

DAN THROOPE, b. 1670, d. Dec. 9, 1737; son of the above; born in Bristol, R.I.; removed to Lebanon, Ct., in 1712, and was a member of the church there in 1726; m., first wife, Dorcas, daughter of Jacob and Ann (Witt) Barney, in 1689; m., second wife, Deborah Marcy at Bristol, in 1697-8; in 1712, m., third wife, Deborah (Tucker) Church, daughter of John Tucker of Hingham, granddaughter of Richard Church, d. 1668, who m. Elizabeth Warren, daughter of Richard Warren of the Mayflower: epitaph, in the oldest cemetery of Lebanon. reads, "Here lies the body of Mr. Dan Throope, who, while he lived, discovered a very serious, generous and public spirit, and after a useful life, departed in ye comfortable hope of a better, thro ye mercy of ye Lord Jesus, in ye 67th year of his age." Children, first w., Mary, b. 1691; Dorcas, b. 1693; William, b. 1695; second w., Mercy and Alary (Twins), b. 1698; Samuel, b. 1700; Deborah, b. 1702; Dan, b. 1704; Submit, b. 1706; third w., Dan, b. 1715, of whom his grandson, Rev. Dan Huntington, says in his Memories, "He planted down on a beautiful eminence in Lebanon, about two miles east from the meeting-house. There was enough land for him and three sons, all of them having large families; comfortable domiciles; happy hearts. The number of slaves he brought with him from Bristol was two or three too many. In my childhood and youth I loved dearly to visit there and to have their visits in return at my own happy home. In their character, embracing two or three generations, I have found the Throops to be ingenuous, sincere and open-hearted. They took everything

easily. They were social, gregarious, fond of good humour, In Lebanon they were agriculturists and and good living. formed very much a neighbourhood by themselves. They were industrious but never, I believe, in a hurry about their business. The Throopes in their persons, so far as I can recollect, have been of manly stature, well proportioned, comely, and naturally graceful in their bearing. I remember among them an unusually large proportion of handsome women, and good singers. One feature somewhat striking was a large. pleasant, prominent eye," he m. Susanna Carey, and her epitaph reads. "Here lies the body of Mrs. Susanna Throope, wife of Capt. Dan Throope, who died Nov. ye 20, 1745, in the 38th year of her age. Beauty and virtue are plants of nature's groth-these she estimated as gifts of real worth, but meekness, temperance, prudence, charity, these she still wears for they can never die;" Joseph, b. Feb. 26, 1716-17, see further. -The Throope's of Lebanon dropped the final e from the name; other branches of the family still retain it. In the early records of colonial America, the name is usually spelled Throope, Throop, Troop, but occasionally, Throp, Thropp, Trop, Trope, Troup, and it is highly probable that nearly all the Troops but very few of the Troups of America have been descended from the first settler, William Throope, b. 1637, for **Troop does not appear to be, or have been, a common British** surname. In olden times, thorpe was the word used for village by the people of England, and it has been proved by the best of authorities that the following surnames are variations of that word: Thorp, Thripp, Tripp, Trippe, Phripp, Fripp, Throop, Throope, Throp, Thrope, Thropp, Throppe, Throup, Throupe, Thrup, Thrupp, Trup; and in compounds,-Westthorpe, Westrop, Westrup, Milthrop, Winthropp, etc. The Germans who settled in Western Ontario, Canada, spelled the name Troup and pronounced it "Trowpe." The Scottish spelling, in the homeland and in America, has been Troup. According to "Barber's British Family Names," Throop is a local name in the counties of Dorsetshire, Hamshire, Somersetshire and Wiltshire, England, which does not appear to be in line with the Scroop Tradition.

JOSEPH THROOP, b. Feb. 26, 1716-17, d. Oct. 4, 1799; son of the above; m. Deborah Buell, sister of John Buell who

was one of the original proprietors of Litchfield which was settled in 1719; lived in Lebanon, where he was born, until 1747, when he purchased land in Litchfield (South Farms), now Morris, where he reared a large family, several of whom emigrated to the Western States; he was identified with many of the early improvements of Litchfield; soon after he came he erected a saw-mill on the stream running through the land. which is said to be the first in Morris; some time later he bought land on the Bantam River, near where the Morris station of the Shepang Railroad now is, in 1881, and built a gristmill, which was one of the first mills in the county; the first mill was built on a stream running by his log house, where he put up a small water-wheel which furnished power to drive the flax spinning-wheel of his wife. Children: Deborah, b. 1741; Joseph, b. 1743; William, b. 1745; Elizabeth, b. 1747; Dan, b. 1748, see note hereunder; Benjamin, b. Sept. 13, 1752, see further; Martha, b. 1755; Rhoda, b. 1758; Samuel, b. 1760. Note. -In "The United Empire Loyalists' Centennial" volume, Toronto, Canada, 1884, we read, "Daniel Throop of Augusta in 1794, lately from Connecticut, had suffered imprisonment and loss of property, as certified by Capt. Joel Stone of Leeds County," according to the "Copy of the United Empire Loyalists' List," preserved in the Crown Lands Department, Toronto, Ont. "Leavitt's History of Leeds and Grenville," mentions Dan Throop, Sr., who, on May 17, 1802, was granted 200 acres of land, Lot No. 21, on the 5th conc. of Augusta Township, Grenville County, Ont. It is recorded in "The Land Books of Upper Canada," which are now in the Archives at Ottawa, that Daniel Throop. Sr., as a Loyalist, in 1797 applied for land and the Land Board recommended that he receive 500 acres including family lands; in 1799, the Board also recommended that Daniel Throop, Jr., receive 200 acres as son of a Loyalist, and that Amy Throop receive 200 acres as daughter of a Loyalist. The Archives happens to have also a Certificate issued in 1794 by the Land Board for the Eastern District, at Edwardsburg, in favour of Dan Throope for 200 acres of land which he apparently received in 1797,—Lot No. 31 in front of the River Rideau, Gower Township. In brief, there is no proof, as yet, that the Daniel Throop, or one of them, referred to in this note was the Daniel Throop, b. 1748, but it is certain that a Loyalist of that name did emigrate to Canada.

BENJAMIN THROOP, b. Sept. 13, 1752, d. Oct. 8, 1833; son of the above; m. Mary Burgess, b. 1750, d. 1813; was a "Minute Man," and was called to Danbury when that place was burned by the British; spent his life upon the farm where his father settled in 1747, in Litchfield County, about seven miles from Litchfield Town, about a mile from Bantham Lake, in the State of Connecticut. Children: Samuel, b. Aug. 12, 1776, who emigrated to Canada, see further; Irena, b. 1778; Calvin, b. Sept. 19, 1779, who also emigrated to Canada, see further; Polly, b. 1782; Benjamin, b. 1784; Deborah and Joseph (Twins), b. 1788, of Joseph, George B. Throop of Lakeside, Ct., in a letter to H. D. Throop of Ottawa, Canada, year 1928, said, "Had some information about Joseph Throop born in 1788. He lived in Canada in 1813 near a friend named Baldwin, also from Connecticut and who, if I remember correctly, married a Throop. Baldwin was drafted into the English army and Throop expected to be soon. Not desiring to fight against the United States, Baldwin deserted, and in company with Joseph Throop, started to cross the St. Lawrence river on the ice with a horse and sleigh. They were fired upon by a guard. The horse soon broke through the ice and was rescued by the guards while the two escaped to the New York shore on foot. Their families crossed in a week or so and were attacked by a huge Indian with a knife and would have killed them but for the intervention of two other Indians who overpowered him. They settled in New York state. I. have just read a letter from Joseph Throop to his brother Dan Throop, my grandfather, written in Nineveh, Colesville Township, Broome County, N.Y., dated either 1847 or 1857, wanting his brother to write as he seemed to be forgotten;" James, b. 1791; Julina, b. 1793; Abigail, b. 1798; Dan, b. 1796, of whom the "History of Litchfield County," Philadelphia, 1881, says, "Dan Throop, whose portrait accompanies this sketch, married Olive Smith. Dan Throop was a farmer, a man highly respected for his upright character and integrity. He lived and died upon the old homestead of his grandfather, and where his widow now resides with her son George. Monroe, the eldest son, lives upon the adjoining farm. They are carriage-makers and mill-wrights, and are among the most respected and reliable men of the town. The children of Dan and Olive Smith Throop were Monroe, Altha, Elizabeth.

Charles, George, Mary, Morris and Amelia." In 1928, George **B.** Throop, of Lakeside, Ct., in a letter to H. D. Throop, of Ottawa, Canada, said, "Of the above family there are only two remaining, Mary, aged about 97 years, living in Washington, D.C., and Amelia, aged 86, living in Waterbury, Ct. Monroe was the father of Mrs. Mary Throop Waugh, of Lakeside, Ct., who called on you recently, and George was my father. Mv farm contains 132 acres. It is located about a mile from Bantham Lake, which is the largest lake in Connecticut, and is a popular summer resort. I live about seven miles from Litchfield, the county seat. I am 31. single, and a farmer on the homestead settled in 1747. I have a mother and two younger sisters. My father, George, died in 1915. Have a cousin, Wm. D. Throop, living in Norwich, Ct., and a distant cousin in Bristol, Ct., as far as I know, I am the only Throop in Litchfield County."————Having reference to the first settler. SAMUEL THROOP, b. Aug. 12, 1776, at Lakeside in the County of Litchfield, State of Connecticut, U.S.A.; emigrated to Canada about the year 1800, settling at Wright's Corners (now Algonquin), in the Township of Augusta, Grenville County, Ontario, Canada; lived there for the remainder of his life upon his farm, the place where Robert Seeley now lives, the house being in Algonquin village; d. Aug. 7, 1864; b. at-Read's cemetery, see tombstone there; m., probably in Connecticut, Abigail Blakesley, b. 1779, d. 1843, probably a descendant of the old Samuel Blakesley family of New Haven, Ct. Children: Benjamin. b. Jan. 9, 1811, see further; Joseph A., b. Jan. 3, 1817, see further; Polly, who m. John Lane, of whom there are descendants in Prescott, Ont., Brockville, Ont., and elsewhere; Minerva, who m. James Bishop, son of the U. E. Loyalist William Bishop who came to Canada in 1793, who settled upon Lot No. 23 of the 5th conc. of Augusta, had a family of seven, -(1) Samuel, who settled in the West. (2) William, who m. Mary Barton, children, Joseph (now Dr. Bishop of New York City), James, George, Brock, Uriah and Mary Elizabeth. (3) Levi. who m. Eleanor McLeise, children, Ida, Elisha, and Armenella, wife of William Wilkins, and a woman of fine character. now resides at North Augusta. Ont.. (4) Uriah, who m. Eleanor Fairburn, (5) Polly, who m. Calvin Throop (see children of Calvin Throop, b. 1779), (6) Lavina, who m. Hiram Buker who ran a lumber business at Merrickville, Ont., children, Hiram and Taylor, (7) Elizabeth, who m. Jobe Buker who ran a farm in Augusta, children, George, Reuben, Ephriam, Samuel, William, Minerva, and Levi who lived at Charleville, Augusta, and reared a large family including Elmer, Leonard, Wilson and Ward; Lucinda, who m. Arving Bartlett, had two children, and probably three, (1) Samuel, who spent his old age, at least, in North Augusta, Ont., of whom there was a son, by first wife, named Irving. who possibly settled in the States or in Toronto, (2) Amantha, who m. a Mr. Bellamy of North Augusta district. Ont., had five children, William, Benjamin, Annie, Lucinda and Ida. (3) very probably another son, name unknown, settled in Toronto. Ont., of whom there are, probably, descendants there, for most certainly a Bartlett of this family did settle in that city; another daughter, name unknown, who m. Norman Webster, had three sons, Joseph, William and Cyrus; another daughter, no Samuel Throop, m. second wife, a widow, no information. issue. Of Samuel Throop, Mrs. William Wilkins, of North Augusta, Ont., a daughter of the late Levi Bishop, said in 1930: "He lived the last few years of his life with my grandfather, James Bishop, and was a grand old man," and a grandson, Israel Throop, b. Sept. 10, 1842, said of him: "He was a

nice old man. I don't think he ever became rich but I suppose it was hard to make money in his time. As I remember him, he had a high forehead, a large nose, blue eyes, and was of medium build. He was deaf at last, very, but his eyesight was fairly good. He had the habit of twirling his thumbs. He was very religious, never smoked nor drank, and was a strong Baptist."

CALVIN THROOP, b. Sept. 19, 1779, at Lakeside in the County of Lichfield. State of Connecticut. U.S.A.; emigrated to Canada about the year 1800 and settled on Lot No. 20 on the 6th conc. of Augusta, Grenville County, Ontario, Canada; removed to the district now known as Throopton, Augusta, and gave his name to that settlement: a man of sterling character; a Baptist; d. Feb. 10, 1844; b. at McGuinn's cemetery, centre Augusta, see tombstone there; m., probably before he came to Canada, Anna ?, who d. Aug. 18, 1856, aged 72, b. at McGuinn's cemetery. Children: Samuel, b. 1808, see further; Calvin, who m. Polly Bishop and removed to the State of Illinois, (see children of Samuel Throop, b. 1776), no issue; Polly, who d. June 30, 1885, aged 58, m. Samuel Montgomery, had three children, William, Calvin and Annie; Sarah, who m. Wm. Earl, the family of whom were, Alonzo, Shanly, and Annie, the widow of Wm. Clark, she is still living, aged 87, at Fairfield, Leeds County, Ontario; Eliza, who m. a Mr. Hough; Lucinda, who m. Ambrose Throop of another branch of the family, possibly a descendant of "Daniel Throop of Augusta in 1794, lately from Connecticut who had suffered imprisonment and loss of property, as certified by Captain Joel Stone, of Leeds," according to the "Copy of the United Empire Loyalist List" preserved in the Crown Lands Department at Toronto, Canada, or possibly he was a son of Dan Throop who took out a patent for land in Augusta, Lot No. 21, 5th conc., 200 acres, on May 17, 1802 (see also, children of Joseph Throop, b. 1716-17), children of Lucinda and Ambrose Throop: Calvin, m. Sarah Crippen, went to Illinois, had a family; Freeman, who was veteran of the American Civil War, lived at Fairfield. Leeds County, Ont., a part of his life at least; Almira, m. Rastus Thompson, lived in Augusta, removed to the States, had a family; Elizabeth, m. John Lennox, had no family, removed to Northern Ontario; Culver; Anson; Hannah, who m. Roswell
