The National Society Magna Charta Dames is composed of women who are lineal descendants of one or more of the Barons of England who in or before the year 1215 rendered actual service toward securing the articles of constitutional liberty called the Magna Charta which John, King of England, ratified and delivered to them at Runnemede, June 5, 1215. Of the twenty-five surety Barons, only seventeen left descendants. The Towles' ancestor Baron is Gilbert de Clare, who died in 1229, and was the heir of the Earl of Hertford

"The Princess Joanna of Acre, when seven years of age, had been betrothed to Hartman, son and heir of Rudolph, King of the Romans. In 1282, Hartman was accidently drowned in the Rhine, just as the marriage was about to be consummated. Shortly after this melancholy occurrence, Edward resolved to secure the goodwill of the premier peer of England, Gilbert de Clare, Earl of Gloucester and Hertford, who was surnamed the Red, by conferring on him the disengaged hand of the dark-eyed Princess Joanna in marriage.

The sober Earl Gilbert had long been divorced from his wife, Alice, daughter of Guy De Lusignan, and niece of Henry the Third, and fascinated by the sunny face, graceful figure, and the wild recklessness of the warm volatile Princess, he fell over head and ears in love--powerful, passionate love--with her. Edward perceiving the effects produced by his daughter's charms upon her mature suitor, arranged the marriage preliminaries greatly to his own advantage. After the doting Earl had placed his vast possessions in England. Wales, and Ireland at the disposal of Edward, and taken a solemn oath, in the presence of the leading prelates and nobles, to keep good faith with the King's heirs, and hold their rights of succession sacred, he was privately married to the Princess Joanna, then in her nineteenth year, at Westminister Abbey. The nuptials were solemnized by the King's chaplain, on Sunday, the thirty-first of April, in presence of the royal family, the royal wards, and other personages of high birth. The occasion was celebrated by mass offerings, a distribution of alms to poor widows, and a general scramble for money to the amount of twenty-eight shillings. At the wedding feast, the hilarity was such that dishes were overturned, tables broken to fragments, and a scene of riotous carousal enacted."

The Towles get their descendants from Col. George Reade of England and Virginia where they trace directly back to the lines through Phillipa Plantagenet, daughter of Lionel. Col. Reade b. 1600 d. 1671 came to Va. 1637, was Secretary to Colony of Va. 1640, then a Burgess. He was a colonel of Militia.

Towles Ancestors of Royal and American Unknown Descent

It is a matter of interest that the family is descended from three American colonists of royal descent: Col. George Reade, Richard Bernard and his wife, Anna Cardray, and from four Colonists of unknown ancestry: Capt. Nicholas Martiau, Sir Augustine Warner, Thomas Smith and Robert Porteus. (D.A. R.Mag. April 1954 P 109)

1. Col. George Reade of Yorktown, born 1608 died 1674, emigrated from England to Virginia in 1637 and was Acting Governor of Virginia in 1638. He married Elizabeth Martiau, a daughter of Capt. Nicholas Martiau. He is said to have founded Yorktown. (W(1) Vol. 3 P. 40)

2. Richard Bernard, born 1608, of Petsoe, Bucks, (Petsworth, Buckinghamshire) of proven royal descent, read law at Lincoln's Inn, was admitted to the bar in 1640, married

3. Anna Cordray in 1634, settled at Purton, Gloucester County, Virginia in 1647 or 8. It seems obvious that Petsworth Parish of Gloucester County got its name from the home of Richard Bernard in England. With Richard Bernard and his wife Anna Cordray, born 1612, when they settled in Gloucester County were Anna's parents, William Cordray of Chute, Wilts, and Bridget Goddard, of royal descent, and the Bernard's daughter Anna, born in 1635. She married Major John Smith of Purton, (whose life is said to have been saved by Pocahontas) son of Thomas Smith mentioned above. Major John Smith was Speaker of the House of Burgesses in 1657, trustee and governor of William andMary College and a vestryman of Petsworth Parish. (W(1) Vol. 3 P. 40, W (1) Vol. 25 P 184.

1. Among the Colonists whose ancestry is unknown were Capt. Nicholas Martiau, born 1591 and died 1657, a French (Huguenot). As a Military engineer, he was sent to Virginia in 1620 to construct fortifications for defense against the Indians. (D.A.R. Mag. April '54 P. 109)

2. Another is Sir Augustine Warner. He was born about November 28, 1610 and died December 24, 1674. He probably came to York County, Virginia about 1628 where as Capt. AugustineWarner, he was Justice in 1652 and also Burgess for York. He then went to Gloucester County, where in 1658 he was a Justice and Burgess for Gloucester. He was a member of the Council from 1659 until his death. He married Mary, (last name unknown) born May 15, 1614, died August 11, 1662. (V. vol. 2 P. 423) Augustine Warner acquired large estates in Gloucester County and built the home he called "Warner Hall" on the Severn River. His son, Augustine 2, born July 3, 1642 and died June 19, 1681, inherited Warner Hall at his death. Augustine 2 was Speaker of the House of Burgesses during Bacon's Rebellion in 1676 and was a member of the Council. He married first, Mildred Reade, daughter of Col. George and Elizabeth Reade and after her death, Elizabeth Martian. (H Vol. 1 P 526, OVH P. 27)

Towles Ancestors of Royal and American Unknown Descent (continued)

3. And yet another Colonist of unknown ancestry was Thomas Smith, an English emigrant. In 1730 he built a house on a grant called Centerville, not far from the East River in what is now called Mathews County. This house, with many later additions is now (1955) called Kingston Hall, but was probably called Warwick at the time it was built. (OVH P. 138) At any rate, we are told (D.A.R. Mag. April 1954 P. 110) that Major John Smith (son of Thomas Smith) formerly Warwick, then of Purton, Petsworth Parish marriedAnna Bernard, born 1635.

4. The last Colonist of unknown ancestry of whom we speak here is Robert Porteus, born 1679, of New Bottle, later called Concord, Gloucester County, Virginia. His father, Edward Porteus. of Poropotank, later called Violet Banks, Petsworth Parish, Gloucester County, Virginia, was the emigrant, who in 1693, was recommended by the Governor of Virginia, as a "Gentleman of estate and standing suitable for appointment to Council." (Sainsbury, Mss.) Edward Porteus was never given the office, but his son Robert was appointed Sheriff of Gloucester in 1709 and declined the office. However, on March 1, 1713 he was sworn a member of the Council and so remained until 1719, when he went to England, dying at Ripon, Yorkshire, August 8, 1758. Robert Porteus first married, in 1700, Mildred Smith, born 1682, daughter of Capt. John and Mary (Warner) Smith of Purton. Emmie Furguson Farrar says in her book Old Virginia Houses: "And to be a descendant of the Smiths of Purton is almost like being descended from royalty." Robert Porteus secondly married Elizabeth Jennings, daughter of the Hon. Edmond Jennings and Frances Corbin. (Eng. Vol. 1 P. 151 and 2, V P. 312, D.A.R. Mag. April 1954 P. 110, W)

Nicolas Martiau-1591-Will Proved 24 April 1657

Nicolas Martiau and Benjamin Blewett came to Virginia in 1620 as the personal representatives of Henry, Fifth Earl of Huntington, a member of the Virginia Company of London. They came over as military engineers. A copy of the Earl of Huntington's Power of Attorney is preserved among the papers of the Huntington family. Nicolas Martiau came to the Colony "in the Francis Bonaventure" which arrived at Jamestown in August 1620.

He was located for some time at Falling Creek (near Richmond). In 1630 or 31 Martiau moved his family to the York River where he had a plantation of 1300 acres which included the present site of Yorktown. He was a Burgess and Justice in 1633. His Gallic temperament was never completely subdued by the hardships of colonial life, as for example, his quarrels with John Downman and Mr. Mayhew.

Captain Martiau had a part in the first open rebellion against royal oppression in America. Several gatherings were held at his house in Yorktown. In April 1635 Governor Harvey hed Martiau and two others arrested and brought to Jamestown for imprisonment. When they demanded to know Harvey's reason for holding them in arrest the latter replied, "They shall know at the gallows." Harvey was eventually forced out and returned to England. The prisoners were released by the Council.

During the Yorktown Sesqui-Centennial Celebration in 1931, a memorial was dedicated to Nicolas Martiau. The monument was erected by the Martiau-Washington Memorial Association, a group representing the several Huguenot Societies. The inscription on the plague, above which is the Grand Cross of the Huguenots, is as follows: "Site of the Home of Nicolas Martiau the Adventurous Huguenot who was born in France 1591, came to Virginia 1620 and died at Yorktown 1657. He was Captain in the Indian uprising, a member of the House of Burgesses, Justice of the County of York, in 1635, a Leader in the thrusting out of Governor Harvey which was the first opposition to the British Colonial policy. The original Patentee for Yorktown and through the marriage of his daughter Elizabeth to Col. George Reade he became the earliest Ancestor of both Gen. George Washington and Governor Thomas Nelson."

In his will.Nicolas Martiau mentions his three daughters: Elizabeth who married George Reade, Mary who married John Scarsbrook, and Sarah who married Captain Richard Fuller. He gives them land, his watch,

horses and cattle. He frees two negroes and provides for an alreadyfreed servant.

WILL OF NICOLAS MARTIAU

born 1591, proved 24 April 1657

In the name of God Amen, I Nicholas Martiau of the County and Parish of York gent being very sick and weak in body But of Sound and perfect memories blessed be God Doe make ordaine Constitute and appoint this my last Will & Testament in manner & forme following Revoking annulling and making void and by these presents Cancelling & disclaiming all & all manner of former other Will or Wills written or Nuncupative all Codicells Legacys & bequests whatever by me at any time before the ensealeing of this my last Will made and signed & Sealed or otherwise by word of mouth of made & delivered. And appoint this only to stand & be my last Will and Testamt as followeth . . . first I bequeath my Soule unto the hands of God my maker hopeing & assuredly believing that when this life shall end I shall through the marritte of Jesus Christ my Redeemer to enjoy ever lasting Rest and happiness And my body to the Earth from whence it came to be decently buried . . .

Item for the estate which almighty God hath been pleased to lend me in this world I hereby give bequeath & dispose thereof in manner & forme following . . .

Item I give and bequeath to my <u>Eldest daughter Elizabeth wife of</u> <u>George Reade Esq</u> & the heirs of her body begotten or to be begotten for ever all that my Divydent of <u>land</u> sciuate lying and being in the sd Parrish and County of York as here under excepsted with all houses and appurtenances . . .

Item I give and bequeath to my <u>Daughter Mary Scarsbrook wife of</u> <u>John Scarsbrook</u> sow much of my sd Divydent of <u>Land in York parrish</u> as is scituate and lying beyond the Swamp called commonly Broccas Swamp upon part of which the said John is now seated to be held by the sd Mary and her heirs Lawfully begotten & to be begotten for ever with

Appurtenances.

Item I give and bequeath to my <u>Daughter Elizabeth Read</u> and her heirs forever my <u>old Maire</u> with her whole increase male and female to her and heirs Except the first Mare foal she shall bring after my decease which I hereby give & bequeath with the whole increase thereof to my Daughter Sarah wife of Capt.ffuller & her heirs for ever . . .

Item I give and bequeath to my Loveing Daughter Mary Scarsbrook & her heirs for ever the Mare ffoale now running with my Mare with whole increase Male & ffemale

Item I give and bequeath to my Loving Daughter Elizabeth Reade my Watch . . .

Item I give to my said Daughter Elizabeth and her heires my Grey Gelding but my sonn John Scarsbrook to make use of him for his occasions . . . Two years after my decease when he shall desyr the Same . . .

Item I give and bequeath to my Daughter Sarah ffuler wife of Capt.

WILL OF NICOLAS MARTIAU (cont.)

William ffuller above named and to her heires forever all that my Divydent of land lying in Potomack and conteyneing Two Thousand Acres But in Case itt shall not be seated by some of them (Vizt) Capt. ffuller or his said wife or heires att least one Moneth before expiration of time limitted by the Pattent for seateing then the same to be made sale of Executrixes hereunder named & the produce thereof to be equally dyvyded between my said Three Loveing Daughters for the good of them & their children . . .

Item my Will is within one yeare after my decease all Cattle now in my possession marked with my daughter ffullers mark shall be delivered for the good her and her Children & I doe alsoe give and bequeath to her and her heires for ever Tenn Cowes more outt of my Stock or to be bought out of my Estate with their whole increase Male & ffemale and alsoe a Bull to be delivered within a yeare as above said . . .

Item my will that at finishing the next Crop after my Debts are satisfied my <u>Two Negroes</u> Phill & Nicholas <u>shall be free</u> & that each of them have then delivered by my Executors <u>One Cow & Three Barrells of</u> <u>Corne Cloathes</u> & alsoe Nayles to build them a house but they or either of them shall hire themselves out after their said ffredom or before or shall remove from the land hereunder appointed them then they or he soe doeing to return to my Executrixes for the good of them and their Children and my will is that they have land sufficient for themselves to plant in the ffield where William Leigh lived for their lives or the life of the longer Liver of them . . .

Item I give and bequeath to Hugh Roy lately my servt one Three Yeare old Heifer with her increase to be delivered on demand after my decease . . .

Item I give and bequeath to my above named Two loveing Daughters <u>Elizabeth Reade</u> and Elizabeth Scarsbrook for the good of themselves & their Children All the rest of my Estate whatsoever in Virginia or else where to be equally divyded betweene them but the Divyson not to be made until all my Debts & Legacyes be satisfied which said severall Debts are to be paid out of the part of my Estate as is given to my said Two daughters & their Children without any Charge to my Daughter Sarah or her heires . . .

Item lastly I doe by these prents nominate & appoint & Confirme my two beloved Daughters Elizabeth and Mary Joynt Executrixes of this my last Will & Testament to see the same performed and kept And in Confirmacon of this my said last Will & Testament & of every matter Clause and thing therein conteyned I have hereto sett my hand and Seale this first day of March One Thousand Six Hundred forty six . . .

Capt. Nicholas Martieu lived near Jamestown, Va. 1624. He was one of the first settlers at Kiskieck, Va. He came to Va. in the Ship Frances Bonaventure 1620. His first wife was Jane, widow of Lt. Edward Berkeley. His second wife was Isabell Beach. Ref. 21 7 page 383. Virginia Heraldica Page 95

Reade. James City county

Arms: Azure guttee d'or, a cross-crosslet fitchee of the last.

Crest: A shoveller close sable.

George Reade, Secretary of State for Virginia, was a descendant of the Reades of Faccombe, in the county of Southampton. In 1585 Andrew Reade purchased the manor of Linkenholt, Hampshire. His will was probated in 1623. His second son, Robert, married three times, his third wife being Mildred, daughter of Sir Thomas Windebanke. They had issue: (1) Andrew, D. D., of Lugershall, Wilts. (2) William. (3) Dr. Thomas, Fellow of New College, Oxford; Principal of Magdalen Hall, Oxford, 1643. (4) Robert, Secretary-to Sir Francis Windebanke and living in 1665. (5) George, who came to Virginia in 1637, and in 1640 was Secretary of State pro tem., Burgess for James City county in 1649 and 1656. Member of the Council 1657-8, holding this office until his death in 1671. He married Elizabeth, daughter of Captain Nicholas Martian of York county and had at least seven children, viz: (1) Mildred, died 1694; (2) George d.s.p.; (3) Robert; (4) Thomas; (5) Francis; (6) Benjamin; (7) Elizabeth.

Bernard. Gloucester County

Arms: Argent a bear rampant sable, muzzled or.

Crest: A demi-bear muzzled and collared or.

Motto: Bear and forbear.

The first of this family in Virginia was Richard Bernard, gent. widower, aged 26 years, who obtained a marriage license, 24 Nov., 1634, to marry Anna Corderoy, aged 22 years, daughter of Corderoy, Esq., at St. Andrew's in the Wardrobe, London. (Chester's London Marriage Licenses.) He was in the Colony 3 January 1647, in which year he rented from Captain Thomas Harwood of Virginia and others, "the plantation in York County, called 'Pryor's Plantation, '" for a term of three years. To this deed is attached a rough drawing made by the Clerk of the Court, of a shield bearing the arms common to the Bernards of Buckingham. Richard Bernard was dead in 1652, as a deed recorded in York in 1662, states that "Anna Bernard, now of Purton, in Petsoe parish Gloucester, widow, purchased Pryor's Plantation in 1652 from Thomas Edwards of the Inner Temple, London, and Margaret, his wife, one of the daughters of William Pryor, deceased. Anna Bernard had a son Richard, who was vestryman of Petworth Parish in 1677, died 1691. He left sons, Phillip and John Bernard.

Warner. York and Gloucester counties.

Arms: Vert, a cross engrailed or.

Col. Augustine Warner, born 28 November 1610, died 24 December 1674. came to Virginia in 1628. He was Justice of York 1652, and of Gloucester 1656, Burgess for York 1652, and for Gloucester 1658, and member of the Council 1659 until his death. He named his home in Gloucester "Warner Hall". He married Mary who died 11 August 1662, and had issue, Colonel Augustine, 2nd, born 3 July, 1642, died 19 June, 1681. He was Speaker of the House of Burgesses 1675-7, and also a member of the Council. He married Mildred, daughter of Col. George Reade, and had issue, Augustine, born 17 January, 1666, died 17 March 1686; George, born 1677 and d.s.p.; Mildred, married, first Lawrence Washington of Westmoreland county and was the grandmother of George Washington. She married, secondly, George Gale and died in England in 1700; Elizabeth, born 24 November 1672, died 5 February 1719-20, married Col. John Lewis and inherited Warner Hall; Mary married 17 February 1680, John Smith of Purton and died 13 November, 1700. The arms are taken from old silver in possession of the descendants.

Arms: Azure, a chevron between three acorns slipped and leaved or.

Major Lawrence Smith of Gloucester married Mary ______. His will was dated 8 August, 1700. His eldest son John was a member of the Council and died in Abingdon Parish about 1719. He married Elizabeth, daughter and heiress of Henry Cox of Rappahannock county and his wife Arabella, daughter of William Strachey of Gloucester, the grandson of William Strachey, who was Secretary to Lord Delaware in 1610. Lawrence, second son of Major Lawrence Smith, settled in York county and was Colonel, Justice, Sheriff and one of the feofees of Yorktown. He married 1st, Mildred, daughter of Captain Thomas Chisman, and 2nd, Mildred, daughter of John Reade. His granddaughter Mildred, daughter of his son Edmund Smith, married David Jameson, and the Jameson arms impaling Smith are found on her tomb at Temple Farm. (See Jameson arms.) The Smith arms are the same as Smith of Totine, Devonshire.

Jameson Arms: Azure, a saltire or contoned with four ships imder sail argent.

PORTEUS

(Pronounced Por-te-us in England, Porteuse by Towles Family in Virginia)

Edward Porteus = "The Relict of Robert Lee," probably named Apagery Robert Porteus = Mildred Smith = (2) Elizabeth Jennings Elizabeth Porteus = Robert Downman Elizabeth Downman = Stokeley Towles Raleigh Downman Towles = Fidelia Belfield Chinn Jeffries

We do not know when Edward Porteus was born, nor do we know when he emigrated to Virginia. Most of the information we have about him comes from his will and tombstone. From his will we see that he had a brother John, who probably preceded him in death, and four sisters, Mary, who married Thomas Lowny, Isabell, Elizabeth, and Christian. He remembered "The poor of Newbottle parish in Scotland," and Petswort parish, Virginia, and he wanted his father's estate in Newbottle, Scotland redeemed for his son Robert. After the individual bequests he said that his wife, not named, was to have one-third and his son Robert was to have the rest. Then he leaves his "property and estate in Virginia" to his son Robert and his heirs. Captain John Smith was named as executor, his "Lady" to receive a cash bequest. Generally, the will is that of a devout, fair-minded, intelligent man of property. -- V. Vol. 14, p. 310

Edward Porteus was living in Gloucester County Virginia in 1681 as he is listed as a vestryman of Petsworth parish. In 1693 he was "recommended by the Governor of Virginia for appointment to the Council as a 'Gentleman of estate and standing suitable for appointment to the Council' (Sainsbury Mss.)" However, he did not serve. --OVH p. 26

He is called the emigrant from England so he possibly spent time there before he settled in Virginia in Gloucester County on the York River. He built his house fronting on the York, east of Poropotank Creek. It was first called Poropotank and then Violet Banks, and it has been referred to as the Porteus mansion. It was a two and one-half story square brick edifice with four rooms to the floor, said to be a counterpart of lovely Cappahosic House, early home of the Stubbs family which may be seen today. Some authorities credit Edward Porteus with the building of both houses. -- OVH p. 26

"Down the York from Porteus Mansion" there were "well-built brick houses about every mile." Among the families were the "Smiths, of Purton, the family of Capt. John Stubbs of Cappahosic, the Burwells, of Carter's Creek, the Warners, of Warner Hall, the Pages of Rosewell, the Manns, of Timberneck, and the Perrins, of Sara's Creek," now called Little England. The above is taken almost word for word from Farrar's Old Virginia Houses.

The tomb of Edward Porteus is at Violet Banks at the mouth of the creek and its inscription, not entirely legible, follows: "Here lies the body of Edward Porteus of Fetsworth Parish, Gloucester County, Merchant, Departed this life ****** 169* in the ** year of his age, leaving only Sir Robert to succeed him." -- Wm. & Mary Quarterly, V. 3,P.28

PORTEUS -2-

2. Robert Porteus (Edward 1) was born in Gloucester County, probably at Violet Banks, in 1679, and died on the 8th of August 1758 in England. His home in Gloucester County, Virginia, was first called New Bottle and then Concord. He was sworn in to serve on the King's Council in 1713, and was a member until he moved to England sometime between 1725 and 1730.

Robert Porteus is the link through which many Americans trace relationship to the Royal House of Windsor. He had nineteen children but there are differences of opinion as to their maternity, as he was married twice. He first married Mildred Smith of Purton, Gloucester County August 1700, and later, date unknown, Elizabeth Jennings.

Mrs. France, a student and writer of the Towles Family, says that according to her father's notes, Mildred Smith died three months after her marriage with no issue.

John S. Wurts, in Magna Charta, seventh volume, says that Mildred Smith of Purton "was the mother of several of his children, including Elizabeth, probably the eldest, and ancestress of the Towles family, and Robert, born in 1705, from whom Queen Elizabeth 2 is descended."

At any rate Elizabeth Jennings, daughter of Edmond Jennings of Ripon Hall, Virginia and formerly of Ripon Yorkshire was the second wife of Robert Porteus and mother of more than a few of the nineteen, although no date seems available for the marriage. Elizabeth Jennings was the mother of Beilby Porteus, born at York, May 8, 1731, died May 14, 1808, who was Bishop successively of Chester and London and Chaplain to George 3.

Robert Porteus (Edward 1, Robert 2) born 1705 returned to England for his education and remained there, married Judith Cockayne and became Rector of Cockayne Hatley, Co. Bedford.

Elizabeth (Edward 1, Robert 2) remained in or returned to Virgini and married Robert Downman of whom we speak elsewhere.

Robert Porteus (Edward 1) first settled in the city of York when he went to England and then in Ripon, to which place "he was probably led by the fact that his second wife had connections there through her father, the Honorable Edmond Jennings who made quite a name for himself in Virginia. He was Attorney General of Virginia in 1684, member of the Council in 1692, Sec. of State 1701-13 and President of the Council and Governor of Virginia 1706-10. Edmond Jennings married Frances Corbin, daughter of Henry Corbin, Council of Virginia 1663, and Mrs. Alice Eltonhead Burnham.

Elizabeth Jennings Porteus died January 20, 1754, aged 80 and is buried at St. Martin's, Coney Street, York.

Her husband, Robert Porteus (Edward 1) died in 1758. "In Ripon Cathedral, on the wall of the south aisle of the choir, is a mural tablet with the following inscription:

> 'Near this place Are deposited the Remains Of Robert Porteus, Esquire,

PORTEUS

A Native of Virginia, and a Member of His Majesty's Council, Or Upper House of Legislature in that Province, From thence he removed to England, And resided first at York, afterwards at this Town, Where he died August 8, 1758, Aged 79 years.'

In this branch of the family there is a legend concerning a cane that supposedly belonged to Robert Porteus (Edward 1). The cane has a hexagon-shaped ivory head and a leather shank ornamented with leather rings that are about a quarter inch deep at the top and grow smaller as the circumference of the shank decreases. Tradition has it that the cane has been passed down through the family through the eldest son named Robert Porteus. Why it did not go to the family of the Rev. Robert (Edward 1, Robert 2), we do not know; but we do know that a grandfather of Hester Towles, Robert Porteus Towles, born in April 12, 1817, eldest son of Rawleigh Downman Towles and Fidelia Belfield Chinn Jeffries had the cane. He married Harry Ann Roach and their son, William Price Towles, married Catherine Hester Johnston. The son of the latter couple a brother of the author and named Robert Porteus Towles inherited the legendary cane.

JENNINGS

Sir Edmond Jennings = Margaret Barkham Edmond Jennings = Frances Corbin Elizabeth Jennings = Robert Porteus

"Edmond Jennings was a son of Sir Edmond Jennings of Ripon, Yorkshire, England, and his wife Margaret, daughter of Sir Edward Barkham, Lord Mayor of London, 1621-2. He was born 1659 and died June 2, 1727. He came to Virginia at an early age and settled in York County. He was appointed Attorney-General in 1680 and retained that office until after 1692. He was appointed to the Council in 1701 and remained a member until his death. In 1704 he was appointed Secretary of State and from June 1706 until August 23, 1710, he was acting Governor. He married Frances daughter of Henry Corbin of Buckingham House and had issue:

- 1. Frances married Charles Grymes of Moratico, Richmond County, and was ancestress of General Robert E. Lee.
- 2. Elizabeth married Robert Porteus of New Bottle, Gloucester County, who afterwards removed to England, where she became the mother of Beilby Porteus, Bishop of London.
- 3. Edmond, Secretary of Maryland." -- T. Vol. 10, p. 33.

In a biography of Bishop Porteus, Hodgson says that the Bishop had in his possession a picture "thought valuable by Sir Joshua Reynolds" of his father's residence. This, presumably, was New Bottle in Virginia (Lancaster County, Virginia, Will Book 8, pp. 34-36)

Will of John Chinn, Sr.

In the name of God Amen the fifteenth day of December An^o Dn¹ 1691 I John Chinn Senr of the County of Lancastr (vente being in sound and Pfect memory thanks bee to Almighty God and calling to remembrance the uncertaine State of this transitory life and that all fflesh must yield unto death when it shall please to God to call Doe make constitute ordaine and Declare this my last will and Testament in manner and forme following, revooking and adnulling by these pents all and evray Testamt and Testamts Will and Wills heretofore by me made declared either by word or writing and this to bee taken only for my last will and Testamt and none other. And first being penitent and sorry from the bottom of my heart for my sins past most humbly desiring forgiveness for the same I give and comitt my scule unto God my Saviour and Redeemer in whome and by the meritts of Jesus Christ I trust and believ assuredly to be saved and to have full remission of all my sins and that my soule with my body at the Generall day of Resurrection shall rise againe to Joy and through the merits of Christs death and passion possess and inherit the Kingdom of Heaven ppared for his blest and chosen and my body to bee buried in such place where it shall my Executrs hereafter named to appoint And now for the setling of my temporall Estate and such goods Chattells and debts as I am now possest with and it hath pleased God farr whome my deserts to bestow upon me I doe order and dispose of the same in manner and forme following that is to say

Item I give unto my loving wife Alice Chinn my saddle horse and all my furniture thearunto belonging calld by the name of Dragon and alsoe her riding horse with all the furniture belonging called by the names of Hester.

Item I give unto my Sone John Trussell and my daughter Elizabeth Trussell his wife twelve pence apiece to bee paid to him six months after my decease.

Item I give unto my son Thomas Chilton and my daughter Sarah Chilton his wife twelve pence apiece to bee paide within six months after my decease.

Item I give unto my Daughter Ann Chinn all that tract of Land be it more or less whereon Thomas Chilton now lives which I bought of Richard Lloyd lying upon the heade of Powells Creek and to her heirs forever I give unto my said Daughter Ann one ffeatherbed a pair of blankets A Rugg a boulster and one pillow, one Iron Pott, a frieng pan, A Mare with all her increase running in Kirbys neck fouor sheep twelve head of cattle when she shall come to the age of sixteen years and not before. Item I give unto my daughter Katherine Chinn All the Right and title which I have to a tract of Land lying at the heade of Morattico which I purchased of Thomas Maddison to her and her heirs forever, tenn head of cattle four sheep a mare A Rugg, boulster, and one pillow one iron pott a frieng pan when she shall come to the age of sixteen years and not before.

Item I give unto my sone John Chinn twelve pence in money to bee paide him within six months after my decease because I have paid and hee hath recd his portion already.

Item I give unto my Sone Rawleigh Chinn All the tract of Land I now live upon, and to his heirs forever, One ffeather bed and furnitur One iron pott, ffour sheep, tenn head of cattle, one mare three years old with all her increase forever, two Guns and a paire of Andjions when hee shall come to the age of twenty yeares and not before and als one Negro between sixteen and twenty.

Will of John Chinn, Sr. (continued)

Item My will and pleasure is that all the said cattle and sheep soe given unto my saide children as aforesaide as they shall come to their respective age or ages to bee delivered as aforesaide the cattle shall not exceed ten years apiece nor the sheep to exceed five years apiece.

Item My will and pleasure is that all my Estate both chattle and psonall Except before excepted given and bequeathed as aforesaide I give unto my Loving wife Alice Chinn whome I make whole and sole Executrix of this my last will and Testament In witness whereof I have hereunto set my hand and seale the day and year above written

Will of Rawleigh Chinn, Gent.

(Lancaster County, Virginia, Will Book 13, page 252)

In the name of God Amen. I Rawleigh Chinn of Lancaster County being in perfect memory do appoint this instrument of writing to be my last will and Testament. First I commit my soul to God who gave it me and my body to the Earth its original hoping at that great day of Resurrection I shall be raised to Life eternal through the mediation and interception of Jesus Christ my Saviour Amen.

Imprimis - I give to my son Joseph Chinn my mannor plantation Viz:-Beginning at a marked pine at head of a cove thence South twelve degrees West to the back Line thence from the back line North thirty five degree West to the waiding place including one hundred and fifty acres to him and his heirs.

Item - I give to my son Joseph Chinn 500 acres of land lying in Prince William County being part of a tract of three thousand three hundred acres to him and his heirs.

Item - I give to my sd. Godson Charles an old desk, a case of drawers, fifteen head of cattle, twenty hogs, four ewes, half a dozen leather chairs, halfe dozen of cane chairs, two feather beds with rugs, blankets and four pair sheets, four new dishes, one dozen plates, one Iron pot and hooks, one frying pan, one new oval table three foot over, two table cloths, a dozen of napkins new, one mare of four years old.

Item - I give to my aforesd. Item - I give to my Godson Elijah one new Desk, fifteen head of cattle, twenty hogs, four new dishes, one dozen of new plates, one iron pot with hooks, one frying pan, one oval table three foot over, two table cloths & one dozen of napkins new, one mare four years old.

Item - my will is that my Godson Charles If I die before my two other Godsons Christopher and Elijah arrive to the age of sixteen years shall have their Estates herein bequeathed to them by me fully in his possession and to by him delivered to them when they shall attain the age of sixteen he my Godson Charles giving Security to my Executor hereafter named for his trust.

Item - I order that my Executor pay to Easter Chinn twenty five pounds or four thousand pounds of tobacco p. annum as p. order of the General Court provided she has no right or title by Law to her dower in my sd. Estate.

Item - My will is that Elizabeth Nichols have the use of my Land which I have bought of Richard Ellit during the time she shall remain unmarried provided she never work more than two hands on it in one year but if she doth marry or work more hands than two on it in one year aforesd that then the aforementioned descend and fall to Celia Nichols Daughter of the aforesd. Elizabeth Nichols and the heirs of her body lawfully begotten and in Default of Such issue to fall to my son Rawleigh Chinn and his heirs.

Item - My will is that my executor pay John Durham ten pounds or a young negro of that value to be paid within six months after my decease.

Item - I give my friend Mr. william Glascock my watch and mourning ring of twenty s. value with this Posey "When this you see Remember me. R.C."

Item - I give to my two sons Rawleigh and Thomas the proffit of my youn; orchard during the term of fifteen years equally to be divided between them.

Item - I give the use of my Still to my three sons Joseph, Rawleigh and Thomas.

Item - My will is that my Estate shall not be appraised my will is that the negroes and stock of my three Godchildren shall be & remain on my plantation in King George County for their use until Charles arrive to the age of twenty years and also to have one half of the crop of corn made on the sd. plantation the year that I decease for their use.

Item - I also give to my son Joseph Chinn twenty pounds sterling which he now owes me, one negro called Mingo, my sword, gun, drum and Violin it being his full portion barring him from any other part of my Estate.

Item - I give to my son Thomas Chinn the plantation he now lives on with all the land on the East side of the land I gave my son Joseph to him and his heirs.

Item - I give to my son Thomas Chinn five hundred acres of Land being in Prince William County to him and his heirs.

Item - I give to my son Thomas nine negroes Viz:- Letty, Dick, Adam, Nan, Obey, Sary, George, Hester and Tony, four large pictures, oval table of gum, Cloaths press a large looking glass two silver spoons marked R^CE it being his full portion.

Item - I give to my son Chichester Chinn all the land I hold in Richmond and King George Countys to him and his heirs.

Item - I give also to my son Chichester nine negroes Vizt: - Offa, Nell Kate, Judy, Will, Dinah, Sclomon, Peg and a child Offa, a large looking glass in the Chamber, three silver R^CE, one silver tanckard and lid, one Silver Salt, one Silver Pepper box it being his full portion.

Item - I give to my daughter Ann Shearman one negro named Jacob, one good feather bed with the furniture and ten head of cattle in full for her portion barring her from any further part.

Item - I give to my grandson Rawleigh Shearman 200 acres of land lying in Prince William County to him and his heirs.

Item - I give to Bryan Stott two hundred acres of land lying in the aforesaid county to him and his heirs.

Item - I give to my Godson Charles the son of Mrs. Margaret Downman fiv hundred acres of land being in Prince William County with four negroes and their increase Vizt: - Frank, Kate, Will and Sepia to him and his heirs forever but in case he die without issue that it fall to his brothers Christopher and Elijah and their heirs and in Default of their issue to return to my four sons Vizt: - Joseph Chinn, Rawleigh, Thomas and Chichester Chinn to be equally divided between them.

Item - I give to my Godson Christopher, the son of Mrs. Margaret Downman five hundred acres of Land lying in Prince William County with four negroes and their increase Vizt: - Cordilla, Ralph, Coffee and Margery to him and his heirs but if he die without issue that it fall to his brothers Charles and Elijah but in Default of issue proceeding from any of three to be divided between my four sons mentioned in the last item or their heirs.

Item - I give to my Godson Elijah son of Mrs. Margaret Downman five hundred acres of land in Prince William County with four negroes and their increase Vizt: - Febey, Nell, Jenny and Jimmy to him and his heirs but if he die without issue to fall to his brothers Charles and Christopher but in case of want of issue proceeding from any of ye three that then it be divided between my four sons mentioned in the last items and their heirs.

Item - I give to Elizabeth Nichols one servant to serve her five years an able well bodied man.

Item - I give Celia Nichols, daughter of Elizabeth Nichols four cows and calves, fifteen head of hogs, a feather bed with bolster, rug, one blanket and two pair of sheets now in possession of my son Chichester in King George County a small square table and a dozen of flag chairs, three new dishes and a dozen of new plates, two table cloths and a dozen of napkins new, one iron pot and hooks and frying pan.

Item - I give to my son Rawleigh Chinn the plantation whereon he liveth with all the land on the west side of the land given to my son Joseph Chinn to him and his Heirs.

Item - I give Celia Nichols daughter of Elizabeth Nichols my negro girl Criss to her and the heirs of her body lawfully begotten in the form and with the land to her before mentioned but in Default of issue lawfully proceeding from her body to fall to my son Rawleigh Chinn and his heirs.

Item - My will is all and every part of my aparrell that I have provided for my bodily wear at the time of my decease linnen woolen may be equally divided between Joseph Durham and Dominick Newgent.

Item - I give to my son Rawleigh Chinn all the remainder part of my Estate real and personal which has not been before mentioned to him and his heirs I do also appoint my sd. son Rawleigh Chinn my whole and sole Exor. of this my last will and Testament.

Item - My will is that if Elizabeth Nichols marry that my friend Mr. Milliam Glascock of Richmond County have the care of Celia Nichols daughter of Elizabeth Nichols, and the land, negro, and what else before bequeathed to Celia Nichols be the sd. Celia come to the age of sixteen years and to deliver it up to the sd. Celia Nichols.

Item - I give to my Godson Charles, son of Margaret Downman, one Iron

Spit I bought of Owen Brosier.

At a Court held for Lancaster County the second Fryday in March 1741 Dominick Newgent made oath that he wrote the will above written by the direction of Mr. Rawleigh Chinn dec'd the greatest part thereof the last week in July last and the other part except the two last paragraphs the first week in August last past and that the sd Dominick is well acquainted with the hand writing of the sd Rawleigh Chinn and he often seen him write and that the sd two last paragraphs are of the sd Rawleigh Chinn's own handwriting and that the time that the sd Dominick Newgent writ the sd parts of the sd will the sd Chinn was of perfect sense and memory. Sworn in Court Dominick Newgent Test T. Edwards Cl. Cur.

At a court held for Lancaster County the second Fryday in March 1741 John Durham maketh oath that he was present when Dominick Newgent wrote the will above written by the direction of Mr. Rawleigh Chinn decd. and that the first part was written the last week in July 1741 and the other part by the sd Newgent was written by the sd Chinn's order the first week in August 1741 and that he is well acquainted with the handwriting of the sd Rawleigh Chinn and has often seen him write and that the two

last paragraphs of the above written will is of the sd Chinn's own hand writing and that when the sd Dominick Newgent wrote the two aforementioned parts of the sd will the sd Chinn was of perfect sense and memory. Sworn in Court John Durham Test T. Edwards Cl. Cur.

At a Court held for Lancaster County on the 12th day of March 1741 This will was proved in open Court to be the last will and Testament of Rawleigh Chinn, Gent. Dec'd by the oaths of Dominick Newgent and John Durham witnesses thereto according to their before written subscriptions and Joseph Chinn, Gent. son and heir at Law of the sd. Testator consenting thereto the sd will was admitted to record and recorded. Test T. Edwards Cl. Cur.

(Note by N.L.C. - Before the adoption of the Gregorian calendar in 1752, the new year began March 25. This explains how Rawleigh Chinn's will could be written in July and August, 1741, and proved in March 1741.)

Item I Give to my Son Thomas Chinn all my land In Loudoun County to him and the heirs of his body lawfully begotten together with all appurtenances Stock and household furniture that is on the plantation;

Item I give to my son Robert Chinn five Negroes namely, Dick, Cesare, Cate, Adam and Will, to him and his heirs,

Item I give to my Son Thomas Chinn five Negroes, E ___?, Lucy, Frank, Harry and Tom, to him and his heirs

Item I Give to Ann Elder, Daughter of Sarah Elder, a negroe girl nam'd Criss, but not to be In her possession untill she arrives to the age of sixteen years, and in case she die without heir lawfully proceeding from her body that the said negroe and her Increase shall Return to use and benefit of my children. My will is that if there be more than five

to each at The time of Division, that my Sons Robert and Thomas have an Equal part with the Other three.

Item I give to my Daughter Easther Chinn my Negroe woman Bess

Item I give to my Daughter Susannah Chinn, my Negroe Girl Lette.

Item My will is That the remainder of my Negroes not before mentioned Shall be Equally divided between My three younger children $(V_{13}-)$ Rawleigh Chinn, Easther Chinn and Susannah Chinn, only to be observ'd that those two Negroes to my daughters mentioned are to Be part of their Share in the Division.

Item my will is that my three youngest Hereabove mentioned, namely Rawleigh Easther and Susannah Chinn shall have each Of them two Good feather beds furnisht with Good Furniture.

Item my will is that my Stock of Cattle may be Divided between my son Robert Chinn, Rawleigh Chinn, Easter Chinn and Susannah Chinn.

Item my will is that my sheep and hogs may be Divided Equally between my five children.

Will of Thomas Chinn (Continued)

Item my will is that all My household Furniture not before Mentioned excepting two Looking Glasses the Largest that Stands in Hall to my Son Robert and that which stands in adj. Chamber to my Son Thomas; only one Bed and Good furniture to be first taken out of it, which I give to Ann Elder Daughter of Sarah Elder: Shall be divided in four parts of which my Sons Robert and Thomas are to have one part to divide between them.

Item my will is that my Stock of horses be Equally divided between my five children.

Item my will is that Dominick Newgent have all my wearing apparrell that is provided for bodily use.

Item I do nominate and appoint my well Beloved Son Robert Chinn hole and Sole Executor of this my last will and Testament Disanulling all other wills by me heretofore made Ratifieing and confirming this to Be the last in Testimony whereof I have set my hand and fixt my Seal this 8th Day of December 1767.

I give to my son Robert Chinn my plantation wherein I now live to him and his heirs forever but if he should dye before he arrive to the age of twenty one years or without heir lawfully begotten then it is my Desire my aforesaid plantation should be Sold by my Executore and the money Equally Divided between my five daughters Viz., Sarah Elizabeth Susannah Mary & Ann Mitchell Chinn or the survivors If Either of them Should Dye before they arrive to the age of twenty one years or without heir.

I give to my aforesaid son Robert Chinn my Gun and Sword It is my Desire that all the Remainder of my Estate not before given of every kind whatsoever be equally Divided between my six children (Viz) Sarah Elizabeth Susannah Mary, Ann Mitchell Chinn and Robert Chinn or the Survivors after paying my Just I give to my son Robert my wearing apparell. Debts. It is my desire after a division of my Negroes among my Children that my Daughters parts may be continued on the plantation for the Support of them until they come of age or marries free from Rent (?) but Should there be any Taxes on the Said plantation they must pay their parts as my Ex'ors Shall think proper. I do nominate and appoint my worthy Friends Richard Mitchell Thomas Belfield Griffin Fauntleroy and John Chinn hole and sole Ex'ors of this my last will and testament Disallowing all other Wills by me heretofore made Fortifying and Conforming thie to be my last. In testimony whereof I have hereunto Set my hand and Seal this 16th Day of June - Anno Domini 1779 -----Sighned Sealed and Delivered in presence of James Ewell Martin Tapscott Henry ?em Robert Chinn ---- (seal) William Tapscott

At a court held for Lancaster County the 13th day of March 1784. OUR DESCENT FROM THE CHINN FAMILY

John Chinn, born in England, settled in Lancaster County, Virginia He was married around 1662 to Elizabeth, said to have been a Travers. Their home was "Morattico."

Rawleigh Chinn, their son, was born 23 May, 1684 and d. 1741. He was married to Esther Ball, daughter of Col. Joseph Ball of Epping Forest.

Thomas, probably the second son of Rawleigh and Esther Ball Chinn, died in 1767-8. He married first Sarah Mitchell, and then the widow. Ann Edwards.

And then we come to Robert Chinn whose will was proved 18 March 1784. He married Elizabeth Belfield of Richmond County, Virginia. Their daughter, Elizabeth Chinn, married Robert Jeffries on 11 March 1796, and died on 5 April 1807.

Their daughter Fidelia Belfield Chinn Jeffries, married Rawleigh Downman Towies 29 February 1817, and d. 13 October 1836 at the age of 39 after the death of her baby, Olivia.

"On November 17, 1752 the last meeting of the vestry of Saint Mary White Chappell was held and it was decided to merge with Christ Church Parish. Among the signers of this agreement were Thomas Chinn and Joseph Chinn." OUR DESCENT FROM THE BALL FAMILY

Col. William Ball of Lancaster County, b. around 1615, was our English emigrant settling here in 1650. He married in London on 2 July 1644 Hannah Atherold, probably daughter of Thomas Atherold of Burgh in Suffolk.

His will was probated at Lancaster County, November 1680. His home was called "Millenbeck."

His son, Col. Joseph Ball of Epping Forest, Lancaster County, Virginia, was born in England 24 March 1649 and was brought to this country in his infancy. He married in England around 1675, Elizabeth Romney, daughter of William Romney of London. By Eliza. he had one son, Joseph and four daughters. Three of the daughters were Elizabeth, Hannah, and Ann. Then there was Esther, b. in 1685 who d. at Lancaster County, Virginia in May 1751. She was married at Stratford-by-Bow, London to Rawleigh Chinn in 1700, and they settled in Lancaster County, Virginia in 1713. Rawleigh's death preceded hers by ten years. He passed on in 1741

This Esther Ball was the daughter of Col. Joseph Ball by Elizabeth Romney. Her father Col. Joseph Ball married Mrs. Mary (Montague) Johnston after the death of his first wife. They had one child, Mary Ball, the mother of General George Washington.

"The Balls of 'Millenbeck' had much to do with the history of the church" (Saint Mary's White Chappell in Lancaster County) "is confirmed by court and parish records: Hannah Ball, sister of Col. Joseph Ball wa the last wife of Captain David Box. Col. William Ball (1) attended the church and his son, William, was a vestryman and presented his aunt, Hannah Fox, to Court for not attending divine services for a month. Col Joseph Ball was a vestryman. His son-in-law, Rawleigh Chinn and Martin Shearman, who married the only daughter of Rawleigh and Esther Ball Chin were vestrymen also.

In a vestry meeting in 1739, Joseph Ball, son of Col. Joseph Ball; Joseph Chinn, his grandson; Martin Shearman, husband of his granddaughte Ann Chinn; Rawleigh Chinn, his son-in-law; Joseph Heale, a relative; Richard Chichester, husband of Ellen Ball; and Jesse Ball were vestrymen present . . .

. .

In 1740 the church was remodeled and called the new church. A nort gallery was "to be built for Col. Wm. Ball, Maj. James Ball, and Mr. Joseph Ball at their own cost and charges." In 1741 a south gallery was ordered to be built "For Mr. Jesse Ball, Mrs. Margaret Ball, Jr., and Mrs. Frances Burgess, daughter of Samuel Fox, and her two daughters, Elizabeth and Frances."

The coat-of-arms was brought to America by Colonel Ball, a painting on parchment is still extant, with the colors but little faded. It is: Argent, a lion passant; on a chief of the second, three mullets of the first. Crest: Out of the clouds, proper, a demi-lion, rampant, sable, powdered with estoiles, argent, holding a globe, or Motto: Coelum Tueri - "Look upward." This coat-of-arms was granted 1613 to the family of Kent, Cheshire and Northampton. The arms of the Balls of New England are the same, but the crest and motto are different. The crest is a stag trippant; the motto, Semper Cavelo -"Always be cautious." The arms have much that is bold about them-the lion rampant and the crest betoken strength and courage.

Mullet supposed to be the rowel of a spur. The points are clear cut. Estoile or star are wavy.

Nicholas Meriweather was born in 1632, a native of Wales. In 1655 and 6 he was Clerk of Surry County, Virginia. He purchased for his home Nathaniel Bacon's "Island House" on Jamestown Island. He was appointed Justice of Surrey Court in 1672 and died December 19, 1678. He was a large patentee of land and founder of an influential Virginia family. Ref. V. vol. 1 p. 291.

Nicholas 2 Meriweather, son of the above Nicholas Meriweather, was born in Virginia October 26, 1667. He first resided in James City County, then in New Kent and laterin Hanover. He was a Justice, Coroner, Sheriff, and Lt. Col. Burgess for New Kent from 1705 to 1722. He was Burgess for Hanover 1723-6 and 1727-34. He had large holdings of land in New Kent, Hanover Albermarle Counties and his will was proved November 20th, 1744. He married Elizabeth Crafford, the daughter of David Crafford. Ref. V. vol. 1 p. 290.

Francis Meriweather, next in line, was a large landholder in Essex County and Clerk of Essex County from 1692 to 1702. He was Senior Justice of Essex in 1711 and Burgess for the County from 1702 to 1706. He married Mary, daughter of Lancelot Bathurst of Sussex, England, a lawyer, who wasthe son of Sir Edward Bathurst of Sussex, whose estates were confiscated because of his loyalty to Charles I. Mary Bathurst Meriweather survived her husband, who died in 1712 or 13, and married Reuben Welch and thirdly, the Hon. John Robinson. Ref. V. vol. 1 p. 290 and 182.

Mary Meriweather, daughter of Francis and Mary Meriweather, married Thomas Wright Belfield, son of Dr. Joseph and Frances Wright Belfield. Ref. V. 1 290.

Elizabeth Belfield, daughter of Thomas Wright Belfield and Mary Meriweather, married Robert Chinn, whose ancestry is mentioned elsewhere, May 15, 1764 at Warsaw, Richmond County, Virginia. Ref. 5 w (1) p. 20.

Elizabeth Chinn, daughter of Robert and Elizabeth Belfield Chinn, married Robert Jeffries in Shelby County, Kentucky in 1796.

And their daughter was Fidelia Belfield Chinn Jeffries, who married Rawleigh Downman Towles, February 29, 1816. Ref. Family records in possession of Susannah Hart Shelby Chapter, D.A.R.

Arms: A lion passant.

The immigrant ancestor was Henry Towles, who settled first in Accomac county and married Anne Stokeley, member of an old family who settled at an early date on the Eastern shore of Virginia. Henry Towles afterward moved to Middlesex. He had issue, Henry, Jr., born about 1670, and Stokeley born about 1695. In the Middlesex Clerk's office is a deed of Henry Towles, Sr., bearing a wax seal of the above arms. The arms cannot be located in the English Heraldic records under the name of Towles. Henry Towles, Jr., settled in Lancaster county. His wife was Hannah Therriot. His will was proved 12 June, 1734, and in it he mentions his children, Stokeley, Judith, Ann, Elizabeth and Jane.

JOHN STOCKLEY and ELIZABETH, his wife

According to Whitelaw, historians presume that Francis and John Stockley were brothers who came to the Eastern Shore rather early. Certainly the names of their descendants indicate a close relationship.

Bishop Meade lists the Stockleys as one of the "old Families" of Accomac.

Stockeleyes Creek was a well known boundary line by the time of Scarborough's patent in 1664.

Francis and John Stockley are among five headrights claimed by Jonas Jackson of Northampton County in 1651. (Nugent)

However, a patent to Francis Stockley for 50 acres is dated 22 Dec. 1634, Accomac p. 406 Patent Book, "on the old plantation Cr.," credit for one transportation, being a servant hamed Francis Jarvis. (Nugent)

This is easily explained. Headrights were often held over for years before being claimed. And as Francis was himself a headright he could not claim any land on his own arrival. John, however, does later claim a right in his name at the same time that he claims one for his wife, Elizabeth. He could have gone back to England and brought himself in a second time, paying his and his wife's passage, or even spent some time in the Islands and returned.

In 1656 Francis Stockley left property to his wife (name unknown), and to a son John, and to two daughters, Ann and Frances. This John married Isobel. This Ann married Bagwell. Francis Stockley's widow (name unknown) married, secondly, William Custis.

John Stockley was given 200 acres of land in 1649 by Phillip

Watkins, which he sold to Simon Fry in 1651. (Whitelaw quoting Patent Book 6).

In 1655 John Stockley bought 400 acres from Capt. William Whittington. (Whitelaw quoting Nugent).

The first direct patent to John Stockley was in 1664. "2600 Acres, Acco., Sept. 2, 1664. Bounded east with the seaboard side, N. by Corrattawaman Cr. S. By Stokeleyes br. & a right lyne parting this from land of Col. Edmund Scarborough. For Trans. of 52 pers." Among these headrights were named John and Elizabeth Stockley. (Nugent, and very interesting).

Again in 1669 John Stockley patented 200 acres, and in 1671 200. In 1670 John and wife Elizabeth assigned 200 acres of this plot to Thomas Eastmad. (Whitelaw quoting Patent Book 6, 269)

Northampton County Court order, Apr. 28, 1663 says that "whereas John Stockley hath in a turbulent manner disturbed and abused the Vestry of Hungars Middle Parish--calling them an illegal Vestry--and not proving his assertion either by law or otherwise," he was "to make

his public Recantation in the Church for his sd. offense in which place it was committed (the next time Mr. Teakle shall preach) in the presence of the then Auditors."

(George Carrington Mason, Colonial Churches of Tidewater, Virginia. p. 335)

John Stockley's will in 1673 left a neck of land to his wife Elizabeth for life, then to go to son Thomas. He left 2700 acres to be divided between his seven sons, Thomas, John, Woodman, Francis, Charles, William and Joseph, - no mention of daughter Ann. (Whitelaw, p. 1225)

Elizabeth, wife of John Stockley, married secondly, John Stratton of Northampton. (Whitelaw, p. 1225)

Charles Stockley, son of John and Elizabeth, signed himself Yeoman. (Whitelaw, p. 1226)

It would be interesting to know what John Stockley did between the time that he came over as a headright and the day that he brought in 52 headrights at L6, cash each.

Accomac Co. rent roll quit 1704. Joseph Stockley had 664 acres. Tho. Stockley had 363 acres.

HENRY TOWLES - ANN STOCKLEY

HENRY TOWLES came to Virginia in the time of Cromwell. He was said to have been twelve years old when he arrived. He bought much land from time to time after 1664, but I have found no grant yet.

He married Ann Stockley in 1668. She was the daughter of John and Elizabeth Stockley of Northampton County. After her death Henry married Elizabeth () who after Henry's death married Rodgers.

The known children of Henry and Ann Towles were Henry, born 1670, Stockley, Job, and Thomas. (Birth dates to be determined.)

According to Ralph Whitelaw, historian of the Eastern Shore, Henry Towles may have been the first resident owner on Chincoteague Island. - Whitelaw, p. 1380.

1709 Henry Towles exchanged 500 acres of this island "land I now live on" for an equal amount of acreage from John Custis. How long Henry had lived on this lush pastoral land is still a question. But Whitelaw quotes a "local Record" of 1687, telling that complaint was made to the Court that "a forcible entry and riot" had lately been "perpetrated upon Gingoteague Island" by "twelve or fourteen persons with force of armes, with strong hand and multitude" and "threatening and terrorfying words." Among the bodies forthwith taken into custody for this misdemeanor were John Stockley (not your John) and Henry Towles of Accomac. (Whitelaw, p. 1377) The Peninsular had been divided at this time (1663) into Northampton and Accomac. It was in 1632 Accawmack, one of the original shires, but for some reason soon became known as Northampton. Chincoteague is in Accomac. The Sheriff who took the bodies into custody may have been John Stratton, a relative of most of the culprits. (This must be ascertained.) Henry himself had been constable six years earlier. (Mrs. France.)

Henry Towles owned many acres both on the Eastern Shore and on

the Northern Neck of Virginia.

Bishop Meade in Old Churches and Families of Virginia gives a handsome account of the Towles in Lancaster County.

Where and why was Henry Towles buried in Middlesex County? And may not some old graveyard in Middlesex or Lancaster County give a clue as to the date of Ann's death?

Gwathmey's Register of Revolutionary service lists,-Capt. Stockley Towles, Goochland Militia, Sept. 18, 1777 Lieut. Henry Towles, 5th Continental Line, Feb. 10, 1776 Major Henry Towles, Lancaster Militia, Apr. 18, 1782 Henry Towles, Madison Militia, 1779

A will probated Northampton County 1679 desired that there be "no Drinking Immoderately nor Shooting" at his funeral.

A younger John Stockley, 1678-82, was arrested for a "breach of the Sabbath by talking and making a noise when the minister was in divine service, and when admonished by a member of the grand jury

(John Stratton, his step-father?) he answered that he was there to do business." The churchyard was for nearly a century and a half the favorite place for informally doing business. And except during Cromwell's time warrants could be served on the Sabbath day so long as the culprit was not caught within the churchyard wall. See Bruce 17th Century Institutions

An Indian who killed another Indian "belonging" to a white planter was ordered by the Northampton Court to pay the former "owner" the price of the slave, which the court set at "15 deer with the skins."

Settlers on the Eastern Shore were never so fired up with tobacco culture as those on the main land. They raised enough to pay clergymen and taxes. But very early wheat and livestock were preferred to the Indian weed. Therefore the ancient forests are still standing in large areas.

Livestock was not only meat and milk and transportation, but also leather for shoes. From the Scarborough plantation "ladies French fall" shoes, children's shoes and slippers, and men's shoes were shipped to other settlements. (1650-1670) He employed nine shoemakers as a rule, but at times as many as fourteen. In 1673 another shoe manufacturer on the Eastern Shore shipped 143 pair of assorted men's, women's, and children's shoes to Yorktown.

Chincoteague Island is in fact partly protected from the full Atlantic Ocean by a long thin island called Assoteague. Chincoteague, so protected and content in a seagirt pastoral life, did not secede with the main land in 1861.

HENRY TOWLES, THE IMMIGRANT

Henryl

Generation 1

Henry Towles from Liverpool, England settled in Accomac County, Virginia about 1652, having come to America at about 12 years of age. He was a planter and landowner. In 1684 he leased one thousand acres from Lt. William Kendall, and he bought eight hundred acres of this land on 30 January 1689. We find him on the tax list of Accomac County in 1680 and 1681.

The eastern shore of Virginia, a flat, fertile strip about 70 miles long and averaging eight miles in width, is divided into two counties: Accomac, the northern, and Northampton, the southern. This peninsula lies between Chesapeake Bay and the Atlantic Ocean, Evidently he was married twice, first to Ann Stokeley in 1668 of Accomac County, and by her he had issue, Henry and Stokeley Towles. Ann was the daughter of John Stokeley and Elizabeth (______) Stokeley. After the death of John Stokeley, his wife married ______ Stratton. In her will she left the larger part of her property to her grandchildren, Henry and Stokeley Towles.

Henry Towles, Sr. was a constable of Accomac County in 1681, and lived in Northampton and Middlesex Counties. In the court records of Middlesex Counties at Saluda, Virginia is a deed of Henry Towles. bearing a wax seal of a "lion passant."

Henry had two wives as recorded from a deed in Accomac County, dated 28 March 1712, where Elizabeth Towles, "lawful wife" of Henry Towles, released her dower rights in property exchanged to Col. Custis. His will was probated on 6 June 1721 in Accomac County, where he leaves his "now dwelling plantation" to my son, Kendall Towles, forever only my loving wife shall have it during her natural life. To his sons Job and Thomas, all the remainder of his land was bequeathed. Unto his sons Henry and Stokeley he leaves one shilling each. Nothing is known of his daughter Elizabeth. He was buried in Middlesex County.

TOWLES POINT

Towles Point is an island between the Rappahannock River and Carotoman River. In 1711 Henry Towles bought Towles Point from John Pyne. The deed or indenture was recorded in Lancaster County court records 10 April, 1711, and was between "John Pyne of the first part, gentleman, and Henry Towles, Jr. of Accomac County, Virginia, but now of this County and Colony carpenter." He paid the sum of "Five shillings, lawful money, of England to him in hand was paid." The full purchase price included four hundred and six L., good money, and thirty thousand pounds of tobacco. It was recorded as two hundred acres but the division plat dated 1868 shows three hundred twenty three acres. The latitude and longitude taken in 1816 was

Towles Point had originally been granted to John Pyne by the Crown by patent 29 January, 1649. Originally there were two houses similar in construction. One was the homestead, the other called "The Grove" which housed the slaves. The latter burned down when the slaves went berserk. The cattle were kept at "The Grove." A"corduroy road" ran through the woods connecting the two houses.

Henry and Hannah Towles were the first owners of Towles Point and then they deeded it to Stokeley and Elizabeth Martin Towles. And they in turn deeded it to their son Henry and his wife Judith Haynes Towles. And they in turn deeded it to Stokeley and Mary Wallace Ball Towles. And they in turn sold it to Frances Towles (daughter of Judith Haynes and Henry Towles) and Porteus Towles (son of Stokeley Towles and Elizabeth Downman.) This Frances Towles was the mistress of Towles Point during the War of 1812, when a British frigate raided the plantation, and it was she who in defiance of the marauders threw the desk keys into the river. But the British soldiers did manage to get the family silver with the exception of two pieces, a teapot which had belonged to Bishop Beilby Porteus and sugar tongs which Frances Towles had inherited from her mother Judith Haynes Towles.

Once again a mistress of Towles Point dealt with war in a courageous way, this time during the war between the states. The plantation was raided and the Union soldiers took everything of use on the farm. On the plea that she was a widow and therefore desolate without menfolk to help, she persuaded a young Union soldier to return a pair of work animals.

Mrs. Kirk says, "In 1868 Towles Point was divided among the children of William Henry Towles. The part containing the homestead, built prior to 1711, and the tobacco barn was given" to James Towles, her grandfather.

"In 1948 this property was again divided among the grandchildren of James Towles," Mrs. Kirk receiving the part on which the ruins of the old homestead stand. . . . "The house was bisected by a tree during a storm in 1937 and now, 1954, is in ruins. It was a six room house of the 'Williamsburg' type, four rooms down and two upstairs with center halls. The original doors, hinges and bannisters have been preserved."

Mrs. Kirk concludes, "The words of Henry Towles' will in 1799 were prophetic and have been carried out--'I give and bequeath to my son Stokeley my Plantation and said land not in any case to be sold but always to remain an inheritance to him the said Stokeley Towles and his heirs and their heirs lawfully begotten forevermore.' It has remained so 1711 to 1954." Towles Point, Lancaster County; V. vol. 6, p. 283, V. vol. 8, p 321 and 428; V. vol. 9, p. 434; W. Vol. 20, P. 182; C. Vol. 10, P. 461; and D.A.R. Mag., April 1955, p. 430.

HENRY TOWLES²

Henry Towles² was born in 1670 in Accomac County, Virginia and died in 1734 in Lancaster County, Virginia. He was buried in the family burial ground at Towles Point,

He married Hannah Therriott (sp. Therriatt, Therrit, Theret, Therit) in 1709 or 1710. She was the daughter of william Therriott of Corrotoman, Lancaster County, Virginia. Her grandfather, Dominick was sheriff of Northumberland County in 1656 and received a grant of one thousand six hundred acres of land by Governor Berkeley from the Crown. Volume 25, page 215, of the Virginia Magazine says that he was sheriff of Northumberland County in 1656 and Court was held at his home. Old Lancaster County records show tht Hannah Therriott inherited a tract of land from her father's inheritance.

We know from the record that Henry had two wives and issue by each, but here we concern ourselves only with the marriage of Hannah and Henry Towles².

Henry Towles was a carpenter and planter and was sheriff of Lancaster County 10 May 1707, when he received revenue taxes from John Chowning and Martin Carter, the receipts of which constitute a family relic. In 1732 he was appointed guardian of Miss Mary Carter, orphan of Peter Parter, deceased. In 1719 and 1723 he sued persons in Liverpool, England. In 1711 he bought Towles Point from John Pyne, and the deed was recorded 10 April 1711 in Lancaster County.

He left his plantation, Towles Point, to his son Stokeley, and to his daughters he left a young negro. He provided that Stokeley take care of his sisters until their marriage.

STOKELEY TOWLES 1711-1765

Stokeley Towles, son of Henry²Towles and Hannah Thierrott Towles, was born and resided at Towles Point and was baptised 3 June 1711. He was a planter, attorney at law, and a vestryman of Christ Church, Lancaster. On 26 July, 1736, he married Elizabeth Martin of "Poplar Neck," the daughter of Thomas and Catherine Martin. "The marriage bond permission is recorded in Lancaster County." Elizabeth Martin inherited her father's estate "Poplar Neck" at his death.

To the marriage of Stokeley Towles and Elizabeth Martin were born the following children: Henry b. 1738 at Towles Point and d. there 1799. He was closely connected with the history of Virginia during the Revolution. He held the rank of Colonel during the war. He was a member of the Capitol House of Delegates in 1783, a member of the Virginia Convention in 1788, a County Lieutenant, 1794, and Clerk of Lancaster County until his death. His marriage to Judith Haynes had the written consent of his mother and William Dymer, her guardian, and this consent was recorded 15 May 1760, four days before the marriage. His mother's inheritance "Poplar Neck" from her father was sold to him in June, 1791, and he willed it to his son Henry.

The second son, Stokeley Towles, was a major in the Revolutionary Army.

The third son was Thomas, b. at Towles Point 21 February 1750, who was a colonel in the Revolutionary Army. At the start of his war career he was quartermaster to the Carolina County Battalion of militia. In 1783 he represented Spotsylvania County in the House of Delegates. His daughter Elizabeth first married William Brock, son of Joseph Brock. After his death she married Captain Phillip Slaughter, and thei: son, the Reverend P. Phillip Slaughter, was a distinguished minister of the Episcopal Church and author of numerous works on church history and genealogy.

Mrs. Dick, Mrs. Payne, and Mrs. Reveley, who married secondly Dr. Croughton.

Stokeley Towles, son of Stokeley and Elizabeth Martin Towles, was b. at Towles Point in 1740 and d. after 1798 at Spotsylvania County, Virginia. He was a planter, attorney of the Superior Courts of Richmond County, Justice of the Peace, and Captain in the Revolutionary Army. From Virginia state papers, compiled by the Virginia Historical Society, he was promoted to the rank of Major in which capacity he served until the end of the war. He married Elizabeth Porteus Downman 13 January 1773 in Goochland County.

In the Douglas Register records, kept by Reverend William Douglas and published in 1928, the marriage record is found on page 120.

Stokeley Towles and Elizabeth Downman Towles had large holdings of land in Goochland and Spotsylvania Counties. They sold all of this including Elizabeth's inheritance of land. Stokeley had almost one thousand acres in Goochland County.

Major Stokeley Towles was born at Towles Point, Lancaster County, Virginia between 1740 and 1750 and died in Spotsylvania County, Virginia in 1811. He was probably the second son of Stokeley 2 Towles and Elizabeth Martin of Poplar Neck.

In Goochland County in 1773, he married Elizabeth Downman, who was born in 1752, the daughter of Elizabeth Porteus and Robert Downman. Through her mother's line, Elizabeth Downman was descended from Sir Augustine Warner.

Stokeley 3 Towles (4th generation) at various times resided in Goochland, Spotsylvania and Richmond Counties where he had large holdings. He was a planter, a justice of the Peace, Attorney of Superior Courts of Richmond County and was promoted from a captaincy to a major during the Revolutionary War in which capacity he served until its end. In March 1781, he received a Court Martial Appointment from George Washington on which he served. His place of residence during the Revolution is given as Goochland County, Virginia.

The Towles line has long been established in the D.A.R. Ella Kirk France (Mrs. Carroll E.) of 1343 The Terrace, Hagerstown, Maryland has number 377497 and has given permission to the writers for its use. National number 253 is used as verification to Mrs. France's number. Col. Henry Towles, a brother of Major Stokeley, can also be used.

It is probable that the William Downman who came to Virginia in the Second Supply in 1608 was the ancestor of our American Downman line but, to date, (1958 Feb.) proof is lacking to the authors.

And so we start the story with John Downman, who came to Virginia on the "John and Francis" in 1614 and his wife Elizabeth who came on the "Warwick" in 1621. They lived in Elizabeth City where he was one of the Commissioners of the Peace in March, 1629 and a Burgess for October of the same year. In 1624, John and Elizabeth Downman, aged 35 and 25, were living in Elizabeth City according to the Census of that year.

William (1) Downman, probably the son of John and Elizabeth Downman, and his wife Dorothy, were living in Lancaster County in 1652. He was dead in 1655.

William (2) Downman, probably the son of William (1) and Dorothy, married Million Travers, daughter of Capt. Raleigh Travers of Rappahannock County. There is a deed recorded in Middlesex County, dated Oct. 1, 1694, with William Downman acting as attorney for his wife Million and Raleigh Travers, Samuel Travers, William Balland and Thomas Jones to make release to Hon. Christopher Wormeley "in behalf of our children" and they are named, "legatees under the will of Elizabeth Wormeley, dated Nov. 12, 1693. Elizabeth Wormeley was a sister of Million Travers Downman and had married first John Carter and then Christopher Wormeley.

The will of William Downman was proved in Richmond County in 1712. and that of his wife in 1728.

Wm. Price Towles, the oldest son of Robert Porteuse Towles and Harryann Roach, was b 26 February 1837 in Hendricks County, Kentucky. He died 6 October 1894 at Silver Lake, Kansas and was buried at Mount Hope Cemetery, Topeka, Kansas at the age of 56.

He married Catherine Hester Johnston 20 October 1859. She was the daughter of Eliza Jane (Talbott) and John Henry Johnston of New Maysville, Putman County, Indiana. She died 21 April 1926 in Kansas City, Missouri, and was buried at Mt. Hope Cemetery, Topeka, Kansas at the age of 81.

Wm. Price Towles and his wife Catherine lived in either Putman County or Hendricks County, Indiana until before 1880 when they emigrated to SilverLake, Shawnee County, Kansas, living on a farm there until 1894.

To this union was born 12 sons and daughters who located in various parts of the United States. From 1885 to 1923 there were 21 grandchildren whom Catherine Hester visited from time to time until her death in 1926. From 1910 to 1956 there were 34 great grandchildren. From 1933 to 1957 there were 22 great, great grandchildren, making a total of 89 descendents. Hester Towles, the youngest daughter of Wm. Price Towles and Catherine Towles, has kept the family records from birth announcements, wedding announcements, newspaper clippings, pictures, court records, and family Bibles until the date of this writing --1957.

Wm. Price Towles had dark brown eyes and dark curly hair. He was strict and firm, but kind with no foolishness. Catherine Hester (Johnston) Towles had dark, fine straight hair and grey eyes. She was very patient, kind, and understanding.

John Henry Johnston

John Henry Johnston, father of Catherine Hester Johnston and Millard Thomas Johnston, was b. 25 October 1821 in _____, Kentucky. d. 2 August 1852 at the age of 30 years, 6 mo., 7 days. Buried in Maysville Cemetery, Putman County Newmaysville, Indiana.

He was twice married and had issue. His first marriage was to Eliza Jane Talbott, Greencastle, Indiana license. 31 March 1842 by Woody Chase, M. G.

Notley M. Roberts affirmed that John Henry Johnston's parents did not live in the state and he had no guardian. Identified certificate from girl's mother before me, signed A. Mc Gaughey, clerk of court, Putman County, Indiana.

Eliza Jane Talbott was b. 13 May 1827, d. 8 January 1846. Buried in Maysville Cemetery, Putman County, Newmaysville, Indiana.

(Inscription from the Mayesville Cemetery located just East of town in the old part of the north side of the road.) There are four graves. A stone was broken and lying flat on top of John Henry's grave. The second stone stands by the first with Liza Johnston's name and dates of birth and death. Two other markers stand south of these with no dates, but with inscriptions, Infant Son of J. H. and E. J. Johnston, and Infant Daughter of J. H. and E. J. Johnston. Her parents were Hester (Scott) Talbott and Lorenzo Talbott.

She named her daughter that was b. 19 October 1844 Catherine Hester after her mother, Hester Talbott. Liza Jane had a sister and two brothers. Her husband, John Henry, was guardian of Lorenzo Dow Talbott and James Edward Talbott, her two brothers, when there was a property settlement of the land. Eliza Jane (Talbott) Johnston received 80 acres of land in Floyd County from her father's (Lorenzo Talbott) estate. This inheritance John Henry willed to his second wife, Mary Elizabeth Johnston and their son, Millard Thomas Johnston.

He married Mary Elizabeth Beaty 9 January 1847 in Putman County,

Indiana. Her stepfather, Abraham Moore, gave his consent. They were married by Sam Taylor. Soon after her husband's (John Henry) death, she married J. P. Killen and had issue: a son, Altis Prescott Killen, b. 16 April 1856; and a daughter, Mary Adele Killen, b. 7 Sept 1858, d. 18 June 1859. Mary Elizabeth (Johnston) Killen d. 6 July 1860. She was buried in Kansas near Ottawa.

John Henry Johnston had a brother, Charles D.Johnston b. in Kentucky 1820. The Putman County, Indiana census of 1850 says John Henry Johnston of Floyd Township was b. in Kentucky, was a merchant with \$1200 real estate and that Charles D.Johnston was b. in Kentucky, was a miller with \$700.00 real estate. Two children were born in Indiana, Leonidas b. 1848 and Joseph b. 1850.

The 1880 census of Illinois says Charles D. Johnston's mother was born in Kentucky and his father was born in Kentucky and Charles D. was born in Kentucky. Three children b. in Illinois: Anna 1863, Erna (Ernest) b. 1866, and Edda b. 1869. He had a boot and shoe factory. Charles D. Johnston died in Olney, Illinois 8 May 1902.
