Dear Sir, — I have to acknowledge the receipt of your esteemed favor of the 20th ult., enclosing draft, value six pounds (£6); a further payment on account of search fees, for which I ambmuch obliged.

In answer to your enquiries, I am of opinion that the ending of the name Towne-raw or rowe signifies "street," or what used to be termed a row, especially in the eastern counties.

"Visitation" refers to the visitations of the heralds which were from time to time to record the pedigrees and coats of arms borne by the landed proprietors and small gentry throughout the country.

"D. & h." stands for daughter and heiress; "s. p.," died without issue; "Archd. Ct.," Archdeacons Court, where the will was proved.

I am noting all parishes where I find families of the name resided at about the period required. If you could only get together sufficient money to enable me to search parish registers, and also to examine the wills of testators of the name, we are bound to get splendid results, but of course you will easily understand that the amount I am limited to does not admit of much work in this direction. If you could get two or three wealthy members of the family to join together in the expense, I should be able to visit the different districts and examine parish registers and the wills proved outside the Prerogative Court of Canterbury. A draft for say one hundred and fifty dollars (\$150) would enable me to do a lot of work in this direction.

Dear Sir, — Your esteemed favor of the 27th ult. has been received, and in reply to same I send you extracts from my notes which I have been making from time to time in the course of researches relating to the family of Towne.

So far as my searches go at present, I have not found by whom

the coat of arms for Towne was originally borne. It has been recorded by several well-known authorities, and appears to have been taken from Haleian Manuscripts, Nos. 1392 and 1459; Cotton Manuscripts, Tiberius, p. 1, and Glover's Ordinary. You will find the blazon quoted by Burke Berry, who was for fifteen years register clerk to the Heralds College, and in the "Ordinary of British Armorials" by the late John W. Papworth and Alfred W. Morant, F. S. A., — Towne or Town and Attowne, — "Arms argent, on a chevron sable three cross-crosslets of the first; crest, — on a rock, a tree growing proper."



I have just had my notes copied as they appear. It is hardly necessary to give all the many authorities I have examined, which are voluminous.

I think it very probable that the pedigree of "Towne-raw" given in the Lincolnshire Visitation may be connected with the family of Towne.

You will, of course, readily understand that there is much work to be done, and that if money is collected, I shall be able to push ahead with official records, such as wills, Chancery proceedings, and parish registers, where testators of the name were settled at the period of William's emigration.

Dear Sir, — I have just returned from Great Yarmouth and find your letter of the 21st ult. enclosing draft for £4.0.0 account of search fees, for which I am much obliged.

I have examined the register of St. Nicholas Church, and, I am glad to inform you, with success. The following entries I have extracted:

"WILLIAM TANE son of NICHOLAS and CYSSELEY, baptized 1 Jan., 1599."

"WILLIAM TOUNE and JOANE BLESSING, married 25th April,

1620, both of Yarmouth." (You will observe that the month is April, not March, as stated in your book.)

With regard to the spelling of the name "TANE" (which is the same as TAUNE or TOWNE): The entry was doubtless made by the then parish clerk, who spelt the name as pronounced. The present parish clerk, who was looking over the register with me, first pointed out the entry, saying, "This is the one you are in search of." He is thoroughly conversant with the registers of St. Nicholas, of which parish he has been clerk for upwards of forty years, and of the peculiarities of the spelling of the names therein, and is convinced that this is the entry of William Towne's baptism.

I also find that a John Taune was one of the two bailiffs of Yarmouth, 1488, and that John Toune, the elder, was mayor in 1494. These two persons are doubtless ancestors of William Tane (Taune or Towne), and I have every reason to believe that if sufficient money is obtained to enable me to devote a large portion of my time to the search and also to cover out-of-pocket expenses, which mount up considerably, I shall be able to trace back the line to the above-mentioned persons, and probably to a much earlier date.

If you can arrange to send me a lump sum of say one hundred dollars, I think it will be sufficient to enable me to exhaust the records accessible at Yarmouth.

I am well satisfied with the result of my work so far, and hope that you will be the same, and that you will be able to get members of the family to subscribe the necessary funds for further searches. With kind regards, I remain,

Dear Sir, — In answer to your esteemed favor of the 17th ult., The entry in the parish register of St. Nicholas, Great Yarmouth, reads as follows: "William Tane, son of Nicholas and Cysseley, baptized Jan. 1, 1599." The parents' name is "Tane" or "Town"; when the surname is given for the child, the surname of the parents is seldom mentioned.

The register book of St. Nicholas dates back to 1558, but the whole was recopied in 1599. I have no doubt as to the above entry being that of the baptism of William Towne, who married Joane Blessing. They were both of Yarmouth, and the date of his birth would agree with the date given in the Towne genealogy.

In Vol. xxxv, p. 87, "Town Rate of Topsfield, 1688," you will find the name spelt "Toune."

In the Visitation of Norfolk, John "TANNE" (or "TOUNE," the "n" and the "u" are written alike in early writing) married Margaret, daughter of William Stubbey.

In the Visitation of Kent, 1619, pedigree of "Watton," with arms consisting of ten quarterings, the third quarter, "Argent, on a chevron sable, three cross-crosslets ermine," is given for "Towne." William Watton de Addington married Benedicta, daughter of Thomas Towne de Towne Place, Throwley, having issue a son, Robert, who died 1470. This record of the Towne arms is an important find, as it shows that the arms ascribed by Burke to "Attowne" should also have been given for Towne of Towne Place, "de" and "at" are equivalent for "of," and "de la" which you ask about is "of the."

I note what you say regarding the difficulty you have in getting together more money so as to enable me to extend my searches. It would appear to me, now that the parentage of William has been discovered, the information obtained should be a great encouragement to members of the family to have the earlier generations searched for, which I am fully convinced can be traced back to a very early date.

If you can arrange to send me, in one payment \$150, I shall be able to go ahead quickly and do really better work than if small payments are made from time to time. Hoping that you will be successful in your endeavors to raise this amount, and with kind regards,

Dear Sir, — I regret to hear that you do not consider I have done sufficient work for the amount received. Although you have not received very much general information regarding the Towne family, I have made a most exhaustive search among the genealogical collections contained in the British Museum library, and have spent much time on the matter, besides making a special journey to Yarmouth in order to personally examine the parish register of St. Nicholas Church, where I really did not anticipate finding the baptismal entry of William, as I understood by your book that the registers had already been examined.

With regard to the coat of arms, I find no further information than that already known, but it is quite possible if search is made among the official records as suggested, some proof of this may be obtained.

It is important now to search official records in the public record office, such as "Chancery Proceedings," which give information (largely genealogical) relating to nearly every family holding landed property from 1558, also "Feet of Fines" records of certain legal conveyances of landed property dating from temp. Richard I. Also, it will be necessary to examine early Towne wills proved in the Prerogative Court of Canterbury, and in the Norwich Registry and perhaps Suffolk, for which I shall have to pay considerable out-of-pocket expenses.

If you remember, I arranged to establish the parentage of your William Towne, estimating the cost at \$150, which has been done, and I cannot possibly commence on official records without a further advance. At the same time, should I come across any information likely to be of interest in the course of my many searches, I would be pleased to inform you.

I hope you will be able to raise funds to enable me to go ahead on the lines indicated.
