The hamlet of Clatterwich in Little Leigh, or Leigh Juxta Barterton, is located on high ground on the north bank of the Weever River, about three miles from Northwich and a short distance from Great Budworth, in the County of Chester. That hamlet was the ancestral home of Robert Taylor who, in 1682, emigrated to America. There the family, of the sturdy landholding, English middle-class, is known to have dwelt as early as the middle of the Sixteenth Century. Tradition, supported by at least one historical writer (see *Pennsylvania Magazine*, Vol. 36, p. 321), locates the family there nearly a full century earlier. But the records of that earlier time are too vague and hazy to be dependable. The earliest entirely reliable records pertaining to the family are in the archives of the Parish Church of Great Budworth. There appear entries of the births, baptisms, marriages and deaths in the family, beginning soon after 1550. Names of the members of the family also appear upon tombstones in the churchyards, and their Wills, with the record of administration upon their estates, appear in the public offices at Chester. In the archives of the same Church are also found like entries concerning the Massey, Livesey, Coppock, Minshall, Worrall, and various other families of the vicinage, representatives of which emigrated to Pennsylvania contemporaneously with the emigration of Robert Taylor. Many of them, including Robert Taylor, settled in Chester County, Pennsylvania, becoming extensive landowners there.

From the English sources indicated, from the association of and intermarriages between the families just mentioned, and from the early records of the various meetings of the Society of Friends, the data concerning the early history of the Taylor family has been obtained.

The first of the family definitely located in the English home is John Taylor, described as of Clatterwich. In the Parish Church of Great Budworth appear the records of his marriages, the baptism of his six children, and the deaths and burials of himself and his wives. The family was thus affiliated, doubtless as members, with that Church. At Chester appear the record of his Will and an account of the administration of his estate. In his Will he describes himself as a "husbandman," an occupation which, as will hereafter be seen, was followed by one line of his Taylor descendants consecutively for more than two hundred years after the immigration of Robert Taylor to America.

From the same English sources, the lineage of the family has been definitely traced to Robert Taylor, the immigrant. He, in his early life, severed his connection with the Church of his forefathers, became a member of the Society of Friends or Quakers, adopting its faith, and lived and served therein during his remaining years, first in the English home of his nativity, and then in his adopted home under the proprietary government of William Penn in the Province of Pennsylvania. He, and many of his fellow members of the new faith to which they had avowed adherence, at the instigation of the believers in other faiths, or public officials, were subjected to various forms of petty persecution and even to criminal prosecution.

Besse in his "Sufferings of the Quakers," Vol. 1, page 103, says:

# "Anno 1662.

"In the Month called January 1662, Twenty-nine of this People were indicted at the Quarter Sessions in Chester, for being at an unlawful Assembly, and were all imprisoned by Warrants issued in the following Form, viz.:

'Cheshire ss.

# 'Carolus Secundus Dei Gratia, Angliae, &c. 'To the Constables of Clutterwick.

Whereas at the General Sessions of the Peace held at Chester in the Castle of Chester, The Day of the Date hereof, Robert Taylor of Clutterwick aforesaid, Yeoman, together with several other Persons, being above the number of five, and also above the Age of Sixteen years, were indicted for unlawfully assembling together at the house of John Dove in Coddington within the County aforesaid, the 19th Day of November last past, upon Pretence of joining together in religious Worship of God, contrary to an Act of this present Parliament in that Case made and provided, whereupon he appeared and pleaded not guilty; which issue being afterwards tried by twelve good and lawful Men of the County aforesaid, he was found guilty. Whereupon our Justices thought good to impose a Fine of 2£. 10 s. on him the said Robert Taylor. We therefore

command you, and either of you, after six Days next after the Date hereof, to levy by Distress or otherwise, of the Goods and Chattels of him the said Robert Taylor, the respective sum of 2£. 10 s. and the same so had and gathered forth-with to pay unto the Clerk of the Peace of this County, at his Office in Namptwich, to be employed as the said Act directs; and for want of such Distress you are to apprehend him the said Robert Taylor so failing, and carry him to the House of Correction, there to remain for the Space of thrce Months, and see that you certify your Doings unto the Clerk of the Peace at his Office aforesaid, within three Weeks after the Receipt hereof upon Peril that may fall thereon. Test. Rich. Grosvenor, Petro Leicester, Thomā Mainwaring Baronetto, &c. alüs focüs Justiciaris apud Cestriam praedict, 13° Jan. Anno regni Caroli secundi 14° 1662.

In the record of the Bishop of Chester's Visitation in the Parish of Great Budworth, it is set forth in Latin that on "December 22, 1665, Robert Taylor, John Minshall, Samuel Naylor, Thomas Livesey, and their pretended wives, were among those who were indicted to appear before the Consistory Court at Chester for being 'unlawfully maryed.'"

The fines in these cases were very moderate, but the Friends consistently refused to pay fines levied for attending their religious meetings or penalties exacted for refusal to take the oath and many instances are set forth in Besse's "Sufferings of the People called Quakers" where they were committed to prison and remained there for years, some dying as martyrs rather than conform to practices contrary to their faith.

It was continued persecution of this character against the Quakers which caused their immigration to Pennsylvania in large numbers.

Robert Taylor was one of the Quaker emigrants who determined to go to the New Colony founded by William Penn, where religious freedom was assured.

Before setting out, he acquired on March 3, 1681/2, from William Penn a Grant of 1000 acres of land to be located and surveyed after his arrival. This land was allotted to him in two surveys, one of five hundred and fifty acres under date of October 30, 1683. in the neighborhood of what is now the village of Broomall, Delaware County, and the other of four hundred acres, November 11, 1682, south of the Springfield Water Basin. These tracts were between Darby Creek and Crum Creek, Delaware County, at that time covered with a virgin forest of oak, maple and beech. The streams teemed with trout and bass and were frequented by many varieties of water fowl. The region abounded with quail, wild turkey, deer, elk and other game. The meadows afforded a variety of wild fruits and berries. Altogether the country was a paradise for the settlers. The Indians were hospitable and helpful, especially to the Friends. (Benjamin H. Smith: Atlas of Delaware County, page xviii, plates 9 and 11.)

As a first purchaser, Robert Taylor became entitled to lots within the limits of the City of Philadelphia or Liberty lands as they were called. One of these lots was situated on Sassafras (now Race) Street and another on High (now Market) Street.

The following deed executed after the death of Robert Taylor, furnishes confirmation of the grants to him by William Penn.

Indenture, March 10, 1700, Mary Taylor, widow of Robert Taylor, late of Springfield, Chester Co., Pa., yeoman, deceased, and Jonathan Hayes of Marple, Executors of the will of said Robert Taylor; Isaac Taylor of same county, yeoman, son and heir of s'd Robert; Thomas Taylor, another son of Robert; John Fincher of same county, Cordwainer, and Martha his wife, the daughter of s'd Robert and Mary Taylor, to Jonathan Taylor of said county, yeoman, another son of s'd Robert and Mary.

Witnesseth: that by Deeds of Lease and Re Lease May 2 and May 3, 1681, Wm. Penn granted unto s'd Robert Taylor 1000 acres of land in Pennsylvania, and whereas s'd Robert Taylor in the year 1683 obtained a warrant from the Proprietary to survey to s'd Robert Taylor 600 acres of the 1000 acres to the southward of Darby Creek which tract by direction of the surveyor-general Thomas Holme, was surveyed by Charles Ashcomb and 550 acres of land lying between Crum Creek and Darby Creek was returned as surveyed Nov. 7, 1688, and said Robert Taylor being lawfully seized thereof, made his will April 20, 1695, and did inter alia devise unto his son, the said Thomas Taylor, 100 acres, to Jonathan Taylor 200 acres of the said 550 acres named in his will as "my land in Marple" and made the said Mary and Jonathan Hayes his executors. And whereas there is another piece of land of 73 acres which is also part of the s'd 550 acres on Darby Creek south 54 Degrees west of the line of Jonathan Hayes, containing 373 acres.

(Philadelphia Deeds H 15, p. 150)

Having established himself in his New World wilderness home, he sent for his wife and children whom he had left behind him in

England. They made the voyage on the ship "Endeavor" and arrived in Philadelphia on July 29, 1683. The ship's log lists among its passengers, Mary Taylor, late of Clatterwich, Cheshire, and her children, Isaac, Thomas, Jonathan, Phebe, Mary and Martha. Two other children, Rachel and Josiah doubtless accompanied their father the previous year, and another, Jacob, was born in Pennsylvania. After becoming settled in his new home in Chester County, he continued the vocation of farming, to which he had been brought up. He also retained his Quaker affiliations and lived surrounded by many of his old neighbors and friends of the same faith, who like him were immigrants from England. His descendants are numerous and widely scattered.

No effort has been made to make this compilation comprehensive. Instead, it is designed primarily to show the ancestry of the author, of his wife, descendants, respectively, of Robert Taylor's daughters, Rachel and Mary, and of Joseph Ward Taylor, of Rochester, N. Y., a descendant of Robert Taylor's first born son, Isaac. Incidentally it shows various other lines, at least partially, among them that of Bayard Taylor, the accomplished writer, traveler and diplomat, also a descendant of Robert's son Isaac. The author ventures to express a high degree of confidence in the accuracy of his work and the results attained. No attention has been given to legends or traditions. Instead, there has been careful and painstaking verification, largely personal, by examination of original records of the Great Budworth Church, of various Friends or Quaker Societies, both in England and Pennsylvania, of wills, deeds, and other public documents, both ancient and modern, of record in various Pennsylvania Counties, and reliable historical publications. The records examined, while not always complete, were sufficiently so to amply support all that has been set forth. Tive author confesses to a very considerable degree of fascination in genealogical researches, and especially so here where his own ancestral line is concerned, and hopes that this modest book will prove of interest to his kinsmen, both near and remote, whose lineages are portrayed.

To Joseph Ward Taylor is due acknowledgment for his suggestion that this book be published and for his assistance in its preparation and publication.

## EXPLANATORY

On March 25, 1752, a change was made in the method of dating. The year which prior to this date ended on March 24, thereafter ended December 31. The Society of Friends used the numerical method of expressing the months. Thus 11th mo. 20th day, 1682/3 would mean January 20th, 1682/3 and not November 20th, 1682.

After March 24, 1752, the Friends continued to use the numerical method, and January 20, 1760, they expressed in their registers as 1st month, 20th day, 1760. It has been thought best to alter the Friends' dating prior to March 25, 1752, to conform to modern usage. Hence 4th month will appear as June; 8 br. as October, etc.

Also, where either the christian name or surname is misspelled in the ancient records, a uniform spelling has been adopted (Telor, Tailer, Tellyer, Tailleur, etc., will be spelled Taylor). The same plan will be used as to place names (Clatterwick, Clutterwick, etc., will be spelled Clatterwich), irrespective of the record. Where it is desirable to maintain the ancient quaint language and spelling as in wills, letters, etc., the record is exact.

Each of the descendants of John Taylor, of Clatterwich, is given his or her own number, which is placed *before* the name (printed in capitals), these numbers all following one another in serial order, in one column.

All children of the same parentage fall into one group, which is preceded by the word "issue," followed by their surname, if it be other than Taylor.

All persons of the same generation fall into one group, which is preceded by a headline, giving the number of the generation, followed (in parentheses) by the first and last *serial* numbers of the persons included in that generation.

A person's serial number printed in *boldface*, indicates that a further account of such person will be found farther on, under the same number, set a little to the left of the serial column. If not in boldface, no further account will be found.

The number placed *after* the name of a person, is the serial number of his or her parent, and is a guide in tracing the line of ancestry backward.

#### ROBERT TAYLOR FAMILY

John Taylor of Clatterwich, the earliest definitely located ancestor of Robert Taylor the immigrant, was born about 1550, and died in 1627. He married (1) July 18, 1575, Joan Gatlife. She was buried November 22, 1586. He married (2) December 11, 1586, Ellen Massey. No record of her burial has been found. He married (3) December 7, 1611, Alice Passey. She died December 14, 1631. All three marriages are recorded in the archives of the Great Budworth Parish Church.

The Will of John Taylor, husbandman, of Clatterwich within Little Leigh, dated March 16, 1625, proved April 9, 1627, directs his burial in Great Budworth Church and provides that all debts, funeral expenses and legacies shall be paid out of his personal estate, "but should said estate be insufficient, same to be made up from my liveing (*i. c.*, Real Estate) which I have alreadye assigned for the purpose and of the overplus if any, fortie shillings to son Richard and the rest to Ales my now wife."

The Executrix of the Will was his wife, and the witnesses were Thomas Saunders, Richard Hilltown and Richard Bancroft.

#### (Consistory Court of Chester.)

The Inventory of his estate was made April 10th, 1627, by Lawrence Taylor, Thomas Burrowes and Richard Bancroft, and shows personal estate of  $\pounds 42$ , s. 16, d. 8.

His children, all baptized at Great Budworth Church, are taken as the First Generation in this book.

Issue, all except last, baptized at Great Budworth Church as children of Thomas Taylor of Little Leigh.

7. ROBERT TAYLOR, 6, baptized December 15, 1633, at Great Budworth Church as son of Thomas Taylor of Little Leigh, died 1695 in Springfield, Chester (now Delaware) County, Pa. He married about 1663, Mary Hayes, died April 11, 1728, sister of Jonathan Hayes.\* Mary Taylor married (2) March 31, 1701, Joseph Selby, died February 7, 1727/8, intestate.

All the children of Robert and Mary (Hayes) Taylor, except Jacob, born in Pennsylvania, are recorded in the Friends' Register of Cheshire, England, as children of Robert and Mary Taylor of Clatterwich.

Robert Taylor died between April 24 and May 16, 1695. He left a Will dated on the former and probated on the latter of those dates, which is recorded in the office of the Register of Wills in Philadelphia County in Book A (the first Will Book used in Pennsylvania) at page 311. The original Will, in a fair state of preservation, is still on file in that office. A facsimile thereof appears opposite this page. Because it is difficult to read, it is here transcribed with its queer spelling and use of capital letters, quaint phraseology, and total absence of punctuation.

Ann Hayes, widow of Jonathan, married (2) October 25, 1718, at Newtown Meeting, David Powel, widower.

<sup>\*</sup>Jonathan Hayes married January 4, 1675, in Cheshire, Ann Williamson of the Williamsons of Crewood Hall. He settled in Marple and probably accompanied his brother-in-law Robert Taylor to Pennsylvania. He was much the largest landholder in Marple Township, and was a man of ability and influence, served as a Justice of the Court and represented Chester County in the Provincial Assembly, 1689-1697.

The Will of John Fincher, of Londongrove, Chester County, Pa., dated June 5, 1746, proved November 24, 1747, mentions sons, Jonathan and Francis; daughters, Rebecca Bennett and Sarah Swain. He left a legacy to Thomas Cox "living over Susquehanna," of £5 for the use of his daughter Rebecca, wife of James Fraiser. Executors: Friends Joshua Pusey and Nathaniel Pennock.

22. Jacob, born circa 1684, died October, 1742. He married circa 1708, Deborah Norbury, daughter of Thomas Norbury, of Newtown, Chester County, Pa.

The Will of Jacob Taylor, of Edgmont, dated September 22, 1742, proved November 3, 1742, mentions friend Mary, wife of Joseph Pratt, and Alice and Mary Pratt, the two youngest daughters of Joseph Pratt, to whom he devised the remainder of his estate. "To brother-in-law Philip Norbury, a remembrance, and to Elizabeth his wife, a gown that belonged to my deceased wife Deborah." Executor: Joseph Pratt.

The Will of Thomas Norbury, of Newtown, Chester County, Pa., dated July 16, 1702. proved August 10, 1702, mentions children: Stephen, Jacob, Deborah, Thomas, Philip, John, Benjamin, Mary, Hannah, Sarah and Rachel

Executors: David Williamson and Evan Lewis.

Witnesses: Bartholomew Coppock and Jonathan Taylor.

## FOURTH GENERATION (23-71)

13. RACHEL TAYLOR, 7, born January 15, 1664/5, at Clatterwich (English Friends' Records, Cheshire). She married (1) April 7, 1687, at Chester, Pa. Meeting, Jonathan Livesey, born June 18, 1666, died November 23, 1698, son of Thomas and Ellen Livesey of Norton and Runcorn, Cheshire, and grandson of Thomas and Anne (Thornely) Livesey of Manchester and Bury, Lancashire. She married (2) 1699, at Byberry Meeting, Joseph Gilbert, born 1675, died August, 1765, son of John and Florence Gilbert. Joseph married (2) Sarah James, widow, but had no issue by her.

The Will of Jonathan Livesey of Dublin Township, Philadelphia County, dated October 31, 1698, proved December 17, 1698, mentions wife Rachel, and children: Thomas, Jonathan, David, Mary, Martha and Rachel Livesey. Executrix: wife Rachel. Trustees,\* Arthur Cooke, William Preston. Edmond Orpwood, and father Thomas Livesey. Witnesses: Richard Worell, John Merick. (Philadelphia Will Book A, p. 429.)

The Will of Joseph Gilbert of Byberry, Philadelphia County, Pa., dated August 28, 1755, proved August 16, 1765, mentions wife Sarah; children: Phebe Comley, Rebecca Ogilby. Benjamin Gilbert, and children of daughter Sarah, deceased (not named), and son-in-law John Baldwin. Executor: Benjamin Gilbert.

Issue, first marriage—surname Livesey.

23. Mary, born February 9, 1687/8. She married (1) May 30, 1709, at Abington Meeting, John Paul, born April 1, 1689, died 1721/2, son of Joseph and Margaret (Roberts) Paul, of Holcombe Rogus, Devonshire, England. She married (2) March 30, 1724/5, at Abington Meeting, Lewis Roberts.

The Will of John Paul of Abington, dated February 9, 1721/2, proved March 10, 1721/2, mentions wife Mary; children: Joseph, Jonathan, John, Mary, Thomas and an unborn child; brother Joseph and brother-in-law Thomas Livesey. Executrix: wife Mary. who renounced, and her brother-in-law Joseph Paul and brother Thomas Livesey administered the estate.

\*Arthur Cook was first Chief Justice of Pennsylvania and Lieutenant-Governor.

- **24.** THOMAS, born December 17, 1689.
- 25. Jonathan, Jr., born May 15, 1692, died March 24, 1764, intestate. He married February 24, 1717, at Abington Meeting, Esther Eastburn, born March 27, 1694, died April 18, 1788, daughter of Robert and Sarah (Preston) Eastburn, o. Swaite Kighley parish, Yorkshire. He left many descendants.
- 26. Martha, born May 1, 1694, died March 29, 1774. She married September 25, 1721, at Abington Meeting, Robert Thomas, died August 15, 1760, son of Evan and Margaret Thomas of Dolobran, Wales.

The Will of Robert Thomas, of Lower Dublin Township, Philadelphia County, dated August 12, 1760, proved September 1, 1760, at Philadelphia, names wife Martha; children: Robert, Joseph, Richard, Elisha; son-in-law Thomas Austin; daughter-in-law Mary Thomas; grandchildren: Robert, Joseph, Richard and Thomas Austin, Mary and Jacob Thomas. Executors: Martha, Robert and Elisha Thomas.

27. Rachel, born April 15, 1696. She married December 30, 1717, at Abington Meeting, Evan Thomas, born 1690, died 1746, son of Evan and Margaret Thomas of Dolobran, Wales.

He was an Elder of Byberry Friends' Meeting, and a biographical sketch of him will be found in "The Friend."

The Will of Evan Thomas, of Philadelphia County, Pa., dated July 18, 1746, proved September 10, 1746, at Philadelphia, mentions wife Rachel; children: Phebe, Martha, Ann, Mary, Jonathan, Evan, David and Elizabeth, wife of Thomas Townsend; brother Robert Thomas. Executors: wife Rachel, brother Robert and sons Jonathan and Evan.

 David, born February 20, 1697, died September —, 1750. He married September 25, 1721, at Abington Meeting, Rebecca Hinkson.

The Will of David Livesey of Lower Dublin, Philadelphia County, Pa., dated November 1, 1748/9, proved October 1, 1750, in Philadelphia, mentions brother Jonathan; children: Thomas, Rachel, Elizabeth and Hannah; Executors: Jonathan and Thomas Livesey. Issue, second marriage—surname Gilbert.

- 29. Sarah, born June 21, 1700. She married about October 25, 1725, at Abington Meeting, John Baldwin, probably son of John and Katherine (Carter) Baldwin.
- 30. Phebe, born February 7, 1702, died February 14, 1773. She married September 26, 1728, at Abington Meeting, Henry Comly, Jr., born April 26, 1702, son of Henry and Agnes (Heaton) Comly.

He left a Will dated December 31, 1771.

- 31. Joseph, born December 13, 1703, died 1730, single.
- 32. Rebecca. She married December 29, 1735, at Abington Meeting, Patrick Ogilby, Jr., son of Patrick and Margaret (Dunkin) Ogilby.
- 33. Benjamin, born 1711, died June 8, 1780, buried on banks of St. Lawrence River. He married August 30, 1731, at Abington Meeting, Sarah Mason, died December 6, 1759. daughter of Richard Mason. He married (2) August 18, 1760, by license of this date, Elizabeth (Walton) Peart, born May 27, 1725, died August 5, 1810, widow of Bryan Peart. (The Pearts were Yorkshire Friends.)

(Philadelphia Deed Book C1, page 334.)

On April 25, 1780, Benjamin Gilbert, his wife Elizabeth, their children, Joseph, Jesse and his wife, Rebecca, Abner, Elizabeth and Benjamin, Jr., their neighbor Benjamin Peart, his wife and children, were taken captives by a band of hostile Indians of the Seneca and Delaware tribes, led by two renegade half-breed chiefs. The homes of the captives were ransacked and then burned, and the captives were led off on a long, harrowing journey through the wilderness to Fort Niagara, which they reached after a month of weary travail. From Fort Niagara they were taken to Montreal. Throughout the period of their captivity they were subjected to the inhuman cruelties customary to their captors. But all survived except Benjamin Gilbert who, on account of his advanced age, became exhausted and died on June 8, 1780, at some place on the St. Lawrence River, where he was buried. The rest of the captives were finally released and, after further arduous struggles and the endurance of great hardship, regained their home at Byberry, whence they started, September 28, 1782.

(For complete accounts, see pamphlet, "A Narrative of the Captivity and Sufferings of Benjamin Gilbert and his Family," published at Philadelphia, 1784. Also, pamphlets published at London, 1790; Philadelphia, 1848, etc.)

Gilbert Cope, the accomplished genealogist of Chester County, Pennsylvania, is a descendant of Benjamin Gilbert.

14. ISAAC TAYLOR, 7, born August 1, 1666, at Clatterwich, Cheshire; died intestate, 1717. He married August 26, 1689, at Chester, Pa. Friends' Meeting, Sarah Brodwell, born about 1669, died about November 1, 1748, daughter of Richard and Mary (Freeman) Brodwell, who were married May 24, 1663, at Ashelworth, Gloucestershire.

Richard and Mary (Freeman) Brodwell's children were: Isaac Brodwell, b. August 26, 1664, Mary Brodwell, b. December 10, 1667, and Sarah Brodwell, b. 1669.

Richard Brodwell was buried May 27, 1673, at Tewksbury. His widow Mary, and children, Mary Brodwell, Jr., and Sarah Brodwell, came over on the ship Unicorne, Thomas Cooper, Commander, from Bristol, England, which arrived December 16th, 1685. (Bucks County Arrivals, page 92.)

Mary Brodwell apparently established her home in Philadelphia. She died probably in January, 1729. She left a Will dated January 8, 1727, executed in the presence of three witnesses, Richard Rodes, Jos. Antrobus and Joshua Lawrence. The Will was proven January 29, 1729. It appoints her grandson, Isaac Taylor, executor. He renounced the executorship and letters of administration c. t. a. were issued to her grandson-in-law, Henry Paul.

#### The Will, in full, is as follows:

I MARY BRODWELL of Philada. in the Province of Pensilvania widow being at Present weak in body but of sound and pfect mind and understanding Do make this my Last will and Testament In maner following vizt.

Imprimis my will is That all my Just Debts and funeral Charges be first payd and Discharged by my Executor herein after named.

Item I give Devise and bequeath unto my son Isaac Brodwell of Great Britain one English Silver Shilling. And to his Children now living the sum of Ten Pounds Lawfull mony of America to be Equally divided among them Share and Share alike at their respective ages of Twenty one years.

Item I give Devise and bequeath unto my Grandson in law Henry Paul's Children to witt, Joseph, Mary, Margaret and John the sum of nineteen pounds Lawfull mony of America aforsd. and one Silver Spoon, one pewter Dish, half a Dozen of plates, one Chamber pot, Two porringers, one pewter Tankard, half a Dozen of napkins, one Table Cloath, Three pair of Sheets, one Long Towel, Two Chairs, and one large Iron pott, and also one large pewter Dish.

Item I give Devise and bequeath unto my Daughter Sarah Taylor (of Springfeild in ye County of Chester widow) the sum of Ten pounds Lawfull mony of America afd. and one Silver Spoon, one pewter Dish, Two pewter porringers, half a Dozen of plates, half a Dozen of napkins, Two pair of sheets, Two Chairs, one small brass boyler one small Iron pott one Chamber pott, one pair of Chest of Drawers, and a pewter Tankard, at the end of Two years after my Decease.

Item I give and bequeath unto my Grandson Isaac Taylor son of Isaac Taylor late of Springfeild afd. Deceased, one bed, bolster, and pillows, a pair of Sheets, a blanket and Coverlet.

Item I give and bequeath unto seven of my Grandchildren (to witt the sd. Isaac Taylor, John Taylor, Joseph Taylor, Benjamin Taylor and Josiah Taylor, sons of the afd. Isaac Taylor Deceased and to James Gillingham and John Gillingham sons of Yoman Gillingham late of ffrankford Deceased, The sum of Three pounds Lawfull mony of America afd. apiece) at the End of Two years after my Decease.

Item I give and bequeath unto my Granddaughter Eliz<sup>a</sup>. Taylor, Daughter of the sd. Sarah Taylor, by her sd. Late Husband Isaac Taylor afd. Deceased, one bed & bolster now in the Garret in the house wherein I now Dwell, with the Green Curtains, thereto belonging, and a pillow, and pillow Case, blanket, and Coverlet, a pair of sheets, one pewter porringer, and a pewter Dish.

Item I give and bequeath unto my Grandaughter Sarah Spicer wife of Abraham Spicer of Philada. aforesd. Currier, one bed, bolster and pillows in the Great Room in the house wherein I now live, with one pair of sheets, one Blanket and Large Curtains one round Table above Stairs, Two pewter Dishes, one porringer, Two Chairs, half a Dozen of plates and half a Dozen of napkins.

Item I give and bequeath unto my Grandaughters Elizabeth and Rebecca Daughters of ye sd. Yoman Gillingham Deceased and to each of them a pair of sheets and a pewter Dish.

Item I give and bequeath unto my Grandaughter Ann Paul wife of ye sd. Henry Paul a set of blew and white Curtains, a Counterpain, new Blankets, a pair of sheets, Two pillows, and pillow cases, a large Trunk, one Table below Stairs and another above Stairs, a large Looking Glass and one large brass Kitle.

Item I give and bequeath unto him the said Henry Paul and Ann his wife all my Shop Goods whatsoever and wheresoever, They paying my just Debts which shall Lawfully appear to be Due to the merchants for the said Goods.

Item I give and bequeath unto my Grandaughters (to witt the sd. Ann Paul Mary Wilson wife of James Wilson the sd. Eliz<sup>a</sup>. Gillingham, Rebecca Gillingham and Sarah, Marcy and Eliz<sup>a</sup>. Taylor the sum of five pounds Lawfull mony afd. apiece) at Two years after my Decease. And to Mary Taylor I give the sum of Three pounds mony afd. at ye end of two years after my Decease.

Item I give and bequeath unto my Great Grandchildren to witt Joseph Taylor and Isaac Taylor sons of Isaac Taylor aforsd. and to James Wilson's two Children to witt Mary and Elizabeth Wilson and to the Two Children of Joseph Taylor of Marburrough in Chester County afd. yoman to witt Jessey and Sarah and to the Child of Abraham Spicer and Sarah his wife to witt John Spicer, the sum of Twenty shillings apiece, at their respective ages of Twenty one years.

Item I give and bequeath the sum of forty shillings to ye poor people belonging to ye Babtis Meeting in Philada. aforsd. to be payd to such of them as my Executor herein after named shall think most Deserving. Item I give Devise and bequeath unto ye sd Henry Paul and Ann his wife their heirs Executors Admrs and assigns all ye rest and residue of my Estate both real and Psonall whatsoever and wheresoever the same may be found. And Lastly I nominate and appoint my Grandson Isaac Taylor of Springfeild aforesd. Yoman Executor of this my Last will and Testament. In Witness whereof I have hereunto Set my hand and seal this Eighth Day of January in the year of our Lord one Thousand Seven hundred and Twenty Seven.

The original Will, the inventory of the estate, considerable in amount, and proceedings relating to its administration, are still, 1925, among the ancient documents and records in the office of the Register of Wills at Philadelphia. Because the Will establishes a connecting link between early generations, as well as because it is an interesting ancient document, a facsimile thereof is made a part of this compilation, and because that is not readily legible a complete copy has been set forth.

By deed of August 20, 1689, Robert Taylor conveyed to his son Isaac 300 acres of land, part of the Penn Grant of 1000 acres, adjoining Bartholomew Coppock. This land was conveyed November 18, 1729, by Isaac's widow and children to Thomas Williams.

Isaac Taylor was a prominent man, both among the Friends and with the public. He died early in 1717.

Letters of Administration upon his estate were granted April 15, 1717, at Chester, Pa., to his widow Sarah and son Isaac.

The Will of Sarah Taylor, widow of Isaac, dated November 14, 1748, proved November 26, 1748, gives legacies to her

eldest son Isaac; to her son John, his wife Elizabeth, and daughter Sarah; to her sons, Joseph, Josiah and Benjamin; to her daughters: Mary Thomas, Sarah, wife of Thomas Massey; Elizabeth, wife of James Sharpless; to her granddaughters: Sarah Dicks, Mary and Rebecca Sharpless; to her grandsons: James, Joshua, Job and Nathaniel Sharpless and Thomas Massey. Executor: son-in-law Thomas Massey. A full copy of this Will appears in the appendix.

18. MARY TAYLOR, 7, born March 14, 1673/4, died circa 1705. She married December 20, 1692, at Radnor Meeting, Henry Lewis, Jr., born December 26, 1671, died 1731/2, son of Henry and Margaret (Protherah-Philpin) Lewis, of Narberth, Pembrokeshire, Wales, and Chester County, Pa.

> (Copy of their wedding certificate appears in the appendix.) He married (2) circa 1707, Katherine Bynon.

Henry Lewis, Jr., inherited from his father, as eldest son, a large landed estate to which he added largely by subsequent purchase.

He was a member of the Assembly during the years 1700, 1708, 1709, 1715, and 1718, and was an active member of Haverford Friends' Meeting.

His ancestors were owners of the manor of Maenclochog, parish of Narberth, Pembrokeshire, Wales, 1588, which was part of the Barony of Kemes (Owen's *Pembrokeshire*, part 2, page 517).

Henry Lewis, Sr., in his will, calls his homestead, "Maencoch," named after his ancestral home where he was probably born.

The house was located on City Line Road about 1½ miles south of Overbrook Station P. R. R., and the farm was contiguous to portions of Philadelphia, Chester and Delaware counties (see Benj. H. Smith's map of Delaware County 1880). The property remained in possession of the Lewis heirs until 1750, when it was sold by them to Capt. John Wilcocks, who added to the building and named it "Clifton Hall." In 1760, Capt. Charles Cruikshank, son-in-law of Wilcocks, became the

owner and greatly improved the grounds by landscape gardening on a grand scale, which included terraced walks, beautiful shrubbery and rare plants. After his death in 1768, it became the residence of John Ross, Esq.. who married December 8, 1768, at First Presbyterian Church, Philadelphia, Clementia Cruikshank. During Ross' occupancy, it became the favorite resort of Washington, Franklin, Lafayette, and other celebrities of the times. Ross changed its name to "The Grange," out of compliment to Gen. Lafayette, whose native place was so named. Until recently it was owned by Richard L. Ashurst, Postmaster of Philadelphia. Mrs. Ashurst informed the writer that a part of the original log house built by Henry Lewis is yet in existence, having been incorporated in one of the other structures. It is now (1925) owned by Benjamin Hoffman.

The Will of Henry Lewis, Jr., of Haverford, Chester County, Pa., dated Nov. 18, 1731/2, proved January 5, 1731/2, in Philadelphia, mentions wife Katherine; children: Henry, James, Jacob, Samuel, Phebe, Hannah, Isaac, John, Sarah Morris, Margaret Price and Elizabeth Pearson, brother-in-law Richard Hayes, brother Samuel Lewis. Executors: wife Katherine and son Henry. Guardians: Samuel Lewis and Richard Hayes.

Issue, surname Lewis:

John Hallowell, Jr., was then living in Hucknall Notts. He emigrated to Pennsylvania and settled at Darby, Chester County, Pa. (The data concerning the second marriage of John Hallowell, Jr., to Mary Holland was given to Alfred R. Justice by Mrs. Emily Manners, of Innisdown, Mansfield, Nottinghamshire.)

The Will of Thomas Taylor of Springfield, Chester County, Pa., dated October 12, 1725, proved December 28, 1725, gives instructions for his executors to sell the homestead when his son Isaac arrives at the age of 14 years, and mentions sons: Thomas, Mordecai, Jonathan and Isaac; daughters Mary, Susanna, Esther and Hannah and mother Mary Selby. Executors: "brothers" Bartholomew Coppock of Marple and Henry Lewis of Haverford.

Jane announced her marriage by a Justice to Isaac Taylor at the Sadsbury Friends' Meeting on September 2, 1741; expressed her sorrow for the manner of her marriage, and asked to be forgiven. Her petition was granted and she thereby regained her status as a Friend. (See Minutes of Sadsbury Meeting, p. 17.)

Jane Taylor died about August 1, 1764, leaving a Will dated July 2, 1764, which was proven August 8, 1764, in Lancaster County, Pa. By the Will she gave a legacy to her stepson, Isaac Taylor, and appointed him and her son, Thomas Jones, executors.

Isaac Taylor had various residences at different times. In the Will of his grandmother, Mary Brodwell, dated January 8, 1727, he is referred to as of Springfield, Chester County, which had been the home of his father and was then the home of his mother. In a deed dated November 18, 1729, by which he, his mother, brothers and sisters conveyed to Thomas Williams three hundred acres of land in Chester County, of which his father had died seized, his residence is given as Salem County, New Jersey. (West Chester, Pa. deeds, Book Z, p. 33.) At some later period he settled in Lancaster County, Pa. strument of conveyance dated October 9, 1746 (Patent Book A, Vol. 13, p. 128, Dept. of Internal Affairs, Harrisburg), granted to him eighty and one-half acres of land at the Gap in Lancaster County, referred to as part of their "Manor of Conestoga." On that property about 1747 he erected a stone house which, with alterations and additions, was standing and occupied in 1924. There he resided until his death about August 1, 1756. He was a man of very considerable prominence. An extended sketch of his career and of the career of his son, Isaac, appears in the Evans and Ellis "History of Lancaster County," at p. 1044, et seq.

His Will, dated June 17, 1756, was probated August 19, 1756, at Lancaster. His son, Isaac, and friends, Nathaniel Newland and Joseph Williams, are named as executors.

A facsimile of his Will is reproduced elsewhere in this volume, and a copy appears in the appendix.

No record of the births of his two sons has been found, but that they were born is certain. Each is named as a great-grandson and legatee in the Will of their great-grandmother Mary Brodwell. Isaac is called "my only son" in the Will of his father, dated June 17, 1756, and is one of the executors thereof. From this it is clear that Joseph had died prior to the date of that Will and that Isaac was then at least twenty-one years of age, hence born in 1725 or earlier, to be eligible to be an executor.

County, Pa., Mary Bulla, born 1744, died 1814, daughter of Thomas Bulla by his wife Anne Williams, widow of Zacharias Williams, who were married at the same Meeting, February 10, 1743. The record of the certificate of Thomas Bulla and Anne Williams also appears in the appendix.

Isaac Taylor was a man of affairs and consequence in the community in which he lived. He was a recommended Minister of the Society of Friends, served as Clerk of the Meeting, and was frequently appointed to represent Sadsbury Meeting at other Meetings and Conferences.

His holographic, unsigned Will, was probated May 19, 1814. A copy thereof appears in the appendix.

109. Jacob, born circa 1768, died in Collins, Erie County, N. Y., May 3, 1840, intestate and unmarried.

About 1806, he was sent by the Friends' Yearly Meeting of Philadelphia, as a missionary to the Indian Tribes in Western New York. He took up his residence in the Town of Collins, Erie County, N. Y., and there acquired a large landed estate and considerable personal property.

His estate was administered in Erie County, N. Y., the realty in the Court of Chancery and the personalty in the Surrogate's Court. By the decree in the Court of Chancery dated May 28, 1844, it was determined that upon his death his real estate had descended in six equal shares to his one surviving brother James Taylor, and the descendants of his one deceased sister, Jane (Taylor) Powell, and his four deceased brothers, William, Isaac, Joseph and Enoch. His sister Sarah (Taylor) Wilson and his brother Samuel thus appear to have had no descendants living at the date of that decree. From that decree, other proceedings in the Chancery action and the records of the Erie County, N. Y., Surrogate's Court, and the Orphans' Court of Lancaster County, Pa., where the father's Will was probated and his estate administered, a considerable part of the information concerning the family has been obtained.

She married ——— Wilson, d. prior to April 3, 1815, date of receipt filed in the Orphans' Court for legacy under her father's Will by her brother James as her administrator. She had one daughter, Beulah Wilson, who died prior to the death of her Uncle Jacob, as appears in the Court records relating to his estate.

He survived his father, and receipted for his share of his father's estate January 17, 1826, by Abner Williams under power of attorney dated at Lancaster, Pa., March 15, 1824. He died before his brother Jacob, leaving no descendant, as appears from the court records relating to the latter's estate.
- 112. James, born about 1774. He married Amelia ———. He and his wife both survived his brother Jacob and were parties to the Court proceedings relating to the latter's estate. No record has been found of their deaths, or of any descendant.

·· John Meredith was a son of Simon Meredith of Radnorshire, born 1663, whose pedigree brought over from Wales shows descent from the Vaughans of Nannan, as follows: David Vaughan, Evan David, William Evan, Meredith William, Hugh Meredith, Simon Meredith.

From Jones's *History of Brecknockshire* it appears that Hugh Meredith was Bailiff of Brecknockshire in 1640, and that Meredith William of Pennant was High Sheriff of the same County in 1620.

Hugh Meredith, eldest son of Simon, was for a time a partner of Benjamin Franklin in the printing business and Simon Meredith loaned them the money to embark in the enterprise. (Smyth's *Life of Franklin*.)

The Will of Evan Lewis of Radnor, Delaware Co., Pa., dated February 15, 1806, proved March 8, 1808, provides for his wife Jane, and names sons: Elijah, Enoch, Evan, Abner and Thomas; daughters: Sarah and Jane; niece Tacy Davis. The homestead was bequeathed to his sons, Evan and Abner, and a tract of land he owned in Berks County to his son Thomas.

The Will of Jane Lewis of Radnor, Pa., widow of Evan Lewis, dated April 5, 1814, pr. June 16, 1814, names children: Evan, Jane, Abner, Enoch and Elijah; step-children: Sarah and Thomas.

Executors: sons Enoch and Elijah.

Enoch Lewis was a noted mathematician, surveyor and author. His education was obtained in the elementary private schools of the country district, and under Waring, professor of mathematics in the Friends' Academy, Philadelphia. He early took up teaching; was in charge or Radnor School, 1792-3; of the mathematical school at the Friends' Academy, a few years later; and of the mathematical department, Friends' Boarding School at Westtown, 1799-1808 and again later. He opened a boarding-school at New Garden, 1808, and another, at Wilmington, 1825.

He served as city surveyor of Philadelphia, also surveyed several railroad routes, and regulated the streets of several of the county towns of Pennsylvania.

As a member of the Society of Friends, he was unswerving in his opposition to slavery, and published several pamphlets on that and allied subjects. He was the author of able treatises on arithmetic, algebra and trigonometry, and as editor of the "Friends' Review," wrote a number of moral essays for that periodical.

124. Elijah, born May 2, 1778, died September 2, 1861. He married September 19, 1799, at New Garden Meeting, Esther Massey, born May 17, 1777, died November 4, 1853, daughter of Thomas and Jane (Goodwin) Massey, of Willistown, Chester County, Pa.

From this and other records, it appears that the descendants of the Taylors and Masseys, both coming from Clatterwich, Little Leigh, frequently intermarried.

Elijah Lewis was prominent in the "Underground Railway," and with Castner Hanway and Joseph Scarlett was indicted for treason for refusal to assist the U. S. Marshal and forces in arresting runaway slaves at

Christiana. They were ably defended by Thaddeus Stevens and found not guilty. (History of Underground Railway.)

March 31, 1784, Jacob Tomkins, wife Sarah, and children, Jacob, Elizabeth, Hannah, Mary and Martha, removed to Northern District Meeting, Philadelphia.

Jacob Tomkins was a highly esteemed member of the Society of Friends. He served as Clerk of Horsham Meeting from the date of his appointment August 29, 1782, until his removal to Philadelphia, and served as Executor for many estates.

Will of Jacob Tomkins, of Philadelphia, dated September 30, 1803, pr. June 20, 1810, mentions wife Sarah; son Isaac to have the house in the "billet" where he now lives (Hatboro formerly called the "Crooked Billet"), grandson Joseph Y. Tomkins, daughter-in-law (step-daughter) Hannah Y. Lukens and six daughters: Susanna Austin, Lydia Jarret, Elizabeth Bunting, Hannah Williams, Mary Jarret and Martha Lukens. Executors: son Isaac Tomkins and sons-in-law: Philip S. Bunting and Thomas Williams (Philadelphia Wills, Vol. 3).

Philip Syng Bunting was a descendant of the Syngs of Bridgworth, County Salop, many of whom removed to Ireland.

Philip Syng, Gentleman, married in County Cloyne, Ireland, 1700, Abigail Murdock and with her and their three children, Philip, Daniel and John, removed to Philadelphia in 1711. He was a silversmith and taught his sons the same trade.

Philip Syng, Jr., was a skilled silversmith, and specimens of his handicraft are highly prized. He was prominent in the affairs of the City of Philadelphia, serving as Warden 1753, Treasurer 1759-1769, Commissioner of Appeals 1765. He was one of the founders of the American Philosophical Society and Treasurer of same for many years; Trustee of the College and Academy of Philadelphia, out of which arose the University of Pennsylvania : a member of Franklin's Junto; The "Colony in Schuylkill" founded in 1732 and still (1925) flourishing; Junior Grand Warden of St. John's Lodge, the first Masonic Lodge of Pennsylvania, of which Franklin was Senior Grand Warden, and a signer of the Non-Importation Resolutions of 1765.

A complete list of the descendants of Philip Syng Bunting appears in "Ancestry of Jeremy Clarke of Rhode Island and Dungan Genealogy," by Alfred R. Justice, published by Franklin Printing Company of Philadelphia.

Isaac Taylor, by his Will gave to the children of his daughter Jane, deceased, late the wife of John Powell, the sum of one hundred and fifty pounds. The affidavit of Isaac and Thomas Powell, dated January 19, 1819, filed in the Orphans' Court at Lancaster, Pa., shows that John and Jane (Taylor) Powell, both then deceased, had eight children; and that said eight children (v. infra) receipted for the legacies due them from their grandfather's will by receipt dated February 6, 1819, which is also filed in the same Orphans' Court. They were also parties to the suit in Chancery in Erie County, New York, brought after the death of their uncle Jacob Taylor for the partition and sale of his real property. They were also the grantors in a deed dated July 23, 1844, recorded in the office of the County Clerk of Erie County, N. Y. (Liber 77,

Elizabeth (Crowell) Root, who were married at Frederick, Maryland, May 14, 1782. Daniel died in 1811 and his wife Elizabeth in 1813. Both died intestate, and their estates were administered at Frederick, Maryland.

Daniel was a son of Daniel Root, whose Will dated October 3, 1804, was probated at Frederick, Maryland, April 18, 1808.

Elizabeth was the daughter of Henry and Margaret Crowell. Henry Crowell's will was probated at Frederick, Maryland, October 2, 1784. (See copies of these two Wills in the appendix.)

On March 3, 1807, Joseph Taylor applied to the Sadsbury Meeting in Lancaster County, Pa., for a certificate to the Pipe Creek Monthly Meeting in Frederick County, Md., which request was granted May 5, 1807, and he presented the same to Pipe Creek Meeting September 19, 1807, where it was read and accepted.

August 19, 1809, he was complained of to the Pipe Creek Meeting for marrying a woman not of the faith, and in due season after being afforded an opportunity to explain, etc., he was, on November 14, 1809, dismissed from the Meeting.

By deed of April 2, 1810, he acquired 95½ acres in Frederick County, and is described in said deed as a carpenter. (Liber W. R. No. 38, Folio 252, Frederick County, Md.)

He died intestate and his estate was administered by his brother Enoch. (Orphans' Court, Frederick County, Liber R. B. No. 3, Folio 97, et seq.)

- 126. EVAN LEWIS, 95, born August 19, 1782, in Radnor, Pa., died March 25, 1834. He married March 9, 1815, at Wilmington, Delaware Meeting, Sidney Ann Gilpin, born February 28, 1795, died March 23, 1882, daughter of James and Sarah (Littler) Gilpin, of Wilmington, Delaware.

His parents were members of the Society of Friends, and he received from them the early religious training which gave direction to his future life. Like his brother Enoch, he had to work his way in securing an education, but endowed with a superior mind and application, he became well equipped for his life work. He early engaged in teaching, and followed this profession for many years. In 1814, he conducted a Ladies' Seminary at corner of Sixth and King Streets, Wilmington, Delaware. During the years 1819, '20, and '21, he was a member of the Borough Council of Wilmington.

Early in life he became interested in the slavery question, and September 29, 1804, joined the "Pennsylvania Society for Promoting the Abolition of Slavery." His certificate of membership bears the signatures of Benjamin Rush, President, Timothy Paxon and John Bacon, Secretaries. In 1816 he was a delegate from Delaware to the American Convention for the Abolition of Slavery, held in Philadelphia, and was appointed to important committees. In 1823, he was elected Vice-President of the Convention. In 1831, he won the prize offered by Ebenezer Dole of Hallowell, Maine, on "The duty of Ministers and Churches of all denominations to avoid the stain of Slavery and to make the holding of Slaves a barrier to Church membership."

During the latter part of his life he edited "The Friend or Advocate of Truth" and during the absence of Benjamin Lundy in a foreign land, he conducted both the editorial and publishing department of the "Genius of Universal Emancipation" which he continued until a short time before his death.

As a Minister of the Society of Friends he made journeys to New York and Maryland on religious missions.

Dr. Edward P. Atlee, who succeeded Mr. Lewis as Editor of the "Genius of Universal Emancipation," announced his death to William Lloyd Garrison, in a letter dated in Philadelphia March 25, 1834.

His widow, Sidney Ann (Gilpin) Lewis, survived him 48 years, and died March 23, 1882, in her 88th year, at 315 Marshall Street, Philadelphia.

- 156. ENOCH TAYLOR, 113, born January 18, 1809, in Frederick County, Maryland, died September 30, 1885, at Port Huron, Mich. He married April 2, 1845, in the Town of Collins, Erie County, N. Y., Louisa Mary Ward, born October 22, 1824, died June 20, 1906, at the residence of her son Joseph W. Taylor, Rochester, N. Y., daughter of Elisha and Hannah (Morse) Ward. Hannah was the daughter of Joshua Morse and Caroline Matilda (Hathaway) Morse. Louisa Mary Ward is No. 2475 in "The William Ward Genealogy," published in 1925, by Artemas Ward.

Enoch Taylor passed his early days at or near Fincastle, Botetourt County, Va. His mother married April 29, 1813, at Frederick, Md., George Crowell, her cousin, and shortly thereafter they removed to Fincastle. There were two children of this marriage, Henry Crowell, born April 3, 1816, married September 7, 1838, Julia A. Osborn, and Elizabeth A. Crowell, born October 14, 1817, married April 28, 1836, James Stewart. Each left a large family, that of the former at Laurel, Indiana, and of the latter at Marysville, Ohio. The dates of their deaths have not been found.

Enoch Taylor was a student at Allegheny College, Meadville, Pa., 1834-5. At Salem, Virginia, he learned the saddler's trade. He then returned to Maryland, where he followed his trade for a time. Then he went West and took up clerical work in country stores at Quincy, Illinois, and other places. He was serving in that capacity at Bentonsport, Iowa, in 1840, when the death of his uncle, Jacob Taylor, called him back to the East. In the settlement and division of that uncle's estate, he acquired the uncle's home farm, on which, upon his marriage, he took up his residence and engaged in farming. Some years later he sold that farm and moved to the village of Gowanda. There he remained, occupied in a mercantile pursuit, until the spring of 1861, when he purchased another farm of three hundred acres. There he resided until his death. He was a man of fine physique, indomitable energy and industry, a highly proficient and prosperous farmer, and a respected, intelligent and useful citizen. Shortly after his death, his farm passed to the State of New York, and has since been known as the Gowanda State Hospital Farm. He died at the residence of his son Charles F. Taylor, at Port Huron, Michigan.

His estate was administered in the Surrogate's Court of Erie County, N. Y., at Buffalo, pursuant to the terms of his will.

Both Enoch Taylor and his wife were buried in the Pine Hill Cemetery at Gowanda, N. Y.

Bayard Taylor was named for United States Senator James A. Bayard of Delaware, for whom his father had a profound admiration.

His early education was obtained in a private school taught by Ruth Ann Chambers near Kennett Square. She was a writer of verses which young Bayard enjoyed and this probably had much to do with arousing the latent poetic genius which in after life made him famous.

He later attended a school of which Samuel Martin was principal. His youth was spent on his father's farm, except when at school; but farming held no attraction for him, and in 1842 he was apprenticed to Henry E. Evans, publisher of the "Village Record," to learn the printing business. After serving one year of his apprenticeship, he purchased the remainder from Mr. Evans. In 1844 he published "Ximena and Other Poems" and having saved \$100, he sailed for Europe, having been employed by the "New York Tribune" and "Saturday Evening Post" to write his experiences. His newspaper contributions were received with much favor which induced him to publish in 1846 "Views Afoot," or "Europe Seen with Knapsack and Staff." In 1847 he accepted an offer made by Horace Greeley to connect himself with the Editorial staff of the "New York Tribune," and while so employed journeyed to California during the gold discoveries as correspondent of that Journal. His experiences are related

in "Eldorado or Adventures in the Path of Empire" published in 1850, a book which had a phenomenal sale, 40,000 copies having been sold within two weeks after its appearance. In 1851, he made a prolonged tour abroad, visiting Europe, Asia, Africa and the East Indies, covering over 50,000 miles.

His first wife, Miss Agnew, was an early friend and schoolmate to whom he had been long engaged. He married her when she was on her death bed.

In 1852, he made a voyage to Calcutta and thence to China where he joined Commodore Perry's expedition to Japan. He published eight books of travel, all well written and popular. Among them may be mentioned "A Journey to Central Africa," "The Land of the Saracens" and "A Visit to India, China and Japan."

Upon his return in 1854, he delivered a number of lectures throughout the principal cities of the United States from New York to Wisconsin. The venture proved to be remunerative and added to the fame he so well deserved.

In 1856, he again visited Europe and travelled through Sweden, familiarizing himself with its language and literature and out of which emanated his narrative poem "Lars" and a volume of "Northern Travel."

After his marriage to Miss Hansen, he travelled for a time in Greece, and again visited the Pacific slope.

In 1862, he entered the diplomatic service of the United States and served his country as Secretary of Legation at St. Petersburg, and the following year he became Chargé d'Affaires at the Russian capital.

In 1864, he returned to the United States and for ten years followed literary pursuits and during this period produced four novels, chief of which was "The Story of Kennett."

In June 1878, he was appointed United States minister to Germany, and died in Berlin shortly after his arrival.

His home in Kennett Square was called "Cedarcroft."

His wife, Marie, survived him, re-edited his works and, in collaboration with Horace E. Scudder, wrote his "Life and Letters" (1884). Besides that biography there

is a Life by Albert H. Smyth in the "American Men of Letters" Series (1896) and a sketch of his personality appears in W. D. Howells' "Literary Friends and Acquaintances" (1900).

Mrs. Lamborn was a woman of culture and scholarly tastes and like her distinguished brother had decided poetic gifts. She travelled with her husband visiting Alaska, Egypt and the Orient. She was an occasional contributor of short stories and poems to eastern journals and magazines.

He studied at the University of Ann Arbor, and later travelled through France, Germany, Switzerland and Italy. When President Lincoln called for troops, after the attack on Fort Sumter, Taylor summoned the young men of the neighborhood of Kennett Square, and in three days had enrolled a sufficient number to form a company, of which he was unanimously chosen captain. Captain Taylor led his men to Harrisburg, where they were incorporated into the Bucktail Regiment. Following the battle of Antietam, Captain Taylor was promoted to the colonelcy of the Bucktail Regiment. He was the youngest man holding a colonel's commission in the Army of the Potomac. He was mortally wounded at Gettysburg, July 2, 1863, while leading his regiment. His remains were carried to his father's house and were interred in Longwood Cemetery. A beautiful monument was erected to his memory.

171. JAMES LEWIS, 126, born November 13, 1816, in Wilmington, Delaware, died July 17, 1875, in Leesburg, Loudon County, Va. He married February 29, 1844, in Beaver Meadow, Pa., Ann Longshore, born September 2, 1826, in Salem Township, Luzerne County, Pa., died October 27, 1898, in Leesburg, Va., daughter of Isaiah and Ann (Wilson) Longshore.

Isaiah Longshore was an officer in the War of 1812 and his widow received a pension for his services: (Pennsylvania Archives, Volume IX, page 361, Sixth Series.) He was a descendant of Robert Longshore, Deputy Surveyor General of Pennsylvania under Captain Thomas Holme, who laid out the City of Philadelphia.

James Lewis was employed by the Beaver Meadow Railroad Company first as Engineer and later as Master of Transportation. He lived in Weatherly, Pa., until 1863. In that year he became Superintendent of the Huntingdon and Broad Top Railroad.

He served as a Justice of the Peace while living in Weatherly, Pa.

In 1865, he became Superintendent of the Clearfield Branch of the Pennsylvania Railroad.

In 1867, he gave up railroading and engaged in mercantile business.

In 1870, he retired from that business, removed with his wife and family to Leesburg, Loudon County, Va., and engaged in farming, which he followed the rest of his days.

### Salsbury Lancaster Coty Pensva 1811

#### Son Jacob

We Recd. thy Letter the 15th of this Instant which was Satisfactory to us as it contained no disagreeable information. Having received a few lines from Pipe Creek the evening before of the Decease of thy Brother Joseph which was very affecting yet a Resignation to the Divine will is Necessary, his complaint we are informed was a Bilious Collic which held him 3 or 4 Days when he departed this Life 16th of the 12th moth. which unexpected Change no doubt will prove very trying to his Widow, being deprived of her partner in so early a period of Life when Just beginning to engage in Temporal Concerns with a prospect to accommodate them in future But alas! how fluctuating & Transitory oftentimes are all Human prospects I was Requested to go out there immediately but do not think it Suitable for me in this Season of the Year to expose myself in Traveling through the inclemency of the Weather. And not seeing what assistance I could afford them being at such a distance & in another State being unacquainted with their Laws in Such Cases as is likely the Circumstance of things will Demand, As I Suppose he hath not been Capable of Making a will So that I have forwarded a Letter to Enoch informing him not to expect my Attention with other matters according to Prospect under the Condition & Circumstance of things-Which in Consequence will have to be attended to Apprehending that Enoch very likely will have to be Concerned in & to Assist the widow in the Settling of the Affairs . . And have desired him to give me an information as soon as the Condition of things will admitt. Thy Mother is in a frail Condition of health at present which is rather Augmented by the Sorrowful tidings. I am through Divine favour in a Midling state of health at present for which I feel thankfull Yet frequently look forward for a State of Dissolution. . With a Measure of Gratefull Acknowledgment that I am favoured to feel at times the revival of that Spirit of Love which breaths peace on Earth & Goodwill to Men. The rest of our family are pretty Well. Several of the Inhabitants of our Neighbourhood are in a Weak State of health, Joseph Dickinson hath been in a Lingering Condition & his Recovery is doubtful.

Old Margaret McDonald is deceased. I Did not apprehend it Seasonable to Communicate to Enoch any of thy Observations thou Mentioned leaving it for a future time. I now think of drawing to a Conclusion with a renewed desire for thy Preservation & Stability in thy Passage through Life Knowing by a degree of experience that this is a State of Probation & that a State of Humble watchfulness is absolutely Necessary Recollecting the admonition "be Ye therefore Likewise also Ready" Time to us here is very Uncertain. Thy mother Joins me in Love to thee & Wishes thee try to Convey & bring a pair or two of Good Mogansens. We remain with affection thy Parents

WHEREAS I Isaac Taylor of the Township of Salisbury, County of Lancaster & State of Pennsylvania, being now advanced in age, And calling to mind the uncertainty of time here Doth for the Setling my outward Estate make this my last Will & Testament in Manner and form following viz

First. My Will is & I order & direct that all my Just Debts & Funeral expences may be timely paid & discharged.

I Bequeath unto my Beloved Wife the whole power & authority of Renting or Letting this Plantation whereon I now live during her Widowhood the incomes arising therefrom for her & my Daughter Sarah's Support during that term if she should live unmarried & Choose to live with her. And Likewise I Bequeath unto my said Wife the sum of Two Hundred Pounds lawfull money of the state aforesaid to be paid to her in Eighteen Months after my decease, also one best feather Bed & Furniture one Case of Drawers, a Desk & spice Box, one walnut ovel Table, six best Chairs, & arm'd Chair, one half of the Tea Ware & Twelve Dollars worth of Kitchen furniture at the Appraisment Likewise one Horse Creature with Saddle & Bridle, & one Cow all of her own Choice. The above Mentioned Premises to be at her own intire disposal & to be considered in full lieu of her Dowry.

I Bequeath unto my Son Jacob Taylor the sum of One Hundred Pounds he having obtained a Bond from me payable from my Estate. I Bequeath unto my other three Sons (to witt) Samuel, James, & Enoch Taylor the sum of Two Hundred Pounds each. I Bequeath unto the Children of my Daughter Jane, Deceased late the Wife of John Powell the Sum of One Hundred & fifty Pounds to be divided among them Share & Share alike if applyed for by themselves, or by their lawfull Attorney within the space of Six Years after my decease they residing in some other State or States And if after the Proper or Usual Care taken by my Executors they should neglect applying that their Share or Either of their shares so neglecting shall return into my Estate. I Bequeath unto the Children of my Son William Taylor Deceased, To Jacob, the sum of Eighty

pounds, To Phebe, the Wife of John Sillymon, the sum of Thirty Pounds, and unto Isaac, the sum of Twenty Pounds.

I Bequeath unto my Daughter Sarah Taylor the sum of two Hundred & Fifty Pounds One Good feather Bed and furniture one Case of Drawers one Good Chest one Good Cow, beside what I have given her in my life time &c. I Bequeath unto her Child Beulah Wilson the sum of fifty Pounds to be put into her mothers care (if my Execrs. may think fit & safe) Seven Years after my decease to help to Educate her in her Minority but in case she should not live to have Lawfull Isue for it then to fall intire into its mothers Possession &c.

I Bequeath on behalf of the Creditors of my son Isaac Taylor Deceased the sum of Ninety pounds to discharge the Principal sum due to each Creditor the same being made to appear Authentic and Satisfactory to my Executors, & if there should be any to remain, That it shall go to his son Caleb, Unto whom also I Bequeath the sum of Thirty Pounds. I Bequeath unto my two Grand Daughters Children of my son Isaac, Aforesd. Namely To Ann, who resides with my Son Enoch, the sum of Twenty Pounds, And to Elizabeth whom I have raised the sum of Thirty pounds when she shall to a proper age to receive it. And to Amy the sum of Ten pounds. I Bequeath unto my Kinsman John Jones as a Compensation for his Service & Attachment to me the Sum of Sixty Pounds.

And I Likewise Bequeath unto Enoch Taylor Child of my Son Joseph Taylor Deceased the Sum of One Hundred & Fifty Pounds, the Interest therefrom after the term of Seven Years from my decease to be Applyed for his Education in his Minority if it can with Convenience.

And in order that my Executors may be Enabled to discharge the trust reposed in them I order & direct that they make sale of all my Personal Estate not otherwise bequeathed as soon as may be Convenient after my decease And Likewise my Real Estate after the decease of my Widow either Divided or together as may appear most advantagious to my Estate.

Also my Will is and I direct that the Reversions and Residue of my Estate may be Equally Divided amongst my living sons. Let it be Considered that where there is no Interest mentioned respecting any Legatee that it is not intended that there should be any intended to be paid but the principal only.

And I do earnestly desire that the true intent & meaning of this Will may be kept to as near as possible it being written with my own Hand. I bequeath to my daughter Sarah one-half part of the tea ware which was omitted in its proper place.

LASTLY I Nominate & appoint my Friends Asahel Walker & his son Isaac Walker Executors of this my last Will & Testament And doth hereby revoke all other Will or Wills by me heretofore made Ratifying & confirming this only to be my Last will & Testament in Witness whereof I have hereunto Set my hand Seal this day in the Year of our Lord one Thousand eight Hundred & Fourteen.

Imprimis. I desire that all my just Debts which I do Owe to any person whatsoever be Contented and paid within convenient time after my Decease.

Item. I leave to my well beloved wife Margaret Crowell besides her thirds during her life or Widowhood the Land and Plantation where I now live with liberty to sow thirty five Acres of Winter Grain Yearly on the place. I also give her besides her thirds the sum of twenty five pounds Current Money which is now lent to Henry Landis. I also give her a Cow and two hundred pounds of Pork and fifty pounds of Beef and thirty Bushels of wheat the meat and wheat to be found her yearly During her life or widowhood. The Rest of my Estate I leave to be Disposed of in the following manner that is to say Whereas I have already given to my son in law Daniel Root in land and otherwise the sum of four hundred and fifty pounds-Now my will is that after my other six children that is to say Devalt Crowel, Michael Crowel Barbara Young, Henry Crowel John Crowel and Savile Crowel shall have received each of them the sum of four hundred and fifty pounds Current Money out of my Estate to make them Equal with my Son in Law Daniel Root and my Daughter Sevile a Cow and a feather bed. Besides her Share after the above Legacies are paid and Satisfied the rest of my Estate I leave to be equally Divided among all my Children. It must be understood that Devalt Crowel has received Eighty

I Daniel Root Senr. of Frederick County and State of Maryland being at present favoured with a midling degree of Health and with the perfect use of my natural understanding do therefore make and publish this my last will and Testament in manner and form following After my Debts and funeral charges are paid I Devise & bequeath as follows—I Give and Devise to my Daughter Margaret Root ninety Acres of Land part of the plantation on which I now live Originally called Williams Intention and part of the Resurvey on Long Tail the said Ninetv Acres to be laid off by a straight line across the Tract parallel with the upper line of my plantation adjoining a Tract of land called Richards Lott with the buildings Improvements and appurtenances to have and to hold the said Ninety Acres of Land to her and to her heirs and assigns in fee Simple—on her paying to my son Daniel Root his heirs or Assigns fifty pounds in equal annual payments of five pounds each the first payment thereof to be one year after my decease. Also I give and bequeath to my said Daughter Margaret Root one years provision after my Decease also my negro man Isaac, my waggon and Team of four horses and Geers with all my farming utensils and one milch Cow her choice. All the property that my said daughter has a claim to as her own is not to be reckoned in my Estate-Also I give and Devise to my son Richard Root the residue and remainder of my plantation after the above mentioned Ninety Acres is taken off To have and to hold the same by what name it may be called, to him and to his heirs and Assigns in fee Simple he to Have Possession thereof one year after my Decease, on his paying to my son Daniel Root fifty pounds in ten equal annual payments the first payment thereof to be made One Year after my Decease-It is also my will and I order all the residue and remainder of my Personal Estate of whatever kind not already herein bequeathed to my Daughter Margaret aforesaid and excepting also my Desk and my chest containing my wearing apparel, to be sold at public vendue by my Executors hereinafter named and the proceeds thereof to be disposed of as follows-

I give and bequeath to my Daughter Sarah Davis Twenty five pounds, to my Daughter Ann Death Twenty five pounds—to my Daughter Jane Richards Twenty five pounds. Also I give and be-

queath to my Grand children, the children of my son James Root deceased fifty pounds to be paid as follows, To my son James's Daughter Elizabeth twenty pounds to his son Daniel Root fifteen pounds, to his Daughter Ann fifteen pounds. And if the sale of my person property aforesaid should not amount to the six last mentioned Legacies it is my will that my Daughter Margaret Root and my son Richard Root, to whom I have bequeathed my real Estate as aforesaid shall make up the deficiency each of them to pay an equal share thereof-Also I give and bequeath to my son Daniel Root my desk and Chest with its Contents, containing wearing apparel, and one hundred pounds in money to be paid by my Daughter Margaret Root and my son Richard Root in Equal portions and in yearly payment as herein before Expressed: and if on the sale of my personal Estate as hereinbefore directed, there should be any surplus over and above paying the aforesaid Legacies to my three Daughters, Sarah Ann & Jane and to my three grand Children Elizabeth Daniel and Ann I Give and bequeath the said Overplus to whatever amount to my said son Daniel Root his heirs or assigns Lastly I constitute and appoint my two sons Daniel Root and Richard Root and the Survivor of them executors of this my last will and Testament revoking and Annulling all former will or Wills by me heretofore made ratifying and confirming this and no other to be my last will and Testament
