THIS little booklet is published primarily for the descendants of Isaac Vandercook, whose service to his country during the War of the Revolution, and that of his family as well, has, as far as known, never been compiled. Nearly all of the early records of the family have been lost. By careful search I have found Revolutionary records of great value to coming generations.

The Genealogical Records

VANDERCOOK, MICHAEL. He was of Holland descent and was born in the Province that later became New Jersey November 10, 1715. Who his parents were, there seems to be no record. He died in Cooksborough, now Cooksburg, Albany County, New York, in 1786 and is buried in the old Cooksborough Cemetery.

He married Cornelia Vanness in 1742. She was born in 1721 and was a direct descendant of the famous Anneke Jans.

In May, 1762, he came with his family to the state of New York and patented land, settling on what is known as "Cooks Patent" land, granted to him by King George II. Here he founded the town of Cooksborough, now Cooksburg, Albany County, New York. His children were all born in the province of New Jersey. His five sons all served in the Revolutionary war. He suffered great privations through loss of his property by confiscation by England.

MICHAEL SIMON³, eldest son of Simon and Leona (Vanderhoof) Vandercook was born in Pittstown, N. Y., April 5, 1774; died there Feb. 17, 1852. He was a soldier in the War of 1812, attaining the rank of Major, commanding N. Y. State Troops. He was a general man of business and of high standing in the community. He married first, Mehitable Haskins; second, Sally, daughter of Major Gilbert Eddy; third, Mrs Betsey Roberts Pickett.

TRADITIONAL ANCESTRY OF ANNEKE¹ JANS

Count William of Nassau (alias William the Rich) of Dillenbourg married the Countess of Stallburg. They had twelve children, one of whom was William (alias the Silent) Prince of Orange, later William X of Orange and William I of Holland, and the first Stadtholder of the Dutch Republic.

This William the Silent (first child of William of Nassau, alias William the Rich) married four times. First in 1551 to Anne of Egmont, daughter of Count de Boreu. She died in 1558, leaving issue. He married second, in 1561, Anne of Saxony, by whom he had issue. They were divorced in 1575. He married third, June 12, 1575, to Charlotte de Bourbon, daughter of the Duc de Montspenser. She died in May, 1582, leaving issue. He married fourth, 1582-3, Louisa de Coligny, by whom he had issue.

Family tradition states that he had "natural" (or morganatic) marital relations, other than his four officially recognized marriages, with another whose name and station do not appear to be known; and by this clandestine marriage he had two children who were christened under the name of Webber, viz, Sara² Webber and Wolfert² Webber.

SARA² WEBBER: Born 1580; married a man named Sybrant, who had a son, Sybrant, who had a daughter, Wyntje³ Sybrant, who in time became the first wife of Willem³ Bogardus.

WOLFERT¹ WEBBER: Born 1582; married in 1600 Catharine (Tryntje) Jonas and by her had three children: viz., Wolfert² Webber, Marytie² Webber and Anneke² Webber.

WOLFORT² WEBBER: Born 1602; married and had a son, Wolfert³ Webber, who married and had several children whose names appear on the records of the Dutch Church in New Amsterdam, N. Y., among whom was a son, Aernout Webber, who married first, Aug. 25, 1669 in Dutch Church, N. Y., Adriantje Adriens and married second, Jannetje Cornelis. By this second marriage he had a daughter, Sara⁵ Webber, baptized Aug. 9, 1685, at the Dutch Church, N. Y. She in time married, May 12, 1706 (intention published May 10, 1706) at the Dutch Church, N. Y., to Sybrant Brouwer, son of Jacob Brouwer by his wife Anna⁴ Bogardus. [Willem³ Bogardus, Rev. Everdus² Bogardus by his wife Anneke² Webber. Wolfert Webber.]

MARYTIE² WEBBER: Born 1603; married first Thymes Janssen; married second, May 28, 1646, Dirck Corneliszen; married third, July 11, 1649, Gonert Loockermans, and left issue by each husband.

ANNEKE² WEBBER: Born 1605; married first, about 1620, Jan² Roeloffsen, and married second, 1638, Reverend Everardus² Bogardus, leaving issue by both husbands. By Rev. Evarardus² Bogardus she had a son, Willem³ Bogardus, born Nov. 1638, who married first, Aug. 29, 1659, Wyntje³ Sybrant [——² Sybrant, Sara (Webber) Sybrant] and by her had a daughter, Anna⁴ Bogardus; baptized Oct. 3, 1663, who married Jan. 29, 1682, Jacob Brouwer, by whom she had a son, Sybrant⁵ Brouwer, born 1683, who married May 12, 1706, at the Dutch Church, N. Y., to Sara⁵ Webber [Aernont⁴ Webber Wolfert³ Weber. Wolfert Webber, Wolfert¹ Webber.]

Such is the ancestry of Anneke² (Webber) Jans Bogardus, according to the belief of some of her descendants.

The Father of Anneke Jans

The name of the husband of Tryntje Jonas, and therefore the father of Anneke Jans, is not established by any authoritative original or published record of which I am cognizant. If such proof be forthcoming in the future, then the husband of Tryntje Jonas was Wolfert Webber, and the wife of Roelof¹ Jansen was Anneke¹ Webber.

It is a fact established in the records of the Dutch Church, New Amsterdam, that the Webbers and the descendants of Anneke¹ Jans were closely allied by intermarriage in at least two generations, as set forth above.

The first husband of Anneke¹ Jans, Roelof Jansen, came over to this country in 1630 with his wife and likely his three daughters, Sara², Catrina² and Sytie or Fytie², who one and all are said to have been born in Masterlant, Sweden, (or in Amsterdam). A beautiful little stream in what is now Columbiana County, New York, still bears the name of Roelof Jansen's Kill. He, probably in 1633 or early in 1634, removed to New Amsterdam where he re-

ceived his grant of 62 acres of land from Director General Wouter Van Twiller, this land lying on the North (or Hudson) River extending north from the West India Company's Bouwerij. From the location of this grant contiguous to the West India Company's Bouwerij, it would seem that he was held in esteem by that company if, indeed, he was not one of the officials. It appears that he and his wife went later to the Dutch West India Company's settlement in Brazil; and it is possible that he died there, as we hear nothing further from him in New Amsterdam after his grant of land in New Amsterdam about 1633-4. His widow early in 1638, married a second time to Reverend Everardus Bogardus with whom she entered into a marriage contract (presumably pre-nuptial) in March, 1638.

The original of this contract was either lost or never recorded; for we find that on June 21, 1642, it was renewed and recorded in due form in the following general terms, viz:—Declaration of Anneke1 Jans, widow of Roelof1 Jansen of Masterlant, deceased, as to the provisions she made March, 1638, for her children by said Jansen, previous to her marriage to the Reverend Everardus¹ Bogardus. death of her first husband, Roelof¹ Jansen, Anneke¹ Jans became possessed in her own right and that of her children by Roelof¹ Jansen of the 62 acras of land granted to Roelof¹ Jansen in 1633-4 in New Amsterdam. This land lay north of the West India Company's Bouwerij (or farm) and roughly extended from Broadway (of today) to the Hudson River and north to about Christopher Street, and on the north is said to have abutted upon a grant of land which had been made to Domine Bogardus, her second husband. (After the death of Roelof¹ Jansen these two joint parcels of land came to be known as the Domine's Bouwerij (or farm). The title to this land was confirmed to Anneke¹ Jans by Director General Peter Stuyvesant in 1654 and was again subsequently confirmed to her heirs in March, 1667, by the then English Governor Richard Nichols. Four years later, March 9, 1671, the heirs of her estate conveyed this land "For a valuable consideration" to Governor Francis

Lovelace, the successor to Governor Nicholls. The deed of conveyance to Governor Lovelace was signed by all of the heirs of Anneke1 Jans with the exception of one, her son Cornelis² Bogardus, who had died in 1666 subsequent to his mother's death in 1663, and prior to the date of conveyance. Neither Cornelis2 Bogardus nor his widow, Helena (Teller) Bogardus, nor his son Cornelis³ Bogardus (both of whom were living on the date of the conveyance) joined in making the deed. This land, the Domine's Bouwerij, after its conveyance to Governor Lovelace was joined to the West India Company's Bouwerij (then in possession of the English) and the whole combined area became known successively as the Duke's (Duke of York) Farm, the King's Farm and the Queen's Farm. Nov. 23, 1705, a patent for this tract was granted to what is now known as the Trinity Church Corporation of New York City. Such in general terms is the history of the tract of land about which, in subsequent generations from time to time, the descendants of Anneke¹ Jans have entered suit against the Trinity Church Corporation to recover their claimed interest which they maintained was alienated without due respect to the law thereunto applying. these attempts to recover have uniformly failed.
