P. 16. WELSH-JACOB

III.¹ Rd. Wsh.³ (of Benj.²), m. 1726, Charity Jacob, b. c1707, will 1772, da. of Jn. Jacob, Jr. (1686-1740) and wf. (m. 1706) Mary Swanson (A. H. 72). Will of Jn. Jacob Jr., dated 1726, pro. 1740 (Md. Cal. 8), names his da. Charity and son-in-law Rd. Welsh. Jn. Jacob, Jr., was the son of Jn., Sr., of South R., "an officer of Co!onial Forces," known as Capt. (See Col. Fam. V., Jacob), and his wf.—Cheney (See w. 1685, of Rd. Cheney, Md. Cal. 2). Capt. Jn. Jacob, Sr., d. 1726; his w., 1719—1726, names his wf.—(living 1719), sons Jn., Rd., Sam., Jo. and Benj., and das. Eliz. and Susannah. Rd. ("of Jn. and Mary") was bap. 1700 (A. H. 49); Md. Hist. Mag., Oct., 1930, states he was b. 1697-8, and m. 1. 1. 1718, Hannah Howard, da. of Jo. Howard and Hannah Dorsey (See P. 154). Eliz., b. 1633, m. Mareen Duvall, the younger (P. 208).

P. 20. COL. JN. WELSH II. P. 28

Recent findings by Mrs. A. S. Dolch, gencalogist, Attica, Ind., and Mrs. Fred W. Guy, Jr., of W., D. C., enable us to complete the record of the immediate fam. (P. 28) of this early Colonial official and merchant, and his 2d wf. Rachel, as follows:

III.⁵ Rach. Wsh., b. 1717-8, m. Th. King, A. A. Co., who d. prior to 1750. In the division of his est., 1750, two of the beneficiaries were Benj. Wsh. and his bro. Hy. Oneale Wsh. Rach. and Th. King had a son Th., named in the w. of Hy. O'Neale Wsh. (P. 28) as "my nephew Th. King."

III.9 Benj. Wsh., b. 1725, "m. a da. of Th. Rutland" who took out letters of adm. on the est. of Benj. in 1763. This Th. Rutland d. c1770. He was prob. Th. Rutland II, b. 1703, w. 1773, who m. Ann Beale (P. 151), da. of Jn. Beale and Eliz. Norwood, a gd. da. of Capt. Cornelius Howard (See Md. Hist. Mag., Dec., 1930).

Ref. for above: Chan. Papers, No. 5674, Annap., "Suit of Hy. O'Neale Welsh vs. Leonard Wayman, Jr.," 1790-94. Among those who gave depositions were Mrs. Comfort Rutland and Wm. Ijams. It is shown that Rachel (widow of Col. Jn. Wsh. II.) d. 1760, and Benj. c1763. Adm. Accts., Lib. 33, folio 186, Annap.—"The 3d Additional Acct. of Rach Welsh, A. A. Co., of the last w. and testament of Capt. Jn. Welsh" (Col. Jn. II.), dated 11.23.1752, gives the remaining 3 chn., viz.:

III.¹⁰ Eliz. Wsh., b. 1726, m. (prior to Nov. 1752) Hezekiah Linthicum, Jr., son of Hez., Sr. (w. 1722, Md. Cal. 5), and gd. son of Th. Linthicum, Sr., A. A. Co. (w. 1699—1701, Md. Cal. 2), whose da. Mary m. Rd. Snowden, "cousin" of Col. Jn. Wsh II. (P. 21). Jn. Linthicum, a reversionary legatee of Hy. O'Neale Wsh., was presumably a son of Eliz. and Hezekiah.

III.¹² Comfort Wsh., b. 1730.1, m.¹ (prior to Nov. 1752), Benj.

Williams, d. 1772; m.² 1772, Jn. Griffith, eld. son of Capt. Chs. Gth. and Cath. Baldwin (P. 198); m.³ Th. Rutland, will 1780.

The Gth. Gen., p. 227, gives the fol. quaint extract from "Chs. Griffith's Pocket Book:" "March ye 23, 1772, Mr. Benj. Williams departed this life, and on the 25th April, 1772, Jn. Griffith in the widow of said Benj. May ye 24, 1774, Mr. Jn. Gth. departed this life, aged 45 yrs., 5 mos. and 8 days (by a fall from his horse), and on the 10 Sep. 1774, Th. Rutland in the Widow of the said John."

This Th. Rutland's w., 1780, provides that his "beloved wf. Comfort' is to be cared for "so long as her widowhood shall last—but no longer"! As above shown, she was still Mrs. Comfort Rutland in 1790. Attractive? One would think so. Her name, Comfort, has been treasured and handed down in succeeding generations of the Welsh family to the present (Pp. 81, 83).

III.¹³ Rd. Wsh., b. 1734. Many years of research having failed to discover this son, it was believed the "unb. ch." of Col. John's will must have d. y.; and out of this failure arose the error of the text (P. 88) that Benj., 3d son (whose marriage was not known), m. Hamutal Hammond—an error above corrected.

Rd. Wsh.³ d. early, but not until he had reached manhood. In one year only, 1755, is he recorded in known official transactions—hence not identified. In that year Capt. Jn. Wsh. III deeded to Rd. Wsh., planter (now known his bro.) 295 a. of "Hopson's Choice," A. A. Co. (B B No. 1.101, 129, Annap.), and to Benj. Williams (his bro.-in-law) a part of the same tract (B B No. 1, 147). In 1766, Capt. Jn. III, as Jn. Wsh., Sr., deeded to Jn. Wsh., Jr., (his son) part of the same "Hopson's Choice" (B B No. 3, 604). After 1755 Rd. Wsh. (of Jn. II) disappears from the records—evidence that he died shortly thereafter. As he was 21 and proprietor of his own plantation it may be inferred that he was married.

It is shown on P. 161 that Hamutal Hammond m. a. Welsh, and on P. 88, for the reasons there given (q. v.) that she m., beyond doubt, into the neighboring fam. of Col. Jn. Wsh. II, already doubly allied to her own fam. by previous marriages. This assurance remains unchanged; the sequel, however, being that she m. Rd. (not Benj.) Welsh, as confirmed by the following remarkable collateral evidence:—

- 1. The births of Rd. and Hamutal Hammond are in close accord. Rd. was b. 1734, Hamutal c1735 (The "conj. b. c1729," of p. 167, was a loose general time-rating only, based on the order of the chn. in Capt. Hammond's will). Hamutal was one of the two unm. das. of the will, and as Ruth, the youngest of the three married das., was b. 1733, Hamutal was b. c1735.
- 2. Hamutal and her Welsh husband m. c1754-5. The proof is that their da. Caroline must have been b. c1755-6 to have been the mo. of Col. Jn. Hammond Riggs, who was b. 3. 5. 1773 (Riggs Fam. Record).

This date of marriage accords with the presumptive marriage of Rd. Wsh. (See above.)

3 and 4. Issue and deaths. Hamutal and her Wsh. husband were the parents of only one known child, which indicates that the young husband d. soon after 1755. His death in fact antedated that of Hamutal (d. 1815) by so many years that his very name became "lost" to his descs. Likewise, Rd. Wsh., dying shortly after 1755, would not have had more than one child, b. c1755-6; and the parallelism with Hamutal's husband is further shown in that Rd. likewise became "lost" to subsequent generations.

These correspondencies—in births, marriage, issue and deaths—are surely more than mere coincidences. Based on the family considerations above mentioned, and flashed through with these illuminating corroboratory facts, it would seem that the union of Rd. and Hamutal (though unconfirmed by official record) is assured beyond any reasonable doubt. And so at last, in Rd. Wsh. of Col. Jn. is found, we believe, the solution of the age-old problems of these two old Colonial families: The long sought "unb. ch." of Col. Jn. Welsh's will, the long "lost" husband of Hamutal Hammond.

Worthington² ("Son of Capt. Jn. and Sarah"), b. 1691 (St. M. 13), w. 1753, and wf. Eliz. Ridgely (See P. 176). His will left to his "da. Cath. Gassaway" the tract "Partnership." He was a mem. of the Assembly, 1753.

Shipley in 1806 died seized of land, "Shipley's Adventure," which descends to the fol. chn.: Roxanna (who m. Josh. Porter of B. Co.); Cath. (who m. Rezin Brashears of Fred. Co.); Geo.; Duncan; Frances (who m. Asa Murphy); Mary (who

m. Wm. Frost); Eliz. (who m. Jas. Barnes); Sarah (who m. Caleb Hipsley), and Talbot Shipley. (Chan. Papers, No. 4719, Dec. 2.1812).

Talbott Shipley left as co-heirs of his estate: "Th. Chew Shipley, Eph. Owings Shipley, and Marcella Owings Shipley (who has intermarried with Saml. Welsh, Jr.); and Josh. P. 57. Maj. Amos Washington (not Amos Wyley) Warfield (1826-66), C. S. A. Enlisted in Capt. G. W. Gordon's Co., 48th Tenn.; was at Ft Donaldson, escaped captivity; "Capt." on Gen. Vandorn's Staff; Commander of the Post at Decatur, Ala., (base of supplies for the Army of Tenn.), as "Maj. A. W. Warfield"—(statement of his son, the late Seth Washington Wfd., d. 1931, of Columbia, Tenn., who preserved his father's sword, War Diary, etc.)

Maj. Warfield's gd. son, Francis Boddie Wfd. (P. 58), served with distinction in the World War. He was 1st Lt., 105th Engineers, under Haigh when he broke the Hindenburg Line; was promoted Capt. for his services. When mustered out he was commissioned Capt. of Reserves, and later Maj. of Reserves.

WELSH-RIGGS-HOWARD

The w. of Capt. Elisha Riggs, proved 9.23.1777 (Annap., W. B. No. 33, p. 36), names his wf. Caroline, and chn. Jn., Jas., Nancy and Mary. A 5th ch., Sarah (not in w.), b. 1777, d. 10.22.1795, unm. ("Founders"). For descs. of Nancy (m. Jesse Hyatt) and Mary (m. Th. Riggs of Sam.), see Pp. 90 and 125, et seq. Of 5 chn. of Mary and Th. Riggs three are named in the w. (1811-15) of their Gt. Gd. Mother Hamutal Welsh (see P. 89).

Col. Jn. Hammond Riggs, of Brookville, Md. (son of Capt. Elisha and Caroline), b. 3.5.1773, d. 4.17.1749; m.¹ Ann Riggs (of Sam.), d. s. p.; m.² 6.26.1800, Rebecca Howard (Md. Rec. 2), b. 12.31.1779, d. 4.9.1859, da. of Jn. Beale Howard (of Hy.) and Rebec. Boone (of Capt. Humphrey). (For proof of Rebec. Howard's ancestry see "Howard-Dorsey," below). Col. Jn. H. and Rebec. (Hwd.) Riggs had fourteen chn.

Note.—A letter, 2.19.1849, from Mrs. Clarinda R. Frame to her "Dear Father and Mother," shows her parents living at that date. A recent letter from Mrs. C. V. Cyrus (da of Mrs. Frame) states: "Col. Jr. Hammond Riggs was my gd. fa. I have his picture. He was a Col. in the War of 1812. He m. Rebecca Boone Howard. I have her picture. She was the da. of Rebec. Boone and Jn. Beale Howard. I well remember her. She was b. in 1779." Mrs. Cyrus added that her oldest records show that "Rebec. Boone was b. 1754, d. 1824, and m. Jn. Beale Howard in 1770."

P. 115. HYATT-TODD-MILLER

Lucy Todd (of Josh. Todd and Sophia Hyatt¹), b. c1806 at Ridgeville, Md., d. 3.17.1899 at Quincy, Ill.; m. 1822, Edwin G. Miller, b. 1801, Fred. Co., Md., d. 1894 at Quincy. His fa., Geo. W. Miller (m. Kath. Rosana Keiss), was the son of Maj. Jacob Miller, 4th Batt., Md. Militia, Col. Baker Johnson's Regt. (Md. Arch.; D. A. R. Lin., 53, 65, 79). The family state that Gen. Lafayette was a friend of Edwin Miller's parents and their guest on the General's visit to Balt. in 1824; that on his departure he presented them a handsome silver service which has been preserved, one piece of which was engraved "Kitty Keiss." Edwin Miller and family settled in Quincy,

Ill., c1835. He was widely known as a hotel proprietor. He and Lucy had eight chn.: (1) Rufus Luther, atty., m. Fanny Pittner (Iss., Georgia, Helen, Annie and Frank); (2) Udolphia F., m.¹ Dominick Eagle (Iss. Edwin); m.² Jerubial Gideon Norman (Iss., Chs. D., Wm. P. 119. BEALL-GANTT-BROOKE-LEE

(Notable Ancestry)

"Jn. Hellen Beall m. Sarah Gantt of Fred. Co., da. of Thomas and Sarah (Potts) Gantt" (Chan. Papers, 4040, Annap.). More specifically given by their da., Mrs. Ann Lee (Beall) Wolfe-Hyatt (Pp. 133, 120), the writer's gracious "Aunt Ann," b. 1819, d. 1911, her parents were Dr. Jn. Hellen Beall, Capt. and Surgeon in the Navy, War of 1812, and his wf., Sarah Eleanor Potts Gantt of "Godsgrace's," b. 1787, da. of Th. Gantt and his 2d wf., Sarah Eleanor Potts. Both of her

gd. parents (Josiah Beall and Th. Gantt, Jr.) were signers of "The Declaration of the Freemen of Md." 9.26.1775 (See P. 119).

Th. Gantt, Jr., b. 1736, was also a delegate to the Md. Conv. at Annap., July 26 to Aug. 14, 1775 (Journal of Proceedings, v. 2, p. 3); as Th. Gantt, Jr., he was commissioned 1st Lt., 5.24.1779 (Md. Arch. 21.414); and as Th. Gantt IV, of P. G. Co., was appointed Ensign of the 6th Md. Regt. of Continental Troops, 11.6.1779 (Md. Arch. 43.10). He signed the "Patriots' Oath," 1778 (Md. Records, 2), and was Judge of the Orphans' Court for P. G. Co. (Md. Arch. 21, p. 45).

Th. Gantt, Jr., was the son of Dr. Th. Gantt III, b. 1710, and his wf. Rachel Smith (b. 1712, m. 1726), "da of Col. Jn. Smith and his wf. Dorothy Taney, da. of Michael Taney and his wf., Dorothy Brooke" (Col. Fam. I. Gantt).

Note.—The Brooke Fam. record (Col. Fam. V, Brooke) states; "Dorothy Brooke (1678-1730), m.¹ Michael Taney (d. 1702), m.² Rd. Blundell (d. 1705), m.³ Col. Jn. Smith (d. 1717)." This Col. Jn. Smith, Gent., Calv. Co., was the stepfather of the three Taney chn. of his wf. Dorothy, viz., Mich. and Th. Tanev and Dorothy (Taney) Smith (See his w., 1715-17, Md. Cal. 4). Itis "da.-in-law" (stepda.), Dorothy Taney, m. prior to 1712, the Col. Jn. Smith, mrcht. of Calv. Co., whose w., 1737-1738 (Md. Cal. 7) names his "Da. Rachel Gant." The Sarah of his will, "widow of Col. Jn. Smith," was his 2d wf., his 1st wf. (Dorothy Taney) having d. prior to 1730 (see w. of Dorothy Smith, Calv. Co., widow, 1730,—Md. Cal. 6,—which names her son Th. Taney, but not her da. Dorothy). It is not known that the two Col. Jn. Smiths were related, except through their marriages. The Jn. Smith, who was son of Col. Jn. (d. 1717) and his wf. Dorothy (w. 1730), was Jn. Smith, of S. M. Co., will 1735 (Md. Cal. 7), as clearly shown by his own will and his mother's, of 1730.

Dorothy Brooke (1678-1730), gd. mo. of Rach. (Smith) Gantt, was the da. of Roger Brooke (of Gov. Robt.), 1637-1700, and his 1st wf., Dorothy Neale, da. of Capt. Jas. Neale (1615-84), mem. of the Council, 1643, Capt. 1661, etc., whose w., 1683-84 (Md. Cal. 1) names his gd. chn., Roger. Jas. and Dorothy Brooke (chn. of Roger, w. 1700—Md. Cal. 2).

Dr. Th. Gantt III was the son of Th. Gantt II and his wf., Prisc. Brooke (m. 1707), da. of Dep. Gov. Col. Th. Brooke (1660-1730), member of the Council, 1692, and Dep. Gov. of Md. 1720, whose w., 1730 (Md. Cal. 6), names his "son-in-law Th. Gantt." Dep. Gov. Col. Th. Brooke was the son of Maj. Th. (1632-76), Maj. 1660, mem. of the Assem. of Calv. Co., 1663 to 1673, who was the son of Gov. Robt. Brooke (1602-55), Pres. of the Council and Acting Gov. of Md., 1652. (For the above Brooke dates and relationships, see Col. Fams. I and V, Brooke; and for services of Gov. Robt., Maj. Th. and Col. Th. Brooke, and Capt. Jas. Neale, see "Index of Ancestors," Soc. of Colon. Wars, 1922).

Sarah Eleanor (Potts) Gantt (Mrs. Hyatt's gd. mo.) was the da. of Wm. Potts, Fred. Co., Md., and his wf., Miss Lee, da. of Hon. Philip Lee (1681-1744), who came from Va. to Md. in 1700, and was a "mem-

ber of the Council of Md. in 1728" ("Index of Ancestors"). He was the son of Col. Rd. Lee of Va. (1647-1711), "Col. of the Horse," Mem. of the Council, etc. ("Index"), who was the son of Col. Rd. Lee 1st, emigrant to Va. in 1641, "Burgess, 1648, Secretary of State of the Colony of Va." (See Col. Fam. I, Lee; and "Descs. of Rd. Lee of Va., in Eng Eng. Hist. and Gen. Register, v. 26, p. 61, 18—).

The w. of Philip Lee (1743-44, Md. Cal. 8), names wf. Eliz., "fa. Col. Rd. Lee of Va.," and seventeen chn., one of whom was his "da.—— Potts, wf. of Wm. Potts." He m.¹ Sarah Brooke (d. 1724), da. of Col. Th., the Dep. Gov.; m.² 1725, Eliz., widow of Hy. Sewall (see w. of Nich. Sewall Jr., S. M. Co., 1727—Md. Cal. 6).

Mrs. Hyatt often stated that Gen. R. E. Lee was her cousin, but could not explain the relationship. The New Eng. Register above quoted shows that Gen Lee (b. 1.9.1809) was the son of "Light Horse" Harry Lee (1756-1818), he the son of Hy. Lee (d. 1789), he the son of Hy. Lee, who was the bro. of Hon. Philip Lee of Md. Gen. Lee was thus the 3d cousin of Sarah Gantt Beall, b. 1787, Mrs. Hyatt's mother.

LINCOLN AND LEE RELATED.—From an article by Wm. E. Barton in Good Housekeeping, as published in the Editorial page of The K. C. Star, Jan. 7, 1929. Following are excerpts:

"Abraham Lincoln was a desc. of the famous Lee fam. of Va., and was directly related to Gen. Robt. E. Lee. . . . Years spent examining documents in musty, forgotten files of old Va., old marriage records back to the 1st days of the Colonies, records of wills and property transfers, conned and sifted, reveal the blood relation of these two men—now, for the first time shown: . . ."

"Col. Rd. Lee came to America from Eng. in 1642. He had a son Rd. Lee through whom descent passed in a direct male line to the famous Confederate General. . . . Col. Rd. Lee had another son whose name is not recorded—a son Wm. (The New Eng. Register, above referred to, gives this son.) . . Wm. had many sons, one named Wm. . . . This 2d Wm. had a da. Ann who m. Joseph Hanks, owner of estates contiguous to the Lee plantation; and Ann Lee Hanks was the gt. gd. mo. of Nancy Hanks, 'who m. Th. Lincoln June 12, 1806, and became on Sunday, February 12, 1809, the mother of Abraham Lincoln.' . . ." (Proof refs. not given).

The author adds: The Hanks ancestry of the President "was one of the proudest lineages in America even apart from its connection with the Lees. It goes back to Th. Hanks, a Cromwell adherent, who fled Eng. in 1643 and settled in Va. on land adjoining that of Col. Lee, an ardent supporter of King Chs. I." These loyalist and rebel ancestors were "next-plantation neighbors in Gloucester Co."

Co.), m. 1909, Mary Livermore Symmes, b. 1882, da. of Arthur Cutting and Kath. (Bates) Symmes, of Medford, Mass. (Iss., Dorothy, b. 1911, and Mary Symmes Lawton, b. 1915). Mr. Lawton, B. S., Mass. Institute of Technology, enlisted in the World War in 1917 and was commissioned Capt. of Engineers; was promoted Maj. of Engineers, 8.25.1918, and was Office Chief to 4.1.1920. Maj. Lawton is a member of the firm of "Jos. Thomas and Son," Balt., Md.

Clinton R. Wolfe (1846-1916), m. 1870, Evalena Wailes Perrie (1842-1927), da. of Dr. Jn. Perrie and Cath. Valeria Wailes (1811-46, m. 1833), da. of Jn. Wailes and Sarah Smith. Jn. Wailes was the son of Capt. Benj. Wailes (w. 1788-89), 1st Lt., Middle Batt., P. G. Co., 1777, and Capt. 1779 (see Md. Records, v. 2, pp. 62, 414), and his 1st wf. Susanna (see "Bowies and their Kin"). Commission was issued to Capt. Benj. Wailes, 9.1.1777 (Journal of Correspondence, v. 16, pp. 35, 36).

Dr. Jn. Perrie of Md. (d. 1854) was son of Chs. Smith Perrie and Eliz. Gantt Eversfield (b. 1787), da. of Chs. Eversfield (and Eliz. Gantt), son of Rev. Jn. Eversfield (1701-80), Rector of St. Paul's Par., Calv. Co., for nearly 50 yrs. He m. 1730, Eleanor Claggett (1712-81), da. of Rd. Claggett, Sr., and Deb. (Dorsey) Ridgely, widow of Chs. Ridgely (d. 1705), and da. of Hon. Jn. Dorsey (see P. 186 for services; also Md. Arch., v. 30, p. 252, et seq.). Rd. Claggett, Sr., was son of Capt. Th. (1640-1703), "Capt. of Calv. Co. Militia, 1683-96" (Index of Ancestors.) [General references: "Bowies and Their Kin"; B. Sun, 4.9.1905, Eversfield.]

P. 138. Christopher Clarke Hyatt, Jr. (1840-1906), Balt. Tobacco Commission Mcht. (son of C. C. Hyatt, Sr., and Cath. Culver), m. 1872, Nancy Higgins Peach, da. of Saml. Peach, P. G. Co., and Caroline Hamilton. Iss.: (1) Saml. Peach Hyatt, P. G. Co. He volunteered in 1917 for the World War, but being rejected, enlisted in the Canadian forces and served in the 11th Batt., C. R. T., Co. D. He was at the front at Flanders and served until the Armistice. He m. Lucy Judson Ingersoll, of Kan. (2) Ellen Peach Hyatt, m. 1911, Chs. Houston Elliott, pharmacist, W., D. C. (3) Hampton (d. 1879). (4) Blanch (contributor of this record), m. Edgar Price Hamilton, planter, Mitchell-ville, P. G. Co. (5) Hamlet Hyatt (d. 1884).

P. 136. GIDEON HYATT,3 OF WM.2 P. 141

Wm. Hyatt, Sr.² (Chs.¹), b. 1718, and wf. Eliz. had seven sons and three das. Of the sons, "Prof. Hyatt's Record" (P. 134) gives Wm. Jr.³ (b. 1748), Christopher³ (b. 1751), Seth³ (prob. b. 1757), and Abednego³ (prob. b. 1764). Nothing heretofore has been known of the

sons b. 1759, 1762, 1770. Recently one of these lost sons, Gideon (prob. 4th of the list, b. 1762), has been discovered. Descs. of Shadrach Hyatt of Ind. (Mr. Jas. F. Hyatt, of Chicago, and Mr. Wm. A. Creath, of Takoma Park, D. C.), in letters (1931) state that early in the last century three bros., Shadrack, Meshach and Abednego Hyatt, triplets, b. 1789 in Md., came to Ind. and settled in Brown Twp., Ripley Co. The Fam. Bible of Gamaliel (son of Shadrach), in possession of his son, Daily W. Hyatt, of Benham, Ripley Co., gives the three bros. as "sons of Gideon Hyatt and Ann Hyatt," b. June 7, 1789, in Md. The name "Gideon" is the clue which has led to definite identification of this Western Gideon as a son of Wm. of Md. In proof:

In 1889 Mrs. Eleanor J. Thompson of N. Y. (See P. 137), in a letter to Mrs. Della Hyatt, widow of Prof. Alpheus (desc. of Seth,³ above), writes of her two gd. fathers, Wm.³ and Seth,³ as bros., and adds: There was "a 3d bro. who had three sons named Shadrach, Meshach and Abednego." She did not know the name of this bro., but she had heard of his three sons of the famous Biblical names, and certainly could not forget them. She recalls them 100 yrs. after their birth. They were 1st cousins of both her fa. and her mo., and this (with their names) makes her testimony direct and unimpeachable.

This bro. of Wm.³ and Seth³ was not Christopher,³ (see P. 137, also census of 1790). Nor was he Abednego,³ who m. Mary Elston Feb. 2, 1788 (Md. Rec. 2). Their chn. (Wm.⁴ and Gideon⁴) were b. after 1790, as proved by the Census, which gives Abednego and his wf, only (1-0-1),—no chn. Hence this son of Wm.² was one of the three sons of lost record; and Mrs. Thompson's statement, with that of the Indiana Bible, is assurance that he was Gideon. This is confirmed by the Pa. Census (1790), which gives "Giddion Hyatt, 1-3-2" (himself and wf., a da., and three sons under 16). Evidently he left Md. shortly after the birth of his sons, which explains his absence from the Md. Census and his loss to subsequent Md. records and Md. Genealogists. It is not known whether he d. in Pa. or Ind. There is no further record of the da. The Bible shows that the sons Meshach and Abednego d. unm.

(a Union soldier); (3) Gamaliel (His Family Bible is the prized possession of his son, Daily W. Hyatt, of Benham, Ripley Co., Ind.); (4) Washington; (5) Jn.; (6) Nancy Ann, m. — Benham. (They were the gd. parents of Mr. Wm. A. Creath, of Takoma Park, D. C.); (7) Da. —, m. Leo Bingham, of Ind.); (8) Da. —, m. Robinson Benham.

P. 153. HOWARD-DORSEY-BOONE. P. 154 (A Clarification of Records)

Jo. Howard³ (of Capt. Cornelius,² services in Md. Arch. 3.444 and 2.239), m.¹ Hannah Dorsey, of Col. Edw. (Test. Pro. 21.3), and had three chn., b. prior Oct. 1704 (P. 179). Of nine chn. listed under "Jo. and Margery" (P. 154), three were doubtless chn. of Hannah: (1) The da. who. m. —— Hitchings, d. early and left a son Jo.; (2) Hannah, living 1736; m. 1718, Rd. Jacob, b. 1697 (Md. Hist. Mag., Dec., 1930); (3) Jo. Jr. (1st), "buried 1717."

Jo. Howard³ m.² 1706, Ann Burroughs, widow of Wm. Burroughs (Test. Pro. 19.266, part C). She was "buried May, 1707," and Jo. Hwd. m.,³ 9.28.1708, Margery Keith, mo. of his six other chn. (See P. 154).

Hy. Hwd.⁴ (of Jo. and Margery), w. 1772-73 (Annap. 39.458), m. Sarah Dorsey,⁴ b. 1715, da. of Jn.³ and Honor (See P. 182). Iss. nine chn. (eight of Qn. Car. Reg., and a 2d Sarah, not registered, b. 1738). Of these, Rach. (m. Dr. Josh. Warfield) d. before her fa., and the 1st Sarah d. y. Two sons d. unm. or s. p.: Vach. Denton (Capt. in a Va. line of the Rev.) and Jas. Of the other five:

V.3 Sarah, b. 1738, "d. 1815, aged 77" (Hist. Graves), m. 1 Burgess Nelson, whose w. 1765 (Fred. Co., No. 1.251), names wf. Sarah, chn. Hy., Benj. and Sarah; m., 2 after 1765, Maj. Hy. Green, b. 1742, "d. 1818, aged 76." She was the "da. Sarah Green" of her fa.'s w. of 1772.

V.4 Honor, b. 1740, m.1 Rezin Wfd.,4 d. 1767; m.2 Jn. Davidge. (In w. of 1772 she was "da. Onner Davidge," with chn. Ann and Sarah Wfd. and Hy. Davidge); m.,3 1773, Jo. Wilkins (no iss.); m.4 Michael Dorsey, Jr., six chn. (See Col. Fam. VII, Ball).

V.6 Dr. Eph., b. 1745; surgeon in Col. Th. Dorsey's Batt. of Marching Militia (Md. Arch. 16.381); m. Achsah Dorsey⁵ (Jn...⁴ Caleb,³ Hon. Jn.²). Iss., Brutus, Cincinnatus, Dr. Hy. (b. 1773), Sarah and Eliz.

Dr. Hy. Hwd. (of Dr. Eph and Achsah), b. 1773, "d. 7.18.1817, aged 44" (Scharf's Hist.); m. Rebec. — (She was not Rebec. Boone, as in "Founders"). His w., 1817 (Balt. 10.342)names his six chn.: Mary Ann, Wm. Hy., Achsah Dorsey, Edw. Cincinnatus, Rebec. Jackson, and Frances Bond Howard. "Va. Soldiers of 1776," v. 2, p. 827, gives an abstract of the w. of Dr. Hy., which names the same chn. and states that Dr. Hy. was the "nephew of Capt. Vachel Denton Howard."

V.8 Jn. Beale, b. 1748, m. Rebec. Boone (further below).

V.9 Josh., b. 1752, m. Rebec. Owings (of Sam), d. prior 1803. Chan. No. 5350 gives their chn. and marriages: Sarah (wf. of Steph. Winchester); Mary (wf. of Sam. Thomas); Rach. (wf. of Sam. Robertson); Sam. Howard; and (minors 1803) Jo., Beale, Josh. and Hy. Hwd.

 $V.^8$ Jn. Beale Hwd. (of Hy. and Sarah) was b. and d. in A. A. Co., Md.

(In "Founders," p. 435, he is confounded with his cousin of Harf. Co.—a misconception responsible for the Howard-Riggs error of "Wfds. of Md.," p. 32, (followed by the writer) as well as subsequently in "Founders.")

Jn. Beale Hwd. was b. 11.30.1748 (P. 154), "d. 4.1.1788, intestate, at the home in A. A. Co. of his aged mo. Sarah, widow of Hy. Howard" (Chan. Papers, No. 27, pp. 111-179, 1787-95). He m. Rebec. Boone, ("sister of Stephen Boone"), who survived him, with five "infant" chn., viz.: Hy. and Jn. Beale Howard, Jr.; Ann Slade Hwd.; Rebec. and Mrgt. Hwd. (Ibid.) Rebec. Howard's will 1824 (Annap. 39.203), names the same chn., some gd. chn., and her "son-in-law, Jn. H. Riggs." Rebec. Boone was b. 1754 and m. Jn. Beale Howard in 1770 (old Fam. papers preserved by Mrs. C. V. Cyrus, Watseka, Ill., gd. da. of Col. Riggs). As the sister of Stephen Boone, she was the da, of Capt. Humphrey Boone (not of Capt. Jn. Boone, as generally given). This is proved by Capt. Humphrey's w., 1766, (which names his wf. Ann, sons Stephen, Chs., Nathan and Humphrey, and das. Ann, Rebec. and Mrgt Boone); and Stephen Boone's w., 1791 (which names his wf. Eleanor, his bro. Chs., and his sisters Ann Warren, Rebec. Howard and Mrgt. Dorsey). Stephen's bros. Nathan and Humphrey, Jr., had died (Inventories, C V, 271), and are not mentioned in Stephen's will. The title "Capt." (on Capt. Humphrey's will) was given by Chs. in declining to act as one of the exs. of the will.

Jn. Beale Hwd. (of Hy.) was commonly known as "Jn. Howard." He is so referred to in his gd. fa., Jn. Dorsey's w. of 1764, in old Bible records, on his son Hy.'s tombstone, etc., and he enlisted and served in the Revolution under the name of "Jn. Howard." The fol. refs., to "Jn. Howard" without exception, have been approved and accepted by the National D. A. R. Society, as giving the services of Jn. Beale Hwd., of Hy.: Md. Arch. 18.564; 18.566; 18.568; 16.73, 74; 18.574; and "Saffeld's Rec. of the Rev. War," p. 242. These show that "Jn. Howard, b. in Md., age 27, enlisted in Capt. Nathaniel Smith's 1st Co. of Matroses, 1.27.1776; that he was present in Capt. Rd. Dorsey's Co. of Artillery, 11.19.1777; that he was present in Co. No. 1, "as it stood at Valley Forge," 1.3.1778, etc. He served through the war, or until "invalided" near its close.

VI.1 Hy. Hwd., "of Jn. and Rebekah" (Bible), b. 1774, "d. 1834 in Md., aged 60" (Hist. Graves, and Bible); m. 1807, Sarah Fauntleroy Graham (1791, Va. —— 1878, St. L., Mo.), da. of Capt. Wm. Graham (see D. A. R. Lineage) and Judith Swan Colston. Issue: Alcinda G., Rebec. Boone, Alex. A., Wm. Hy., Juliet Colston (3 others d. y.). These five chn. are named in "The Final Acct. of Sarah F. Hwd., admx. of 'Hy. Hwd. of Jn.,' late of Montg. Co., deceased," 1838 (Adm. Accts., liber V. 219-222, Rockville, Md.); and three of them in the w. of their gd. mo., Rebec. Howard, 1824 (q. v.).

Bessie Lee Woodson, b. 1882, m. 1819, in St. L., Abbeford Scherer Dolch, of Edw. Wm. of Md. They reside at Attica, Ind. Mr. Dolch is Traffic Manager of the Chicago, Attica and Southern R. R. Mrs. Dolch is the accomplished genealogist of her Howard and Boone family, compiler of "The Descs. of Jn. Beale Hwd (of Hy.)," and contributor of the Jn. Beale Hwd. record, above given. For later descs. see her chart in the Md. Hist. Soc., of Baltimore.

VI.4 Rebec. Hwd. (of Jn. Beale and Rebec.), b. 1779, d. 1859, m. 1800, Col. Jn. Hammond Riggs. (For Descs, see under "Welsh-Riggs-Howard," above.)

P. 179. EDW. DORSEY, JR.3

Test. Pro. 21, fol. 3, Annap., gives the adjudication (1708) of the Est. of Edw. Dorsey, Jr., of which "Col. Edw. Dy., deceased, was in his lifetime Administrator." The "relations" who had received "their portion of the deceased's est." were: "Jn. Petticourt, who m. one of the sisters (Sarah) of the dec'd Edw. Jr."; "Mr. Joseph Howard, who m. another sister (Hannah) of the deceased"; Mr. Saml. Dy., Mr. Josh. Dy., Nich. Dy. and Jn. Dy. Jr., bros. of Edw. Jr. As the legatees were chn. of Col. Edw. Dy.² by his 1st wf. Sarah, and the son Benj. is not

in the settlement of 1708 but was in Col. Edward's w. of 1704, it is evident he had d. prior to 1708. The da. Hannah d. shortly before or shortly after her father, as Jo. Howard remarried in 1706 (P. 153).

P. 181. CHS. DORSEY,⁵ OF NICH.⁴

Col. Nich. Dy.4 was the 2d son of Nich.3 (of Col. Edw.2), who m. Frances Hughes Dec. 30, 1709. He was b. prob. 1712-3; was living 1777, (Md. Arch. 16, p. 75), 1778, and later (P. 180), and d. 3.4.1779 (Prof. Warfield in D. A. R. papers). His w., 1769-1780, names six "elder chn. who had received their part" (i. e., had reached their majority prior to 1769). Of these, Chs. was b. 1744 (Dorsey and Polton records). Of the six "younger chn.," Lucretia was b. 6.4.1754 (P. 214). She m. Jn. Welsh IV, and was the mo. of Cath. (Kitty) Wsh., b. 1781, who m. 1807, Chs. Griffith Dorsey, her 1st cousin, son of her uncle Chs. of Nich. (See P. 31, and the Bible record of Capt. Upton Welsh, bro. of Cath., on P. 214). Further, Lydia Wsh., sister of Cath., was the gd. mo. of Gov. Warfield, and her husband, Joshua Wfd., was the uncle of Prof. Wfd. Hence we may be sure that the statement in "Founders" (p. 400): "Chs. G. Dorsey, son of Col. Nich., m. Cath. Welsh" (which eliminated Chs. and debarred his descs. for years from patriotic societies), was simply an inadvertence—or possibly a typist's error, "son" for gd. son. Happily, the bar has been removed and Chs. accorded his proper place as the son of Col. Nich.

Note.—The Fam. Record of Chs. Dy. of Col. Nich.) is given on P. 181. An interesting confirmation of it is found in letters, in possession of Mr. Wm. C. Dorsey, of Omaha, Nebr., which have come down to him from his gd. fa., Jn. Wesley Dy. One, dated 10.1.1811, is addressed to "Dear Son," Jn. Wesley Dy. of Ind., and signed "Your affectionate father, Charles Dorsey of Nichs." The other, 8.18.1837, is from Chas. G. Dorsey. of Ky. to his "Dear brother," Jn. Wesley Dy. The two give all the chn. of Chs. Dy. by name (as on p. 181). For Chs. G. Dorsey's descs., see p. 31.

Hammond, b. 1733 (see P. 164). Ruth m. ³ Jn. Howard, ⁴ son of Jn. ³ (d. 1702) and his wf. Susanna (P. 153); no issue.

Jn. Greenisse left his A. A. Co. lands, at the death of wf. Ruth, to his two das. (Kath. and Ruth); shd. das. d. s. p., "to go to Jn. and Edw. Dorsey, sons of wf. Ruth." When Jn. Howard died the two Greeniffe das. of Ruth were dead and his w., 1745 (Annap., D D No. 3.368), left pty. to Ruth's gd. das., Eliz. Hammond and Ruth Todd; his lands, at death of wf. Ruth, to Jn. Greeniffe Howard, and the residue of his pers. est. to his wf. Ruth and Jn. Greeniffe Hwd. equally. When Ruth died, 1747, the lands she held passed as devised in her husbands' wills; she had no real est. to dispose of, and she left pty. to her "gd. da. Eliz. Hammond," "20 s. to my gd. son Jn. Greeniffe Hwd.," and the rest of her prs. est. and crops to "sons Jn. and Edw. Dy." The Laws of Md., Chap. 18, 1755, and the Balt, record office (B B No. 1.457) give Jn. Greeniffe Howard as "heir at law to Cath. Greeniffe"; and Lemuel Howard's w., 1758-59 (Balt. 2.306) names him as "my son Jn. Greeniffe Hwd." From the above, and from St Jn. and St. Geo. Par. register (p. 91, etc.), we have:

IV.² Mareen,⁴ b. 1714, m. (prob.) Esther Saper, whose fa., Jn., in w. of 1742, names her as wf. of "Mareen Duvall of P. G. Co." Their da. Kezia m. Cornelius Duvall (Chan. 4703), son of Mareen,³ of Mareen,² the younger. They moved to Ky.; known iss.: (1) Hy., d. 3. p., whose w., 1806, names his parents, Cornelius and Kezia, and bros., (2) Zach., (3) Mareen, and (4) Jn. Duvall.

Capt. Jn. Duvall (1783-1859), son of Cornelius and Kezia, officer in War of 1812 and mem. Ky. Leg., 1827; m. Jane Branham (1783-

1859), of Scott Co. — (Refs.—Collins' Hist., v. 2; Johnson's "Franklin Co."; Vital Statistics). Their son, Judge Alvin Duvall, b. 3.20. 1813, in Scott Co., d. 1891; mem. Ky. Lea., 1850, Circuit Judge, Judge of Court of Appeals, 1854 (Collins Hist. and Johnson's "Frankfort Cemetery"); m. 1843 Virginia Holzclaw. Iss., 13: (1) Virginia (d. unm.); (2) Sallie (m. — Greenhow); (3) Annie, m.; (4) Mary S. (d. unm.); (5) Harriet (d. unm.); (6) Willie (m — Sneed); (7) Hy., m. c1876, Nannie Rodman, sister of Admiral Hugh Rodman, U. S. N., and da. of Dr. Hugh Rodman of Frankfort. They had one son, Hugh Rodman Duvall. (8) Alvin Duvall, Jr., d. unm. The other chn. of Judge Alvin Duvall d. pr. 1882 (no rec.).

IV.3 Saml. Duvall⁴ (twin of Mareen⁴), b. 6.22.1714, P. G. Co., Md., was beyond doubt the Samuel Duvall of Va., whose descs. state that he was b. 1714, in P. G. Co., Md., twin of Mareen, and d. 1784, in Henrico Co., Va. Qn. Anne register (see above) gives Benj., b. 1717, as the bro. of Mareen and Sam., and Justice Gabriel Duvall, in his fam. hist., states that Benj. had a son Lewis. The will of Sam. Duvall of Va. confirms this: it leaves to his 3d son Daniel a 400 acre tract, "the deed, which should of right have been made to me by the exs. of my bro. Benj., deceased, to be, by them and the Heir of sd. Benj., made to my sd. son Daniel."

Saml. Duvall (1714-84) was a mem. of the Va. H. of Burgesses, and of the Henrico Co. Com. of Safety, 1774-76 (Appleton's Cyclopedia, v. 2, and D. A. R. Lin., vols. 4, 14, 32, 44, 48, 52, 56, 61, 62, 70, 71—); m. Lucy Claiborne, of Wm., Va. His w., 8.23.1783—3.1.1784 (Henrico Co., No. 1, p. 122), names his wf. Lucy, his sons Wm., Sam., Daniel, Philip and Claiborne, his das. Polly and Philadelphia, and "my da. Lucy Pope" (wf. of Wm.).

1. Maj. Wm. Duvall (1748-1842), of Sam and Lucy, was an officer of the Revolution and Chancery lawyer of high distinction, Richmond, Va. (Appleton, v. 2, and D. A. R. refs. above); received large grants in Ky. for his military services. He m. 1772, Lucy Ann Pope of Capt. Nathaniel. Iss.: (1) Sam Pope; (2) Benj., m. Mary Warrick (D. A. R. Lin., v. 4); (3) Gov. Wm. Pope Duvall (1784-1854); M. C. 1813-15; Gov. of Fla. Ter. 1822-34, etc. (See Collins' Hist., Appleton's Cycl.); m Nancy Hynes, of Ky.; (4) Ann; (5) Nath. Pope; (6) Lucy Pope, m. Wm. Price, Richmond, Va., moved to Ky. (Iss.: Ann Pope Price, m. Dr. Alfred Leyburn; Alx.; Harry; Dr. Wm., m. Eld. da. of Gov. Wm. P. Duvall; and Jas. Price—See Fam. record, by Dr. Leyburn's da. in B. Sun, 2.2.1908); (7) Hon. Jn. Pope Duval, b. 1790, d. c1855 in Fla.; Lt. and Capt., War of 1812; in Tex.—Mex. War, with title of Brig.-Gen.; Sec'y of Fla. Ter.; lawyer (Appleton's Cycl. 2.599).

Maj. Wm. Duvall m.² Susan Christian; their da., Susan E., m. Isaac Adams, b. 1800 (See D. A. R. Lin., vols. 44, 56, 61, etc.)

Except in various deeds, etc., we have no record of the other sons of Samuel and Lucy Duvall, viz.: Sam., Daniel, Philip and Claiborne;

nor of the da. Polly. The da. Philadelphia Duval, m. Andrew Dunscombe; and their da., Philadelphia H. Dunscombe, b. 1797, m. 1814, Jn. Horsley, b. 1787 (D. A. R. Lin., v. 52).

P. 206. DUVALL-FARMER-WATERS

In a reprint of "Huguenot Proceedings," v. III, part 2, by Miss Rebec. Duval, it is stated that Nathan Waters m. Rach. Duvall (Bap. 1731—A. H. 112), da. of Lewis Duvall and Eleanor Farmer, and gd. da. of Capt. Jn. Duvall.² (The same reprint gives Wm. Duvall (of Lewis) as "ancestor of Gov. Wm. P. Duval of Fla."—an error, as has been shown).

Justice Duvall (1752-1844), in his Fam. Record, makes no mention of Rach. Duvall (of Lewis), but says: Rach. Duvall, Bap. 1706, da. of Capt. Jn.,² m. Nathan Waters, "by whom she had many chn." (Nathaniel, Nathan, and Mrs. Nelson are given), "and after the death of her 1st husband m. a Mr. Morray (Marony?), by whom she had two sons, Harry and Philip." If so, Nathan Waters was her 2d husband, per the following records:

III.9 Rach. Duvall (of Capt. Jn.2), b. 3.14.1705 (A. H. 54), m. 11. 3.1724, Wm. Waters (Ib. 99). "A deed of Oct. 1737, names the chn. of Capt. Jn. Duvall, and among them 'Rachel, wife of Wm. Waters.'" (Mr. Edw. Hammond, author of the new "Hammond Genealogy"). In 1743 "Rachel Waters, widow of Wm. Waters," conveys by deed a part of "Waters' Lott" (Ibid.). As Rachel was about 37 or younger when widowed, a 2d marriage would seem very probable. The dates above, with subsequent dates of births and marriages, tend to substantiate the Justice's position. Nathan and Rach. Waters had issue (order uncertain):

Judge Madison Nelson, Fred., Md. (1802-70), m. 1823, Josephine Morrell Marcilly (1806-82). Of ten chn., their 4th son, Arthur Emilius (b. 1830 in Md., d. 1925 at Liberty, Mo.), m. 1855, Malvina Byng (1836-92), and had: Child (d. inf.), Frances Marcilly, Madison, Nellie, Rose (see P. 67), Helen, Louis, Eugene, Kate and Jn. (twins).

2. Nathan Waters, Jr., m. Cath. Wilson (d. 1798-Md. Rec. 2);

Iss.: Eliz., m. 1777, Archibald Chisholm, Rev. soldier (Md. Rec. 2); Jonathan, Rev. Soldier (Ibid.); Lt. Wm. (m. Jane Nelson); Ro. (d. y.); Dr. Wilson, Rev. Surgeon; and Mary Cath. P. 207. DUVALL-TYLER

Col. Ro. Tyler, Gent., P. G. Co. Md., is said to have been the son of Ro. Tyler, Calv. Co., and wf. Joan, widow of Capt. Chs. Reid of Calv. Co. (see Inv. and Accts., 1.54, Annap.; w. of Ro. Tyler, 1673, Md. Cal. 1; w. of Joan Beale, 1675, Md. Cal. 1). He m. 1 1694, Susanna Duvall 2; m. 2 1718, widow Mary Todd (St. Ann's register). His w., 1735-38, (correction of P. 207), reads: wf. Mary; son Edw. (and four chn.): da. Mary Whitehead (and her four Baldwin chn.); son Ro. (and his three chn., Wm., Ro. and Mary); son Mareen (no chn.); da. Susannah Lamar; da. Eliz. Pottenger (and her son); da. Prisc. Wickham.

Edw. Tyler I (of Col. Ro. and Susanna²), b. 1696, m. Eliz. Duvall,³ b. 1698, da. of Sam. Duvall² (w. 1741, Md. Cal. 8) and his wf. Eliz. (Ijams) Clarke, widow of Daniel Clarke (w. 1676, Md. Cal. 2, q. v.), and da. of Wm. Eyoms, Sr. (w. 1698-1703, Md. Cal. 3, q. v.). Susanna Tyler (of Edw. and Eliz.³), b. 1717, m. Benj. Duvall,³ b. 1719, son of Benj.² Their son, Justice Gabriel (1752-1844), was thus the gt. gd. son of Mareen 1st, but through both Sam.² and Susanna² (as above shows) he was the gt. gd. son of the Emigrant.

THE KENTUCKY TYLERS

(Contributed mainly by Capt. Jas. Blythe Anderson, Lexington, Ky., from wills, deeds, tombstones, court records, marriage bonds, etc.; and in part by Mr. S. W. H. Tyler, Louisville, author of "The Tyler Fam. in Ky.")

Ruth Howard,⁴ of Jo.³ (P. 153), gd. da. of Capt. Cornelius Howard² (Services, P. 150; Md. Arch. 3.444 and 2.239), m. 1724, Mareen Duvall³ of Mareen the younger² and wf. Eliz. Jacob (P. 208), da. of Capt. Jn. Jacob, "an officer of the Colonial Militia" (Col. Fam. V, Jacob). Their 8th ch., Priscilla Duvall, b. 2.11.1737, living in Md. 1779 (P. 209), m. conj. c1755, Gideon Walker (Justice Duvall).

Gideon Walker moved to Pa. (once part of Old Va.) about 1779, and was a "private in Capt. Andrew Linn's Co., Washington Co. Militia in the Revolution" (Pa. Arch. 2.233, 6th Series). In 1788 he bought land in Fayette Co., Pa., which he and "Priscilla his wf." sold to Wm. Evans, 11.2.1793 (County Book B, pp. 13, 14). The Fayette Co. Census, 1790, gives Gideon, 4-2-4 (That is, himself and wf.; three sons, 16 or over; two sons under 16; and three das.). In 1798, Gideon was settled in Nelson Co., Ky., where in that year he gave consent to the marriage of his da. Sarah to Jo. Mahan (Bardstown records). He d. c1809-10, the appraisement of his est., Nov. 1810, naming eight chn. his "legatees:" Mareen D., Martha, Ruth, Zach., Alex. and Gideon Walker, Sarah Mahan and Howard Walker. The same chn. are given in an indenture, 1.10.1818, which records the sale in Nelson Co., Ky., of 70 acres ("which Gideon died possessed of"), by the first seven

"legatees" above named to Howard Walker, "another of the legatees." Jo. W. Mahan, as husband of Sarah, was also a signatory.

(Except as otherwise indicated, we are indebted to Mrs. Cora E. Behrends, Dallas, Tex., the "Family Historian," D. A. R., etc., for above Walker data and the following record):

- I. Mareen Duvall Walker, b. —, m. 1787, in P. G. Co., Md., Ann Berry (Md. Rec. 1). Census (1790, P. G. Co.) gives him and wf., with a son and da. In 1802 he bought land in Nelson Co., Ky., with his father. His son Rd. m. 1814, in Ky., Sarah Basyc.
 - II. Martha Walker, b. ---, living 1818, unm.

III. Ruth Walker, b. prior to 1765, m. — Walker (Chs., it is thought). She was Ruth Walker, widow, "Head of the Family," over 45 years old, in the Ky. Census, of 1810, with five das, one b. prior to 1794, and four b. between 1794 and 1800. In the same year, 1810, she gave written consent to the marriage of her da. Jane to Eli Berkhead, her bros. Mareen D. and Gideon being the witnesses. The census shows all her chn. were b. before 1800. She m.² 1811, Daniel Philip Walker, d. 1815 (memo. of Mrs. Behrends).

IV. Zach. Walker, b. conj. c1766, d. after 1818, m. c1788, Ruth Duvall, b. c1771-2 (his sister Eliz. was b. 1773), da .of Jo. Duvall (bro. of Prisc.) and his wf. Susanna Stewart (Q. Ann 331). The marriage is given in Justice Duvall's Record. Zach and Ruth had a da. Sarah, b. c1790, "about 18 yrs. old" in 1808, when she testified in court (Chan., No. 1411 A, Annap., Md.). The suit also shows Sarah's parents had their "home" in Md. some 20 yrs. before their removal to Ky. after 1808. Doubtless most of their chn. were b. in Md., in that time, not registered in Ky. where other chn. were b. later. In 1810 Zach. was one of the legatees in Ky. of Gideon's est., and in 1818 he joined with the other legatees in the sale of land in Nelson Co. He is thought to have d. soon after 1818; Ruth d. in 1844. Their chn. were b. in Md., 1790 to 1808, and later in Ky.

We thus have two Mrs. Ruth Walkers, both of whom had children, and both survived their husbands. Owing to the destruction of Bible with records, and other early data, nearly all dates of birth of the chn. of these Ruths have been lost, but the marriage of eight of them is of official record at Bardstown and Louisville, Ky. According to "Family Hist." of present-day gd. chn., these were all "chn. of Ruth." Recalling the proved records, above, that both Ruth (of Gideon) and Zach. (and Ruth) had chn, prior to 1800, but only Zach. and his wf. Ruth after 1800, the eight chn. of marriage record may be given as follows:

- (1) Jane, m. 2.25.1800 (with mother's consent), Eli Kirkhead. She was b. prior to 1800, da. of the widow Ruth (of Gideon).
- (2) Hannah, m. 10.16.1814, Wm. Hugh Birkhead, bro. of Eli. She was b. before 1800; doubtless also da. of Ruth (of Gideon). They had

- (4) Caroline, m. 1.30.1826, Jo. Melton. She was probably b. after 1800, a da. of Zach. and Ruth, and prob. b. in Md.
- (5) Miranda, m. 1.24.1827, Jo. Parker Ferguson; was doubtless b. after 1800. da. of Zach and Ruth. (These five marriages are from Bardstown records, the fol. three from Louisville):
- (6) Gabriella N., m. 5.6.1830, Nelson J. Maynard; da. of Zech. and Ruth.
- (7) Euphemia Eliz., m. 2.1.1831, in Louisville, Jn. R. Derrick (b. 1794 in Bucks Co., Pa.). She was b. 5.19.1813, in Bloomfield, Ky., d. 1.28.1866 (Bible record), da. of Zach. and Ruth. Her mo. Ruth, widow, gave consent to the marriage, 1.31.1831. Iss. (a) Irene E., b. 1835 in Mobile, d. 1856, m. 1854, E. A. Absteating; (b) Hy. Of the remaining chn. of Gideon and Prisc., viz., Alx., Gideon, Jr., Sarah and Jo. Howard Walker, the records are lacking. It is known that Sarah, b. 1779, m. 1798, in Bardstown, Ky., Jo. W. Mahan, and that J. Howard m. Polly Featherkiller.
