## INTRODUCTORY REMARKS.

---

These few pages are published in compliance with urgent solicitations from several sources.

It is probably well known to the Woodmans generally in this section of the country, that a List of some of the Descendants of Mr. Edward Woodman, compiled by that distinguished Antiquary, Joshua Coffin, Esq., of Newbury, Mass., has already been published.

Inasmuch, however, as many of the Woodman name have not seen Mr. Coffin's List, I have deemed it highly proper to extract a portion of the same, and have it incorporated in these pages. In some instances, the arrangement has been varied; and I have, occasionally, quoted *verbatim*.

The List of Joshua Woodman's Descendants, herein presented, may be considered as *full*. The Woodman Family has been traced in various *other* directions: and I have concluded to give, in an Appendix, two *additional* lists.

One of these has been furnished, in part, by Elder Jonathan Woodman of Sheffield, Vt., and, in part, by Dr. Lucius C. D. Woodman of Paw Paw, Mich. See Appendix, letter B, *Descendants of Mr. Joseph Woodman*. For the other, I am indebted, principally, to Dea. Azor G. Woodman of Amesbury, Mass. See Appendix, letter C, *Hilton's Descendants*.

As I confidently believe that Mr. Edward Woodman of "Ould Newberry" originated from Wiltshire, I have presumed to offer a few Geographical Remarks concerning the same. See Appendix, letter A, *Wiltshire*.

To look up the descendants of Mr. Joshua Woodman, and of two or three others who were among his cotemporaries, may well be regarded as comparatively easy; but to continue the *whole* of Mr. Coffin's List and bring it down to the present day—

*Hoc opus, hic labor est.*

It would be a most gigantic undertaking, and I almost shudder at the mere *thought* of it!

Among the gentlemen who have kindly assisted me in these genealogical investigations, I am happy to name the following:

## THE WOODMAN FAMILY.

ORIGIN OF THE SAME—AND A VIEW OF THE GENEALOGY

TO THE FOURTH GENERATION.

---

The ancestor of the Woodman Family in America was Mr. Edward Woodman, who, in company with Mr. Archelaus Woodman, settled at Newbury, Mass., in 1635. The latter was passenger in the ship James, which sailed from Southampton in the month of April of that year. Tradition says that they were brothers.\* Of this we have not the least doubt: and, as Archelaus is known to have come from "Christian Malford," a Parish in Wiltshire, we take it for granted that Edward once lived there too. It is not known whether Edward came in the same vessel,—but it is certain that they both settled at Newbury at the same time.

In view of the probable causes which induced them to leave friends and kindred—to venture across the perilous waves and to seek a new home in these western wilds, we are strongly reminded of the following truthful lines in reference to the Pilgrim Fathers generally:

"Oh! 'twas a hard unyielding fate  
That drove them to the seas,  
And Persecution strove with Hate  
To darken her decrees;  
But safe above each coral wave  
Each looming ship did go,—  
And God was on the western wave  
Two hundred years ago."

Edward and Archelaus were, for a long series of years, among the leading men of Newbury.

Archelaus died Oct. 14, 1702, leaving no children. Edward was living in 1687. The time of his death is not known. His wife's name was Joanna. Edward 1 and Joanna Woodman had seven children, four sons and three daughters. The sons are in the following order: Edward 2, John 2, Joshua 2 and Jonathan 2.— Hence the four great Branches of the Woodman Family.

We now give a general View of the four Branches down to the fourth generation, the names of females being omitted.

1st BRANCH: EDWARD 2, two sons: Edward 3 and Archelaus 3. EDWARD 3, five sons: John 4, Samuel 4, Joseph 4, Edward 4 and Daniel 4. ARCHELAUS 3, six sons: Edward 4, Archelaus 4, JOSHUA 4 OF KINGSTON, John 4, Joseph 4 and Benjamin 4.

2d BRANCH: JOHN 2, two sons: John 3 and Jonathan 3. JOHN 3, [no record of any sons.] JONATHAN 3, six sons: John 4, Jonathan 4, Joshua 4, Edward 4, Downing 4 and Archelaus 4.

3d BRANCH: JOSHUA 2, four sons: Jonathan 3, David 3, Joshua 3 and Benjamin 3. JONATHAN 3, five sons: Joshua 4, Jonathan 4, David 4, Stephen 4 and Nathaniel 4. DAVID 3, five sons: Moses 4, David 4, John 4, Benjamin 4 and Samuel 4. JOSHUA 3, [no record of sons.] BENJAMIN 3, seven sons: Joseph 4, Benjamin 4, Joshua 4, David 4, Jonathan 4, Nathan 4 and Stephen 4.

4th BRANCH: JONATHAN 2, three sons: Jonathan 3, Ichabod 3 and William 3. JONATHAN 3, two sons: Jonathan 4 and HILTON 4. ICHABOD 3, one son: Ichabod 4. WILLIAM 3, [no record of sons.]

Among the descendants of John 2 [2d Branch] is Prof. John S. Woodman of Dartmouth College. For a List of College Graduates of the Woodman name, see Appendix, letter E.

who settled at Newbury, Mass., A. D. 1635.

So far as we are able to learn, Joshua 4, who settled at Kingston, was a man of sterling integrity. His religious character must have been moulded early in life. His father, Dea. Archelaus, was very much devoted to the Cause of Vital Piety, and must have exercised a beneficial influence on the minds of the whole family. The precise time of his settling in Kingston is not known. We have

reasons for believing that it was sometime in 1736, the year of his marriage. And, no doubt, when he left the paternal roof, it was, as in the days of Jacob of old, *with the blessing* of his dear father upon him and all of his posterity, though in numbers they might be as sands upon the sea-shore!

### Descendants of Joshua of Kingston.

---

Joshua and Eunice Woodman had, in all, fifteen children. Three of the children died young. [There have been 116 gr. ch.; 80 of the Woodman name; and 36 of other names.] The following are the names of the twelve children who lived to the age of maturity and married.

Omitting all fractional parts of a year, the numbers representing the ages are given with the nearest possible degree of accuracy. In some instances they fall short, two or three months; in other cases, they over-run by two, four, or even six months.

The above table has been introduced from the fact that it affords the most remarkable specimen of an OCTOGENARIAN FAMILY that has ever come under our immediate inspection. We refer, of course, to these modern days when three score years and ten are accounted as no ordinary measure of a life time. Can another instance of the kind that shall equal *this*, be shown from any authentic Records in the United States? Please mark the following: The good Dea. ARCHELAUS of Newbury is permitted to live to the advanced age of almost 94; and his son Joshua of Kingston who attains to the age of almost 83, leaves a family of TWELVE CHILDREN whose combined ages at decease amount to nine hundred and ninety six years!

### The Venerable Twelve !

Like the twelve Patriarchs of ancient days, they were permitted to live in the enjoyment of their most holy faith, and to be fruitful, and to multiply exceedingly upon the face of the earth, and to see their children and children's children oftentimes collected around

them! And finally,—even at a good old age—to be forever gathered unto their fathers, with a goodly name indelibly stamped upon their useful lives!

Not only was length of days their earthly portion, but unsullied Virtue illumined their pathway. And now that they have passed away from earth—to dwell in heavenly scenes—

Peace to their revered ashes!

And may those bright Exemplars of the past long serve as beacons of light to their numerous descendants and namesakes! May their virtuous doings upon earth ever be held in SACRED MEMORY. Their Spirits may be hovering over us.—Be it so: and may we, confidently and joyfully, anticipate a blessed re-union in the Spirit world!

## APPENDIX A.

### WILTSHIRE.

---

England is divided into forty counties. Wiltshire is in the S. part. It will be long remembered, if for no other reason, for *this* alone, that in it was born the immortal Addison.

To say nothing of Hobbes, Crabbe and William, the historian, two of whom once lived in Malmsbury, within six miles of that little Parish called "Christian Malford"—to say nothing of the famous STONEHENGE composed of hewn rocks weighing from ten to seventy tons, each—to pass over, in silence, the numerous vestiges of British and Roman camps, of walls, ramparts, castles, cathedrals and celebrated abbeys—and to omit a thousand objects of interest that pertain to Wiltshire—the mere fact that Joseph Addison was born there, shall give it celebrity for ages and ages yet to come!

Wiltshire is bounded N. E. by Berkshire; S. E. by Hampshire; S. by Hampshire and Dorsetshire; W. by Somersetshire, and N.W. by Gloucestershire. These five surrounding counties may be distinguished—even on a common map—by their principal towns. Thus: Newbury, Reading and Windsor, in Berkshire; Winchester, Portsmouth and Southampton, in Hampshire; Dorchester, in Dorsetshire; Bath, Wells and Taunton, in Somersetshire; Bristol and Gloucester, in Gloucestershire.

It is longer N. and S. than E. and W. Its whole perimeter is extremely serpentine: and yet, the general form of the county is that of a parallelogram, or oblong square, the length being about twice the width. The four sides being represented by four straight lines, may be determined as follows:—

1. The N. side coincides very nearly with the parallel of  $51^{\circ} 30'$  N. and passes through a point about one third of the way from Gloucester to Bath.

2. The E. side, with the meridian of  $1^{\circ} 30'$  W., and passes near the middle point between Salisbury and Southampton.

3. The S. side—with the parallel of  $50^{\circ} 55'$  N., and passes a little N. of Southampton.

4. The W. side—with the meridian of  $2^{\circ} 15'$  W., and passes quite near or through Gloucester.

It may be well known that England has three rivers bearing the name of Avon: the Upper, the Lower and the Hampshire Avon. The Lower Avon is the one with which *we* have to do. There upon the banks of the beautiful Avon—not *Shakspeare's*, but dearer to *us* by far—once lived our English forefathers. Once played there, day after day, the little EDWARD—and gazed, with fond delight, upon its crystal waters. There along its purling stream, how would he catch the varied music of songsters that loved to frequent its overhanging trees—and how would he rove, in conscious security, in that charming vale; and, amid scenery so gay and picturesque, how did he, in the fulness of his heart, admire its unnumbered—its unspeakable attractions!

The place, called “Christian Malford,” though probably not over thirty miles in a *direct* course, must have been, by the course of the river, some sixty miles or more, from the mouth of the Avon.

This river is very circuitous in its windings. Its entire length is about eighty miles. Its general course *above* Malmsbury is E.: from Malmsbury to Chippenham, nearly S.; a few miles below Chippenham, it turns to the N.W. Bristol is eight miles, and Bath—to which place it is navigable—is twenty miles from its mouth.

If Malmsbury is not laid down upon the map, please *imagine* its locality thus: Suppose a straight line connecting Gloucester and Salisbury: another straight line passing N.N.E. from Bath: the point where these two intersect, shall represent Old Malmsbury. It is in the extreme N.W. part of the county: about 20 miles from Bath, and about the same distance S.S.E. from Gloucester.

Its bearing from Bath must be about N.N.E.—The map which I have used, is a very large one, published in London: and I can have no possible doubt of its correctness.

## APPENDIX D.

### GENEALOGICAL REMINISCENCES.

---

In confirmation of the generally received opinion that Edward and Archelaus were brothers, I wish to make a few statements. They are necessarily somewhat egotistical—and may perhaps, with good reason, be considered as of minor importance; nevertheless I am induced to offer them, sincerely hoping that to *some* at least they may not be wholly unacceptable.

My father, who was Jabez 6 [See 23, Joshua's Descendants] was tolerably well versed in the Woodman Genealogy. [His Line of Descent, it will be seen, is as follows: Edward 1, Edward 2, Dea. Archelaus 3, Joshua 4, John 5, Jabez 6.] In relation to the Woodmans of Newbury, however, he must have been wholly dependent on tradition.

The first important genealogical lesson that I ever had was from *him*. Though very concise, still it made a lasting impression. These were the exact words: "My grandfather's great grandfather came from England."

Though not familiar with all the names and dates, he seemed to understand the Woodman genealogy from Edward 1, down to his grandfather Joshua of Kingston; and often gratified my insatiable curiosity by answering the numerous questions proposed. Among other things I can recollect for a certainty that he spoke of the Woodmans who came from England as being *brothers*. Again—and more to the point:

Joseph 5, [See 8, Joshua's Descendants] who was an uncle to my father, and who, when I was some twelve years of age, spent several months at our house, used to take great delight in telling what he had heard respecting the Woodmans who first came from England. He told us particularly

too, about his grandfather DEA. ARCHELAUS OF NEWBURY. To use his own words,—for the following at least is deeply engraven on my memory—"My father once carried me clear to Newbury on purpose to see my grandfather." How many times, at my request he told about that visit to Newbury! And at each successive repetition of the same, I could almost see the aged Archelaus—sitting there in his big ARM-CHAIR—and those silvery locks were just as plain as day; and I could almost hear the tremulous accents that fell from his lips at the time of that visit to Newbury!

I became so deeply interested in what was communicated, at various times, respecting the Woodmans of Old Newbury, that I in fact *took notes*, intending, by all means, to preserve the same. And the paper *was* kept for several years—but more recently—though years before the publication of Mr. Coffin's List,—when wishing on a certain occasion to refer to said Document, lo! and behold, after the most diligent search, it could not be found.

I am certain of one thing, however—that it was distinctly stated in said paper, that the Woodmans who first came to this country were *brothers*, and that they settled at Newbury.

I am fully aware that such a statement from Joseph 5 does not *prove* the fact. There is no question but that Dea. Archelaus knew pretty well whether *his own* grandfather Edward 1 and Archelaus who came from "Christian Malford" were brothers or not. And how could the opinion that they *were* brothers, be so current in the family of his son, Joshua of Kingston, *unless such was literally the fact?* For my part, I think there is but little room for any doubt on this question.

### CONCLUDING REMARKS.

---

It is, of course, understood that the seven children of Edward 1 constitute, in full, the second generation.

The entire number of the Woodman name pertaining to the third generation, may be readily ascertained as follows :

Edward 2, eleven children [page 9] : John 2, two ch. [p. 7] : Joshua 2, nine ch. [p. 7.] : Jonathan 2, [App., letter C], seven ch. ; whole number twenty nine.

We have not the requisite data to determine, for a certainty, the exact number of the 4th generation ; but, so far as is *known*, the number of the 4th generation, females being excepted, may be called thirty seven. See general View, p. 6.

One of these last was Joshua 4 of Kingston. *His* descendants alone have been more than three hundred and fifty. On the hypothesis that the descendants of each of the other thirty six, have been equally as numerous, we should have for Edward's descendants--of the Woodman name--from the 5th to the 8th generation inclusive, the modest aggregate of twelve thousand, nine hundred and fifty ! And even this would be but a trifling moiety of the number of *actual* descendants, if all of *other names* were included in the estimate.

We have satisfactory evidence, however, that the number of *Joshua's* descendants ought not to be assumed as the basis of calculations in reference to the others of the 4th generation.

It shall be admitted that the Woodmans are abundantly multitudinous. Nevertheless, it is not believed that the descendants (of the Woodman name) of any other individual belonging to the 4th generation, would amount to three hundred and fifty.

Calling the average number of descendants for each of the thirty seven, only two hundred, we should have, for the entire number, seven thousand and four hundred. Now we ask,—and we do it with all deference to the

opinion of those who wish to have the *whole* of the Woodman genealogy looked up--would it not require the patience of Job and a considerable portion of the days of Methuselah--to complete such a task?

In conclusion, we would remark,--and it is shown by our labors--that we are not, like some persons, opposed to all genealogies. On the other hand, we rejoice in being able to trace back the high ancestral line. We have seen many a youth who did not know even the *name* of his grandfather. Now, instead of encouraging such unaccountable ignorance, on the part of the young and rising generation of the Woodman name, we would rather, if possible, instil into their minds a due regard for the memory of departed ancestors, and enable them--one and all--to trace back their lineage even to Edward 1 of Newbury.

Trusting that our labors thus far will not be wholly unappreciated, and humbly soliciting indulgence for all the imperfections which may be noticed in these pages, we take this opportunity to say that we propose to push our genealogical inquiries no farther.
