#### THE WALLACE FAMILY IN AMERICA.

Pioneers in the field of American genealogy, delving among the scattered records and random notes, of our forebears, must have realized that the proverbial characteristic of the canny Scotch had effectually limited the influx of immigrants of that nationality; and present searchers of their published works find but few, bearing historic names of that noble race, recorded therein:—which fact, necessarily prescribes our account of one of the best known families of Scotland.

In the minds of those students of Scottish history, and literature, who have never ventured beyond our own shores, there stand equally well-defined the figures of bold Rhoderick Dhu, and Sir William Wallace:—patriot and martyr.

Of the same ancient and virile race are many of whose enrollment as American citizens we are justly proud.

Savage, names ten as original Wallace immigrants, and these with later accessions numbered over two hundred and seventy-five families at the taking of our first census, in 1790. The many thousands now of record in our town and city directories, convincingly testify to the virility of their forefathers.

At Lanark, Scotland,—the seat of the renowned knight, and the great Wallace family,—about 1675, and of unknown parentage, JAMES WALLACE was born, (the predestined father of an American fam-

ily,) the storying of whose life has here its primal delineation.

For five-and-twenty years he had dwelt among kindred; and then the development of his future began, and he drifted down the Clyde valley. Spending considerable time at Glasgow, then at Greenock, the waters of the Firth witnessed his unwilling transfer, to one of Britain's floating fortresses; there he was tutored in all the manœuvers of warfare on the high seas.

The year 1705 found his barque headed toward the colonial realm of Her Majesty, and the seasoned man-o-war's-man indulged hopes of early release. In due time the ship was off the American coast, and entered Long Island sound, bound for New York, on a course well over to the northern shore. At noon-of-night, with Stratford Point astern, young Wallace slid overboard on a trailing rope, and quite unobserved, headed shoreward, eventually reaching the sandy beach, at a point near Norwalk, Conn.

Within a year he acquired a wife in the person of Mary Hyatt, daughter of Thomas and Mary (St. John) Hyatt, who was born in 1682. They settled at Ridgefield, Conn., where a family of seven children were born and reared, viz:—

John, October 16, 1708; Rachel, February, 1711; James, February 6, 1713; Agnes, January, 1717; Thomas, April 13, 1719; Jacob, August 31, 1721; Martha, July 25, 1724.

Serving the country of his adoption faithfully as

a soldier, Sergeant James Wallace passed from life March 8, 1762, aged 87; his wife following him February 20, 1766.

JOHN WALLACE, the oldest son, married (1746) Martha Schofield, born in 1730, and removed to North Salem, N. Y., where they raised a large family, born as follows:—

John, June 2, 1747; and his twin sister Martha; Rachel, January 5, 1749; William, October 15, 1750; Jonathan, November 18, 1752; Samuel, November 17, 1754; Ruth, December 26, 1756; Jacob, June 1, 1759; James, July 8, 1762; Agnes, February 21, 1765; Epenetus, in 1766. The father died March 23, 1812.

Captain James Wallace, the second son, and his wife Abigail, born in 1712, were married in 1735, also settling at North Salem; their children were:—

James, born April 30, 1737; Abigail, December 21, 1740; Abijah, August 13, 1748; Uriah, October 22, 1750; Sarah, July 28, 1752; Jacob, June 17, 1754; Lucy, April 19, 1757; Deborah, in 1759. Captain James died March 20, 1782; and his wife, July 12, 1797.

THOMAS WALLACE, third son of James and Mary, died in October, 1742; and his younger brother, JACOB WALLACE, in 1754.

WILLIAM WALLACE, second son of John and Martha, married Sarah Dickerson, about 1778, removing to Oak Ridge, N. J.

Three sons of Captain James and Abigail,

(James, Abijah and Jacob), were in the army during the Revolution.

The eight children of William and Sarah, were born as follows: Amelia, August 27, 1780; Chloe, May 14, 1782; Charles Thele, April 25, 1788; William S., May 20, 1790; Sarah, October 3, 1793; Henry L., May 23, 1796; Eliza, April 4, 1802; John D., October 29, 1806.

Henry L. Wallace, third son of William and Sarah, married about 1818, Catherine Frederichs, born June 1, 1800; she died October 18, 1833, soon after the birth of their seventh child, none of whom are recorded; he taking as his second wife, Rhoda Cobb, by whom he had two sons: William Henry, born June 27, 1840; and Edward Lewis, born June 21, 1843.

CHARLES WALLACE, of Prince George county, Maryland, who with his wife, Sarah, were the parents of seven children, was the first of that name recorded there,—in 1717. Their sixth child, William, who married Elizabeth Walker, was the father of five, the youngest of whom, Seth, of Hyattsville, married Jemima Jones, of whose nine children, Alpheus, of Baltimore, was the last. He married first, Rachel Stelinus, who died. His second wife, Harriet R. King, presented a son, Alpheus, Jr., April 5, 1838, who married Audella Bebee, who bore him three children.

JOHN WALLACE, of unknown birth and parent-

age, came from Antrim, Ireland, in 1720; probably landing at Newburyport, Mass., and going thence to Londonderry, N. H., where he was first of record. Annis Barnet became his wife, and their son, William, born in 1730, married Hannah Thornton, (sister of Matthew, who was one of the signers of the Declaration of Independence), who in 1760, gave birth to William Jr., who by his wife, Anna Dendal, was father of James J., born in 1805, whose wife was Eliza T. Bond. William, Jr., removed to Rochester, N. Y., where his father died, 1823; James J. died in 1878.

ROBERT WALLACE is supposed to have reached America about 1720, and to have had four sons, John, Joseph, William and James. In 1739, Robert and John were in Bucks county, Penn., where the family has been prominent through all the intervening years. Of the other sons little is known. for William married a widow named Creighton, and removed to York county; Joseph had a son, John, born in 1748, who was a soldier in the Revolution; and James is said to have died in 1765; no further records as to those sons being available. John, who died in 1777, left a son, James, born about 1724, who married in 1754, Isabel, daughter Their children were :--Robert, of William Miller. John, William, Jean, Margaret and Isabel. James Wallace, was a member of the Committee of Safety, preceding the Revolution, and died in 1777. His son, Robert, was a Captain in the Militia, and saw service in the war of 1812; he married, November 2, 1792, Mary Long, (daughter of Lieut. Hugh and Margaret (Graham) Long), whose children were:—Priscilla, Eliza, Isabel, Mary, Margaret, Rebecca, and James. Captain Robert Wallace entered into rest in 1850. His son James, born December 29, 1800, married, February 14, 1833, Mary, daughter of James Ford, who was born April 4, 1807, and died December 14, 1864; he died January 27, 1886; their children were:—Mary Jane, John Bowers, William, Charles Irvin, Rebecca, and James.

John Bowers Wallace, of Philadelphia, was born March 23, 1836; his wife was Maria Louisa, daughter of Peter and Mary LePage, born July 25, 1834; she died August 23, 1870, and he also passed away March 9, 1877; having had four children, viz:—William Stewart, John LePage, Mary Jane, and James; of whom the second died in 1872.

WILLIAM STEWART WALLACE, a well-known member of the Philadelphia Bar, was born May 13, 1862, and married, June 8, 1888, Mary Comfort, daughter of Jacob S. and Mary (Flack) Brand, of Chambersburg, Penn.

About 1730, a company of Scotch-Irish immigrants were landed at Philadelphia, and after a brief sojourn went out to Lancaster. Among them were the brothers Peter and William Wallace,

whose wives were sisters named respectively, Elizabeth and Hannah Woods.

Peter Woods, the patriarch of the family, was an enterprising individual, restless and loquacious, bent on the acquisition of an extended domain. He fell in with one John Lewis, who was about to remove his family to a location he had selected for preemption, in the valley of Virginia, west of the Blue Ridge. Determining to accompany him thither, Peter Woods placed his family and affairs in charge of his three sons-in-law, and departed with the Lewis family early in 1734, passing southwestward across the Susquehanna, through the country bordering the Potomac, and crossing that stream, they went down the Valley, east of the Alleghenics, to the vicinity of what is now Staunton, Va., where Lewis proposed to settle.

Early in the spring of 1735, two of the young men journeyed to Albemarle county, Va., one of whom remained and raised a corp of corn; the other returning to forward the preparations for the transfer of their entire connection to that section,—later; and that was accomplished the following spring.

The old people settled on the site selected by the father; Peter Wallace, a little farther south; William next; and John McDowell, third of the sons-in-law, at Meacham's river: there they lived, prospered and reared their children.

The children of Peter and Elizabeth (Woods) Wallace, were:—Andrew, Adam, Samuel, and

Peter; all of whom are supposed to have been born in Ireland; and little is known of their subsequent history, except,—that Andrew married Catherine Parks, and settled near the Allegheny mountains; and that the children of Peter, Jr., were:—Joseph, Samuel, Janet and Rachel; while Samuel married Esther, daughter of Caleb Baker, of Prince Edward county, settling in Charlotte county, where their children were born; removing later to Kentucky.

The children of Samuel and Esther (Baker) Wallace were:—Caleb, born in 1742, Elizabeth, born in 1745, Andrew, born September 25, 1748, and Samuel, unrecorded and unheard of after he returned to Scotland.

All that is known of this entire family comes through CALEB WALLACE, whose biographer relates the career of a remarkable citizen, and United States Judge, who throughout a busy and strenuous life was ever a leader among the men of his time; active in shaping the legislation of Virginia, before the Revolution, and of Kentucky, after her admission as a State, in 1792. He was a graduate of Princeton, as was also President Madison, with whom he maintained relations of friendship. studied for and entered the Presbyterian ministry, in which he held a distinguished place until the troublous times preceding the breaking out of war, when he became noted as a staunch advocate of emancipation from the tyranny of King and Parliament; and the separation of Church and State: including entire freedom of conscience.

He married first, his cousin, Sarah McDowell, born October 10, 1755, who died early in 1776, leaving no issue; and second, in 1779, Rosanna, daughter of Captain Israel Christian, born in 1754, by whom he had nine children, born as follows:—Samuel McDowell, April 16, 1780; William C., October 16, 1781, who died young; Priscilla C., March 12, 1785; Caleb Baker, May 22, 1787; John, October 13, 1789; Henry, March 24, 1792; Wm. Christian, April 15, 1794; Charles, September 9, 1796; and Christian, November 21, 1800. Mrs. Rosanna (Christian) Wallace, died December 4, 1804; and he married third, Mrs. Mary Brown. Judge Caleb Wallace died in 1814, at his home in Woodford county, Kentucky.

Joined through his parentage to two noted clans, John Wallace, born January 7, 1718, at Drumellier, in the south of Scotland; son of the Rev. John and Christian (Murray) Wallace, at the age of twenty-three, bade adieu to his Gaelic home, and in due time found himself at Newport, R. I. Not finding there the opening he desired, he proceeded to Philadelphia.

In 1749, he was one of the founders of the St. Andrew's Society,—which still endures; and also a subscriber, with Gov. Hamilton and others, to a Dancing Association, now perpetuated in the Philadelphia Assemblies.

Six years later he was chosen to membership in the Common Council, composed of citizens of the highest business standing and influence; retaining his membership until the occupation of the city by British troops changed the form of government.

In 1750, he bestowed both heart and hand on Mary, daughter of Judge Joshua Maddox, of the City Court. They established a home in the city, where their four children were born; and in later years, added a country house, beyond the Delaware, (known as Hope Farm,) in Somerset county, N. J. His death occurred September 26, 1783; and that of his wife, four months later.

JOSHUA MADDOX WALLACE, eldest son of John and Mary (Maddox) Wallace, born in Philadelphia, Penn., October 4, 1752, was educated at the College of Philadelphia, and after his graduation engaged in mercantile pursuits; having a city residence and a country house, "Ellerslie," in New Jersey; to which he removed previous to the occupation of the city by British troops, under Gen. Howe. Returning for a brief sojourn in 1784, and settling finally at Burlington, N. J.

There he became the foremost citizen, being actively interested in the promotion of her material and educational institutions, her benevolences, and moral uplift. As a judge and legislator, his leadership was universally acknowledged. His death occurred in 1819. His wife was "Tace," daughter of Col. William Bradford; of their seven children four died in early life.

WILLIAM WALLACE, youngest son of John and Mary (Maddox) Wallace, was born September 4,

1762, and is believed to have been graduated from the College of New Jersey, (now Princeton University). He married in 1782, Sally Durham; she died in February, 1796, and he in September, following; leaving three young children. John, the eldest, is said to have died in the army during the war of 1812; at Plattsburg, N. Y. Durham, the younger son, married and left a son, named William.

Joshua Maddox Wallace, Jr., born September 24, 1776, was also graduated from the College of New Jersey, and entered business. Financial reverses, however, overwhelmed him in 1819; and he passed from life January 7, 1821. He had married in 1805, Rebecca McIlvaine, who was left with seven young children at his death. Her father, William McIlvaine, M.D., was an able physician; and her eldest son, Joshua Maddox, (third of the name), became a physician of note. He was born January 13, 1815, and in 1847, married Alice Lee Shippen, who bore him three children, two of whom died young; and he died November 10, 1851.

John Bradford Wallace, second son of the first Joshua Maddox Wallace, born August 17, 1778; entered the practice of law. Was appointed Reporter of the Supreme Court of the United States, and in that position received high praise from Daniel Webster, and other legal lights of the time. His wife was Susan Binney.

WILLIAM ELLERSLIE WALLACE, brother of the third Joshua, born June 15, 1819, was also a phy-

sician; he married Susan Wistar. His son, Ellerslie, born October 22, 1849, followed his father's profession. The father died March 9, 1885; and the son February 17, 1907.

SHIPPEN WALLACE, born February 26, 1850, was the son of Joshua M. and Alice (Shippen) Wallace, and a graduate of Yale. He married Laura C. Barclay; was prominent as a chemist. He died, December 4, 1911. After the death of his cousin Ellerslie, he was the only Wallace of this line.

JOHN WILLIAM WALLACE, eldest son of John B. and Susan (Binney) Wallace, born February 17, 1818; was graduated from the University of Pennsylvania, in 1833, and admitted to the Bar in 1836; became Librarian of the Law Association in 1841; went abroad as its representative in 1850, making the acquaintance of many distinguished lawyers, judges and publicists; and after his return to America, (and the death of his brother in 1852,) took up legal literary work; was appointed Reporter of the Supreme Court of the United States, in 1864: resigning in 1875; and leaving enduring evidence of great ability in the Reports which bear his name. He had married Dorothea Frances Willing, in 1853; his death January 12, 1884, left her with an only daughter to share her grief.

Horace Binney Wallace, born December 26, 1818, and graduated from the College of New Jersey, in 1835, was admitted to the Philadelphia Bar, in 1840, but preferring literary work as a

vocation, gained an enviable reputation for brilliancy during a brief career; which was terminated by his death, December 16, 1852, at Paris, France.

Benoni Wallace, of Lunenburg, Mass., was born about 1730, and in 1755 married Rebecca Morse, of Lynn; their son David, of Ashburnham, born October 6, 1760, married Susannah Conn, by whom a son, David, Jr., was born July 14, 1792; he married in 1821, Rosanna A. Gowen, and settled in New Ipswich, N. H., where their son Rodney, was born December 21, 1823; who in 1853, at Rindge, N. H., married Sophia, daughter of Thomas Ingalls.

RODNEY WALLACE, removed to Fitchburg, Mass., where he engaged, successfully, in manufacturing, and later was elected to Congress.

James Wallace, of Leicester, Mass., was there in 1732, and is supposed to have been born in Connecticut; his son John, born in 1736, married in Pelham, in 1761, Agnes Lindsey, and settled in Colerain. He was a soldier of the Revolution, and after its close went to Franconia, N. H., becoming later a proprietor at Littleton; his son David, born in 1770, married Nancy Palmer, in 1799; they had eight children.

Their son, Captain HIRAM WALLACE, of Concord, Vt., born April 27, 1808, married in 1836, Lovina, daughter of James, and Rhoda (Jones) Pike; he died in 1889.

THOMAS WALLACE, born at Largo, Scotland, April 19, 1808, came thence in 1822, and is of record at Ryegate, Vermont.

James Wallace, of unknown origin, in 1768 married Jane Beard, probably of Rockbridge county, Ky., where their son John, was born December 15, 1771; they removed (presumably before 1790), to Harrison county, Ky., where she died in 1806, and he in 1812.

JOHN WALLACE, son of James and Jane, about 1797, married Ruth Barlow, of Iredell county, N. C., and appears to have gone to Georgetown, Ky., where the following children were born:—John, May 4, 1798; Elizabeth, March 8, 1800; William, April 5, 1802; James, September 1, 1804; their father died July 24, 1830; their mother survived until December 4, 1841; dying in Jefferson county, Ind., to which most of her children had removed.

Rev. WILLIAM WALLACE, son of John and Ruth, married December 21, 1820, Sarah Conway, and removed to Lafayette county, Wis.

JOHN WALLACE, eldest son of John and Ruth, married February 25, 1823, Elizabeth Giltner, born March 31, 1798, in Bourbon county, Ky.; two children were born, viz:—Mary, November 30, 1823; Okey, in 1825, who died in 1826; and they removed to Jefferson county, Ind., where other children were born, as follows:—John, July 7, 1827; Elizabeth, August 7, 1829; Ben., November 20, 1831; James, January 31, 1834; Barnett, December 20,

1836; William, October 20, 1839. Mrs. Elizabeth (Giltner) Wallace died October 11, 1854. Removing to Lafayette county, Wis., Mr. Wallace took a second wife in the person of Mrs. Eliza Delong, April 12, 1855; she gave birth to Celestia Irene, March 1, 1856; and Ada May, March 6, 1861. John Wallace died August 26, 1866.

James Wallace, youngest son of John and Ruth, married Mary Morris, in Trimble county, Ky., December 14, 1826; she was born February 24, 1806; he died in Jefferson county, Ind., May 13, 1868; she surviving until October 21, 1884.

Elizabeth, daughter of John and Ruth (Barlow) Wallace, married William Conway; they removed to Jefferson county, Ind., where he died June 30, 1862, and she, December 25, 1863.

JOHN WALLACE, oldest son of John and Elizabeth, married December 17, 1846, Minerva E. Duffy, born January 21, 1830; she died September 20, 1853, and he married second, September 21, 1854, Reta A. Lawlor, and now resides at Moscow, Idaho.

BENJAMIN WALLACE, second son of John and Elizabeth, married October 19, 1854, at Taylorsville, Ind., Catherine Anderson, born December 15, 1834, at Augusta, Ky. He died May 28, 1867; his widow surviving until October 27, 1899.

Dr. WILLIAM WALLACE, youngest son of John and Elizabeth, December 21, 1859, at Louisville, Ky., married Emma Hewett, born February 16, 1841. He died August 18, 1862, at Carrollton, Ky. She is living at Louisville, Ky.

DR. BARNETT WALLACE, fourth son of John and Elizabeth, married at Franklin, Ind., December 20, 1860, Artemisia Williams, born November 28, 1837; she died without issue January 15, 1864, and he married second, December 30, 1868, at Lafayette, Ind., Rebecca S. Goodwin, born December 30, 1843, at Cincinnati, Ohio. They reside at Franklin, Ind., their children are:—Bertha, born January 19, 1870; Edna, January 26, 1872; Earl, October 18, 1876; Ruth, March 4, 1879; Paul, February 7, 1882. After forty-five years of active practice, Dr. Barnett Wallace, retired in 1912.

Mary, daughter of John, and Elizabeth (Giltner) Wallace, married, September 21, 1843, Richard M. J. Cox, of Scott county, Ky., born January 25, 1819; she died June 11, 1850; he passed away December 23, 1901, at Brownstown, Ind.

Elizabeth, younger daughter of John and Elizabeth, was married March 3, 1852, to William Cochran, born February 25, 1825, in Jefferson county, Ind.; he died February 19, 1905, in Iowa.

JAMES HARVEY WALLACE, born November 16, 1834, in Juniata county, Penn., married October 16, 1862, at Wooster, O., Sarah J. Troutman, settling in Canaan, where children were born, viz:—George Elvin, October 3, 1863; Charles Robert, November 3, 1865; Franklin Emmet, March 25, 1867; Carrie Louella, April 22, 1869; Anna May, February 23, 1871; Lewis Eugene, March 6, 1873; and Clarence Leroy, November 10, 1875, at Smith-

ville, O. The second son died April 12, 1870; and after the birth of the youngest, the family removed to Monmouth, Ill., where he died February 20, 1878; the father dying there January 12, 1897. The eldest son now resides at Kansas City, Mo. Anna May, youngest daughter, married May 5, 1892, Charles W. Dougherty.

Dr. Franklin Emmet Wallace, third son, married October 28, 1897, Helen Edwards Dean, and they reside in Pueblo, Col.

LEWIS EUGENE WALLACE, fourth son, married August 25, 1903, at Washington, D. C., Alice Candee Gale; they now reside in Galesburg, Ill.

John Harper Wallace, born January 18, 1849, in Washington county, Penn., married first, in 1868, Louisa J. Donaldson, who died May 3, 1871, leaving a son, Joseph D., born June 3, 1869; and the father married second, April 4, 1873, Jennie B. Oliver, who presented him with six children, born as follows:—James Wilbert, January 10, 1874, Oliver Clare, October 8, 1875; Alice May, May 25, 1879; John Hankins, June 25, 1881; Robert Ewing, March 29, 1886; and Frank Myler, November 20, 1890.

Dr. Joseph H. Wallace, of Sandusky, Mich., was born February 6, 1852, in Louisville, Canada, and married Sarah Powell, in 1878. To them four children have been born, as follows:—Harry Leon, March 15, 1881; and Daniel James, November 27,

1883, at Merlin, Can. Removing later to Michigan, where William Rich, and Hazel Irene, were born; the former, January 23, 1890, and the latter August 16, 1894. The second son died September 21, 1906.

#### THE CENSUS OF 1790

The following pages contain the complete records of all persons of the name of Wallace from the first United States census taken in 1790, now on file in the census office in Washington, giving the names and residence of heads of families and the number of male and female children in each family.
