Preface


A record of the Ward family, descendants of William Ward, who settled in Sudbury, Mass., in 1639, was published by Andrew Henshaw Ward, A. M., in 1851. This record contains the names of nearly four thousand Wards, together with the names of many families that have intermarried with them. In 1897 copies of this book were for sale by Joel Munsell's Sons, Albany, N. Y., and it may still be found in the genealogical departments of many libraries in the United States.

The immense amount of research, labor and perseverance required to gather the necessary data for the above mentioned record, bear evidence of the desire of Andrew Henshaw Ward to hand down to posterity a carefully compiled genealogy of the Ward family. He is indeed deserving of the gratitude of all of us who take an interest in our fathers. The family may be pardoned for having a just pride in such ancestors as General Artemus Ward, Colonel Joseph Ward, and Captain Josiah Ward, of the Continental armies.

Herein I have followed only the direct line of our immediate family from the first generation, headed by William Ward, to the sixth generation, headed by Josiah Ward, as given in the above mentioned record of Andrew Henshaw Ward. Certain errors in the record of the sixth generation, found therein, I have corrected and have brought the genealogy down to the ninth generation, so far as it has been obtainable to date.

In gathering statistics all our cousins of the seventh generation have aided. Without their assistance the work could not have progressed. I have merely tabulated and arranged the information they have kindly sent me. The work is theirs more than mine and to them is due the thanks of all who may hereafter prize this little volume.

William Ward came from England. He first lived in Sudbury, Mass., and afterwards in Marlborough, Mass. In both places he was a man of prominence. He died at Marlborough, Aug. 10, 1687. It it probable he was twice married.

SECOND GENERATION.

He had a second wife, Elizabeth, who survived him. He died in 1729, aged 84. In his will, dated May 22, 1727, he says he is "well stricken in years and crazy in body, but of perfect mind and memory." His will was contested in the Prob. Court, Dec. 19, 1729, by all his children (save his son, Samuel, to whom he gave most of his estate) on the ground that he was crazy in mind as well as in body, when he made his will. At length the heirs agreed among themselves touching his will and desired the judge to approve it.

Over half of the boat's crew were lost and the balance were captured by the confederates. The boat was blown up and burned by confederate shells. In 1866 Capt.
