The Williams Family.

DESCENDANTS OF JOHN WILLIAMS OF NEATH GLAM-ORGANSHIRE, WALES.

HE only definite and (presumably) reliable account of the earliest ancestors of the Williams Family, which was in possession of the family for many years, was that recorded

by the late Samuel Williams of Cincinnati, Ohio, who in the beginning of his manuscript memoirs, which he wrote about 1850, stated, as a legend (received from his father, William Williams), that the earliest known ancestor of our family was "supposed to be one John Williams, a hatter by occupation, of Glamorganshire, Wales, who had been one of those persons who advanced funds to aid Oliver Cromwell in the conquest of Ireland, in 1649, and who, after the subjugation of that island, went to Ireland, where he received from the Protector, in return for the above advance, and possibly for military services, a grant of lands, probably a portion of the confiscated lands of the rebels, and settled on the same. It was supposed that this land, or a portion of it, was the same estate that was subsequently known as 'Lappan' and 'Lower Groves,' in Monaghan County, where the family resided for nearly two centuries."

It is remarkable how this family legend, or tradi-

tion, handed down orally from father to son, through several generations, was found, afterward, to agree with the real facts of history, regarding the origin of our family, and is now substantiated by actual records. Samuel Williams was not in a position, when he wrote in 1850, to push his investigations to a point where he could get any definite and tangible clue to the genealogy of our family, for which, however, he left such valuable material on record in his memoirs. He had no access to any documents in the archives of Great Britain, and had no means to make a pilgrimage to the ancestral home.

The untiring investigations of historians and scholars in later years have thrown valuable light on many events concerning which but little was known when Samuel Williams wrote his memoirs in 1850, and has made it possible to prove definitely and clearly what was before merely surmise.

Some 25 years ago Mr. John P. Prendergast, an attorney of Dublin, began an investigation of some old manuscript documents in the Tower of that city, with a view to ascertain facts regarding the Cromwellian Invasion of Ireland. He secured a large amount of material whose existence was hitherto unsuspected, and soon after published a historical work on the era above mentioned, entitled:

"THE CROMWELLIAN INVASION OF IRELAND."

Among other documents which Mr. P. discovered and prints in his interesting work is the original "List of Adventurers," as they are there termed, of which our ancestor, John Williams, was one. The history of this movement may be briefly given as follows:

The "act of parliament, 17 Charles I, chap. 33, A. D.

1642," and subsequent acts, had authorized a scheme for suppressing the Irish rebellion by forfeiting two and a half million acres of Irish lands, which were to be offered as security to those who should advance moneys toward raising and paying a private army for subduing the Irish rebels. The subscribers, or "adventurers," as they were called, were to have estates and manors of 1,000 acres each given to them in Ireland of various prices in the several counties, ranging from £200 to £60, and lands proportionably for less sums. The rates by the acre were to be 4 shillings in Ulster, etc. On the "List of Adventurers for lands in Ireland," etc., published in Prendergast's work, we find a subscription as follows:

919 John Williams, ffeltmaker.....£50

The term "ffeltmaker," of course, is synonymous

with "hatter," which we know was the hereditary occupation of the family for seven generations.

After the suppression of the rebellion in Ireland, the confiscated lands of the rebels were distributed to the discharged soldiers who had taken part in the conquest, and to the subscribers to the fund. It must have been under this apportionment that "John Williams, ffeltmaker," was granted his estate in Ireland. As it was located in Ulster, he would have received for his £50 subscription about 250 acres. This tract, a full investigation shows, was the same subsequently known in the history of the family as the homestead called "Lower Groves" and "Lappan," and which are now shown on the official maps by those names. These farms, "Lappan" and "Lower Groves," were certainly seats of the Williams family very soon after the close of the rebellion, and remained permanently in their line for 180 years, when Matthew Williams (five) and his son Matthew Bell Williams (six) removed to America.

THE WILLIAMS FAMILY IN WALES—ITS OR-IGIN, AND MEANING OF THE NAME.

John Williams, "The Adventurer," was a descendant of one of the oldest families in the principality of -Wales, and which had long resided near Neath, Glamorganshire. It is useless and unnecessary, therefore, to search for the etymology of our name in the langauges of any other race but the Cymbrian. The name "Williams" is entirely Welsh (so far as our stirps is concerned), and the family are indubitably of ancient Briton or Cambrian stock, for generations back. name, in the Cymbrian tongue, is derived (says Dr. Alex. Jones, an eminent Welsh scholar) from the verb "gwylio"—to watch. The noun of this verb is Gwilym (pronounced William) and would therefore mean—a watcher, a sentinel, a guard, a warder, a patrol, etc. The name (as applied to a person) evidently arose from a military occupation, as it was one common in Wales at that period, and belonged to a large class, which can be readily understood by anyone who reads the history of Wales, its frequent and almost constant wars, its predatory raids from rival chieftains and princes, and foreign foes, together with frequent domestic broils. To give timely notice of these invasions, and collect the trusty men-of-arms who should repel the foe, the princes and military leaders were accustomed to have, on their towers, and other points, trusty sentinels. There were also stationed on mountain cliffs and summits, near the sea-coast, and at the head of defiles, to spy the advancing invaders, and signal the danger. Each Gwilym was to light a beacon fire on the first sign of alarm. This was answered from another mountain peak, and then another caught up the warning flame, until, from every hilltop over a whole county, blazed the signals of danger, calling the men-of-arms to buckle on their swords and saddle their steeds, and rally at the accustomed rendezvous.

FURTHER NOTES ON THE NAME WILLIAMS.

Though the Welsh, or original British race, are a very ancient people, and probably came from Asia many centuries ago, the exact time when the word, or name, "Williams," became a fixture among them, is now only conjecture. In the Domesday survey of England (1086), the word William, as a surname, occurs 68 times, but generally in such a form as this, "William, filius Ricardi," or "William, son of Richard." Some centuries later this would become, "William Richardson." The names Willelmus and Willielmus also occur in the Domesday.

The name "Williams" (as we write it now) is not, however, of great antiquity, for it has been used as a surname only about four centuries. Its earliest mention in the records and archives of Great Britain was about the middle of the 15th century. I think that in every case, in that period, it referred to a native of Wales. Still, I find in the "Carew Manuscripts" (relating to affairs in Ireland), date 1571, the expression "Williams Sept," indicating that there was a clan or tribe of the name there then, but it seems certain that they must have been incomers, and not natives of Ireland, as the name is not found in ancient Irish archives. A careful examination of Burke's genealogical works, the "Peerage" and the "Landed Gentry" of Great Britain, seems to prove that but few of the oldest and most distinguished families of the surname "Williams" can trace farther back (under that name)

than 1600. One lineage, in Burke, speaks of a Williams -born in 1473 (reign of Henry VII), but it is not certain that he used our surname, as Burke, in another pedigree, mentions a Roger Williams in the time of Henry VIII (1543), who, he says, "was the first of the family who adopted a surname of any kind." In the lineage of another family, he speaks of a "William Williams, who was the first of the family who assumed the name of Williams." In 12 Edward IV (1472) a Sir David Williams is recorded as living in 1490. Thus it can be seen that the surname "Williams," as a permanent family name, did not come into use much over 400 years ago. This was about the date that printing was "Williams" is given as one of the characters in Shakespeare, in King Henry V, act 4, scene 1 (1413-1422).

The orthography of the name, at first, does not appear to have been well fixed. In an old pedigree in the Harleian MSS. (date about 1620), the name is spelled Gwilliams. Burke, in his genealogical works, frequently spells it Gwillym. Geo. T. Clark, a Welsh genealogist, in his great work on Glamorganshire pedigrees, always spells the name Gwilim. The family of Roger Williams, the founder of Rhode Island (A. D. 1550-1650), used to spell their name Wyllyams, and subsequently Willyams, Rogers himself so writing it in his earlier life. Many families in England still spell the name thus.

The name became a very common one in Wales. In the city of Neath, Glamorganshire, a large percentage of the inhabitants bore the name "Williams." They have been prolific authors, too. In the great catalogue of the British Museum, I found 116 pages of a folio volume, devoted to the list of books written by authors of our name. Lower, author of a learned work

on Patronomatology, says that 21 different surnames are derived from the name "William."

Common and widely extended as the name is in Great Britain, it is singular that no genealogies of any of the Williams families of that realm have been published. At least the great catalogue of the British Museum shows none, although three genealogies of American families of the name are entered there. Yet some may have been "privately printed" which have not yet been secured by the libraries. "Visitations" in Wales contained pedigrees of the family in a number of cases. I found them in "Glamorganshire Pedigrees (by Sir Isaac Heard), edited by T. Phillipps," published in 1865, and also in Lewis Dunn's "Visitations of Wales," edited by S. R. Meyrick, date 1846.

HOW SURNAMES ORIGINATED IN WALES.

Surnames had not been generally adopted in either Wales or England, much prior to four centuries ago. It was the custom in Wales to designate men by their father's name, to which their own was prefixed. Thus, if a Welshman, named "Gwilym" had a son, whose name was also William, the latter would be distinguished by calling him "William ap William," that is, the son of William. Somewhat later on, it would become plain "William Williams." If he had a son named Morgan, the latter would be called Morgan ap Gwilym, or Morgan the son of William. Later on, this would glide into "Morgan Williams." This actually happened in the family of Cromwell, which was Welsh, and whose real family name was Williams, "Cromwell" being an adopted name coming through an estate left to the family two or three generations back of Oliver. See Russell's life of Cromwell and other reliable works of the same kind. It is such a custom as the above which makes the confusion in Welsh pedigrees. Several sons of one family, named Morgan, Evan, Rhys (or Reese), Owen, etc., when the system of surnames was adopted, would thus establish families with the surnames Morgan, Evans, Reese, Owens, etc., and, though related in blood, all connection with each other would be lost in a generation or two.

JOHN WILLIAMS, OUR OLDEST KNOWN ANCESTOR.

whose name is given to an extensive and widely spread family now known as "Williams," and who was probably born in Glamorganshire about 1620, must have been a man of considerable means for that period, and of some influence. He was certainly accustomed to arms, and doubtless bore his full share in the troublous wars of his time. When not in the field or camp, he was peacefully employed at home, in the manufacture of hats—a craft of considerable importance at that time.

John Williams possesed many admirable traits. He was a stanch Puritan, an honest burgher who feared God but not man—who could pray or fight with equal zest—a brave hater of wrong—a warm advocate of popular rights, and he lived in a period that would call such men into action. Events were now occurring which were to change the whole current of his life, and exercise an influence on the destiny of generations of his descendants yet unborn. One of these events was the raising of the fund heretofore spoken of, for the conquests of Ireland. This scheme had been begun in the reign of Charles I, but its projectors were delayed

in its execution by the civil war, and it does not seem to have been completed until after the overthrow of that monarch, and it remained for Oliver Cromwell, the Welshman, as Lord Lieutenant, to carry out the conquest of Ireland, and its settlement by his disbanded army and the "adventurers" who had advanced the funds (£43,406) for the military operations. To this fund John Williams, as mentioned previously, subscribed £50, a very considerable sum for those days, and shows that he must have been a man of some sub-As his name appears to be the 919th on the stance. list, it is probable that he did not subscribe to the adventure until the latter part of the movement, as the subscription was in progress for several years. This fact, together with the circumstance of John Williams having held the rank of Lietutenant and Commissary in Cromwell's army, during the invasion of Ireland, have led to the assertion on the part of some of the family that he was a cousin of the Protector and also a cousin of Archbishop John Williams, as it is well known, as heretofore stated, that Cromwell descended from a Welsh family named Williams. But in the absence of any definite proof of such relationship, we can only give this as "tradition," which will need further genealogical research to substantiate.

When John Williams (one), the "felt maker," went to Ireland in 1649, it is probable that he was a man of about thirty years of age. It is hardly presumable that he was much, if any, less than that age, as, were he a younger man, it is not reasonable to suppose that he would have been possessed of means sufficient to have contributed a sum so considerable, in that period, as £50, to the Irish "adventure." It seems quite certain that he was married, and quite probable, also, that he had children, who could not, at that time, have been

grown up, and consequently must have accompanied him to Ireland, or at least gone there to rejoin him after he received his quota of land in 1653. If so, we have no account of them, thus far, and know only the name of one of his children, John Williams (two), who, we have good grounds to suppose, was born after his settlement at "The Groves" or "Lappan."

THE WILLIAMS FAMILY IN IRELAND.

O'Hart in his "Irish Pedigrees" states that the soldiers of the commonwealth "were not disbanded, at soonest, before September, 1653, and up to that time they had received no grants of land in Ireland." same author, in his "Irish and Anglo-Irish Landed Gentry," in the "List of adjudications of arrears of commissioned officers who served before June 5, 1649," gives John Williams' name as one of them. "Lieut. John Williams" is again mentioned as serving as a soldier of the commonwealth, and also in "names of persons in the grants under the acts of settlement and explanation." Prendergast states that the act allowing the "adventurers" to cast lots for lands was passed Jan. 1, 1652, but that it was not until Sept. 26, 1653, that all the ancient estates and farms of the people of Ireland were declared to belong to the "Adventurers and the army of England." The "lots" were actually cast in July, 1653. The amount then due the Adventurers was £360,000. Lands in Monaghan County were included in this allotment. It must be remembered that at this time it was deemed very hazardous for the "Adventurers" and others who had been allotted lands under the Cromwellian confiscation to settle on them. The original Irish, who had been forcibly driven from their homes, were infuriated with hatred against the newcomers, and ready for any desperate and bloody act of revenge against the latter. The lands could only be held vi et armis by those having a support of soldiery in the vicinity, or a force of workmen and tenantry on their own estates, sufficient to protect themselves from raids, by vigilance and hard fighting. "It was not (says Prendergast) until toward the close of 1653 that the island seemed sufficiently desolated (sie) to allow the Cromwell soldiers to occupy it."

Lewis, in his Topographical Dictionary of Ireland (1860), says of Monaghan County:

"A considerable portion of the lands consists of grants to Cromwell's soldiers, many of whose posterity now possess farms so small as not to yield an annual income exceeding £20. Few of the farms on the larger estates are tenanted in perpetuity. The usual term is 21 years and a life, or 60 years and three lives."

Thus, we find that, in 1653, John Williams was probably put into possession of some 250 acres of land in the county of Monaghan, including the two farms called "the Lower Groves" and "Lappan," 31 miles due east of the county town of Monaghan, and there established himself as a hat manufacturer and farmer. Here he must have lived many years, peacefully (as we trust), and died, doubtless, near the end of the seventeenth century, aged probably 75 years. Whether this John Williams built the old stone house which is now in ruins on the "Lower Groves" domain, or not, we cannot now determine. But it is most probable that he did, it is hardly presumable that the previous dispossessed tenant left it there. It is certain, in any event, that he built the addition to the house mentioned elsewhere, which was for his workshop.

JOHN WILLIAMS (TWO) SON OF JOHN WILLIAMS (ONE).

An old, broken, and moss-covered tombstone, discovered after some search, lying flat in the burying ground attached to Tyholland Church, about two miles from "the Groves," gives us the most definite clue to this ancestor. The inscription reads: "Here lyeth the body of John Williams, who departed this life February 14th, 1723, aged 70 years." This would have made the date of his birth 1653—the year of the settlement of his father, John Williams, at "the Groves" or "Lappan." It is conjectured that it may have been this John Williams who is noted on the Parish Records of Tyholland Church as being a church warden in said parish, in 1721.

JOHN WILLIAMS (THREE).

Son of the foregoing, was probably born at the Groves, about 1675 or 1680, as, at the time of the Revolution in 1690, he is said to have been about 10 or 15 years old. Whether he had any brothers or sisters, is not now known. His occupation, like that of his father, and grandfather, was that of hatter. He died (so Samuel Williams recorded) "about the age of 75, near the middle of the eighteenth century." From dates given in the Tyholland vestry book, we are satisfied that he was living as late as 1754, as he appears to have served as a church warden in that parish nearly 30 years. He had nine children, five daughters and The names of his daughters or who they four sons. married, if they were married, have not been preserved. The sons were named: William, Henry, John and Matthew. William and Henry emigrated to America about 1750, and settled in North Carolina. since which we have no account of them or their families, if they left any.

JOHN WILLIAMS (FOUR),

1708

Was born at "the Groves," Dec. 11, 1711. He followed the family occupation of hatter. Samuel Williams recorded in his memoirs that "he married <u>Sarah Hall</u>, a most estimable woman, by whom he had six children." But in John Williams' will (dated 1795), he speaks of his wife as "Elizabeth," which doubtless refers to his second wife, and not the mother of his children. The wife who bore the latter must have been a superior woman. Her son, William Williams, always spoke of her in terms of warmest affection, and highest eulogy.

John Williams (four) inherited or acquired the "Lappan" homestead, which remained in this line for several generations. John Williams (four) is said to have been a strict, severe, exacting man, rigorous in enforcing the tasks given to his chilren. He was a man of great industry, energy, firmness of will, and more than average intelligence. Some of his marked characteristics have been noticeably impressed on his descendants for three or even four generations. His will, which is a valuable acquisition to our fund of genealogical data, I fortunately found preserved in the Public Record Office in Dublin. The following is a copy:

LAST WILL AND TESTAMENT OF JOHN WILLIAMS OF LAPPAN.

In the name of God, Amen. I, John Williams, of Lappan, parish of Tyhallan, and County of Monaghan, being sick of body but of

sound and perfect memory, thanks be to God, and calling to mind the uncertainty of this life, do publish and declare this my last will and testament, in manner and form following: First, I leave and bequeath unto my wife, Elizabeth Williams, all the farm of land now in my possession, with my dwelling house and cow house. together with two cows and my mare, my chest of drawers, my bed and bed clothes, and my kitchen furniture, with the following bequests-that at her decease the said houses and land shall go and revert unto John Williams, son to my son Matthew Williams of Lappan aforesaid. Also, I leave unto my said wife all the turf bog I now possess. Also, I leave unto my son William Williams all the land belonging to me, occupied by tenants, if he comes home, and the profits, rents of said lands, until he comes, I leave unto my said wife and said grandson, John Williams, equal share and share: and if the said William Williams does not come home before my wife's decease, it is my will that the whole profits of said land go to the said John Williams. Also, I leave unto my son Matthew Williams, my desk. Also, I leave unto my son-in-law, Thomas Short, one shilling, sterling. And it is my will that as soon after my decease as convenient, there shall be an inventory taken of the remainder of my goods and chattels and sold by auction by my executors whom I shall bereafter nominate, and the money arising from the sale thereof, my funeral expenses to be paid thereout, and the remains to be divided equally between my two sons-in-law, viz.: William Bell and Thomas Armstrong. And I nominate, constitute and appoint John Williams, of Coote Hill, County of Cavan, and William Renderson, of Groves, and County of Monaghan, executors of this, my last will and testament.

In witness whereof, I have bereunto put my hand and seal this ninth day of March, 1795.

JOHN WILLIAMS [Seal].

Signed, scaled, published and declared, in presence of Matthew Williams,

William Anderson.

1795, July 10, on which day John Williams and William Anderson, executors named in the foregoing will, made oath as well to his belief of the truth thereof as also to execute the same.

From this document, which is of great value to us for genealogical purposes, we may infer that John Williams was a well-to-do man for that period, and had quite a good estate. The will was evidently drawn up, and signed by him, while on his deathbed. The signature is a mere scrawl, and evinces the bodily feebleness of the testator. He probably died within a few hours after signing it, aged 81 years. His seven children are recorded in the genealogical table following.

John Williams had 38 grandchildren, and 134 great-grandchildren. Thus he was the progenitor of a mighty line of descendants, nearly all of whom are now living in the United States, and many occupying positions of trust and honor. His son,

WILLIAM WILLIAMS (FIVE),

was born at Lappan, July 2, 1754. In his youth he received a good education and learned the hatting trade, as an apprentice to his father. About 1779 he married Margaret Widney, of Emyvale, and lived for several years either at Lappan or Ballyclareen, a hamlet close by (see map). In 1783 he appears to have been a church warden of Tyholland parish. Three children were born to them, all of which died in infancy, the last in 1784, while on their ocean voyage to America. Mr. Williams settled first in Carlisle, Pa., where he carried on his trade, then in Path Valley, Pa., and in 1803 removed to Charleston, W. Va., and in 1807 to Chillicothe, O. Meanwhile, three sons and one daughter were born to him.

Mrs. Margaret (Widney) Williams died at Chillicothe, Dec. 22, 1813, and he himself on Aug. 8, 1815. He was a handsome man, intelligent, and vivacious in his manners, and a superior workman at his trade. He had 7 children, 28 grandchildren and 110 great-grandchildren.

LA FABRIQUE DE CHAPEAUX.

The Williamses, for several generations, as noted above, were hatters by occupation, and were all superior workmen.

THE GROVES AND LAPPAN—WHICH IS OLDER?

The question, as to which is the older of the two ancient seats of the Williams family, "Lower Groves," or "Lappan," may well claim our attention at this point. Family tradition gives the seniority to the Groves homestead as the place where the Williams ancestors planted themselves on coming to Ireland, and I am of the opinion that this is correct, but Wm. Williams of Dublin asserts positively that he always heard that Lappan was the first seat of the family. Groves house certainly seems the oldest building, in its style and appearance. Just when the Lappan house was built cannot now be definitely determined, nor by whom. Williams (two), who died in 1723, was, so the traditions of old people in the neighborhood declare, a resident of the Lappan homestead at the time of his death. William Williams (five) was undoubtedly born at Lappan in 1754. The latter always declared that "Lower Groves" was the original seat of the family. Another theory is, that the Groves and Lappan estates were formerly one, and divided between the two sons of the family, John and Matthew. We are more inclined to accept this supposition than any other. houses are just half a mile apart, in an air line. presuming that the original "Adventurer," John Williams (one), the fielt maker, did receive, in the original allotment of land by Cromwell, 250 acres, it is probable the boundaries of said tract included both the "Groves"

and "Lappan" property. A half mile square, as is well known, amounts to 160 acres.

However this may be, we do know beyond a doubt that before the middle of the eighteenth century, the Williamses were inhabiting both the Groves and Lappan homesteads, and carrying on the manufacture of hats and farming.

Matthew Williams (four), son of John Williams (three), was born at the Groves, perhaps about 1730. He married Anne Smith, of Coote Hill, perhaps about 1755. The latter died March 27, 1781, aged 44 years. Her tomb is in Tyholland churchyard. His body was subsequently buried in the same grave. The children of Matthew (four) and Anne (Smith) Williams are given in the genealogical table.

THE GROVES AND LAPPAN IN 1888.

For many years, the writer of this sketch (John Fletcher Williams) had resolved to make a pilgrimage to the ancient homesteads of the family in the county of Monaghan, and ascertain what facts he could, regarding the history of the Williamses of Monaghan clan. It was not until 1888, when I was able to accomplish this, in connection with a general European tour, at the close of which, in the month of September, I visited Neath and Cadoxton, Wales, the ancient Cymbrian home of the Gwilym tribe, and from thence proceeded to Dublin, Ireland, where (on September 13) 1 received a warm welcome from our cousins William and James Williams, and their families. Mr. Wm. Williams, No. 2 Dame St., is a naturalist by profession, a gentleman of fine attainments and much scientific knowledge, and author of valuable treatises on natural

history. Mr. James Williams resides at No. 43 Dame St. Although suffering somewhat from the infirmities of age, Mr. Wm. Williams kindly offered to accompany me to the old family home, and it was fortunate that he did so, as his knowledge of the localities, and of the family history, were of the very greatest value to me. We arrived at Monaghan on Friday evening, September 14, and were cordially greeted by Mr. Robert Whitla, brother-in-law of Wm. Williams, who took us to his comfortable residence.

The next morning (September 15), which we had planned to employ in visiting the Groves and Lappan, was cold and rainy. Cousin Wm. Williams was feeling too unwell to venture out in such weather, but as my time in Ireland was so limited, I felt that I could not lose an hour. Wrapping myself up in my water-proof ulster, I at once sought a livery stable, and hired a "jaunting car," with a smart driver, and a brisk nag, and started off to visit

EMYVALE,

an old town five miles north of Monaghan, where the Widney family lived over a century ago, and where my grandfather, William Williams, married Margaret Widney just a century ago. The roads were splendid, smooth and hard, and we galloped along between the beautiful hedges of hawthorn, through rows of century-old trees that lined the highway, past comfortable stone houses, along carefully cultivated fields, and all this through a landscape of incomparable loveliness. Soon the rain ceased and the clouds broke away. We reached Emyvale in about an hour. It is a quaint old Irish town, built along the highway for over half a

mile. All the houses are one-story stone structures, many of them very poor, with thatched roof, and it is certain, from their appearance, that not a new house had been built in the town for a century, at least. people generally seemed very poor. Perhaps the number of signs that I noticed over doors, "Licensed to sell spirits," may account partly for this. I went into several dwellings and stores, and was pained at the appearance of poverty and discomfort everywhere. My main object in visiting Emyvale was to get some trace of the Widney family. To this end, I conversed with several very old people, one, indeed, who said he could remember back eighty years, but I could find no one who had heard the name Widney. I inquired of the postmistress also, but she asserted that there was no such name ever inquired for at her office, so I abandoned further search, and started off to find the rector of Glaslough church, in which church I felt certain that the marriage of William Williams (five) and Margaret Widney must have taken place. Glaslough itself is a village some two miles from Emyvale, and the residence of the rector is on the road between the two places. We soon reached Glaslough rectory, beautiful villa, embowered in an old forest, and I alighted and inquired for the rector, Rev. J. C. Hudson. Unfortunately, he was absent from home, so I was baffled in my project of examining the Donagh parish) registers of a century ago. I subsequently found, by corresponding with him, that the parish had no registers earlier than 1836, all prior to that date having been lost or destroyed. We were now in the immediate vicinity of Cool-Collet-hill, which was the old home of the Anderson family, but I did not have time to visit it, to my great regret.

We returned to Monaghan, and the weather hav-

ing now become warm and clear, cousin William Williams and I set off after dinner in a car, to visit

"LOWER GROVES" AND "LAPPAN."

These ancient seats of our clan are situated about three and one-half miles directly east from Monaghan, on the grand highway to Armagh. We soon passed the Ballyclareen river, and a few steps beyond hailed an old native making hay by the roadside, of whom Wm. Williams inquired which was the Lappan house. "Is it the ould Williams house ye want?" said the rustic. "It's yon," pointing to a structure on an eminence near by. This was, for us, an interesting incident. The Williams family had not occupied either of their old homesteads in this locality for over a half century, and yet here was a local tradition calling the old houses by the names of their ancient proprietors. Thus tenacious of life are local traditions in that region.

On reaching the top of the hill, we saw the Lappan house on our left, up a long lane, and the ruins of the Groves house, plainly in sight, half a mile distant, on an eminence, across a low valley. We determined to visit this first, and drove thither. Just as we turned off from the highway into the hawthorn-hedged lane that led to the old ancestral manse, we were fortunate enough to meet a clever farmer who lived close by, Mr. Samuel Gilliland, who greeted us politely and asked us if we were Williamses. On replying "yes," he said he had suspected it from our personal appearance, and that the idea came to him who we were, and our object, when he saw our car approaching the old place. He was very glad to see us, and offered to show us the Groves house, or what remains of it, with

which he had been familiar since childhood, and it was lucky for us that we met him as we did, as he gave me much very valuable and interesting information.

THE OLD "GROVES" HOUSE.

As I dismounted from the car, at the side of the old house, on the summit of the eminence, a painful feeling came over me, as I saw its ruinous condition. I would have given a large sum to have seen it as it was when whole and in good order, such as our ancestors inhabited it a century or two ago.

Still, enough of its walls remain to show what it was, and its arrangement and appearance. Mr. Gilliland kindly explained to me the interior arrangement and appearance, as he had been in it hundreds of times when a boy, and remembered nearly all the particulars With his aid, and my own measureregarding it. ments, I drew a plan of the house, which he pronounced The house was probably 40 feet front, and 24 deep. It was well and thoroughly built of hewn stone, and had been stuccoed both outside and inside. It was 13 stories high, and had (as do all the houses in that region) a thatched roof. Mr. Gilliland says it was a well finished and comfortable residence and looked very neat on the outside. To the north of the main house was an addition quite spacious in size, one story in height, which, I have no doubt, was used for the hat shop. Still north of this, down the slope a little, and detached from the house, was a large barn, built of stone, which is still standing in good condition.

Fruit trees were scattered around the house, and along the front wall of the yard. Farther on was the vegetable garden. The main cultivated fields were

on the east side of the lane. West of the house, in the valley, was an immense peat bog, over a mile long, in which the family got their fuel for over a century. It is now exhausted, and turned into a meadow, carpéted with bright verdure.

The Groves house stands on a lovely eminence. The name Monaghan is said to signify "the little hills," and this describes the appearance of the country—a succession of undulations as far as the eye can reach. Standing on the ground by the Groves house, one can see two or three miles in every direction, a most lovely panorama of green fields, cultivated patches, just then yellow for the harvest, with lines of deep green hedges around the fields, stone walls, clumps of trees and whitewashed stone cottages. I have never laid eyes on a more charming landscape.

The soil of the Groves neighborhood is as rich and productive as any I ever saw anywhere. I wish some descendant of the family would purchase the property, which is now for sale, and rebuild the old house, as a memorial to our ancestors.

A VISIT TO LAPPAN.

After lingering around the old place as long as we could, we bade good-bye to neighbor Gilliland, and mounted our car, to pay a visit to Lappan.

In a few moments we were driving up the hedged lane of the Lappan estate. Mr. James Hughes, the present tenant of the farm, advanced to meet us. He had already suspected who we were and our purpose, and when we alighted remarked, "I think your names are Williams." Guided by him, we commenced an inspection of the premises, to me a most interesting spot.

We appeared to approach the old house in the rear, a fact which Mr. Hughes explained by stating that the house had once fronted to the east on a roadway that then ran north and south on the other side of it, but which had since been closed up and was now cultivated ground. On my Ordinance survey map, dated 1836, I find that the road did then run east of the house, as he said.

The house, like all those in this region, was of stone, a story and a half high, and covered with a thatched roof. It was stuccoed on the outside, and brilliantly whitewashed. It was a neat-looking residence outwardly, but showed marks of antiquity. It was probably 50 feet front, and 24 deep.

I entered this venerable house of our ancestors through the low doorway, and sat down in the main family room. Inside it was poorly lighted, and the rafters and ceiling above were absolutely ebonized by the smoke from the fireplace, where peat had been burned for over 200 years, and by lamp smoke, etc. A woman was leaning over the fireplace, cooking, probably—a woman with some traces of intelligence and beauty, but showing the marks of hard work and hopeless poverty. There was no wooden floor in the entire house, and perhaps there never had been one. The floor was paved with stone and brick, and it appeared very old and much worn. It was undoubtedly the one which was put down when the house was built. An old staircase, not inclosed, ran from the rear of the room to the attic above. It looked more ancient than anything else; the oaken planks seemed worn hollow by the footsteps of maybe two centuries. The walls were roughly plastered, and had been white once. The doors and their frames, the windows and window frames, were all very old and battered, and showed the marks of wear and time. There were two quite large apartments in the house, and two smaller ones.

Running at right angles to the house was a rough stone structure, used now as a stable. It may have once been the hatting shop, but Wm. Williams thinks this was the original dwelling of the family, and that the other building was erected subsequently. We cannot fix the date of either definitely. In his will (1795) John Williams (four) evidently refers to it as the "cow house," which I think it always was. A stone wall ran in front of this, the ancient inclosure along the line of the once road, above referred to. In front of this the ground slopes off to the eastward, toward the peat bog mentioned in the will of John Williams (four), who died in the Lappan house in 1795. The peat has long ago all been cut off from it, and it is now meadow land. It is underlaid by a splendid bed of marl, from which the best quality of bricks are now made.

Mr. Hughes is an industrious and intelligent man, but speaks of his condition and prospects very despondingly. He says he has to work very hard, early and late, for a very poor living, and cannot get ahead. He pays £13 a year rent for the house and 10 acres of land. The land he rents now belongs to the Coote Estate, descendants of the Earl of Bellomont at Coote Hill, County Cavan. The land, however, is very rich and productive.

I remained at Lappan, walking about, and carefully examining it, until evening, when the hour came to return to the city. I left this interesting neighborhood, the Groves and Lappan, with much regret, and with many emotions, as I thought of their past, and the fortunes of the family identified with them. I hope to see them again.

SOME HISTORICAL NOTES OF ANCIENT MONAGHAN.

The region in which Monaghan is included was the home of the Irish tribes since remote ages. In the "allotment of 1591" "Lower Groves" fell to Toole Mc-Gilduffe MacMahon, and "Lappan" to Con O'Clerian. After the conquest of Ireland by Cromwell, 1649, the country was reapportioned. An ancient map of Ulster, fully 300 years old, with letter press description in Latin, gives the following account of Monaghan:

Erno lacui ad orientem praetenditur Monaghan, Comitatus collibus, aditus, sylvis vestitus, sed nullo notus oppido, nisi Monaghan, quod nomen universo agro impertiit, dividitur in quinque baronias, etc.

Skirting Lake Ernus on the east lies Monaghan, hilly, elevated, covered with forests, marked by no town except Monaghan, which name is shared by the whole region. It is divided into five baronies, etc.

"The Groves" must have been so called from the ancient forests which once covered that neighborhood, and are spoken of in the foregoing extract and by other early writers, as very heavy and extensive. Nothing remains of them now.

The word "Lappan," says Evelyn Philip Shirley, in his history of Monaghan County, signifies, in the Irish tongue, "a little paw." The name is evidently a very ancient one.

According to the Ordinance Survey, Lappan now has 102 acres, and the Groves (lower) 117. The Groves (upper), I am told by a person residing there, was once part of the possessions of the Williams family; if so, it must have been sold by them at an early day, as the dwelling house on it, occupied by a Mrs. Patten, seems very old. This is some quarter of a mile south of the old "Lower Groves" house.

A VISIT TO TYHOLLAND CHURCH.

The next day (September 16) was the Sabbath, and I resolved to pay a visit to Tyholland church, to see that venerable structure, in which our ancestors worshiped for over 150 years, and in the yard of which, I had reason to believe, some of them were buried.* Cousin Maggie Whitla kindly offered to accompany me, and, engaging a car, we reached Tyholland church a few minutes before the time for service, 12 o'clock. The day was a lovely one.

I went at once to the burial ground, accompanied by Miss Whitla, and commenced my search, although the bell for service was even then ringing. I found without delay, the tomb of Mrs. Ann Smith Williams, since we knew where it was. I then continued my investigations. After reading the inscriptions on a number of gravestones, I noticed one very ancient looking one, lying flat, and covered with dirt, moss, grass, etc. I scraped some of this away with my foot, and read the letters WIL. This made me believe I had found that of one of our family, and I at once eagerly began to pry it up and scrape off the dirt from it.

Just then the church bell ceased to toll, and I was compelled to suspend my search and go in to service. We asked one of the vestrymen if he could show us into the old pew known as the "Williams pew," which he did. The family undoubtedly worshiped in this pew over a century. The interior of Tyholland Church is quite plain, but there is a movement on foot to restore it. The pews are the old-fashioned square ones, where

^{*}Tyholland is a very ancient locality. Its name dates back to 1306, when it was called Tech-thalain, or Tech-talam, "House of Talan," subsequently spelled Tyhallan, and now Tyholland. St. Patrick is said to have founded the original church. The present building (on the site of the ancient one) is about 200 years old.

a part of the audience sit with their back to the desk. The backs of the pews were straight, the seats uncushioned, and not very comfortable or easy.

When the services were closed, I sought the rector, Rev. James Wilson. whom I found to be a very courteous and affable gentleman. I told him my errand to Tyholland, and he assured me he would aid me in any way he could. He, accompanied by his wife and two sons, went with me to the old stone I had found in the yard, and I went to work on it again, aided by the sexton, who brought a broom and a pail of water, with which we cleansed the surface of the stone. Quite a group gathered around, much interested in the proceedings. At length I was able to read the inscription on it as follows:

HERE LYETH THE
BODY OF JOHN
WILLIAMS WHO DEPA
RTED THIS LIFE FEBUARY
THE 14TH 1723 AGED 70 YEARS.

I felt a great joy when I had deciphered this, as it convinced me that I was on the right track, and I had now got a definite clue, after all my outlay and trouble. I was not able, however, to continue my researches then, as the hour was already late. We accepted the kind invitation of Mr. and Mrs. Wilson to accompany them to the rectory a few steps distant, where we partook of refreshments, and then returned to the city on foot. That evening I left for Belfast, where I was hospitably entertained by Dr. William Whitla and his wife, and the next day returned to Dublin, en route for Queenstown, where I was to embark on the steamer.

Believing that there were other old tombstones of

the earlier members of our family still to be found at Tyholland, I enlisted Dr. William Whitla of Belfast in the project, to have the place thoroughly examined. He caused this to be done soon after, by a competent person, but no more tombstones of our family were found. This was somewhat of a disappointment to me, as I was certain that more would be discovered, which would give us valuable facts and dates.

THE WILLIAMSES AS CHURCHMEN.

From the vestry book of Tyholland Parish, which records reach back to the year 1712, we learn that the Williamses were all devoted members of the Established Church, and that several of them held offices in the parish during more than a century of its history. Rev. James Wilson, Rector, has copied for us a number of extracts from the old vestry book, which are very valuable as giving much light on the history of the family. John Williams (three), "of Groves," appears to have been elected church warden at various times from 1726 to 1754, and most probably served continuously during all that period. The minutes are dated Jan. 2, 1721; Apr. 12, 1726; Apr. 5, 1743; Mar. 27, 1751; Apr. 15, 1754; Apr. 10, 1770, and Oct. 1, 1771. We are somewhat puzzled to determine whether it is the same John Williams that is referred to in all these entries. We started out on the theory that it was John Williams (three) "of Groves," born in 1675 (perhaps), and who, in 1721, when he is first noted as a church warden, would have been 46 years old. the first entry noted may relate to John Williams (two), who did not die until Feb. 14, 1723. It could not certainly have been John (four), because he was not born

until 1714. In two entries, the person referred to is termed "John Williams, of Groves." These are on Apr. 12, 1726, and on Apr. 15, 1754. These two entries undoubtedly refer to John Williams (three), notwithstanding the memoirs of Samuel Williams indicate that he died about 1750. We are now certain he lived to after 1754. It could not certainly have been John Williams (three) who was the church warden in 1771; no residence of this one is mentioned on the records. We are satisfied that this latter entry means John (four), who at that date (1771) had become the proprietor of Lappan, and died there in 1795, and whose will is given in a previous portion of this work. The other entries in the Tyholland Parish Record are as follows:

April 15, 1754, William Bell, mentioned as vestryman.

April 16, 1759, Walter Bell, mentioned as Church warden, and Mathew Williams, as a vestryman.

April 10, 1770, John Williams, mentioned as Church warden.

October 1, 1771, John Williams, mentioned as Church warden, and Mathew Williams, as a vestryman.

April 21, 1783, Wm. Williams, of Bally Clareen, as Church warden.

April 6, 1795, Alexander Williams, of Groves, Church warden. November 27, 1824, Matthew Williams signs as an officer.

Thus, it will be seen, that, for over a century, the heads of the various families of Williams, in Tyholland Parish, during three generations, if not four, were prominent as church officers in that parish. Only men well to do, living under the tongue of good repute, and leading blameless lives, were chosen to those offices.

It is gratifying to know that our ancestors were devout and pious people. The influence of heredity is very powerful. "Bon sany ne peut mentir." Good progenitors generally have good descendants, and their best traits are thus perpetuated from generation to generation. All the Williamses that we have ever

heard of are religious people, many of them intensely so.

SOME ETHNOLOGICAL NOTES.

During their residence in Ireland of nearly two centuries, the Williamses do not seem to have intermarried with the native race, at all. This may have been largely owing to differences in religion, nationality, or social position.

The Wilsons were Scotch; Hall is a Scotch name. The Widneys were of Hollandish descent. Bell is Scotch and so is Armstrong, Anderson, Johnston, McAllister, McCullough, Browne, Campbell, Linn, Gordon, and other families noted herein, who have married with the Williams clan, which appears to be purely Welsh-Scotch in blood. Their general physical characteristics and temperaments also indicate Celtic (Cymbrian) origin.

There are other records of whose existence I did not learn until about to leave, which would undoubtedly give us many valuable facts of family history.

The absence of any family manuscripts or papers, such as letters, wills, deeds, records in family bibles, etc., was another cause which added much to our labors, and to their unfruitfulness. None of the branches of our family seem to have any of these records which reach back any distance, and the loss of all the oldest parish registers has destroyed valuable data of that kind.

One other point that we wish to allude to is the importance of keeping in every family some accurate records of births, marriages and deaths. Some families to whom we sent for information had no written records of this kind whatever, and were compelled to

guess at dates. A good plan to accomplish this registry would be, for persons receiving a volume to have it bound, adding to it a number of leaves of writing paper, on which to record such genealogical facts as they deem valuable for preservation.

In order to aid in such a commendable work, and to give each member of the family now living a clue to connect his other descent back to the earliest known progenitors of the family, we append a pedigree, not complete in all portions, but which will be found very useful.

If the relatives who receive this book will go over it carefully and note any errors or omissions and report them to David Williams, Room 29, No. 167 Washington street, Chicago, Ill., corrections will be made in any future edition printed. Would like particularly to have further information of the Rachel Bell (Hoy) family, No. 91½, and the Thomas Short family, No. 22, not brought forward in this history for want of reliable information. Other families, also, are not fully accounted for, for the same reason.

LINEAGE OF THE WILLIAMS FAMILY.

DESCENDANTS OF JOHN WILLIAMS OF NEATH GLAMOR-GANSHIRE, WALES.

1. JOHN WILLIAMS.

A hatter by trade of Neath, Glamorganshire, Wales. We can only estimate the date of his birth by the date of his enrollment on the list of "Adventurers" in the Cromwell army in 1649, and by the date of the birth of his only son of whom we have any account, John Williams (two), in 1653. Taking these two dates as a basis for the purpose of this work, we put the date of his birth at 1620. If the exact date is ever ascertained it may vary 5 years either way from this, but probably not more than that. He is enrolled on the list of "Adventurers for Lands in Ireland" as No. 919, as shown by Prendergast's history of the Cromwellian invasion of Ireland, heretofore quoted from. He moved his family from Wales to Monaghan County, Ireland, in 1653, and settled on one of the two farms heretofore described as "Lappan" and "Lower Groves," where he died near the end of the 17th century. His rapid advancement to lieutenant and commissary in the Cromwell army lends color to the family tradition that he was a cousin of Oliver Cromwell, but we have no sufficient evidence to support this statement. It is, however, a well-known historical fact that Oliver Cromwell descended from a Welsh family named "Williams"-the name "Cromwell" being assumed only two or three generations back of Oliver.

2. JOHN WILLIAMS (two),

Of "Lappan," son of John Williams (one). Born at "Lappan" or "Lower Groves" in 1653, the same year his father moved from Wales to Ireland. Died February 14, 1723. His tombstone, now in Tyholland churchyard, bears the following inscription: "HERE LYETH THE BODY OF JOHN WILLIAMS, WHO DEPARTED THIS LIFE FEBRUARY 24, 1723. AGED 70 YEARS." His oc-

cupation, like that of his father, was a hatter and farmer. His only descendant, of whom we have any account, is John Williams (three), shown following.

3. JOHN WILLIAMS (three).

Of "Language Groves," son of John Williams (two) of "Lappan." Born in 1675. Died about 1755. Name of wife unknown. He had four sons and five daughters (names of latter unknown). His four sons were:

- 1. William Williams, who emigrated to North Carolina about 1750, since which we have no record of him or his family, if he left any (a search is being made, however).
- 2. Henry Williams, who went with his brother William to North Carolina in 1750, since which we have no account of him or his family, if he left any.
- 3. John Williams (four). Born at "Fourth Groves" December 11.

 The Died at "Lappan" in March, 1795. See copy of his Will, shown previously in this work, which is on record in Dublin.
- 4. Matthew Williams (four). Born at "England Groves" about 1730. Died there July 8, 1805.

The parish records of <u>Tyholland Church</u> (Episcopal) show that John Williams (three) of "Lower Groves," served as warden in that church almost continuously from 1726 to 1754. These parish records are entirely reliable, and not only give his name, but also the name of the farm, "Lowes Groves," on which he lived, thus placing his identity beyond question.

4. MATTHEW WILLIAMS (four),

Son of John Williams (three). Born about 1730. Died July 8, 1805. Married Ann Smith of Coote Hill. Born in 1737. Died March 27, 1781. Aged 44 years. Married about 1756. Their children, fifth generation:

- 1. Alexander Williams. Born about 1760. Married Eliza Bocock.
- 2. John Williams, of Coote Hill. Born 1765. Died January 10, 1808, at Lappan.
- 3. William Williams. Born 1769. Died April 2, 1810. Unmarried.
- 4. Matthew Williams. Born 1773. Died July 20, 1837. Married Mary Thompson.
- Sarah Williams. Born 1775. Died March 18, 1841. Married Woodney Browne.
- 6. Margaret Williams. Born 1777. Died August 23, 1824. Married Mathew Browne.
- 7. Elizabeth Williams. Born 1780. She died in 1824 at Chillicothe, Ohio. Unmarried.

5. ALEXANDER WILLIAMS,

Son of Matthew Williams and Ann Smith. Born about 1760. Died in 1843. Married Eliza Bocock. Their issue—Sixth generation:

- John Alexander Williams. Born about 1805. Died July 1, 1855.
 Married Alice Pearson.
- 2. Alexander Williams,
- 3. Eliza Williams. Twins. Both died young.
- 4. William Williams. Born March 1, 1813. Married Alice West.
- 5. Ann Williams. Born October 24, 1818. Married Robert Whitla.

6. JOHN ALEXANDER WILLIAMS,

Son of Alexander Williams and Eliza Bocock. Born about 1805. Died July 1, 1855. Married Alice Pearson. Born——. Died——. Married in 1827. Their children—Seventh generation:

- 1. Hanuah Williams. Born August 27, 1828. Died young, 1834.
- 2. Alexander Williams. Born February 5, 1830. Died young.
- 3. John Alexander Williams. Drowned at Cincinnati, Ohio, July 1, 1355.
- 4. William Williams. Born April 7, 1835. Died young.
- 5. George Pearson Williams. Born October 8, 1836. Lives 413 Union Street, Brooklyn.
- 6. Alice Pearson Williams. Born—. Died in 1887. Married Thomas James, 413 Union Street, Brooklyn, N. Y.
- 7. Elizabeth Ann Williams. Born June 5, 1842. Died July 17, 1854. John Alexander Williams and family emigrated from London to this country in 1855. They reached Cincinnati early in the summer, and both he and his son John Alexander were drowned in the Ohio River July 1, 1855. The widow, Alice Williams, remained in Cincinnati until her death.

7. WILLIAM WILLIAMS,
