Great care has been exercised in compiling this second edition of Joseph Wilder and his Descendants and it is beleived that very few errors occur. An occasional date and name, however, is yet wanting, as is the case in nearly every lineage and the Compilers will be greatful to any one who will furnish the missing data.

Joseph Wilder was a lineal descendant of Nicholas Wilder of Germany, the first of the line in England, to whom Henry VII., in 1497, gave a landed estate with a coat of arms, in recognition of his faithful services in the battle by which he secured his crown. The estate is still in the possession of Nicholas Wilder's descendants.

The line of descent from Nicholas to Joseph is: - Nicholas: John: John: Thomas, the last in this descent to live at Shiplake; Edward, 1623, who is was in America in 1638 on the arrival of his mother Martha: Jabez, 1658: Theophilus, 1710; Theophilus, 1740: Theophilus, 1766: Joseph. 1797.
