As will be seen from the chronology which follows, little is known of Amos West before he settled in Logan County, Kentucky.

According to the Herndon genealogy published in 1956:

#75-4 FRANCES HERNDON (75 James) was b about 1774, probably in Chatham County, N. C., and d before 1808 in Logan County, Ky. She m. 2 April 1791 in Sumner County, Tenn. Amos West. who was b 1766 in Louisa County, Va., was reared in Orange County, N. C.; removed to Logan County, Ky., about 1792, where he d in 1819. Amos West m 2ndly, 18 April 1808, Ann Thompson.

Hoping to find references for the statements underscored above, I wrote Ruth Herndon Shields of Chapel Hill, North Carolina, requesting the name and address of the person who furnished the data on Amos West. A portion of Mrs. Shields' reply dated August 30, 1957 follows:

The sketch for James /Herndon/ #75 was completed by Dr. Herndon, and I put it in exactly as he wrote it. The WEST information was furnished many years ago, probably by several members of the family.

Before John Goodwin Herndon, Ph.D. (1888-1957) could complete this volume, the sixth in a series of Herndon genealogies, illness overtook him and he turned over his manuscript and notebooks of source material to Mrs. Shields who finished the work.

Another account of Amos West and his family is a record made by J. J. Jepson of Simpson County, Kentucky. Mr. Jepson, now deceased, made these notes in 1940 and it is my understanding they were to be used in connection with a commemoration service to be held at the Sulphur Spring Baptist Church located in Simpson County. I copied these notes in September, 1957, at the home of Miss May Belle Morton of

Above dates are correct with reference to Agness and Leonard (twins) and approximately correct with reference to the rest.

The West Family 1730-1940 - English lady of royal blood left home coming to New York and married a wealthy Virginia planter. Reared family and six children, both dying in Louisa County, Virginia. Children were reared by an old maid aunt in Orange County, North Carolina. They married before coming to Kentucky.

James who helped Walker survey Walker's line in 1780 was evidently in the Engineer Corps during Revolution. Later he settled on Red River, Logan County, Kentucky before 1800. He married Mourning Howard September 30, 1807, afterward he married Susan Morgan February 1808. This family has not been traced further by the writer.

William served in Revolution, settled in Logan County, Kentucky 1808 on BuPond farm which he purchased from John Neely, Jr., the original owner. This is now farm owned by Mel Dinning heirs. He reared a large family of children and moved to Calloway County about 1820. Returning in old age he secured his pension in Simpson County, Kentucky. One daughter Ann married Dr. Jesse Milliken whose descendants are numerous today, as Robert Franklin, a grandson, and Hon. C. W. Milliken of Franklin, Kentucky whose memory is now cherished by many good citizens of our county, as well as noted descendants. Another daughter, Elcy married James Milliken before leaving Orange County, North Carolina or upon arrival in Logan County, Kentucky. Their generations are represented as follows: James and Elcy West (1), William West (2), Dr. John Robert (3), Harbeson (4) and his children (5).

Agness married George Milliken in Orange County, North Carolina. See Milliken Family Book, Goodnight Memorial Library, Franklin, Kentucky for their descendants.

Leonard West. Sr. left North Carolina as young man and married Phoebe Morgan at Morgan's Station just south of Kentucky line about 1798. He had served two terms in Revolution for which he obtained pension in Calloway County, Kentucky in 1833. Returning to Simpson County he died and was buried on his headright obtained in 1799. This land is now owned by Mrs. John Hatter and descendants. A great great granddaughter, Mrs. J. P. Atkinson of Pueblo, Colorado has prepared a splendid genealogy of this noted pioneer. His descendants by generations are as follows: Fielding Bradford (2), Leonard Morgan (3), Kate, Florence, Robert, etc. (4), their descendants (5). (Nannie

Copeland Atkinson is a granddaughter of John Bottomley, who married a sister of Leonard Morgan West.) Refer to Mrs. Atkinson for further information.

<u>Richard</u> settled after marriage on Spring Creek, Logan County, Kentucky prior to the year 1795. Between the fork of Red River and Spring Creek he obtained his headright and began a mill in July 1795 on Spring Creek. His marriage and descendants have not been traced further by the writer.

Amos married first, perhaps in North Carolina about 1790, Frances, daughter of James Herndon, Sr. and sister of George Herndon, both of Revolutionary fame. Their children were born in Logan County, Kentucky as they obtained land on Big Whipporwill Creek in 1792 and on Spring Creek in 1796. Residing near the creek, at bridge crossing, at Sulphur Spring, he entered many hundreds of acres of land. Most of this land he disposed of before his death in May or June 1819 except his headright which he willed to his youngest son Richard, and the widow's dower now owned by Nrs. E. B. Ellis and children. After the death of Frances, he married Anne Thompson April 18, 1808 and the children were by his first wife. The home where Amos lived and died was just southeast of the bridge cross and the home where his widow received her dower in December 1819 is now marked by an old locust tree just southeast of new cemetery on south side of the Gallatin Road. This farm passed at her death 1826 to Thomas C. Coghill, then to Orson Morrow, then 1846 to Clayton and John Washington Edwards and to E. B. Ellis and heirs.

Children of Amos and Frances Herndon West:

- (1) Isabella married Logan County, Kentucky January 18, 1813 to Hiram Halcomb.
- (2) Polly born 1791 married William Milliken August 9, 1808. See Milliken Family Record.
- (3) Agness married John P. Bush March 16, 1822. They probably moved newer frontiers as we find no record of them after 1834.
- (4) James settled and reared a family on the old West place near Price's Mill. Some of his children were Leonard and Amos. Mrs. Lon Young and Mrs. John Gilbert (Mrs. W. W. Payne) are daughters of Leonard, and Ewing West is a grandson of Amos who passed away in January or February 1940 at the ripe old age of 85 or 86.
- (5) Leonard married a Miss Doss and reared a family on Red River.
- (6) Richard who ----- the home place probably moved to Calloway County, Kentucky or Illinois or Missouri or Kansas as did others of his near relatives. His descendants have not been traced by the writer.

Accounts of William West and Leonard West are given in <u>The West Family</u>

<u>Register</u> and a sketch of Agness West and her husband, George Milliken, is included in a Milliken genealogy, 2 from which the following was copied:

THE WEST FAMILY. The grandmother of Agness was an English lady belonging to a family of wealth and rank. Here is a bit of romance. She had a lover who was objectionable to her father because below her in family connections, or was not born with the "golden spoon" in his mouth. He was sent into the army or carried off by a pressgang and seen no more. She wrote many letters trying to find him and, finally ran away and came to New York in her search. Her money failing, she found employment in a hotel. A young merchant from Virginia saw her, admired her refined appearance, made love to her and, learning her history, married her, and took her to his Virginia home. After the death of her father she got her portion of the estate.

Agness West had a brother Leonard. Their parents died in Virginia when they were small children, and they were brought up by an aunt. Both came to Kentucky. Leonard West married, settled in Simpson County, and raised a large family. The sons were Amos, Fielding and James. There were five daughters, William Milliken's wife being one of them. James Milliken married another. Dr. Jesse Milliken's wife was also maiden-named West.


Of particular interest is a letter written in 1942 by Malcolm P. Wallace to Letta Brock Stone, compiler of <u>The West Family Register</u>. Mr. Wallace, an attorney of Celina, Chio, is a descendant of Agness (West) Milliken.

July 22, 1942

Mrs. Letta B. Stone Washington, D. C.

Dear Mrs. Stone:

In order to preserve what little information I have on the West family and put it in the hands of one who perhaps will have use of it or may be called upon for some information regarding this branch of the family, I am giving you the following:



Thus there were <u>four</u> marriages between the Millikens and Wests. In addition to that between George and Agness, their sons James and William Milliken married their first cousins Elsie and Mary (Polly) West, the wives being also first cousins to each other. George Milliken's nephew, Dr. Jesse Milliken, married Anne West, daughter of William West and sister to Elsie West, Jesse being of course a first cousin to James and William Milliken.

All the above data, except <u>dates</u> under William, Leonard and Amos West, mention of Amos himself and the relationship between William and Agness and Leonard West, came from "Genealogies, Milliken, etc." by G. T. Ridlon, pages 476, 480 and 481, which doubtless you have seen.

Now here is my proof or evidence that these four, viz: Agness, William, Leonard and Amos West were sister and brothers. Ridlon (who doubtless obtained his information from William Crewdson, a grandson of Agness West who "spent much of his youth" in her home), says in a footnote at page 476 that, "Agness West had a brother Leonard". Although Ridlon gives no dates of his birth and death, yet I am sure it is the same Leonard as you have at page 394 of the Register. The above footnote undertakes to give his children's names, at least the sons' names. The latter were Amos, Fielding and James, and it further states that James Milliken and William Milliken married two of his daughters and that there were five daughters altogether. I believe that Ridlon is incorrect in stating that William Milliken married a daughter of Leonard. He, or his source of information, probably confused Mary (Polly) West, the daughter of Amos West, with her cousin, of the same name, daughter of Leonard West. My information that the latter had a daughter of that name is based upon a letter of Mrs. J. Marshall Miller (nee Edith Johnson) of Jacksonville, Illinois, whom you mention at page 394 of the Register, who also states that this Mary (Polly) West married James Herndon. (Could he have been related to the wife of Amos West, Frances Herndon?) Furthermore, information I have from Mrs. William Day Dickinson, of Glasgow, Kentucky, states that Mary (Polly) West, daughter of Amos West, married William Milliken. (They had eleven children - names, etc., appear at page 493 "Genealogies, Milliken, etc.") Thus, at least, Ridlon is corroborated in that he agrees with the Register that Leonard West had a son, Amos West. Ridlon also says in the aforesaid footnote that Agness and Leonard "were brought up by an aunt", and you seem to think this aunt was a "maiden aunt, Miss Lucy Fike", (page 394-B of the Register). (Therefore their mother's family name was Fike.) I believe then, we may accept as fact that Leonard, who was only about two years older, was Agness' brother.

Then how do we know William was their brother? Now if Leonard and Agness were full brother and sister, and we can establish that William was a brother to either of them, then he would be a brother to the other, of course. We might as well include Amos West in this too! He married April 3, 1791 (I have no date of birth) so he must have been born not later than 1773 - probably sooner, say about 1770 or 1765. Therefore, all four of them were born close enough together but not too close - to have been in the same family! Again referring to Ridlon's book we find (page 481) that it is definitely stated that William Milliken "M. Aug. 10, 1808, Polly West, his first cousin". We saw above that she was Amos West's daughter (instead of William's) and so, since William Milliken was a son of Agness West and George Milliken (Ridlon, page 481), this would make Amos a brother to Agness and Leonard. Of course, if she were his "first cousin", whoever was her father, either William or Amos, would be a brother to Agness West and Leonard West. The same author, Ridlon, also says (page 481) that James Milliken, another son of Agness West and George Milliken (page 481) "M. Elsie West, daughter of William West". This is partly (I don't like to be too positive) corroborated by the Register (page 262) wherein it is stated he, William West, lived "with James Milliken in Simpson County, Kentucky". He lived to be 90 years old and it

would be only natural or ordinary for him to live his last years with his daughter and son-in-law, James Milliken. This sheds no light upon the kinship of Amos, William, Agness and Leonard, of course, but does indicate proximity. A Mrs. Desha Milliken, D.A.R. (Lineage Book 135-127), also traces her descent from William West, through Elsie West, his daughter, and James Milliken's wife.

Also from Jillson's "Land Grants in Kentucky" we find that <u>both</u> Leonard West and William West received a grant of land "West of the Tennessee River". Now Calloway County, Kentucky, is "West of the Tennessee River", and you will recall that it was in this County that Leonard West lived when he applied for his pension (see Register, page 394). A check of the records on these grants in the office of the Secretary of State, Frankfort, Kentucky, shows they were issued the <u>same</u> day, January 3, 1825.

Likewise, we find from the same sources that <u>both</u> Leonard West and Amos West received grants of land "South of the Green River" in Kentucky, the former November 5, 1801, and the latter May 28, 1797, about  $4\frac{1}{2}$  years later. Simpson County, Kentucky, where they both undoubtedly lived (Register, pages 262 and 394) at one time, is in the region "South of the Green River". Also one James West received a grant in the latter region. He may have been William's son since he had a son, James (1772-1844), but so did Leonard (Ridlon, page 476).

You will also note that the name "Leonard" appears once or twice in the descendants of the William West mentioned at page 261 of the Register. Also, as noted above, Leonard had a son named Amos - page 394 of the Register. Furthermore, the names "Leonard" and "Amos" appear 8 or 9 times among the Millikens (Ridlon's book), descendants of George Milliken and Agness West, and there was among them a "William West Milliken" and an "Amos West Milliken" - the latter an uncle of mine.

Mrs. Miller, above referred to, also says her cousin, Mrs. R. L. Cowherd, formerly of Bengal, Kentucky, later of 1820 Ingleside Terrace, Washington, D. C., has told her that their great-grandfather, Leonard West, had a brother William West, also a soldier in the Revolutionary War and whose descendants also lived in Simpson County, Kentucky.

Therefore, from all the above, there is very little doubt that these four were sister and brothers.

Since Ridlon's book gives the descendants of Agness West, and the West name stopped with her anyway, I will not give any of these names other than the above-named, but refer to it only for her descendants. However, I have found a few of the descendants of William, Leonard and Amos West and will set them forth for the reasons stated in the beginning of this letter. You may already have much or all of this data - but it doesn't appear in your book, except as noted hereafter.

# Descendants of William West (1752-1842) (Biography - page 261, Register)

- 3. James West, b. Aug. 27, 1772 (above from Register, page 262)

- 4. Elsie West, daughter of William West, married James Milliken in 1805 about the time the family moved to Kentucky. They settled five miles West of Franklin, Simpson County, Kentucky. The plantation was situated on the "Springfield Road" between Franklin, Kentucky, and the Tennessee State line. She was a "tall, dignified old lady with strongly marked face". They had four children (Ridlon "Genealogies Milliken, etc.", page 481 for descendants see same).
- 5. Annie West, daughter of William West, married Dr. Jesse Milliken, a physician and a first cousin to the above James Milliken. Their family was raised in Orange County, North Carolina. They moved to Calloway County, Kentucky, about the year 1817 and in 1825 established a permanent home in Simpson County, Kentucky. There were eight children. She died in Simpson County, Kentucky, in 1848 and was buried on their farm. (Same page 480 also descendants.)

- 1. Fielding Bradford West, son of Leonard West, was born October 9, 1799. He married Mary G. McMurry February 22, 1820. She was born in 1793, the third daughter of John McMurry (b. 1752, Ireland, d. Nov. 7, 1832, Bradfordville, Kentucky) and wife, Elizabeth Bomin (b. 1764, d. 1844, buried Colony, Knox County, Mo.). His wife died in 1853. They were the parents of:
  - Morgan Leonard West
     (He married twice a son, Mayor West, died 1900 in Colorado, and Florence West, of Long Beach, California, grand-daughter of Fielding, was probably Morgan Leonard's daughter.)
  - 2. Mary Elizabeth West (She married Sam Hecker of Marion County, Kentucky, and died Pueblo, Colorado.)

- 3. Miranda West
   (She was married died sometime after 1904 in Franklin
   County, Kentucky.)
- 4. Emily Margaret West (She was married.)

The following was copied from supplemental page 394-B, which was added by Letta Brock Stone to the copy of <u>The West Family Register</u> purchased from her in 1942 by Malcolm P. Wallace:

Richard West seems the most likely parent of Agness and Leonard West. The latter in his application for a pension says definitely that he was born in Granville County, North Carolina in 1760. Agness West was born in 1762. Richard West was in this county on those dates, and lived next to John Fike. He also sold land in 1764 to Malachi Fike. The tradition is that Leonard West was accompanied to Kentucky by his maiden aunt, Miss Lucy Fike. . . . Agness West was said to have been reared by an aunt in Virginia and George Milliken is said to have come from Orange County, North Carolina to marry her.

The following records may substantiate the tradition that Leonard West was accompanied to Kentucky by his maiden aunt, Miss Lucy Fike. In any case, there can be no doubt that a Lucy Fike resided in Logan County, Kentucky, where numerous records of Leonard West may be found:

1799 - Oct. 1 - 100 acres on Red River in Logan County were surveyed for Lucy Fike. 1 Amos West and Leonard West were chain carriers for the survey. 2

1800 - Lucy Fike was taxed in Logan County. 3

- 1804 Apr. 3 30 acres on Red River in Logan County were surveyed for Lucy Fike. 1
- 1805 June 18 In a survey made for Amos West (66 acres on Red River in Logan County), Lucy Fike's land was mentioned.<sup>2</sup>
- 1805 June 19 In a survey made for Amos West (25 acres on Red River in Logan County), Lucy Fike's land was mentioned.
- 1812 Mar. 16 The sum of \$50 was paid to Lucy Fike "on account of a note given her by James West and Matthew West."

Pension Application - William West<sup>5</sup>

State of Tennessee )
August Term County Court 1832
Robertson County )

On this 16th day of August 1832 personally appeared before the Court of Pleas & Quarter Sessions of the County of Robertson & State aforesaid, William West a resident of the County of Robertson & State of Tennessee aged eighty years, he being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the provisions made by the Act of Congress passed June 7, 1832. That he doth depose & say that he entered the service of the United States under the following named officers and served as herein stated, Col. John Litterall, Major John Griffis, Captain William Douglas, and that he entered the service in the month of April 1781 and that he left the service in the month of July 1781 was a volunteer for three months and served the whole time - was in a scrimmage party at the battle that was fought at Linlys Mill where Col. John Litterall was killed and that he resided at the time he entered the service in the State of North Carolina Chatham County, was marched through different parts of the State of North Carolina

routing of the Tories though never left it. I was acquainted with General Butler of the Militia. The company to which I was attached was commanded by Captain William Gibson, Captain Abram Allen, Capt. William Jones & others which I have forgot & in July 1781 I got a discharge which I have lost after first serving out the three months which I volunteered for.

In the month of July? 1781 & which was the latter part of sd. month I again entered the service when I was drafted for three months service under the following named officers to wit. Col. John Mayburn, Major Roger Griffis, Captain Tavender? Nash, Lieutenant John Foshee - was marched immediately into service in search of the Tories - served from that time until after Genl. Corn Wallace was taken, which was a ---or more than the time? for which I was drafted and a short time after Corn Wallace was taken I got another discharge which I have also lost. I was at the time I was drafted a citizen of the State of North Carolina. Chatham County. I was marched through different parts of the State but was never marched out of it. I was acquainted with following named officers of the regular army - Col. Robert Mayburn, Col. Chrysman, Maj Edward Douglas, Capt. Chrysman, Genl. Morgan, and Genl. Green was the general of the same, but Genl. Green had the command of the regular Army - that was in the State of North Carolina I think at that time.

I hereby relinquish every claim to a pension or annuity except the present and declares his name is not on the pension roll of the agency of any state.

Sworn to and subscribed the day & year aforesaid.

Pension Application - Leonard West<sup>1</sup>

On this twenty-third of October 1832, personally appeared before Rezin Davidge, Judge of the Calloway County Court, commonwealth of Kentucky, Leonard West, a resident of the aforesaid county and commonwealth, aged seventy-two years and two months who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the aforesaid benefits of pension.

That he entered the service of the United States and served under the following named officers.

He states that he entered the fall of 1780 the month or day not being

recollected he was a resident of Lincoln County, North Carolina, and during the fall he volunteered and went out against the Torries who at that time were troublesome.

That he went out for three months and under Captain Shorkey.

That he continued the full three months and was engaged during this time in quelling the Torries and the greater part of said service was rendered in the county of Burke, State of North Carolina.

He states that there were no other superior officers over him at the time. He would further state that he was in no general engagement with the Torries but was frequently in skirmishes.

He states that he furnished his own horse and that he knows of no person living he could prove his service nor does he recollect having received any written discharge and if he did he has lost it.

He would now state that after his discharge from the three months in the spring of 1781 he joined the company of Captain Godrey Adams in the state of North Carolina and that he marched with his said company to Camden in the state of South Carolina where he joined the army of General Sumpter. That after marching to Camden, Captain Adams was carried as Supernumerary officer and he was attached then to the company of Captain Francis More in the Regiment commanded by Colonel Charles Middleton and served in said company for ten months.

After serving out said term he was discharged at Four Hole Bridge about forty miles from Charleston.

He cannot be positive it was in February or March 1782.

He was in the Battle of Juniper Springs and in no other battle.

The army to which he belonged was designated as the Army of General Sumpter, State Troops of South Carolina.

He states that for proof of his last term he knows of no person by whom he can establish same except by the evidence of Joshua Murray whose affidavit is made part of this declaration.

He served in the army of the Revolution term of thirteen months. He was born on the twelfth of August 1760 in Granville County, North Carolina as recorded by his fathers Bible but does not know whereabouts of same at present time.

He states he lived in Lincoln County, North Carolina when first called into service, then from North Carolina to Sumner County, Tennessee, and resided here for three years, then to Logan County, Kentucky, for thirty-five years and then to Calloway County, Kentucky where he has lived ever since.

He has no documentary evidence as to his service or his being a soldier of the Revolution except the foregoing declaration and knows of no living person whom he could procure for the court.

For the three month term he thinks he received no discharge and has already stated names of the officers particularly recollected.

He is known to the following named persons residing in his neighborhood: James Martin, H. Milliken, E. Heath, Edmund and William Curd, Henry McCurad.

He hereby relinquishes every claim except the present one to a pension and states that his name is not on the pension role of any agency of any state whatever.

- Sept. 2 200 acres on Little Whipperwill were surveyed for Amos West.

grant, see item dated May 28, 1797.) Chain carriers were Leonard West and Elisha Herndon.

  - July 8 "Amos West's corner" was mentioned in the description in a deed between Hiram Halcomb, his wife "Esabala," and William B. Milspaugh. 7

Hiram Halcomb married Isabella, daughter of Amos and Frances (Herndon) West, on January 18, 1813.8

May the 6th AD 1819. I Amos West Being at this time in a Low State of health but in intire Strength of mind do feell it injoind on on me to make this my Last will and Testament (Viz) I do here will to my beloved wife Anne one negro Girl caled Charlotte during hir life or widowhood also the the third of the Land whereon I now live Including the house &c agreable to a true estimate of value also one third of the Stock and &c which is not hereafter willd -- I also will to my Daughter polly Millikin one negroe Girl called Harrott also I will to my Daughter Isabel Holkem one negro Girl call'd Clarion also I will to my Daughter Agness one negro Girl called Nancy & one Sorrel mare which is now called Her's one Saddle & Bridle which is to be paid out of my estate one Cow and Calf one ewe & Lamb one feather bed & furniture Also I do will to my Son Leonard West Ninety Seven acres of Land where he has now Improved and agreable to the lines laid off to him also one bed and furniture -- I also will to my son James West one horse worth Sixty Dollars one Saddle and bridle one feather bed & furniture one negroe boy call'd Carry I also will to my Son Richard all the home tract & twelve & a half acre extended in the name of Charles Vickery together with the third of the Land I alot to my wife Anne at her death or widowhood also my negroe man George I alot to work for the Support of my present wife & two sons James & Richard During her life or widowhood --I also intend that Richard to pay to James My son Four hundred Dollars when they both become of age all other part or parsel of my estate after the Dec'd of my wife or Widowhood the Remains of my estate together with George shall be equally Divided & I desire James Herndon & William Millikin to Execute this my will day and date above Signd.

# An Act for the relief of the Settlers on the South Side of Green River

### Approved December 21, 17951

WHEREAS a number of people have settled themselves on the vacant land south of Green river, under belief that they were no longer liable to be taken by military warrants, and that the legislature would grant them settlements therefor on paying a moderate price for the same; and it is therefore thought proper to pass an act for that purpose. Therefore,

Section 1. <u>BE it enacted by the General Assembly</u>, That every house keeper or other free person above the age of twenty-one years, who shall have actually settled himself or herself on any land within that boundary, set apart for the said officers and soldiers on the south side of Green river, or any other vacant land within this state, which shall not have been previously taken by a military warrant, on or before the first day of January next, and shall actually reside thereon at that time, shall be entitled to hold any quantity of such land not exceeding two hundred acres including such settlement.

<u>Provided</u>, they shall not include any salt lick, or any body of ore; that he or she shall on or before the first day of August next, make an entry thereof in the office of the surveyor of the county where the land lies, and pay for the same according to the directions and provisions of this act. And for the purpose of ascertaining who shall be entitled to land under this act.

Sec. 2. Be it further enacted, That three persons shall be appointed who shall have power and authority to hear and determine the right of settlements under this act, at a court to be by them held at a court house in the counties of Logan and Green, on the first day of June and July, and then continue by adjournment for the term of fifteen days at each place, if the business should require it; any person claiming a settlement right under this act shall before the said fifteenth day of July, lay in the same before the commissioners and have their or his witnesses ready to support his or her claim, and if the said court shall be of the opinion that the said claimant under this act is entitled to the same, they shall cause it to be located, specially describing the boundaries, and certify the same to the surveyor of the county where the lands lie, who shall make an entry of the same in a well bound book kept for that purpose, and shall thereupon file away the certificate as his voucher, . . .

# An Act to Amend the Act, Entitled "An Act for Settling and Improving the Vacant Lands of This Commonwealth"

## Approved December 19, 1801

WHEREAS the act passed at the last session of the general assembly of this commonwealth, for settling and improving the vacant lands of this commonwealth, hath in many respects been found impolitic and unjust:

- 1. Be it therefore enacted by the General Assembly, that where two hundred acres of land, or any less quantity, as the case may be, may have been located by a person holding and actually residing upon two hundred acres, or a less quantity, obtained under any former law granting lands to settlers south of Green river, he, she or they shall not hereafter be obliged to settle and reside upon the lands so located; but shall have the same privileges and right as those who locate, settle and reside upon four hundred acres: Provided, that no settlement hereafter made shall interfere or affect any claim as aforesaid on account of the same not being settled on before granting such claim.
- 2. And be it further enacted, that the eighth section of the above recited act is hereby repealed, except so much as relates to salt licks and salt springs; and two years from the passage of this law be allowed all persons who have or may obtain certificates by virtue of the said act to obtain warrants in the manner therein directed, paying 5 per cent interest per annum from the time the money became due, or hereafter becomes due agreeable to said act.
- 3. And be it further enacted, that persons who have actually obtained certificates ---- for lands under the authority of any law for granting lands to settlers south of Green river, and who has located the same, shall not be at liberty to relinquish the same and locate and hold it under the above recited act.
- 4. And be it further enacted, that as soon as any person shall have obtained his warrant as aforesaid, he may proceed immediately thereafter to survey the land so appropriated, and the patent shall issue and the land be completely vested without further limitation.
- 5. And be it further enacted, that no claims granted under any law passed prior to the year 1800, for granting relief to settlers south of Green river, where the same be surveyed and a platt and certificate thereof returned to the register's office, shall be . . . This act shall commence and be in force from and after the passage thereof.
