### **EXTRACTS FROM RECORDS.**

1863, April 9.—Commenced to form company.

May 6.—A squad of twelve boys dug poke-root to earn money to buy uniforms. May 9.—A squad of boys went after Indian poke-root.

May 14.—A petition was made to the trustees of the academy, wishing "that they would decide and send in their decision respecting the muskets." June 3.—The Captain received from Mr. D. W. Sanborn an order for the guns, which have been purchased by the trustees for the company. The guns arrived in the afternoon, to the number of thirty-three; three guns to be sent by express.

June 6.—A subscription paper was sent out to raise money for the uniforms. June 19.—Company uniforms were received. June 20.—Drilled in the afternoon in uniform. The company were reviewed by Mr. Sanborn.

June 26.—The company escorted, or helped escort, the "Woburn Mechanic Phalanx" (nine months' troops) in Woburn. First appearance on the public streets as an escort.

The names of those who paraded June 26, 1863, to receive the "Woburn Mechanic Phalanx," were:

The above, with the exception of Marcellus H. Allen (uniformed by himself) and Henry L. J. Warren (without uniform), were furnished with uniforms June 19, 1863; under J. P. Tyler's bill, No. 1.

General Orders, No. 5, June 10, 1863, "Each soldier who carries a gun is hereby requested to clean his bayonet (if rusty) and return it at the next drill that he is present."

General Orders, No. 6, June 19, 1863. "Each soldier must have his face and hands clean when he appears to escort the *Phalanx*. Also his hair neatly brushed, shoes well blacked and polished, and in full uniform. And remember that on the march there must be no talking in the ranks, and no looking

around, but keep the head to the front, except in those movements in which the head is turned. And keep strict attention to orders.”

Orders previous to this date were :

General Orders, No. 1, April 15, 1863. “ When the line is formed for drill, all soldiers when they form in line must remain there till otherwise ordered, and no talking.”

General Orders, No. 2. “ No soldier is to leave the ranks without the permission of a commissioned officer.”

General Orders, No. 3. “ No soldier or soldiers, or any other person, is allowed to beat false signals on the drum. Also each soldier must salute his superior officer or officers.”

Sept. 2.—Company paraded in the afternoon in full uniform. A constitution and by-laws for the company were adopted Sept. 2, 1863. The constitution, after a preamble, provides for a company of not more than 47 members, officered by the principal of the academy, 1 captain, 1 first lieutenant, 1 second lieutenant, 1 orderly sergeant, 1 second sergeant, 1 color sergeant, 4 corporals, 4 musicians and 31 privates. Also a clerk, a treasurer, 1 armorer and a standing committee of four persons, whose duties were to receive all applications for membership. The by-laws treat of the withdrawal of members, absentees, visitors at meetings, and other subjects.

Those furnished with uniforms on Tyler’s bill, No.

2, Aug. 26, 1863, were A. E. Bodwell, J. D. Melindy, E. W. Sawyer and S. B. Sewall, privates.

Sept. 11.—Col. Clark came to see the company.

Nov. 3.—Company received new muskets, belts and bayonet-scabbards.

Nov. 20.—Drilled before the trustees. Col. Clark was up. Nov. 23.—Exhibition in the evening. Company drilled at its close.

1864, Feb. 26.—The school had an exhibition for the benefit of the company in Lyceum Hall, consisting of declamations, dialogues, music by the Woburn Brass Band, and the company drill—including a portion of the manual of arms—the number of soldiers present being twenty. The bayonet drill came before the manual, and was quite well done—the number of soldiers present in this drill being thirteen or fourteen. Col. Clark was drill-master. The exhibition was quite successful.

March 4.—Sixteen new muskets arrived at the academy.

April 9.—The company has been formed one year. During which time the company has had 77 members. Of whom 46 have been discharged, and 7 have re-enlisted. Three have joined the army and one the navy. During the year there have been 120 drills of the company; and, besides the principal of the academy, there have been 2 military instructors, 1 captain, 2 first and 3 second lieutenants, 6 first (or orderly) sergeants, 5 second sergeants, 3 color ser-

geants, 3 first, 6 second, 5 third and 4 fourth corporals. Also the trustees of the academy have furnished the company with 84 muskets and bayonets, 48 belts and 48 bayonet-scabbards. The company provided themselves with uniforms, and two exhibitions have been held for the benefit of the company.

Aug. 4.—George R. Smith died; he was formerly a member of the company.

Sept. 8.—Private Blank was discharged by his mother's request. A valuable feature of the "quarter-master's book" is a list of the "Names of those persons who have ever been uniformed in the company," to Sept. 9, 1864, each article of uniform being carefully accounted for. This book contained the "treasurer's department" of the corps, which was organized for the purpose of paying for the uniforms, all of which were paid for by Sept. 12, 1864, with a balance of forty-five cents remaining in the treasury.

The proceedings of a council of administration held at this period here demand our attention, as follows:

"A record of the proceedings of a council of administration, W. C., held at the house of Lieut. Marion. The council consisting of Capt. W. R. Cutter and Lieut. Marion, who were the only officers able to be present." Promotions were made by the council, and articles were agreed on to the effect, that recruits joining the company, who do not belong

to the school, are to be mustered in, H. J. L. Bodwell to act as mustering officer. No recruit to be less than twelve years old, or under four feet, seven inches tall (drummers excepted). A roll to be kept of recruits mustered in. Proceedings signed by Capt. W. R. Cutter, president, and Lieut. W. Marion, recorder, Burlington, Sept. 1, 1864.

Another council of administration, held at the house of Capt. W. R. Cutter, Sept. 10, 1864, consisted of Capt. Cutter, president, and Orderly Sergeant S. F. Trull, recorder. "The council agreed to pay the sum of five cents to any member of the company bringing a new recruit." Ten the number required. The money to be raised by the members of the council, consisting, when full, of the four highest company officers. The money was to be immediately:—[for some unexplained reason this sentence was thus expressed.]

Oct. 7.—A meeting was held to consider about the company's doing escort duty at the return of Co. F, 22d Mass. Oct. 8.—It was voted to turn out on Monday. The company drilled outdoors.

Oct. 10.—Company turned out to receive the 22d regiment. The company marched to the common at 1.30 P.M. Then marched to the railroad station on Fowle Street. The procession consisted of a cavalcade; Woburn Brass Band; Woburn State Guards, commanded by Capt. T. J. Pierce; Warren Cadets, commanded by Capt. W. R. Cutter; returned soldiers



and citizens. A. J. Parker, chief marshal. The procession returned over Academy Hill to Pleasant Street, up Pleasant Street to Lyceum Hall, where there were exercises, consisting of speeches by John Cummings, Jr., Esq., and Rev. Eli Fay, with music by the band. The company then partook of a collation furnished by the "State Guards." After which they marched to the academy, where they were dismissed.

Converse; acting 3d corp., Private Skinner; acting 4th corp., Private Bodwell; musicians, F. O. Lyman, C. Parker, C. H. Bean; privates, J. F. Barrett, S. Butters, F. A. Buckman, D. P. Briggs, A. C. Champney, E. Collamore, W. F. Davis, J. T. Davis, A. Davis, C. T. Dearborn, W. M. Flaherty, S. Foster, J. A. Griffin, C. Hale, W. Henchy, J. Kimball, W. C. Kenny, T. Merriam, W. Marion, F. Marion, H. Preparations were now made by the company for

the 7th of Nov., or the day following the return of Co. G, 5th Mass., and a few pages of the "quarter-master's book" devoted to the recruiting service contain the signatures of a number of the members who re-enlisted at this period.

The constitution was altered on Oct. 15, 1864, so that the company should consist of 59 members. Instead of 3 sergeants, to be 6, and 39 privates instead of 31. Also 2 markers or guide-boys. The clerk and treasurer to be hereafter the orderly sergeant; and 2 armorers instead of 1, and 2 armorer's assistants. Under this regulation, Sergts. Turner and Melindy were appointed armorers, and Privates Seaver and Skelton assistant-armorers. The standing committee was dropped.

Nov. 5.—Company drilled in the afternoon. Marched down to Winchester.

Nov. 7.—The company drilled at 8 o'clock; and 1 and 10 P.M.

Nov. 8.—Company came home this morning. The W.C. turned out. [Company referred to—Co. G, 5th Mass. (one hundred day's men).]

Nov. 12.—The company marched to West Cambridge [now Arlington]. The company assembled at half past 12 o'clock at the armory. The company being formed, they marched at 1 o'clock, nearly, through Warren, Sturgis and Cambridge Streets to West Cambridge, where they partook of a collation provided by Mr. Samuel A. Fowle. After drilling

sometime, they marched home. "Each boy did his duty." On this date Private William M. Flaherty was discharged, by his own request, on account of his family moving to Boston—"a good soldier."

Those who marched to West Cambridge were: Capt. Cutter; 2d Lieut. Trull; 1st Sergt. Butler; 2nd Sergt. Turner; 3d Sergt. Ellis; 4th Sergt. Melindy; 5th Sergt. Henchy; Color Sergt. Bodwell; Corps. Collamore, Buckman, Rolph; musicians, Lyman and Bean; privates, J. F. Barrett, W. J. Buckman, W. H. Claffy, J. T. Davis, A. Davis, C. F. Hale, H. W. Lull, T. G. Merriam, W. C. Marion, F. Marion, H. Nichols, C. F. Page, B. F. Parker, F. B. Pierce, J. J. Skinner, S. Skelton, J. T. Trull, A. W. Vye, G. E. Waters, A. H. Willoughby, W. W. Ellis, (guide-boy), R. McDonald, (guide boy), S. Butters. 36. Among the absentees was William F. Davis, private, who was "wounded in the hand," and thus unable to carry his musket.

Nov. 14.—The muskets, &c., were cleaned. They were quite rusty on account of the storm which overtook the company while marching to West Cambridge, on Saturday last. The company to-day has 48 members, 36 of whom went to West Cambridge. The muskets and accoutrements were all in good order, except the loss of one hammer, several screws, and one musket unfit for service, with two scabbards damaged. Nov. 16.—Corp. Charles W. Rolph was discharged on account of his leaving the town—"a

good soldier." Nov. 16.—It was proposed to form the company into a battalion of two companies, and a meeting was appointed to consider it. Nov. 19.—Privates Skelton and Hale were discharged on account of their being obliged to "tar trees." The company was this day changed to a battalion.

The first records were carefully kept and minutely indexed. The clerks were H. J. L. Bodwell, F. G. Richardson, 1st Sergt. J. W. Long, S. H. Dow, C. W. Converse, and 1st Sergt. S. F. Trull. The persons named as military instructors of the company were Kendall L. Flint, Col. George Clark, Jr., and William Miller.

The battalion book of the independent battalion of Warren Cadets commences Nov. 19, 1864, and ends with the disbandment of the organization, April 29, 1865.

1864, Nov. 19.—The battalion was organized with 1 major, 2 captains, 1 adjutant, 4 lieutenants, 1 sergeant-major, 1 quarter-master sergeant, 5 sergeants, 4 corporals, 4 or more musicians, and 42 privates.

"A record of the proceedings of a meeting of the Warren Cadets to consider and organize a battalion. Time 2 P.M. The meeting was called to order by Capt. Cutter, who acted as chairman, who, after stating the object of the meeting, put to vote the plan of forming a battalion, and it was voted unanimously to form a battalion of two companies, commanded by a major, &c."

The quarter-master sergeant's "clothing account" gives the uniform of the battalion officers: major, 1 dress-coat, 1 cap and trimmings, 1 pair of pants with stripes, 1 pair of shoulder-straps; other commissioned officers, each, 1 jacket, 1 cap and trimmings, 1 pair of pants with stripes, 1 pair of shoulder-straps; non-commissioned officers, generally, 1 jacket, 1 cap, 1 pair of pants, 1 pair of chevrons each.

Nov. 21.—Lieut. Ellis purchased shoulder-straps for several officers.

Nov. 23.—A general order was issued for each company to have a gun-rack with 24 muskets assigned to it, the company commander to be responsible, &c. Nov. 26.—Drilled a short time, and then marched to a field near Horn-Pond Mountain to learn guard-duty.

Dec. 1.—The officers adjourned to the boarding-place of Mr. Sanborn, and asked him to approve of the formation of a battalion. They received a satisfactory answer. Dec. 2.—The weather was dull and rainy. The battalion having made preparations to bivouac for the day at Camp Pierce, not wishing to be disappointed, about thirty of them bivouacked acting as one company. Three prisoners for running guard were sentenced. One reduced to the ranks—afterwards discharged at his own request. The two others discharged. But afterwards their sentence was commuted to be under arrest till their case was further considered. Dec. 5.—Officers met at Lieut. Ellis's. Dec. 9.—Preparations made for encamping.

The weather and the parents prevented. The boys remained in the hall drilling. Dec. 9.—Articles took effect for the government of the battalion, and an order was passed about “veterans.”

1865, Jan. 30.—A bayonet class preparing for an exhibition were: W. F. Davis, sergt.; S. Skelton, corp.; A. H. Willoughby, C. F. Hale, J. F. Barrett, F. B. Pierce, privates. Feb. 2.—The squad chosen for the exhibition drilled. Privates F. Richardson, C. E. Marion, F. J. Phillips, A. Tufts, A. C. Winn, H. Andrews, G. W. Butters, N. Eaton, C. Leathe, chosen for their “soldierly conduct, behavior and size,” to be a platoon of a company on that occasion, the remaining platoon to be taken from the other members of the battalion.

Feb. 4.—The class who have the bayonet exercise are well established in the drill, so far as the motions are concerned. “But it cannot be expected they can fence well, on account of the short time they have drilled.” Feb. 10.—Examination-day. The school drilled.

Mar. 4.—Preparations made by the battalion to march to the town of Lexington; a small number met at the hall at 9 o'clock, A.M. The weather being stormy they resolved to postpone the march. After drilling a short time they dispersed.

Mar. 11.—A march to Lexington was accomplished by a portion of the battalion. Namely, the major commanding; caps. Marion, Trull; adjt. Bodwell;

lieuts. Butler, Ellis, Henchy, Turner; sergts. Davis, Converse, Willoughby; corps. Skelton, Marion; drummers, Augustus Davis, E. W. Sawyer (volunteer); privates, J. F. Barrett, W. H. Claffy, H. Nichols, W. C. Marion, F. B. Pierce, Warren N. Blake, Edward W. Manning, John Ryan, and Herbert Woodman (volunteer) of Co. A, and C. F. Hale, Clarence Leathe, Frank Leathe, Charles S. Lowell, J. A. Griffin, and J. W. Marrinan of Co. B. In all 30. These assembled at the armory at 9 A.M., and at 9.30 the march commenced through Warren, Pleasant and Lexington Streets to Lexington Common, where a halt was made at 12 M. At 2.30 the detachment formed, marched to Durenvile and thence to the armory, and after a drill dispersed. The reason why more were not present, was "that some boys were afraid of the mud." Mar. 13.—The officers met at 7 P.M., pursuant to the special orders nos. 1 to 7, of March, 1865. At this meeting it was resolved "to go to Medford, if we can raise a good crowd."

Mar. 25.—A march was made to the town of Medford. The battalion started from the armory at 11 o'clock. Those who marched were: W. R. Cutter, major; S. F. Trull, capt. Co. B; H. J. L. Bodwell, adjt.; W. T. Butler, lieut. Co. A, acting captain; lieuts. Ellis and Henchy of B, and Turner of A; sergt. major Buckman; sergt. Sawyer, acting drummer *pro tem.*; sergt. Buckman, Co. B; sergt. Wil-

loughby, Co. B, acting orderly sergeant of Co. A; corp. Claffy. The privates were: Co. B, J. T. Davis, transferred to Co. A, *pro tem.*; Neal, Waters, McDonald, Hale, Bowers, Lull; McConologue, transferred to Co. A, *pro tem.*; Hadley, transferred to Co. A, *pro tem.*; Griffin, Lowell, Marrinan, Smith, Flagg, Jameson. Co. A, Kenny, Barrett; Vye, acting color-sergeant, *pro tem.*; Wilson, Buckley, George Pierce, Mulheron, Shehan, Rooney, Finn. Bradley; Caldwell, acting marker, *pro tem.* Total, 39. The battalion marched through Warren Street to Winchester. Thence to Medford. Through Medford to where "Camp 'Clellan" was situated, on the street to Somerville, where a halt was made at 1 o'clock, P.M. At 4 P.M. the corps assembled, and began their march for home.

After marching to the centre of the town, they were invited into an eating-saloon, where they received a collation. The name of the gentleman, who so kindly gave this, was Mr. David Simpson. A crowd of Medford boys having assembled outside, some one of them struck Lieut. Ellis with a stick on the shoulder as our corps passed out of the door. As we marched we were followed, and volleys of stones were thrown at us. We marched to the Unitarian Church (in Medford) and halted, while stones were thrown among us. We faced about and charged, and the Medford boys retreated. At the command "halt," the battalion reformed, and the march was



continued. Private Hadley, of Co. A, was struck with a stone on his head. Private Pierce, of same company, was wounded in the shoulder. Sergeant Buckman, of Co. B, was struck in the hand with a stone. The march continued through Winchester to Woburn, to the armory, where the boys dispersed.

Mar. 27.—The battalion numbers 69 members.

Mar. 31.—Mr. D. W. Sanborn resigned. Apr. 1.—A march was made to the town of South Reading [now Wakefield]. The corps passed through the town of Stoneham. At South Reading a collation was provided for the battalion by Dr. S. O. Richardson. The doctor was thanked, and the battalion gave him three cheers. About 4 P.M. the battalion marched home. "All things passed off well, considering the many raw recruits." Those who marched were: major Cutter; capt. Trull and Butler; lieuts. Ellis, Turner and Henchy; adjt. Bodwell; sergt. maj. Buckman; Q. M. sergt. Barrett; sergts. Davis, Willoughby, Skelton; corps. Eaton, Claffy; musicians, Davis, Neal; volunteer marker, Newcomb; Co. A, privates, Arthur Davis, Kenny, Nichols, Weston, Buckley, Manning, Swan, Ryan, Mulheron, Shehan, Bradley, Finn, Rooney, Chase, King, Murphy, Oliver, Law, Brodeur, Baird, O'Connor, Clark; Co. B, privates, J. Davis, McDonald, Hale, Ellis, Griffin, Marrinan, Daly, Ferren, Doorley, Trull, Wellman. 50.

Apr. 3.—The battalion marched through the town

in the evening. The "Woburn State Guards" marched also. We numbered about 50.

Apr. 9.—W. C. formed two years. Apr. 10.—Battalion marched on the street in the evening, on account of the great victory by Lt. Gen. Grant over Gen. Lee. Stormy weather, but we had a good attendance. Apr. 19.—Battalion, numbering 29, marched as one company to the town of Winchester in the evening. The major, capt. Butler and lieut. Turner of Co. A, and lieut. Henchy of Co. B, who acted as private, were the only officers present. Apr. 21.—The officers, with the exception of Turner, met at the house of Major Cutter, at 7 P.M. It was resolved to disband the battalion. They resolved, with the exception of the major, to keep their shoulder-straps. To give the battalion a collation of 250 crackers, 2 lbs. of cheese, 1 box of herrings, 10 qts. of cider. To march through the streets of Woburn, Saturday, April 29. Towards the collation Sergt. Barrett and Major Cutter gave 50 cents each; capt. Trull and Butler, lieuts. Henchy and Buckman, and adjt. Bodwell 25 cents each. \$2.25.

1865, Apr. 29.—The battalion made its last march through the streets of Woburn. A collation was served at the hall of the academy. After which the corps disbanded. Those who were present at the last drill were: maj. Cutter; capt. Trull and Butler; adjt. Bodwell; lieuts. Ellis, Turner, Henchy and Buckman; sergt. maj. Buckman; Q. M. sergt. Bar-

rett; musicians, A. Davis, F. O. Lyman, H. E. Neal; Co. A, sergt. Claffy, corp. Eaton, privates Kenny, Vye, F. B. Pierce, Wilson, Blake, Buckley, G. Pierce, Swan, Mulheron, Shehan, Rooney, Clark, John Maxwell, James Maxwell, Phillips, Buxton, Harts-horn; Co. B, sergts. Willoughby and Skelton, corp. Lowell, privates Bodwell, Davis, Perham, Waters, McDonald, Hale, C. Leathe, Bowers, F. Leathe, Lull, McConologue, Hadley, Griffin, Marrinan, Daly, Ferren, Smith, Jameson, Doorley, Wellman, Stag-gles, Foster, Hogan, Newcomb. Total, 59. The battalion property was disposed of by a general order, that all officers and non-commissioned officers keep all uniform jackets, trowsers, caps and shoulder-straps in their possession, for service rendered. McDonald and Ellis, privates, to have each a marker's flag. The adjutant, all company and battalion books. Swords to be returned to the owners. The equipment of the corps was—48 muskets, bayonets, waist-belts and bayonet-scabbards—2 gun-racks—purchased by the trustees of Warren Academy; 1 stand of colors —2 marker's flags—purchased by the corps.

The "quarter-master's book" contains copies of all receipts and all bills for uniforms. A preamble

by the captain states that the accounts of First Lieut. Charles W. Carter, treasurer, being lost, it was deemed advisable to copy those of First Lieuts. Henry E. Smith and William B. Jones, treasurers, with other valuable papers, into a book for preservation, this book to be used for all future accounts.
