PREFACE

There appears to have been some confusion regarding the early Westmoreland records. Perhaps due to a transcript made in 1801 and 1802. This is clearly written and easy to read but uncertain in fact. The abstracts shown here are from the originals which are in miserable condition.

It therefore may be that Major Hallewes' stray cow "Saddleback with a mealy nose" is more authentic than much printed illusion based upon other printed illusion concerning a Washington, a Monroe, a Mason. We are too early for Lee.

The first records of the county may be consulted in the Archives Division of the Virginia State Library in Richmond.



Westmereland County Records. 1653 plus.

The abstracts to follow are taken from 'Deeds, Wills, Patents, etc. 1653-1659. They go as far forward as I can crowd in this volume. This book has a notation in a modern hand, over which is pasted a small label marked 'Journal'. The visable part reads '-- tains a lot of -- Deputions, Deeds, etc., and also a lot of Orders entered in court. These papers were found by me loose, without any back or cover. M. L. Hurt.' Then this:
'Letter:

Deeds, Wills, Patents etc. 1653 to 1659. Pages 1 to 13 or 26 pages in all are lost. C. A. Hoppin, Examiner of Records. Feb 6 1917. See appendix of this volume for possible (not positive) record of some of the lost items. These are from the transcript of 1802 and are not to be relied upon.

- p.13. First part of entry not here. " - of Henry Brook; - southwest upon the land of Capt Baldridge and Mr James Baldridge, Northeast along there land to the place where it first began. The said Land being due unto the said Hercules Bridges by and for the transportation of fower persons into the Colony all whose names are - menconed under the Pattent etc. Given at James Citty under my hand and the Seale of the Colony this 3 of Septem- 1651 William Berkeley".
- p.13. Hercules Bridges assigns above land to Daniel Lisson. 18 Feb 1653/4. Wit: John Dodman Signed Hercules Bridges

 Ack by Bridges and recorded 20 Feb 1653/4.
- p.13. Patent. Jan 1650/1. Sir Wm Berkeley to John Hallowes, Gent. 600 acres in Northumberland Co, on S side Potomack. Adjs Hallowes' Creek, etc. Entry stained and mutilated.
- p 13. John Hallowes of Northumberland Co., Gent., assigns above to John King. 29 July -. Year torn away. Wit: Richard Browne. Abraham Moone and Thomas -.
- pel3. P of As Date worn away. Entry headed " Pitt attur of Mr King his assignm't Mr Dodman". This entry half gone and badly stained. The following words appear "- John Pitt by - lre of attur - the Isle of Wight - Pattent of land unte - forever - from the claime of maner of persons whatsoever In w- whereof I sett my hand the 20th of Feb: 1653 John Pi- Tho Wilsford". 20 Feb 1653 (1653/4). This Assignmt

of John Pitts to Mr Dodman was ack in Court by said Pitts and recorded under the patent, as also the letter of atty of Mr. King to Jno Pitts.

p 13. P of A. 20 Feb 1651/2. Jno King to "My friend Mr John Pitt" to act regarding a patent of land. Signed John King. Wit: Samuel Parker. Recorded 20 Feb 1653/4.

Note: Now right here, before the following abstracts appear, Mr. Fleet plainly understands that they are in contradiction of accepted interpretations. All he can do is to present the record as it appears to him. Please do NOT write 75 letters asking why. To his best count there are 37 errors in the transcript of Mrs. Bernard's letter. It is shown here as best he can. Also the name in the entry is 'Peter Fifepound'. Possibly this is the origin of our good old Virginia name of Flippen. At any event it is positively not 'Peter Phispound' - certainly nobody would like that very much, and it is not true according to this entry.

p.13. Walter Brodhurst of Westmoreland, Gentleman, in consideration that Mr John Hiller has undertaken to seat a plantation of Mrs Anna Bernard's adjoining the said Hiller's plantation. By virtue of advice rec'd by the said Brodhurst from Mrs Bernard, dated 16th Aug 1653, he gives Hiller 100 acres "upon which Peter Fifepound is now seated", out of the land, Dated 20th Feb 1653/4. Signed: Walter Brodhurst. Wit: Paul Simpson, Th Wilsford Acknowledged and recorded 20 Feb 1653/4.

p. 13. Then follows Mrs. Bernard's letter.

"For her much respected friend Mr Walter Brodhurst at his house at Nominy in Potomake river These
Yorke the 16th of August (53)
Noble Sir

I give you many thanks for your care of my business I canot resolve of of my comeing to Potomacke my selfe till the returne of the shipps which makes me desire you wilbe pleased to have this land seated for me I will give a hundred Acres to any honest man forever to seat it. I should be gladd of a good neighbour, but desire this hundred Acres may lay without me on some side of this tract of land and not hindering one seat of land, now lie (ing) betweene me and the River, the prospect of the water will be my pleasure, S'r I shall wholly depend on You for the seating of this land and I am confident you will doe in this for me as for your selfe I love to have what is mine intire so that I may not trespass my neighbour nor he me what charge you are at in my business these lines shall obleige me to pay and your leve and care I shall ever studdy the best way of returning I give Mrs Brodhurst many thanks, for accepting soe poore a token I should be gladd of a good occasion to draw you and Mrs Brodhurst into these parts that I might not onely enjoy your company but pay part of the respect I owe you. my service waites on you both, my daughter Anna Smith presents her service to you both, and Sir I am your

most humble servant Anna Bernard. Sir I must seate this land this year, therefore pray let me have timely notice 20th Feb: 1653 This letter recorded".

p.14. Agreement. John Hiller, gent., acknowledges the 100 acres upon which "Peter Fypound is at present seated" and in his (Hiller's) right to belong to Mrs Anna Bernard of York, "and she by the seating thereof to keepe the title of all that dividend according to her Pattent". He agrees to pay quitrent on the 100 acres, etc. Dated 27 Jan 1653/4. Signed John Hiller. Wit: Jo Rosier. John Dinely. Ack and rec 20 Feb 1653/4.

p.14. Lieut Tho Boys discharges Nathaniel Jones from all debts. 21 Febry 1653/4. Signed "The marke of The Boys". Wit: The Blagg. Rich: Browne. Rec. 20 Feb 1653/4.

p.14. Mortgage. 20 Feb 1653/4. John Knott of Appomattacks mortgages his plantation to The Blagg for 1170 1b tobo of the next crop. Signed "The marke of John Knott". Wit: Sam Mottershed. Daniel - (torn away, shown in transcript of 1802 as 'Daniel Sisson'. This not to be relied upon. Ack and rec 20 Feb 1653/4. (Prob. Daniel Lisson)

p. 14. John Walton, atty of Michael Tinter, discharges John Vaughan of all debts. Date torn away. Recorded 20 Feb 1653/4.

p.14. P of A. 19 Feb 1653/4. Thos Youlle to Wm Hardich to represent him in all causes. Signed Tho Youlle. Wit: Rich: Sturman. Gabriel Odger. Recorded 20 Feb 1653/4.

p.14. "These are to Certifye to whom it may concerne that the bearer hereof Ann Harrison wid' is a freewoman and by Gods assistance is bound to Potomacke river in Maryland about her busines. As witnes my hand this 15th of Aprill 1652 George Stephens.

From my plantacon on the head of Launes Creeke 20 Feb 1653 This Cer't was Recorded".

p.14. "Mr Stephens his Mr Yewell my love remembered unto yeu unknowne lie to Tho Youlle I understand by year letter That Ann Harrison my servant hath contracted her selfe to one Mr Wells for two yeares to serve him which is quite contrary to my express chardge and order for although I gave her a Cer't to pass to Mr Simpson to Potomacke to acquitt her for being taken for a Runaway and see be

stopt in her way at least being gone without her masters consent It did not thereby any way give her liberty to inthraule her self in bondes through the care I had of her to any other for I had tolde her she neither should nor by law could make any contract in any kinde till her first Indenture was expired which said Indenture is not expired till Christmas next come twelve month next ensueing Therefore I doe desire you soe farr forth as I may a stranger to acquaint Mr Paul Simpson of the matter and to require the letter that I sent him by the said Ann Harrison and tell him that my request is that he will preforme my desires to him in that behalfe And I doe by theise presentts order and impower Mr Simpson againe that the said Ann Harrison shall no way Act any thing touching bindeing or obleidgeing her selfe but by his consent according to my former letter to him in that kinde Thus haveing no more at presendt but my love to you and my respects to Mr Simpson I rest Yours to Command Dated this 5th of August 1653. George Stephens 20 Feb: 1653 This letter was Recorded" (1653/4)

p.14. Abstract of Deposition. Richd Browne, aged 35 yrs or th-abts, says Tho Blagg gave a bill of sale of 96 acres to Jno Knott, not then having the patent. When the patent came there was a difference betw it and the bill. Blagg said he had sold Knott 15 acres more than the patent. Whereupon Blagg said he would have the bill before he delivered the patent to Knott. Knott said he would burn the bill as soon as he got home and take the patent. The date is now torn away in the original but the transcript of 1802 shows this deposition as sworn 20 Feb 1653/4.

p.15. Abstract of Deposition. Sworn 20 Feb 1653/4. Wm Freke aged 30 yrs or th-abts. Swears as above. That Knott said he would burn the bill or deliver it to Blagg and would accept the patent.

p.15. Abstract of Deposition. Sworn 20 Feb 1653/4. John Knotts aged 36 yrs or th-abts. Says "That about 2 yeares agee he saw Daniel Lisson deliver a gun to a King of Naniatticoe at Daniels owne house the Indians name goes by the name of Wattle Jaws or Loggerhead This Deponent haveing bene there divers times since hath seen the said gun there and asking the Indian why he did not bring home the gun he answered he had bought it And further saith not. John Knotts his mark".

Abstract of Deposition. Sworn 20 Feb 1653/4. John Addams aged 27 yrs or th-abts. As foregoing. Signed "John Addams his marke".

p.15. Abstract of Deposition. Sworn 20 Feb 1653/4. Wm Umfries aged 25 yrs or th-abts. As foregoing. Signed "Wm Umfreys his marke".

- p.15. Deposition. Wm Freake, aged 30 yrs or th-abts. Says "That he this Deponent goeing with John Walton and others for drincke to be sent for to Hercules Bridgeses sent for two gallons of Brandy He the said Bridges or some by his appointment sent a runlet for 2 gall' of drams which formerly he hath had for a gall' and an half and further saith not" Sworn 20 Feb 1653/4.
- (Note: I am certainly surprised at my old friend Heroules! I just cannot believe it. B.F.)
- p.15. Thos Wilsford files mark for hogs and cattle. Rec. 20 Feb 1653/4.
- p.15. Entry mutilated. Half torn away. It is a bill of Richard Bennett to Tho: Wilsford, gent. for 2000 lb tobo. Dated 20 Feb 1653/4. Signed "The mark of Richard Bennett". Wit: Clauds Mace. The mark of Robert Jones. Paul Simpson. Recorded 2 March 1653/4.
- p.15. Capt George Mason of Westmoreland Co files mark for hogs and cattle. Recorded 20 Feb 1653/4.
- p.15. Deposition. Walter Brodhurst aged 36 or th-abts. Says he was employed by Mr Richd Nicholls, Factor to Mr Haywood, Mercht., to receive tobacco. He was to receive 1 hhd of Henry Lilly to contain 432 lbs tobo, to be delivered at John Armslyes house. That meeting at Mr Spekes with Mr Hallowes and Saml Bonam, Mr Hallowes requested this deponent to return back with him for Bonam was going to Armslyes and would receive the tobo. Within 3 or 4 hours Bonam returned with Lilly to this deponent's house and said "the Tobacco was naught". This deponent said he would have nothing to do with the tobo. Lilly said he had no tobacco anywhere else to pay Nicholls and that he ask Nicholls to forbear with him until next year, which this deponent did. Signed Walter Brodhurst. No date but recorded with items of Feb and Mar 1653/4.
- p.15. P of A. Dated 22 Feb 1653/4. Thomas Cornwaleys of Maryland, Esqr, to "my loveing friend John Hallowes of Nominy in the County of Westmoreland in Virginia Gent" to collect a/cs due in Westmoreland Co. Signed Tho Cornwaleys. Wit: Tho Redby. Wm Withers. Rec March 1653/4.
- p.16. Deposition. Peter Brackett gent, aged 47 yrs or th-abts. Says he went with Richd Walker to John Myles to receive some tobo. Myles said he would pay Walker as soon as he would come to an a/c that he owed him "never a pound". Signe@ Peter Brackett. Sworn in Court 10 Mar. 1653/4.
- p.16. John Dynely of Nominy files his mark for hogs and cattle. Rec. 10 March 1653/4.

p.16. Ino Hallowes acquits Paul Simpson of all debts. 30 March 1654. Wit: Will Hardish. Th Wilsford. Rec. 1 Apl 1654.

p.16. John Knott sells Jno Hiller 2 cows with calves and an old cow with Mr Pope's mark. 2 Apl 1654. Signed John Knott his mark. Wit: Robert Streete his mark. Humphry Jones his mark. Rec 3 Apl 1654

p.16. Indenture. 5 Apl 1654 (this date may be 15th Apl 1654). Between Gyles Brent of Peace in Westm: Co., Esqr of one part and Mary Brent of Peace, sister of the said Gyles, of the other part. Gyles Brent intending "to pass the seas unto England" makes over to his sister his whole personal estate in Va and Md for the use of his wife and children. To educate the children, allow Mary Brent wife of the said Gyles Brent "housercome for her to dwell in", etc., etc. This is a long entry. Signed Giles Brent. Wit: Margaret Brent. Richard Cottsford.

On 17th April 1654 Giles Brent delivered to Mary Brent "all his other servants vist Thomas Hiat. James Marten. John Coleman. John Matthewes

servants vigt Thomas Hiat, James Marten, John Coleman, John Matthewes and Thomas Conapescok". Witnessed by Margaret Brent. Christopher Bowes his mark. Richard Cottsford. Recorded 18 Apl 1654.

p.16. "These Presents to witnes That I Giles Brent of Peace in the County of Northumberland or of Westmorland in Virginia Esqr" sets over to his sister, Mary Brent of Peace, all his land, 768 acres, on W and SW side of the river of Oquio and Potowmock and lying over against the dwelling house of Peace. Also the land 1040 acres called "the rich land" N from Peace for "Fower skore and nineteene years". This land may be purchased from his son Giles Brent or his heirs during his lifetime or after death. Dated 14 Apl 1654. Signed Giles Brent. Wit: Margaret Brent, Christopher Bowes his mark. Edward Parker. Richd Cottsford.

p.17. Giles Brent and Maria Brent his wife of Peace, give their daughter Mary Brent 2 cow calves. This cattle not to be disposed of till she marry or be 20 yrs of age. Tated 15 Apl 1654. Signed Giles Brent. Mari Brent. Wit: Margaret Brent. Marie Brent. Richd Cottsford. Rec 18 Apl 1654.

pel7. "At a Quarter Court held at James Citty the 14th of March 1653
Pres: Richard Bennett Esqr Governor Colo: Wm Claiborne Colo The Pettus
Colo George Ludlow Colo Higginson Colo Freeman Colo Wm Taylor Esqr".
This day Capt Giles Brent petitioned that being seated on S side Petemack
River, bu authority and patent of this Government of Virginia, nevertheless the Lord Baltimore has instructed his Surveyor and Secretary, though
gratis, yet to issue grants for this land, etc.
The Court orders the local Justices and inhabitants to protect Captain

p.17. "An Order of Maryland Court concerning Cap't Brent At a Court held at St Maries the 4th of October 1648 Present Tho corneway'l Esqr Giles Brent Upon the sute of Capt Giles Brent versus Mr Fenwicke for unjust molest-

a'con The Defend't denyeth that any Judgmt hath heretefore passed in this Court And the Pitiffe desired the Govern'r to deliver what he knew concerning this busines who was at that time present in Court Who delivered that after much debate of the cause (and to the best of his rememberance) the Judge delivered there was no more due of the Bill of 2500 now in question then pro rate for the time that he James Cauther (to whom the Bill was first signed) had served And the Defend't being demanded to deliver also what he knew conserning the Bill saith That he heard John Hampton say that he had taken (or some other) this Bill from out of the old Records And the Jury returned their Verdict in writeing vizt Wee finde for the Pitiffe to have discharge for the time James Cauther had to serve And the Govern'r com'anded it to be entered for the Judgem't Concordit cum Record exaint per me The Hatton Secr 22 Aprill 1654 This Ord'r was Recorded.

p.17. Patent. End of entry in the original missing. Date gone. However the transcript of 1802 shows the date of this patent as of 4th May 1653. "Richard Bennett Esqr Governor and Capt Generall " etc., sends greeting in our Lord God everlasting. "Whereas by Articles Dated in James Citty the 12th of March 1651 concluded and signed by the Com'rs appointed by authority of Parl't for the reduceing setling and gouverning of Virginia" etc., etc. Gov. Bennett grants to Capt Giles Brent Esq., 300 acres on Quiough river, WW on land of sd Brent, NW and SW on the main woods. Due for transportation of 6 persons.

End of entry on page 18 which is missing from original book. This patent recorded prior to 24 June 1654.

Pages 18 and 19 missing from original book.

p. 20. Mr Augustine Hull of Westmoreland County files his mark for hogs and cattle. 24 June 1654.

p.20. Nicholas Russell of Westmoreland Co., indebted to Tho Boys 440 lb tebo and to Tho Moss 1200 lb tebo., mortgages his crop to them. 15 July 1654. Signed Nicholas Russell. Wit: Paul Simpson. Th Wilsford. Recorded 15 July 1654.

p.20. Will of Ann Sturman. Dated 22 June 1654. Preb. 21 Aug 1654. "By a Will and Testam't my late husband Thomas Sturman deceased made me sole and whole Executrix and there being no Court since the death of my husband to make a Probate", etc. Weak in body. To son John 2 cows and

l bull, all the hogs "that be at Maryland" except 1 sow to "my Grand childe Thomas Youlle". Other personal property to son John, also half of rights of land due in Maryland, the other half of the rights to son Richard.

To Ann Youle, cattle, "my hatt my bodies and my red coat, my best stockings and my new pare of sheads".

To daughter Elizabeth Hardich, cattle, "my best petticoate and two wastcoates belonging to it".

Weaving linen to be div betw daus Ann Youle and Elizabeth Hardich "excepting a white petticote and white wastcoate which I give to my Grandohilde Ann Youle".

To Grandchild Winefride a yearling.

To "grand child little Betty Hardich" a yearling.

To son Richard cattle at Nominy. Also 2 bills, one from Jno Wood and the other from "olde goodman Tasker", a servant man, crops, goods in the house, etc.

Refers to a suit in Maryland Courts.

"One thousand pounds of Tobco that wilbe overplus of paying my debts I give to my daughter Rosamond wich lives in England".
Wit: Signed "The mke of Ann Sturman".

Proved by oaths of Mr Brodhurst and John Wood.

p. 20. Deposition of John Wood "aged 29 years or thereabouts". Says Ann Sturman made her will and forgot to name exors. She therefore called him and Geo Day and bid them bear witness she wanted her sons John and Richard Sturman as exors. Signed John Wood. Sworn 21st Aug 1654.

p. 20. Deposition of George Day "aged 23 years or thereabouts". Says as foregoing. Signed "Geo: Day, his marke". Sworn 21st Aug 1654.

p.21. John Walton assigns to John Dynely all interest "of this Pattent within specified". Note in margin states "The Pattent is Recorded folio 12 - - libri being Tho Blaggs Pattent". This assignment dated 22 July 1654. Signed John x Walton. Wit: James Baldridge, William Baldridge. Recorded 21 Aug 1654.

p.21. Patent. 14 May 1653. Richd Bennett, Governor, etc to Corbett Pedell, gent, (also as Pedle in this entry) 1000 acres in Northumberland Co. Adj SE on the Potomack river, SW on a creek called Aqueconde about 15 miles above Capt Brent's, etc. Due for importing 20 persons.

- p.21. Patent. 3 Sept 1651. Sir Wm Berkeley, Knt., etc to Geo: Watts, 132 acres in Northumberland Co., adj N on land of Jno Armeby, E on main woods. S and W on a creek issueing out of Nominy bay. Due for transporting 3 persons.
- p.21. The dates in this entry are evidently confused in the original. The date of record shown as 21 Aug 1653 doubtless should be 21 Aug 1654. Geo: Watts assigns the foregoing 132 acres to John Paine on 20 Oct 1653. Signed "Geo Watts his marke". Ask and recorded 21 Aug 1653.
- p.21. Corbet Pedell assigns to Gervase Dodson 1000 acres (see last entry on preceeding page). Signed Corbet Pedell. Wit: John Hallowes. Jo Rosier. No date shown but acknowledged in Court by Pedell on 21st August 1654.
- p.21. Patent. 19 Oct 1653. Rd Bennett Esq Governor, etc to Geo Watts, 300 acres in Northumberland Co, on S side the lower Muchoticke river, near 2 miles up the river and near an oyster shell point, etc. Due for transportation of 6 persons.
- p. 21. Geo Watts assigns the above to Jno Wood. 21 Aug 1654. Signed "The marke of Geo Watts". Wit: Phillip Silvester. Wm Baldridge. Ack and rec 21 Aug 1654.
- p. 21. Patent. 14 May 1653. Rd Bennett, Gov. etc to John Jenkin, 1000 acres in Northumberland Co. Adj S on a little creek parting it from the Doeggs Island and on the Western branch, etc. Due for transporting 20 persons.
- p. 21. Jno Jenkin of Westmoreland Co, planter, assigns the above 1000 acres to Gervase Dodson. 8 March 1653/4. Signed John Jenkin. Wit: by Gervase Bell his mark. John Williams his marke. Ack and rec 21 Aug 1654.
- p.22. Patent. 3 Sept 1651. Sr Wm Berkeley, Knt, etc to John Tompkinson, 100 acres in Northumberland Co. Adj N on "Hollis his Creek", etc. For importing 2 persons.
- p.22. Ino Tompkinson assigns above to Tho Blagg. 21 Aug 1654. (This date may be 4th of Aug.). Signed John Tompkinson his marke. Wits by Rich Sturman. John Pitt. Ack and rec 21 Aug 1654.

- p. 22. Patent. 14 May 1653. Ri Bennett, Esqr. Governor, etc to Matthew Tomlin. 200 acres in Northumberland Co. Adj SE on Hollis his creek. NE upon a branch of this creek toward the land of Wm Freake, SW and NW on the main woods. Due for transperting 4 persons.
- p.22. Matthew Tomlin assigns above to Gervase Dodson. 18 Oct 1653. Signed Matthew Tomlin his marke. Wit: Richard Tidmarse. Arthur Long. Ack by Mr Jno Dodman atty of Tomlin and rec 21 Aug 1654.
- p. 22. P of A. 18 Oct 1653. Matthew Tomlin of the Ile of Wight Co., planter, to "my loveing friend" Mr Jno MANNA Dodman or John Jenkin or Gervase Bell of Westmoreland Co or any of them, to sell the above 200 acres. Signed Matthew Tomlin his mark. Wit Rich Tidmarse. Arthur Long. Recorded 21 Aug 1654.
- p.22. Patent. 26 Jan 1651/2. Sir Wm Berkeley, K't., Governor, etc. to Thomas Davis. 600 acres in Northumberland Co. Abutting NE on upper Mucholix river. NW on upper Mucholix Towne. SE and NE upon the main woods. Due for transporting 12 persons. This patent recorded 21 Aug 1654.
- p. 22. "Cap't Davis his lre of Attur to Ger Dodson". Note: I do wish somebody would take the time and trouble and go to the expense of preparing a genealogy of the Thompson family. They are not ancestors of mine, so far as I know, but every way I turn they are back of and behind the early ancestors of some aristocratic and important old Virginia family. Their family ramifications would explain a great deal. It would not surprise me in the least to find them the earliest American ancestors of General Washington through the Wrights for instance. Very likely predating Read and Martiau. I might remark that Stevens Thompson, Attorney General of Virginia, and grandfather of George Mason of Westmoreland County (Bill of Rights) did not arrive in the colony until after 1700. He may have been, and I think he was, the most priggish pettifogger we were ever cursed with, (ask any Monroe) but nevertheless he was a fine gentleman of high education (if you call that education) and a most aristocratic English background. All that I know from English records.
