#### PREFACE

The first Continental Congress, which met on the 5th of September, 1774, adopted on the 20th of October a paper called the "Association". This was in its most important features a strict non-importation, non-consumption. and non-exportation agreement made by the delegates of the various English colonies in America in reference to all articles of trade with Great Britian and signed on behalf of themselves and their constituents, the several parts of which were to be put into effect at different dates, and were to remain in effect till certain oppressive acts passed by the British Parliament should be repealed. It had, however, additional provisions, looking to the promotion of agriculture and manufactures, the discouragement of extravagance and dissipation, and, generally, the strengthening of the inhabitants of the colonies for the struggle which had been entered into with the mother country. The necessity that there should be local agencies for the execution of the "Association", in addition to the committees of correspondence already in existence in the several colonies, caused the insertion in the document of a provision that a committee should be chosen in each county, city, and town in the country by those qualified to vote for representatives in the popular houses of the general assemblies of the colonies, whose business it should be "attentively to observe the conduct of all persons touching this Association", and to bring the force of public opinion to bear against violators.

In accordance with this provision of the "Association" local committees were formed very shortly all over the land, and the way in which they carried out the suggestions or directions made by the Continental Congress and by provincial congresses or conventions may be seen in the Cumberland and Isle of Wight proceedings which follow. The Virginia county committees soon became, when in the further progress of the revolution the several agencies of royal government disintegrated, the actual governments in great measure of their respective communities till the provisions of Virginia's first constitution. adopted by representatives of her people in June, 1776, went into They were at first called committees of observation, or committees of effect. inspection, or committees of inspection and observation, or committees for carrying out the provisions of the "Association", or merely committees, but in course of time, after the formation of the central Committee of Safety by the Virginia Convention on August 24, 1775, they came to be referred to as local committees of safety.

Of the proceedings of these committees, though not a few extracts from them, in the form, particularly, of important resolutions, are to be found in the "Virginia Gazette" and the "American Archives", only those for Cumberland and Isle of Wight counties have, so far as is known by the writer of this preface, been preserved; and these not in their entirety, but in sufficient fullness, happily, to give to them a very great value. Enough remains to show how these two committees conducted business, and what business was considered within their province. The proceedings of these two may undoubtedly be taken as examples of the proceedings of all the other committees, which now, unfortunately, are lost.

The proceedings of the Cumberland Committee are recorded in a manuscript volume now in the Virginia State Library, which came into the posscript history of Virginia has been left by Edmund Randolph, a member of the Convention, which gives some account of the proceedings of the committee, and there are a few other sources of information. They do not disclose, however, the part taken in the debate, if any, by Mr. John Mayo or Mr. William Fleming, the two delegates from Cumberland, who were content to follow the leadership of Patrick Henry, Edmund Pendleton, Thomas Nelson, and others. The resolutions were agreed to unanimously by the one hundred and twelve members present out of a total membership of the Convention of one hundred and twenty-eight. Hence it is almost certain that the two members from Cumberland voted for them.

The proceedings of the Isle of Wight Committee are recorded in a book in the clerk's office of Isle of Wight County whose contents are even more miscellaneous than are the contents of the Cumberland book, since it contains, in addition to the committee proceedings, tax records, land line records, and marriage records. Nor are the proceedings so nearly complete as are those for Cumberland, the first date being January 13, and the last, July 27, 1775. They are, however, so far as they go, of equal interest and value. As is the case with the Cumberland proceedings, they are evidently slightly postponed copies of loose sheet originals. The handwriting seems to show this, the name of the chairman, "John Sck. Wills", being written in each case by the same person who wrote the minutes themselves, and just before the name there being in each case inserted the formula, "The Minutes of these proceedings were signed". Moreover, the proceedings for the 15th of May appear twice, the second time, however, under date of June 15. The theory is that this duplication was merely the mistake of a careless copyist. The proceedings are printed only once in the following pages, and under the date of May 15, that being beyond doubt, from references in the proceedings of the next meeting, the correct date.

Because of their great historical value, the two sets of proceedings should have been printed long ago. Since this has not been done, however, their publication at the present time seems almost imperative. It will not be long, it is to be hoped, before the proceedings of some at least of the local councils of defense brought into being in the prosecution of the war with Germany are given to the public, and a comparison of the activities of these bodies with the activities of the committees of our forefathers will be extremely interesting and instructive.

#### Cumberland Committee Proceedings

At a Committee held for Cumberland County the 18th day of February 1775.

Present. George Carrington, Chairman, William Fleming, Littleberry Mosby, John Mayo, Joseph Carrington, Richard James, Carter Henry Harrison, George Carrington junr., John Netherland, Robert Smith, Maurice Langhorne, Benjamin Wilson, Joseph Calland, Frederick Hatcher, Edward Carrington, John Woodson, the Rev. John Hyde Saunders, Charles Woodson, junr.

Resolved, That Friday the tenth day of March next be appointed for the Freeholders to meet at the Court House to elect Delegates to attend the Convention to meet at Richmond the twentieth day of March, and it is recommended to all the Freeholders to attend accordingly.

Resolved, That the Members of this Committee now present will give a Premium of three Shillings per pound to the first Person or Company of Persons who shall within eight Months from the date hereof produce to this Committee or the Chairman thereof fifty Pounds weight of good Gunpowder manufactoried in America on due proof that the same was made wholly of American Materials.

Resolved, That the defenceless State of this Country renders it indispensably necessary that a Quantity of Ammuntion should be immediately provided; and as the same will be for the common Benefit, Defence and Protection thereof, it is but just and reasonable that the Expences incurred in procuring the same should be defrayed by a general and equal Contribution; and whereas in the present confused State of this Colony, no Method hath been adopted, nor Powers created to levy Monies to put this Colony in a Posture of Defence against the oppressive Measures of the British Parliament: It is the Opinion of this Committee that William Fleming, John Hyde Saunders, Edward Carrington, Carter Henry Harrison do draw up and prepare proper Instructions, empowering the Delegates to be elected for this County to attend the Provincial Convention at Richmond on the 20th of March next and concur with the Delegates of the other Counties for laying \* what \* \* \* Exigencies of the Colony may require and in making such \* \* as they shall think necessary for the Well being and support thereof: And that each Member of this Committee shall furnish himself with a Copy of the same and use his utmost Endeavours \* \* \* \* The Freeholders of this County to sign it. That the Members of this Committee if they meet with any Person or Persons who shall refuse to be agreeable to this Resolu-\* \* : tion, they shall take Notice of \* Names of such Person or Persons and give them in to the next Committee held for this County, to the End that the Enemies to America may be known.

Resolved, That this Committee do approve the Association formed \* \* \* \* and other Proceedings of the Continental Congress held at Philadelphia the 5th day of September last past and that they adopt the same as their Rule of Conduct and that an Address be drawn in behalf of themselves and their Constituents to the Delegates from this Colony, by William Fleming, John Hyde Saunders. Edward Carrington and Carter Henry Harrison expresing their most grateful Sense of the important Services they have rendered their Country in the present alarming Conjuncture of Affairs.

Resolved, That each Member of this Committee be answerable for and pay his Proportion of fifteen Pounds for the Support of the Provincial Delegates who shall be appointed to attend the Continental Congress at Philadelphia in May next, and that the same be paid to the Delegates from this County on or before the 20th day of next Month.

Ordered, That Mr. Langhorne and Mr. Calland Members of this Committee do wait upon Henry Macon who was one of the said Committee chosen by the Freeholders, and that the Rev. John Hyde Saunders do wait upon Richard Eggleston and Edward Haskins who were likewise chosen, to know whether the said Macon, Eggleston and Haskins will sign the Association and accept their Places as Committee Men; and if they refuse, to know the Reason of their Refusal and report the same to the Committee.

Resolved, That wherever a Suspicion arises that any Merchant in this County hath infringed the Association of the late Continental Congress, the Person or Persons who suspect the said Merchant of such Misconduct, do make Information thereof to any three or more of this Committee, and if upon Enquiry they think that the same is well grounded they forthwith inform the Chairman and he summon the Committe of this County to take the same under their Consideration.

Thomas Miller is appointed Clerk of this Committee, and in his Absence Francis McCraw.

Present, George Carrington Chairman, William Fleming, John Mayo, Carter Henry Harrison, James Pleasants, Maurice Langhorne, Littleberry Mosby, William Smith, John Woodson, George Carrington junr., Richard Eggleston, Robert Smith, Benjamin Wilson, Frederick Hatcher, Charles Woodson junr. and Edward Carrington.

Resolved, That Edward Carrington act as Clerk of this Committee.

The Members appointed to prepare and draw up an Address of Thanks to the Delegates who attended the late Continental Congress held at Philadelphia, in behalf of this Colony produced the following Address.

"To the Honourable Peyton Randolph Esq., Richard Henry Lee, George Washington, Patrick Henry junior, Richard Bland, Benjamin Harrison and Edmund Pendleton Esqrs. the Delegates from this Colony who attended the Continental Congress held at Philadelphia September 5th, 1774.

Gentlemen, Permit us, in Behalf of ourselves and our Constituents, to acknowledge our grateful Sense of your faithful Discharge of the Trust reposed in you by the unbought Suffrages of your Countrymen, in the important Duties you have rendered them at the present alarming Crisis of Affairs. We beg Leave to declare our full Approbation of, and hearty Concurrence in, the prudent and pacific Measures adopted by the late Continental Congress, of which you formed so respectable a Part, and to assure you that we will exert our utmost Diligence and Zeal to carry the same into Effect; at the same Time when we reflect on the Manner in which the Schemes agitated against the Colonies for their Destruction have been conducted, we should be greatly wanting in our Duty and Prudence did we not extend our Views to the most unhappy Events and endeavour, as far as Circumstances will permit, to prepare for every Contingency.

With Hearts deeply impressed with the Pleasure of handing down to Posterity your Names and those of your worthy Brethren of the Congress, as the Friends and Guardians of your Country, of beholding your wise Measures applauded and adopted by every City, Town and County throughout British America; and overflowing with the warmest Wishes for every Blessing on you and your Posterity, we beg Leave to assure you that we shall be ready to risque our Lives and Fortunes in your Defence when any personal Insult shall be offered you by the Tools of an incensed and corrupt Administration; and that we are your affectionate Countrymen, and much obliged humble Servants."

Resolved, That the Committee approve of the said Address, and that it be transmitted to the Printers to be published in the Virginia Gazettes.

The Members appointed to prepare and draw up an Address and Instructions, to the Delegates chosen to represent this County, in the Convention to be held at Richmond Town on the 20th of this Instant, produced the following Address and Instructions, To wit. To the Delegates &c.

Resolved, That the Committee approve thereof, and recommend it to the Approbation of the Freeholders of this County.

Resolved, That the Election to be made this day of Delegates to represent the County in the Convention to be held at Richmond Town on the 20th of this Instant be made polling and that the Sheriff of the County be requested to conduct the said Election.

At a meeting of the Committee for Cumberland County on Friday the \* \* \* of April 1775. Present, George Carrington Chairman, Littleberry Mosby, John Mayo, Joseph Carrington, Carter Henry Harrison, Richard James, James Pleasants, George Carrington junr., William Smith, Robert Smith, Benjamin Wilson, Maurice Langhorne, Richard Eggleston, Edward Carrington, John Woodson, John Hyde Saunders, Clerk, and Charles Woodson junr.

The Chairman recommended that the Committee should take under consideration the Proceedings of the late Provincial Convention held at Richmond Town in the County of Henrico from Monday the 20th of March to Monday the 27th of the same; The Committee accordingly proceeded to the Consideration thereof and after the maturest Deliberation came to the following Resolutions. Resolved unanimously that this Committee doth cordially approve the Proceedings and Resolutions of the late Provincial Convention and also recommend it in the strongest Terms to the Inhabitants of this County to observe them in every particular, and that they use every means in their Power to carry them into effect.

Resolved unanimously, That the most cordial Thanks of this Committee and of all the Inhabitants of this County are justly due to the Honourable Peyton Randolph Esqr. and the rest of 'he worthy Delegates who represented this Colony in the late Provincial Convention, for their cheerful Undertaking and faithful Discharge of the Trust reposed in them, and for the Wisdom and Spirit displayed in their Proceedings.

Resolved, That in Compliance with the Recommendation of the late Provincial Convention for procuring Ammunition and other Articles of Military Preparation, the sum of one Shilling and three Pence be collected from the Inhabitants of this County for every tithable Person in it; and this Committee doth recommend it to the different Housekeepers, and all other Persons in this County as speedily as possible to pay to any Member of this Committee who shall apply for the same, the Sum of one Shilling and three Pence for every tithable Person which they listed or ought to have listed according to Law on the tenth of June last.

Resolved, That to avoid any further Request of Money from the People on this Occasion, the Members of this Committee will take on themselves the Collection of the aforesaid Money; and that Mr. Mosby, Mr. James, Mr. Joseph Carrington, Mr. George Carrington jr. and Mr. Edward Carrington divide the County into twenty-four Districts and allot to each Member his District for Collection.

Resolved, That the utmost Industry be used in collecting the said Money as soon as possible; and, although this Committee has the greatest Confidence in the Virtue and Spirit of the People of this County in general, yet knowing that in all Nations and Societies there are some who want Virtue, it is further resolved, that reports be made to this Committee of the few who shall refuse Payment and of their Reasons for refusing that proper Steps may be taken for publishing such Delinquents, in order that the Foes to the Cause of Freedom may be known, if from the Circumstances of their Refusal such Publication shall seem proper.

Resolved, That Mr. Chairman be appointed Treasurer and that each Member shall to him account for, and pay his Collections.

Resolved, That some Part of the Ammunition and other Articles to be procured for this County ought to be procured as soon as possible: be it therefore further resolved, that Mr. Mayo, Mr. Pleasants, and Mr. Charles Woodson, junr. be a select Committee for the Purpose of securing the same; that they as speedily as possible procure 500 lb. of Gunpowder, 1000 lb. of Lead, and 2000 Flints; and that the Treasurer out of the Fund to be lodged in his Hands, furnish the said Committee with as much Money as the aforesaid Articles, with Charges of Transportation, shall cost.

Resolved, That Wednesday the 17th day of May be appointed for the Election of Delegates to represent this County in Provincial Convention; that it be recommended to the Freeholders thereof to convene at the Court House on that day for the Purpose of electing the said Delegates.

Resolved, That this Committee conceive the bestowing any Victuals or strong Liquors by Way of Treat on account of such Elections as a Species of Extravagance, and that it directly tends to lead the People into Dissipation; It is therefore further resolved, that no Candidate shall by himself or by means of any other Person either previous to, at, or after the day of Election, give or bestow any such Treat, or make Preparation for or by any Means encourage an expectation of a Treat at his own House or elsewhere.

Present, George Carrington, Chairman, William Fleming, Littleberry Mosby, John Mayo, Joseph Carrington, Richard James, Carter Henry Harrison, James Pleasants, John Netherland, Robert Smith, Frederick Hatcher, Edward Carrington, Richard Eggleston, John Woodson, Peter Stoner, Mr. Saunders, Clerk, and Charles Woodson junr.

Mr. Chairman opened the Business of the day by laying before the Committee the Information received from the Northward, respecting the Attack lately made by the British Troops on the Inhabitants of Massachusetts Bay, upon which the Committee after the maturest Deliberation came to the following Resolutions.

Resolved unanimously, That the Attack lately made by the British Troops on our Brethren, the Inhabitants of Massachusetts Bay renders it absolutely necessary, both to secure ourselves against an Attack from the same Quarter and to enable us to afford them Assistance if required, that the Military Powers of this County be immediately collected and put in the best condition; It is therefore further resolved that Wednesday the 10th of this Month be appointed for a general Muster of the Militia of this County; and that all free Men be summoned agreeably to the Militia Law, to appear at the Court House on that day equipped with whatever Arms and Ammunition they can procure.

Resolved that this Committee be adjourned to Wednesday the third day of this Instant.

Resolved; That each Member of this Committee will pay the Money due for his own Tithables according to the Resolution of the 21st of April on or before the 10th day of this Month, and that Mr. Chairman write to the absent Members of this Resolution.

A Complaint being made to this Committee by John Wily Collector of Mr. Langhorne's District, that Zachariah Hendrick refuseth to pay the Request of one Shilling and three Pence per Tithable, and otherwise misbehaves himself with respect to this Committee, it is resolved that Mr. Langhorne or his Collector summon the said Henderick by Authority of an Attested Copy of this Resolution, to appear at the next meeting of this Committee to answer the said Complaint.

Resolved unanimously, That the Thanks of this Committee and of all the Inhabitants of this County are justly due to Captain Charles Scott and his Independant Company for their spirited Offers of their Service in defending this Colony against wicked Invaders; and their cheerful Appearance at this Place to-day in Readiness to march forward, on a late Alarm; and that this Committee in Behalf of themselves and of their Constituents do accordingly present to the said Captain Scott and his Independant Company, the most cordial Thanks as aforesaid.

Resolved, That this Committee be adjourned till Wednesday the 10th of this Month.

At a Meeting of the Committee for Cumberland County at the Court House on Wednesday the 10th day of May 1775. Present, George Carrington, Chairman, William Fleming, Littleberry Mosby, John Mayo, Joseph Carrington, Richard James, James Pleasants, Carter Henry Harrison, George Carrington junr. William Smith, Robert Smith, Benjamin Wilson, Joseph Calland, Frederick Hatcher, Edward Carrington, Richard Eggleston, John Woodson, Peter Stoner, Mr. Saunders, Clerk, and Henry Macon.

Mr. Chairman having informed the Committee, that he as Treasurer of the same had received one hundred and fifty eight Pounds and three Pence, a free Contribution of the Inhabitants of the County, for the purpose of purchasing Ammunition &c. for their Use; Resolved, That Mr. Edward Carrington be fully empowered to lay out the Money so contributed in such Manner as to him in his Discretion shall seem most proper for the Purpose aforesaid at the County's Risque; and that Mr. Chairman pay him from Time to Time whatever Money he may call for out of the Fund in his Hands, as Treasurer.

John Scruggs appearing before the Committee confessed that he had lately imprudently fallen into a Breach of the Continental Association, by Gaming, made Concessions [confessions] and exhibitted such Marks of true Penitence, that it is resolved that the said Scruggs be again considered as a worthy Member of this Community.

A Complaint being made to this Committee that Ray Moss and John Woodson junr. have within the Limits of this County, made a Breach of the Continental Association by Gaming. Resolved, that John Scruggs summon the said Woodson and Moss, by Authority of a Copy of this Resolution, attested by the Secretary, to appear before the Committee at the Court House on Wednesday the 17th of this Instant to answer the said Complaint; and that the said Scruggs to attend as a Witness.

Resolved, that this Committee in Behalf of themselves and of their Constituents, doth offer Protection to the Inhabitants of the lower Parts of this Colony for their Families and Property in Case any Invasion shall be made there and that Mr. Harrison and Mr. Fleming do prepare an Address for the Purpose of inviting them in such Case to remove their Families and property to us.

Resolved, that the most cordial Thanks of this Committee are justly due to the Inhabitants of this County, for so cheerfully contributing the Money requested of them for the Purpose of procuring Ammunition &c.

Resolved, That this Committee be adjourned to Wednesday the 17th day of this Instant.

Present, George Carrington, Chairman, William Fleming, Littleberry Mosby, Joseph Carrington, Richard James, James Pleasants, Carter Henry Harrison, George Carrington junr. William Smith, Robert Smith, Edward Carrington, John Woodson, The Rev. Mr. Saunders and Charles Woodson junr.

Mr. Chairman opened the Business of the Day by laying before the Committee the Information lately received by Express from the Northward respecing the Government of New York, among which is a Resolution of the Maryland Provincial Convention, for immediately suspending all Exportations from that Province to Quebec, Nova Scotia, Georgia and Newfoundland, or any Parts of the fishing Coast or fishing Islands or to the Town of Boston until the Continental Congress shall give further Directions therein; Wherefore the Committee after the maturest Deliberation came to the following Resolutions:

Resolved unanimously that this Committee doth heartily approve the said Resolution of the Maryland Provincial Convention, as well concerted upon a View of the present conjuncture of Affairs, and do recommend it as a proper Rule of Conduct to all Men.

Resolved, that the present alarming Situation of American Affairs especially in the Province of New York renders it absolutely necessary that a Colony Convention be immediately called, and this Committee doth recommend it to Robert Carter Nicholas Esquire in the most earnest Terms to call a Colony Convention as speedily as possible, provided the General Assembly now called to meet on the first Thursday in June, shall be prorogued to a further day.

Resolved, That it is the Opinion of this Committee that the Public Treasury of this Colony is at this Time in an insecure Place; and this Committee doth in the most earnest and respectful Manner recommend it to Mr. Treasurer to remove it nearer the Center of the Colony where it shall be more secure.

The following Address to the Inhabitants of the lower Parts of Virginia was proposed and unanimously agreed to.

Friends and Countrymen.

We, the Committee for the County of Cumberland, taking into our serious Consideration the unremitting Efforts of a despotic Administration to effect the total Subversion of American Liberty; aided by the wicked Tools of Corruption who are endeavouring by the basest Misrepresentations and Falsehoods to effect an unnatural Division between the Mother Country and her Colonies; covering their wicked Design under the specious Pretence of Duty and Attachment to our gracious Sovereign and the sacred Laws of the British Empire: And also the unhappy Situation to which you will be reduced in Case of an hostile Invasion of this Colony, do for ourselves and our Constituents (should such a distressing Circumstance take place) most cordially invite you to remove so many of your Wives and Children into this County as the Inhabitants thereof can conveniently entertain, where they will meet with the best Protection and Accommodations which we are able to afford them.

Resolved unanimously, That Mr. James and Mr. Edward Carrington or either of them be fully empowered to lay out the Money contributed by the Inhabitants of this County for the Purpose of purchasing Ammunition and other Articles of Military Preparation, in such Manner as to them in their Discretion shall seem proper, at the Risque of the County, and that Mr. Chairman pay whatever Monies they or either of them, shall from Time to Time call for or direct, out of the Fund lodged in his Hands as Treasurer of this Committee.

Resolved, That Mr. Chairman, Mr. Joseph Carrington, Mr. James, Mr. Harrison, Mr. George Carrington Jr. Mr. Edward Carrington and Mr. John Woodson, or any three of them, be a select Committee, from Time to Time to select from the Proceedings of this Committee such Parts as may be proper for Publication, and direct them to be published accordingly.

A Complaint being made to this Committee, that Ray Moss and John Woodson Jr. Inhabitants of the County of Buckingham, have lately within the Limits of this County made a Breach of the Continental Association by Gaming: Resolved that Mr. Chairman do at any Time hereafter, when he shall appoint a Meeting of this Committee, issue his Summons directed to any Person, ordering them to summon the said Moss and Woodson to appear before this Committee to answer the aforesaid Complaint: And that he in like Manner order any Witness which he shall be informed of to be summoned.

Mr. James and Mr. Edward Carrington informed the Committee, that their most careful Endeavours to procure Gun Powder in America had proved ineffectual; and desiring to be advised whether they should risque the Money put into their Hands for that Purpose upon a Plan proposed by Robert Carter Nicholas Esqr. for importing that Article from foreign Parts; Resolved that it is the Opinion of this Committee that Mr. James and Mr. Carrington continue their Endeavours to procure Gun Powder and other Articles of Ammunition in America; but that the Attempt to procure it from foreign Parts be suspended till the Resolution of the ensuing Convention in that Respect be known.

Resolved, that Application be made to the several Committees of Amelia, Chesterfield, Goochland, Buckingham and Prince Edward, requesting them to join this Committee by Way of Subscription in erecting a Powder Mill, with six Beaters on each side; and that Mr. Eggleston and Geo. Carrington junr. or either of them, apply to Amelia, Mr. Mayo to Chesterfield, Mr. Fleming to Goochland, Mr. Ed. Carrington to Buckingham and Prince Edward.

Resolved, that Mr. Fleming and Mr. Edward Carrington, draw a Scheme for the Purpose aforesaid and furnish Copies to the Members aforesaid, also each Member of this Committee that they may apply for Subscriptions.

The following Address to the Inhabitants of this County was proposed and unanimously agreed to:

Dear Country Men.

In Contemplation of securing your dearest Rights and Liberties against the Oppression of Great Britain, you, some Months ago, by your free and unbiassed Suffrages, elected us, subordinate to those august Bodies, the Continental Congress and Provincial Convention, Guardians of these invaluable Blessings. At an early Period, after receiving this Honour, we convened ourselves for the Purpose of discharging the important Trusts, so reposed in us, and have from Time to Time devised such Measures towards a happy Event of your important Contest, as the maturest Deliberation could suggest: in return you have ever paid us the grateful Tribute of entire Confidence, testified by the most implicit Acquiescence and Concurrence in whatever we We with Pleasure bear in Mind a very recent Instance of recommended. your Confidence, that of the speedy and cheerful Contribution of Monies requested of you for the Purpose of making Military Preparation, and this Contribution you may depend that no Means shall be untried for laying out to the best Advantage. We however find that you can still contribute much to this Preparation by immediately applying with Diligence to the making of Salt Petre; this is an Article much wanted as an Ingredient for Gun Powder; your Tobacco House and Stable Floors are Foundations from which it may be produced, with but little 'Trouble, in great Abundance and Per-We therefore most earnestly request, that you obtain the most fection: short and ready Process, and lose no Time in making this necessary, but easy procured Article.

We have been attentive to the Movements of the cursed Instruments of your Troubles, and, had any Prospects of an Accommodation with the Parent State come within our View, should gladly have laid them before you; such an Event however we have till lately hoped for, but must now tell you it cannot be expected at all. Your Enemies seem Implacable in their Determinations to ruin American Liberty, and for effecting that diabolical Purpose, suffer no Engine to ly still, that can be put in Motion, by any Manouvre, however mean, cowardly and detestable: For Instances we need only to refer you to the late Conduct of that MERCENARY MINESTERIAL TOOL, LORD DUNMORE, within your own Colony, and be assured that many such Hirelings are employed, and will be as long as Means can be Supplied for paying them. In short believe us, when we say, that Nothing can be expected for your Relief from the Virtue of a British Ministry or Parliament; although there are some Members in both Houses of the latter, who, ashamed of the black Deeds of their Body, daily, to their lasting Honour, hold out their Names as Dissentients; yet, unhappily for Britain, and America too, they You may indeed consider yourselves as in a State of War are but few. with Great Britain, for several Engagements have been between her Troops and the Inhabitants of your Sister Colony of Massachusetts Bay, and each

Power still stands in opposite Military Array. All the American Colonies have long since united in opposing British Oppression, a Blow, therefore. struck at one, must be considered as struck at all; You may daily look for the Invaders in your own Colony, or should the whole Force of the Enemy be bent on that, or any other Province, your assistance must not be denied. In your Arms under divine Providence, rests your Security. We entreat you therefore by that Regard you have for the Safety of your own Persons; for your Liberties, civil and religious; for every Thing which can render your Being on Earth happy, for, what is of more weighty Consideration, the Happiness of yr. Posterity for endless Ages to come; under Sanction of that Confidence you repose in us; that, without Delay, you take up your Arms: put them in the best Condition; get acquainted with Military Discipline; and stand in Readiness for actual Service, upon the first Sound of the Trumpet of War. Suppress every Animosity among yourselves; pay Obedience to Officers properly appointed; let no Discontents on Account of their Advancement interrupt the necessary Preparation; let Harmony dwell amongst you:--Remember the old Proverb, "United, we stand; Divided, we fall". Preserve what Ammunition you have by you; do not expend it on any Occasion whatever, except in the greatest Necessity, for more will be wanted for your Protection than can shortly be procured. Observe these our Entreaties, and fear not; Your American Bretheren are firm; you have many Friends in Great Britain and Ireland; and in the Justness of your Cause, you may, with Confidence, look up to Heaven for Assistance; In Supplication for whose Interposition to avert the approaching Scene of Blood and Destruction, we recommend that you universally, in Compliance with the Appointment of the Grand Continental Congress, devote Thursday the twentieth Day of July to public HUMILIATION, FASTING AND PRAYER.

Resolved, that the foregoing Address from the Committee to the Inhabitants of Cumberland County, be read by the several Ministers to their Congregations; that it be sent to Mr. Purdie to be printed; and that he also be requested to furnish the Chairman with a Number of Hand Bills thereof for the Benefit of this County.

It appeared farther that Bartlett Thompson had 82 Votes minuted down and counted to him, and 4 other Votes minuted down and counted to Bartholemew Thompson; Whereupon the said Barlett prayed that he might have the Benefit of the said four Votes, minuted down and counted to Bartholemew, to be added to his Number of eighty two, by which he would have eighty six Votes, and be elected a Committee Man in Exclusion of Thomas Davenport, who had eighty five Votes only, minuted down and counted to him; and further said, that there was no person of the name of Bartholemew Thompson within said County of Cumberland, or elsewhere, as far as he knew or believed, and the four Votes aforesaid of right belonged to him, and were given to Bartholemew, instead of Bartlett Thompson, altogether through a Mistake of the Name, or Manner of Spelling it; but as George Carrington junr. who had kept that Part of the Poll, had minuted down the eighty two Votes to Bartlett Thompson, and the four other Votes to Bartholemew Thompson, it

At a Committee held for Cumberland County at the Court House on Thursday the 29th Day of February Anno Domini 1776. Present, Mr. Chairman, Mr. Mayo, Mr. Fleming, Mr. Randolph, Mr. Pleasants, Mr. Mosby, Mr. Skipwith, Mr. Charles Woodson, Mr. George Carrington junr. Mr. Miller Woodson and Mr. Allen. The Resolution drawn up by Mr. Harrison, a Member of this Committee, touching some Resolutions lately published by the Continental Congress, and received by this Committee at a former Session, being transcribed stood as followeth.

"Whereas it is notorious to this Committee, that every Artifice has been practiced, and no Stratagem unattempted, by a Sett of Men among us, who, notwithstanding their false Glosses and external Demeanour, are avowed Enemies as well to the Constitution of Great Britain as the happy Union which once subsisted between the Mother Country and her Colonies, to draw many, otherwise honest and well meaning, but uninformed People in this Colony into erroneous Opinions, and to obstruct, as far as in their Power, that Universal Harmony and Union, which we wish to establish through the Continent, have endeavored to detach them by the most dreadful Apprehensions of the probable Issue of the present Contests; and whereas it is recommended to the different Committees by the Honourable Continental Congress, to treat all such Persons with Kindness, and to view their Errors as proceeding, rather from want of Information, than of Virtue or publick Spirit; to assure them, that Necessity, not Choice, has driven us to defend, by Arms, our Rights and Liberties; and, in Order to explain to them the Origin, Nature and extent of the present Controversy, liberally to distribute among the People the Proceedings of the Congress, the late Speeches in Parliament relative to American Grievances and such other Pamphlets as tend to elucidate the Merits of the American Cause:

Resolved, that the Printers be encouraged to print in a Pamphlet the Speeches of the great Patriots in both Houses of Parliament relative to American Grievances; and that the Members of this Committee use their utmost Endeavours, to carry the above recited Resolution into Effect, and that fifty Copies of the Proceedings of the Continental Congress, and other necessary Papers be purchased at the Expense of this Committee for the Use of the County.

And whereas it is incumbent on us, particularly at this Time, to preserve Unanimity and Harmony among ourselves, and to show that we are determined to promote Merit to the utmost of our Power wherever to be found:

Resolved, that it be recommended to the Inhabitants of this County in particular, and of the Colony in general, that all Distinction of Colonies and Countries be laid aside; that there be no other Name known among them than that of Americans and that every Man, who will heartily join in this common and ever glorious Struggle for Liberty, be considered and treated as an American born."

Thomas Miller reported to this Committee, that in Pursuance of a former Order directing the Clerk of this Committee to apply to the Printer or Printers for such Resolutions, Speeches and Publications as might be useful to the People in this County, he had purchased of Messrs. Dixon and Hunter in Williamsburg sundry Speeches of the Bishop of St. Asaph and Political Pamphlets of one Sharp, amounting in the whole of both Kinds to the Number of five dozen, and costing the Sum of two Pounds two Shillings and six Pence. That they were all of the Kind he could find in any of the Printing Offices, now on Hand; but that agreeable to the Resolution of this Committee he had endeavoured to encourage the reprinting in a Pamphlet the Speech of Edmund Burke, Esquire, on the American Question, and some other Political Productions, which might prove entertaining and useful to the County: That the above mentioned Speeches and Pamphlets already purchased were charged to him, and brought up and distributed through the County.

The Company complete of Captain Charles Fleming, of the Regular Service, reviewed by Mr. Mosby and Mr. Netherland and others, was reported to this Committee and received, and a Certificate ordered to be granted to the said Captain Fleming.

The Regular Company of this County, under Captain Charles Fleming, is directed to march to Gloucester Court House, and to begin their march in one Week from this Time.

Nathan Glenn, Gentleman, Ensign in Captain Miller Woodson's Company of Militia in this County took the usual Oath and qualified agreeable to the Ordinance of Convention.

Ordered, that Mr. Mosby do contract for the Waggon, Team, and Driver employed by Captain Charles Fleming to carry his Company's Baggage down to Gloucester Court House, after being disengaged from Captain Fleming, to proceed immediately from Gloucester Court House and go to Hampton and bring up from thence a Load of Salt for the Use of this County, and that the said Waggon, Team, and Driver be employed by the Day from the Time of leaving Gloucester Court House till he brings up his Load of Salt to Cumberland Court House.

The Committee then proceeded to go into an Examination of the disputed Election between Thomas Davenport and Bartlett Thompson, and after examining sundry Witnesses and hearing Evidence; It is considered and resolved, That Bartlett Thompson be received as a Member of this Committee in Exclusion of Thomas Davenport who hath hitherto set a Member in this Committee since the last Election; and that the said Bartlett Thompson have Notice of this Resolution.

Ordered, that the whole Proceedings of the late Committee of this County; and also of this present Committee be fairly transcribed by the Clerk in a Book or Books of Record to be kept for that Purpose: And also, that all Letters which come directed to the Chairman of this Committee, or to the Committee, for the Use of this Committee, be communicated to the Committee at their next Sitting, and filed by the Clerk of the Committee in his Office.

Present, Mr. Chairman, Mr. Fleming, Mr. Harrison, Mr. Pleasants, Mr. Hatcher, Mr. Scott, Mr. Thomas Harris, Mr. Mosby, Mr. Langhorne, Mr. Carrington and Mr. Thompson.

Mr. Chairman laid before the Committee the Business of the Day.

It appearing to the Committee, that William Turpin, nominated a Captain to a Minute Company to be raised for this County, has not completed his Number of Men agreeable to an Ordinance of the Convention, and further that the said Turpin, by Letter, is willing to resign his Appointment; Resolved, that Littleberry Mosby junr. Gentleman, be nominated and appointed a Captain of the Minute Company in the Room of William Turpin lately the Captain; he the said Mosby having been Lieutenant under Turpin, and it appearing that he had raised his Complement of Men as Lieutenant.

The Committee proceeded to vote by Ballot for a Captain of the Minute Company in this County in the Place of Edward Carrington, who was lately a Captain of a Minute Company (the said Edward being now disqualified by another Appointment) and upon Examination of the Ballots by the Clerk, the Votes stood as follow; For John Langhorne 9 Votes, and for John Swann 1 Vote—John Langhorne having a Majority of the Votes of the whole Committee; Resolved therefore, that John Langhorne, Gentleman, be nominated and appointed Captain of the Minute Company in which Edward Carrington was lately Captain.

John Mosby having resigned and vacated his Place as Lieutenant in the Minute Company under Captain Edward Carrington formerly of the said Company: Resolved, that John Clarke, Gentleman, lately an Ensign in the said Company, be nominated and appointed Lieutenant in the said Company of Minute Men, now under Captain John Langhorne.

The Committee then proceeded to vote by Ballot for a Lieutenant in the Company of Minute Men now under Captain Littleberry Mosby junr. and after Examination of the Ballots by the Clerk they appeared to stand as follow; For John Wiley 6 Votes; for Thomas Thompson Swann 2 Votes; for John Swann 1 Vote, and for Charles Ballow 1 Vote:—John Wiley having a Majority of the Votes of the Whole Committee; Resolved therefore, that John Wiley, Gentleman, be nominated and appointed a Lieutenant of the Minute Company under Captain Littleberry Mosby junr.

The Committee proceeded to vote by Ballot for an Ensign in the Company of Minute Men under Captain John Langhorne, and upon Examination of the Ballots by the Clerk, they appeared to stand as follow: viz. For, Robert Mosby 4 Votes; for Charles Ballow 2 Votes; for John Mosely, 2 Votes, and for Thomas Thompson Swann 2 Votes: As none of the Persons voted for had a Majority of the whole Committee and as Robert Mosby had the greatest Number and the others were equal in Number, the Question was, whether the said Mosely, Ballow, or Swann be voted for with Mosby, and it was resolved, that Thomas Thompson Swann be balloted for with Robert Mosby, and upon Examination of the Ballots by the Clerk, he reported them to stand as follow; viz. For Robert Mosby 6 Votes, and for Thomas Thompson Swann 4 Votes:— Robert Mosby having a Majority of the Votes of the whole Committee; Resolved therefore, that Robert Mosby, Gentleman, be nominated and appointed Ensign in the Company of Minute Men under Captain John Langhorne.

The Committee then proceeded to vote by Ballot as before for an Ensign in the Company of Minute Men under Captain Littleberry Mosby junr. and upon Examination of the Ballots by the Clerk they were reported to stand as follow: viz. For, Charles Ballow 5 Votes, and for Thomas Thompson Swann 5 Votes: It appearing that the said Charles Ballow and Thomas Thompson Swann had an equal Number of Votes, the Chairman agreeable to Ordinance and Rule was to determine the Matter by his Vote, which being given to Thomas Thompson Swann, he had a Majority of the Votes of the whole Committee; Resolved therefore, that Thomas Thompson Swann, Gentleman, be nominated and appointed Ensign in the Company of Minute Men under Captain Littleberry Mosby, junr. Resolved, that Richard Allen, Gentleman, lately a Lieutenant in Captain John Langhorne's Company of Militia be now appointed Captain of the said Company of Militia in the Place of John Langhorne promoted to the Minute Service.

Resolved, that Moses Arnold, Gentleman, lately an Ensign in Captain John Langhorne's Company of Militia be nominated and appointed Lieutenant thereof under Captain Richard Allen.

Resolved, that Benjamin Allen, Gentleman, be nominated and appointed Ensign in Captain Richard Allen's Company of Militia in the Room of Moses Arnold lately Ensign thereof.

The Committee proceeded to vote for an Ensign in the Company of Militia under Captain John Burton in the Place of Simon Gentry who refuses to act in that Capacity: Upon Examination of the Ballots by the Clerk, they appeared to stand as follow; viz. For John Burton junr. 7 Votes; for Thomas Davenport junr. 2 Votes, and for William C. Hill 1 Vote: John Burton junr. having a Majority of the Votes of the whole Committee; Resolved therefore, that John Burton junr. Gentleman, be nominated and appointed Ensign under Captain John Burton of the Militia in the Room of Simon Gentry.

Ordered, that Mr. Harrison, Mr. Pleasants, Mr. Fleming and Mr. George Carrington junr. or any two or three of them, do draw up and prepare Instructions for the Delegates in Convention to be chosen for this County on next Court Day, directing them what Line of Conduct to pursue in their future Deliberations.

Ordered, that Mr. Pleasants, Mr. Mosby, Mr. George Carrington junr. and Mr. Charles Woodson junr., or any two or more of them, do review the Companies of Minute Men under Captain John Langhorne and Captain Littleberry Mosby junr. as they shall be completed, agreeable to the Ordinance of Convention.

Thomas Miller resigned his Office as Clerk of this Committee, and relinquished his Place.

Mr. Harrison reported from the Sub-Committee appointed to draw up Instructions for the Delegates, in Convention to be chosen for this County, that they had drawn up Instructions for the Concurrence of the People, which he read in his Place, and being approved were received by the Committee and stood as hereto annexed.

Mr. Harrison moved that it be recommended to the People of this County strictly to observe the seventeenth Day of May as a Fast agreeable to the Resolution of the Continental Congress; Resolved therefore, that the Resolution drawn up by Mr. Harrison be received by this Committee, and the same was received accordingly and is annexed to the Proceedings of the Day, together with the above recited Resolution, being both read and approved of.

The Instructions to the Delegates to be chosen for the County of Cumberland on Monday the 22nd Day of April 1776 to sit in the general Convention of this Colony drawn up and reported by Mr. Harrison for the Concurrence of the People, and approved by the Committee at their last Meeting and generally agreed to by the People, were annexed to the Proceedings of the Committee at the Time aforesaid and stand as follow.

"To John Mayo and William Fleming, gent. When the King of Great Britain, deaf to all the humiliating and well intended Petitions from his once loyal Subjects, not only of America, but of Great Britain also, changes his Justice into Severity; when he stoops to the low Artifice of bribing to carry despotic Designs into Effect, and his first Dignities are Marks of the first Servitude; when he prefers arbitrary Sway unknown to the Constitution which placed his Family on the Throne to the Love and Happiness of his Subjects; when the British Parliament so far sunk in Venality and Corruption as to sacrifice their most inestimable Priviledges, adding Insult to Oppression, have given his Majesty the warmest Assurances, that they will, with their Lives and Fortunes, support him in a ruinous and cruel War against us. When his Majesty, after a wanton Abuse of his Negative on our Acts of Assembly, by which he has forced the Slave Trade on us for several Years, unmindful of his Coronation Oath, has ordered his Governour, Lord Dunmore, to arm our Slaves against us, in open Violation of several Acts of Assembly which have the Royal Sanction; when an uniform System through all the Acts of Parliament in the present Reign, tending evidently to the total Destruction of American Liberty, leaves no other Alternative than a base Submission to their inhuman, impolitic and oppressive Measures, or Independancy; Actuated by a tender Regard to ourselves and to our Posterity we think ourselves indispensably obliged to declare boldly for the latter. We therefore your Constituents instruct you positively to declare for an Independancy; that you solemnly adjure and Allegiance to his Britannick Majesty, and bid him a good Night for ever; that you promote in our Convention an Instruction to our Delegates, now sitting in Continental Congress, to do the same; that they, in their Line

of Conduct, follow the British Parliament Step by Step, and since all American Property is declared forfeited to the Crown, that they shall endeavour to procure an Act of the Congress, condemning the Property of every British Subject residing beyond Sea, and every Subject not taking an Active Part in the present Contest, to the Use of the United Colonies; that they listen to no Terms of Accommodation from the British Court, without a previous Renunciation from the King of Great Britain of all Right, Title or Authority in and over these Colonies, and a formal and solemn Recognition of our Rights and Independancy, nor form any commercial Treaty, till they are satisfied of a Removal of their Ships of War and Troops from our Coasts and Seas; that they immediately open a free Trade to all Nations; that they exert themselves in procuring such foreign Assistance and forming such commercial Connexions as they, in their superior Wisdom, shall think prudent. Should any Proposals be made to you, we strenously insist that you order the Commissioners immediately to withdraw and refer them to the Continental Congress. And whereas the necessary Expenses of the present War, from a Scarcity of Coin, must occasion an emission of a Paper Currency to so great Amount as will depreciate its Value, a great Proportion whereof will be laid out in Provisions, which we have perishing on our Hands thro' a Stoppage of Trade, every Mode which tends to remedy the Evil must deserve your Attention, we therefore, assuring you of our hearty Concurrence in the present Measures, and wishing a vigorous Opposition, recommend to you to procure an Ordinance for an immediate Assessment in Provisions when necessary, and that proper Landings be appointed for the Delivery thereof.

Since we can neither love, honour, nor esteem, but must detest the Wretch, who hath brought Fire and Sword into our Country, we conceive a manifest Inconsistency in our Act of Worship, we acknowledge his Britanni? Majesty for our lawful Sovereign; we most heartily beseech Almighty God to strengthen him, that he may vanquish and overcome all his Enemies, at the same Time, begging his Protection, and that he will save us from the Hands of our Enemies, abate their Pride, assuage their Malice, and confound their Devices; thus we dishonour him, who hath enjoined us to pray with the Heart and Understanding also, and must appear to be rank Hypocrites: We therefore recommend, that so much of the Liturgy as respects the King be altered; that a Prayer for the Preservation, Happiness and Union of the Colonies be substituted, and that the Clergy be directed to use the same on Pain of an immediate Removal."

The Resolution drawn up by Mr. Harrison, read to and approved by the Committee of Cumberland County on Monday the 22nd of April 1776, touching a Fast to be observed the 17th Day of May following, stood as hereto subjoined.

"Whereas Friday the 17th Day of May next is fixed on by the Honourable Continental Congress as a Day of Humiliation, Fasting and Prayer,

Resolved that it be recommended to the Inhabitants of this County piously to keep the same, that under a due Sense of God's superintending Providence we may, with united Hearts, confess our manifold Sins and Transgressions, and by a sincere Repentance and Amendment  $\sim$  Life appease his righteous Displeasure, and through the Mediation of Jesus Christ, obtain his Pardon: Humbly imploring him to frustrate the cruel Purposes of our unnatural Enemies, and to prevent the further Effusion of our kindred Blood: But if Necessity constrain us to repel their hostile Invasions, that it may please the God of Armies to animate our Officers and Soldiers with invincible Fortitude, to cover them in the Day of Battle, and to crown the Continental Arms with Victory: Earnestly beseeching him to bless our Civil Rulers and the Representatives of the People in their several Assemblies, to preserve and strengthen their Union, to inspire them with a disinterested Love of their Country, and to give Wisdom and Stability to their Councils: And that the Ministers in the different Parishes be requested to prepare a Sermon suitable to the Occasion."

Present, Mr. Chairman, Mr. Mayo, Mr. Pleasants, Mr. Haskins, Mr. Hatcher, Mr. Scott, Mr. Mosby, Mr. Skipwith, Mr. Langhorne, Mr. Charles Woodson, Mr. Carrington, Mr. Netherland and Mr. Thompson.

The Chairman laid before the Committee the principal Cause of their convening, and informed them that they were to appoint Officers to Command a Company of fifty Men to be composed of Minute Men, or Minute Men and Militia agreeable to the Resolution of the General Convention passed the 10th Day of this Month.

Resolved, that there are now present fifty Privates or more of the Minute Men of the several Companies in this County, that they have the Liberty of chusing which one of the three Minute Captains of this County they will serve under; and that their Choice under the aforesaid Restrictions be the Sense of this Committee; when the other Captains gave up the Point in Favor of Captain Joseph Carrington who had the general Voice and Sense of the other Officers and the Soldiers: Resolved therefore, that Joseph Carrington, Gentleman, be nominated and appointed the Captain to command the fifty Men from this County under the Resolution of the Convention of the tenth Instant.

The Committee left it in the Choice of the Soldiers to nominate a Lieutenant from among the Number of Minute Officers, when Robert Hughes was chosen by the Soldiers: Resolved therefore, that Robert Hughes, Gentleman, be nominated and appointed Lieutenant under Captain Joseph Carrington to command the fifty Men as aforesaid. The Committee then resolved that the Soldiers should chuse the Ensign to command them under Captain Carrington from among the Number of Minute Officers, when Thomas Railey was choosen: Resolved therefore that Thomas Railey, Gentleman, be nominated and appointed an Ensign under Captain Joseph Carrington in the Expedition aforesaid.

John Langsdon having applied to this Committee for Leave to pass and repass through this Colony; and more especially to and from Kemp's Landing where he has a Waggon employed in the Country's Service, the Committee recommend the said Langsdon to be an inoffensive Person as far as they know; and they believe his Intentions are honest and blameless. Ordered that the Treasurer of this Committee do refund to the several Collectors of the Powder Money their respective Quotas, after deducting the necessary Expenses and Disbursements, to be distributed among the People.

Resolved, that it be recommended to the Inhabitants of this County and others, to furnish the Company directed from this County to North Carolina, with Blankets, Potts, and all other Necessaries in their March, to be paid for by the Publick.

Ordered, that the Prisoners sent to this County by the Committee of Safety be kept at the Court House till they contract with proper Persons for hiring themselves, and Mr. Mosby is appointed to deliver the said Prisoners to such Persons as he shall approve as shall make Contracts with them for hiring them, taking proper Receipts.

The Committee being informed that Robert Scruggs of this County hath been guilty of making sundry Speeches tending to influence and inflame the Minds of sundry Persons against the Rights and Liberties of the Country, It is ordered that the said Robert be summoned to attend at the Meeting of this Committee to be held at the Court House on the fourth Monday this Month to answer the said Information.

William Hudgins and Jesse Merryman to be summoned as Witnesses: And the said Merryman is appointed to serve the said Summonses.

Thomas Miller, Clerk of this Committee took the said Oath and qualified.

Robert Scruggs, having been summoned to answer an Accusation lodged against him at the last Meeting of this Committee, appeared in Person, and sundry Witnesses, having been summoned, appeared likewise.

The said Scruggs confessed he might have said many Things inadvertently before sundry Persons which might seem to reflect upon some Members of Committee, or others concerned in the great American Struggle for Liberty; but as he is a sincere Wellwisher to the Interest of America, he is heartily sorry that any Thing he should say might tend or be construed to tend to the Injury of the common Rights of America: Resolved therefore that the Prosecution be dismissed, and the said Scruggs, upon his Confession and Promise of a cautious Conduct for the future is hereby discharged.

The Committee proceeded to settle the Allowance of the Clerk of this Committee to this day: Resolved that Thomas Miller, Clerk of this Committee be allowed the Sum of twenty five Pounds for his Services as Clerk of this Committee to this day.

The Committee adjourned 'til next Court Day.

The Committee taking into Consideration what Method shall be taken in distributing the Salt allotted to this County after mature Deliberation thereupon had It is considered that it be distributed to the People according to the Number of Souls taken last year—that any Persons claiming any Part thereof shall be examined on Oath what Quantity they have by them that they may have no more delivered than what will make what they have equal with others who claim any thereof.

Resolved that Mr. Mosby measure out and distribute among the People who apply, the Salt, under the above Resolution and agreeable to the Resolution of this Committee at their last Meeting.

Ordered that if any Salt be left on Hand after the ninth Day of October, Mr. Mosby do sell it to those he can treat with.

The deposition of Gabriel Gibbs of full age taken concerning a charge exhibited against Mr. George Purdie being first sworn on the Holy Evangelists of Almighty God, deposeth and saith that he purchased of the said Purdie three or four yards of Crown Roles for which he gave him one shilling current money of Virginia per yard and further saith not.

The deposition of James Peden of full age taken concerning a charge exhibited against Mr. George Purdie being first sworn on the Holy Evangelists of Almighty God deposeth and saith that he purchased of said Purdie two yards of Crown Role for which he gave one shilling current money per yard, and that he also purchased of the said Purdie three scanes of thread for which he gave one shilling current money and further saith not.

The deposition of William Flake of full age taken concerning a charge exhibited against Mr. George Purdie, being first sworn on the Holy Evangelists of Almighty God, deposeth and saith that he heard the said Purdie say that every person who signed the Continental Association would be sent for to England and hanged, that he, the said Purdie would never signe the said Association unless compelled by force thereto for that he had known a number of people hanged at home for signing associations, whereupon this deponent refused to signe the said association for some time 'till at length he was applied to by John Scarsbrook' Wills Gent. who informed him, this deponent that no danger could happen to him for signing the said association, that he, the said Wills would venture to be hanged for him, this deponent, if he was ever called upon for signing as aforesaid and thereupon this deponent did signe the said association, and further saith not.

The deposition of John Driver of full age taken concerning a charge exhibited against Mr. George Purdie, being first sworn on the Holy Evangelists of Almighty God, deposeth and saith that he was sometime ago at Mr. Purdies store and that he saw a lady (who he does not now recollect) purchase some pins in the said store for which she gave one shilling and six pence or three shillings per paper current money, and at the same time he, this deponent purchased the same kind of pins for seven pence and half penny per paper current money, and further saith not—

The deposition of Richard Hardy Gent. of full age, taken concerning a charge exhibited against Mr. George Purdie being first sworn on the Holy Evangelists of Almighty God, deposeth and saith that the said Purdie acknowledged that he had violated the Continental association by selling needles at a double price, and further saith not.

Resolved that Brewer Godwin, Thomas Peirce, Thomas Smith, Arthur Smith and Jethro Gale, or any one of them do summon George Purdie, Robert Tynes and John Sym to appear at the next Committee then and there to answer sundry complaints lodged against them.

Resolved that the above mentioned Gent. or any one of them do summon John Sterling to appear at the next Committee then and there to answer sundry complaints lodged against him. John Armstrong personally appeared in Committee this day and made his recantation which is in words following to-wit: "Having made use of the expressions inemical to the interest of North America, I take this method publickly to declare that the words were spoke without consideration, and that I should think myself guilty of the greatest ingratitude in acting against a Country, in which I have been treated with the greatest humanity and obtained a livelihood by the generosity of the inhabitants, I am sincerely sorry that I have forfeited the esteme of the good people of this Country and hope that my future behaviour will be such as to gain their good opinion, John Armstrong".

Whereupon, the said John Armstrong signed the Continental association.

Ordered that the Committee be adjourned 'till the 7th. day of August next, at 10 o'clock.

The minutes of these proceedings were signed.
