FOREWORD

The Inventory of the Town, Village and City Archives of Vermont is one of a number of bibliographies of historical materials prepared throughout the United States by workers on the Historical Records Survey Program of the Work Projects Administration. The inventory of the archives of the town of Windham County is number 13 of the Vermont series. The publication herewith presented, Town of Brookline, is volume 3 of the Windham County series.

The Historical Records Survey Program was undertaken in the winter of 1935-36 for the purpose of providing useful employment to needy unemployed historians, lawyers, teachers and research and clerical workers. In carrying out this objective, the project was organized to compile inventories of historical materials, particularly the unpublished government documents and records which are basic in the administration of local government, and which provide invaluable data for students of political, economic and social history. The archival guide herewith presented is intended to meet the requirements of day-to-day administration by the officials of the town, and also the needs of lawyers, business men and other citizens who require facts from the public records for the proper conduct of their affairs. The volume is so designed that it can be used by the historian in his research in unprinted sources in the same way he uses the library card catalog for printed sources.

The inventories produced by the Historical Records Survey Program attempt to do more than give merely a list of records — they attempt further to sketch in the historical background of the county or other unit of government, and to describe precisely and in detail the organization and functions of the government agencies whose records they list. The county, town, and other local inventories for the entire county will, when completed, constitute an encyclopedia of local government as well as a bibliography of local archives.

The successful conclusion of the work of the Historical Records Survey Program, even in a single county, would not be possible without the support of public officials, historical and legal specialists, and many other groups in the community. Their cooperation is gratefully acknowledged.

The Survey Program was organized and has been directed by Luther H. Evans, and operates as a nation-wide series of locally sponsored projects in the Division of Professional and Service Projects, of which Mrs. Florence Kerr, Assistant Commissioner, is in charge.

Explanatory Notes

This inventory of the archives of the town of Brookline consists of an inventory of all the records kept by the town officers both current and non-current. An historical sketch of the town has been written; short essays pertaining to the history of each of the officers and other supplementary material as shown in the table of contents have been propared.

Like other Vermont towns there is no archivist, yet in practice the town clerk always has been, since the creation of the state in 1777, the town archivist and as the inventory will show, a large majority of the non-current records both of his own office and those of other officers are now to be found in his custody. In the preparation of the inventory we have placed the records under the office of origin rather than under the office of custody, therefore, in many cases the location of the records listed under one office will show that they may be found in the office of town clerk.

Abbreviations, Symbols and Explanatory Notes

To assist both the town officers and the user of the inventory we have prepared a brief listing of the records covered by this inventory, see page 63. A special copy of the inventory with a number of blank pages following this section is being bound for the use of the town clerk. It is hoped that this simple type of listing will be kept current for the use of researchers or perhaps those preparing a new inventory of the town archives, after this volume has become antiquated.

Town Office Sketches

These sketches, written from information secured from the town records, are only brief histories of the officers. The town officers duties are established by law and do not vary from town to town. All the Vermont statutes beginning with the origin of the State are being carefully read and eventually the various duties which have, at one time or another, been assigned to town officers will be listed and published.

Titles

Titles are shown exactly as found on volumes, file drawers, boxes, or bundles. The current or nost recent title of a series is used as the exact title of the entry. Variations to the entry title are listed in the title line. An exact title appears in upper case. An assigned title, which appears only when the record has no exact title, is written in upper case and enclosed in parentheses. An explanatory title which is used in conjunction with an exact title when the title is vague or misleading, appears in lower case and enclosed in parentheses.

The same theory is applied to sub-entries, which are numbered with roman numerals within an entry. A sub-entry will never have an exact title, but when it bears a title cross reference to some other entry in the inventory it appears under the title of the entry to which it is cross referenced whether that title is actual or assigned. If the title of the entry to which a sub-entry is title cross referenced is exact, it appears with initial letters in upper case; if it is assigned it appears with the initial letters in upper case and enclosed in parentheses. For sub-entries which are not title cross referenced we have used the title by which the record is commonly known in Vernont.

Dates

The dates that appear directly after the title are the earliest and latest dates found within the entry. Dates shown in he body of the entry or following sub-entries are the dates of that particular item; where dates are not given for individual items the dates of that item are identical with those in the title line.

Abbreviations, Symbols and Explanatory Notes

Labeling

Letters or numbers placed in parentheses directly following the quantity indicate the exact labeling.

Cross Reference

Title-line and body-of-entry cross reference to records which are a part of the same series have been used; for references to records which are related in subject matter or type the third-paragraph cross references have been used. Where no cross reference is made, it may be assumed that no other records of the same or similar nature were found. References in the office essays are made to reports or records made by that office but in the custody of another.

Indexes

Where an entry is served by a separate index, a separate entry covering the index is given immediately following the record. Where an index covers more than one entry, it is given immediately following the last entry that it serves and cross-references are made between the index entry and the entries it serves.

Condition

Records are in good condition unless otherwise noted in the inventory.

Dimensions

Dimensions of volumes are given in order of height, width, and thickness; dimensions of file boxes and drawers in order of height, width, and dopth. All dimensions are given in inches unless otherwise specified.

Location

Usually the exact location of a record is given in each entry. Where the location is not given in the entry, a general statement on location of records, which may be found in the section titled "Housing, Care, and Accessibility of the Records," preceding the inventory, will give this information.

HISTORICAL SKETCH

Brookline, a small irregularly outlined town, lies in the east central part of Windham County. The town is separated from others by natural division lines, a range of hills east and west, with the highest peak in the eastern range eleven hundred feet from the valley below. Brookline is bounded on the north by Athens, east by Westminster, southeast by Putncy, southwest by Newfane and the West River, and northwest by Townshend.

The town is about six miles in length and from one and onehalf to three miles in width and contains six thousand six hundred fifty-seven acres. The elevation, near the east town line, is called by Brookline townspeople, Putney Mountain, and by the inhabitants of Putney, Brookline Mountain.

The soil was and is more adequate for the raising of grass than grain. During a violent freshet a bed of kaolin or porcelain clay was laid open in this town, but has never been commercialized. Geologically the predominant rock is calciferous mica schist although there is some gnoiss in the western part.

The land in Brookline occupying the valley of Grassy Brook is classified as suited to dairy farming. The remainder of the town is suitable for forestation only.

The early settlers of Brookline occupied their lands without title and left the matter of legal rights to the future. A somewhat larger group of settlers came into the territory north of the "Grassy Brook" settlement and were in the same predicament so far as legal titles were concerned. The group in the northern section, which afterwards was included in the town of Athens, was organized on November 24, 1779 under the name of the "Society of Adventurers and Proprietors." A committee was appointed to survey the land and subdivide it. This committee, with three other members, made up a prudential committee with discretionary powers to take such steps as might be necessary to secure legal title to the lands which they had occupied. A covenant was drawn up and signed.

The "inhabitants of Grassy Brook" were invited to join an Athens group and sign the covenant, by vote of the prudential committee, December 6, 1779. A petition was sent to the General Assembly asking for the grant of a township including large parts of what is now Athens and Brookline. This was approved March 11, 1780 and the necessary fees being paid, the seal of the State

was affixed to the Charter on May 3, 1780.1

Difficulties of transportation made it inconvenient for the residents of the area now included in the town of Brookline to go to Athens to transact town business and attend town meetings. Therefore, on January 3, 1783, the inhabitants of Athens voted to consider the south part of the town, to the extent of 21 of the town's 68 proprietary holdings, as a separate society for the future. A record of this is to be found among unbound town papers in Athens and is signed by Jonas Gray, moderator for the town and for the society. Members of the south society petitioned the freemen of Athens on February 27, 1786 for permission to be released from connection with Athens so that they might join parts of Townshend and Putney to form a separate town. An act of the Assembly of October 18, 1788, confirmed this action and designated the territory as the "South Parish of Athens." Permission was granted by Athens to the South Parish to petition the Assembly for incorporation into a separate town on September 2, 1794. On October 30, 1794, the Assembly incorporated the South Parish into the town of Brookline but provided that it should have no representation in the Assembly or conventions, the inhabitants voting on state and national elections with the towns from which they came. 4

Organization of the town was effected at a town meeting on.
March 17, 1795, at the home of Ebenezer Harwood. The officers
elected were: John Waters, town clerk; Peter Benson, moderator;
Peter Benson, Lemach Blandin, and Jotham Stebbins, selectmen; and
Abijah Moore, treasurer. A petition for representation in the
Assembly was disapproved in 1796. Voters attended freemen's meetings in other towns depending upon where the voter lived and warnings
by Athens were, by law, to be posted in Brookline as well. An act
of the Assembly in 1797 provided that the joint freemen's meetings
might be held in the north part of Brookline. A law passed
February 28, 1797, provided that parishes incorporated into towns
should have the privileges of towns but there is no record of any
further move by this town to secure representation until 1813.

when a petition was sent to the Assembly asking for the right to be represented.

Efforts of Brookline to secure representation in the Assembly apart from Athens extended over more than ten years and resulted in a deadlock between the Assembly and the Governor and his council which ended in the seating of a representative without the concurrence of the Governor. A petition for representation was reported unfavorably in 1813 but in the same year Brookline was annexed to Athens for joint representation. A petition from both towns to terminate the annexation was acted on favorably in 1815 but another petition for separate representation was reported unfavorably. Similar petitions met a like end in subsequent years until 1819, when one was reported favorably and passed the Assembly. The Governor and council nonconcurring, the bill was referred to the next session. The following year, action again was referred to the next session. In 1822, the Assembly passed the bill and sent it to the governor and council, which sent it back nonconcurred. In spite of this, the Assembly acted favorably on a rollcall vote and again sent it to the Governor and council. It now was returned to the Assembly with a proposed amendment vitiating the main purpose of the bill. To this the Assembly nonconcurred and returned the bill to the Governor and council, where action was suspended until the next session.

In 1823, the freemen of Brookline met at the warning of the constable and elected Benjamin Ormsby or Omsbee to represent them in the Assembly. His right to take his seat was challenged and the matter was referred to a special committee. The report of this committee reviewed the history of the case and recommended that, in its opinion, Brookline was entitled constitutionally to a seat in the assembly. The report was accepted in this way dispensing with the concurrence of the Governor and council. The bill, which was held over from the previous session, was dismissed. 3

The name, Brookline, was adapted from Grassy Brook, which rises in Athens, runs through a deep valley in all almost straight line the entire length of the town from north to south and empties into West River on the southwest boundary. Grassy Brook derived its name from the open meadows in the northern part, which produced a heavy crop of grass, and where the pioneers of the region went to cut their hay.

The first settlement in this town was made about the year 1776. Although historians disagree as to who were the first settlers. Timothy Wellman and Lemach Blandin were among the earliest

and their descendants are now living in Brookline. It has been ascertained that Timothy Wellman, the earliest Wellman of Brookline, removed to this town from Norton, Massachusetts, and that he was born in 1757. From 1780 to 1790 settlers came into the town in great numbers. 2

The Baptist Church of Brookline was organized in 1785. The Rev. Amos Beckwith was its first settled minister. Its first building was of logs, with slabs for seats, no floor, and with no means of heating. The present church building was erected in 1836. It was a Union church, to include Universalists, Methodists, and Baptists. It was dedicated in 1837. It was rededicated as a Methodist Episcopal Church in 1895. The building was sold in 1924 to private parties.

The first school was held in the home of Cyrus Whitcomb. 6 The first teacher is said to have been Lucy Skinner, daughter of one of the first settlers. 7 Brookline is noted for having the only round schoolhouse in Vermont. Land on which it stands was deeded to the town by Peter Benson. August 10, 1821, for the sum of five dollars. 8 Tradition has it that this unusual little building, constructed in 1822, was designed by Dr. John Wilson, an eccentric teacher and doctor, who, after his death, was reported to have been Captain Thunderbolt, a highwayman wanted in England where his partner, "Lightfoot," had been hanged. 9 Preparations for the erection of the round schoolhouse were made in 1821. Bricks, placed several rods north of the present location, were washed down in the freshet of this same year. This brick building replaced a log schoolhouse which had served its purpose for about twenty-five years. 10 The original furnishings consisted of the teacher's desk in the center, with benches in a somi-circle around her desk; those benches next to the wall were for larger pupils, each row toward the center of the room being smaller than the previous row. 11

The town was divided into three school districts in 1796.1 In 1824 there were one hundred and eighty-four scholars in the four school districts of the town, a greater number than the entire population of the town today, the present population being one hundred and twenty, 2 Former students and friends gathered to celebrate the one hundredth anniversary of the old round schoolhouse. June 20, 1923, with a suitable program of commemoration. 3 In 1925 the Brookline Union School, held in the round school building, won the silver attendance cup over thirty-three schools in Windham County. with an average attendance of 98.4%. In this school it is necessary for each pupil and the teacher to carry a noon lunch, and, to aid them, a hot luncheon equipment was presented them by the Vermont Women Teacher's Club, 4 In October of 1927 Brookline was awarded the one hundred dollar Proctor prize for the rural school in Windham County showing the greatest improvement during the spring and summer of 1927. Lack of a suitable playground prompted the building of a new schoolhouse on a site donated by the Baptist Society. 5 The schoolhouse now in use was built in 1928. 6 On March 5, 1929, inhabitants of the school district voted to turn the Round Schoolhouse over to the town in care of the selectmen. Secondary education is provided at the Leland and Gray Academy in Townshend, the town paying \$75.00 tuition per pupil.8

The very earliest means of livelihood were not by the cutting and burning of wood in a kiln, from the ashes of which salts of lye were made, packed in wooden troughs and taken by the settlers on their backs over the hill to Putney, a settlement on the Connecticut River. During this early period, more business was carried on than at any other period in the town's history. The town in 1824, contained three stores, two hotels, two blacksmith shops, three sawmills, two grist mills, two tanneries, one potashry, one doctor, and one counsellor at law. 9

The mill sites in Brookline were not good. However, in 1868 on Grassy Brook a saw and grist mill was erected. A freshet in 1869 took away the dam and part of the flume. It was rebuilt the following year with the same waterwheel running both mills. High water again in the late seventies took away the dam. 10 In 1890,

a steam mill was in operation and in 1891 Pierce's chair shop was running full time. The earlier freshet of 1821 caused great damage to the town; roads across the hills became impassable, stores closed, small farms were sold and, the hillsides being deserted, the population decreased. The building of roads up the West River made it unlikely that traffic would again run through Brookline. 2

In the early part of the ninetcenth century a medical spring on Windmill Hill in the southern part of town, about a mile from Valley Road, was considered efficacious for cutaneous afflictions. This medicinal spring was very popular with persons from outside the State, who patronized Codding Tavern and made stores possible until the decline of the spring's popularity. The stores closed in 1823 and the hotel in 1850. The spring still exists on the farm now known as Spring Farm but has not again been commercialized.

The first passways or roads led across the valley east and west; three of these were abandoned long before the close of the nineteenth century. Early business transactions took the people to Putney, as merchandise could be boated up and down the Connecticut River; therefore, these roads were built first. The first valley road that was built followed close under the hill upon the east side and has been rebuilt at different times and makes the pleasant passway which it now occupies. 3

A lawsuit brought by Brookline against Westminster to recover a part of the cost of a bridge over the West River to Newfane was carried to the Supreme Court at its February term in 1932 and caused considerable discussion in legal circles, since it established the precedent that a stream constituted the boundary line between towns for the purpose of bridge and highway laws even though one bank or the other of the stream might be stipulated as the jurisdictional boundary.

The bridge was built by Brookline at the order of the Windham County court, the expense to be shared by the towns of Brookline. Newfane, Putney, and Westminster, as all benefitted from the construction of the bridge. Westminster refused to pay its share and the suit was brought in the county court. The verdict was for the plaintiff and the defendants appealed.

There were several plans on legal technicalities but the main contention was that the law, relative to the construction of bridges between towns, did not apply since, at the point where the bridge

was built, the West River was in Newfane in its entirety, the high water mark on the east side being the boundary. The court held that this contention was specious and sustained the verdict of the county court.

In 1820 it was voted in town meeting that the selectmen should provide some means to have the burying ground fenced in. At an adjourned meeting in 1893 the cemetery committee was charged to report on the desirability of buying land to enlarge the cemetery, build driveways and enclose the cemetery. After examination and consideration a deed was accepted from the South Cemetery Association for said cemetery and it was renamed Riverside Cemetery. The cemetery was enlarged, carriage roads were made, and the entire cemetery was enclosed. In 1907 the townspeople voted to assume the charge and care of the so called Samuel Bennett family cemetery upon terms and conditions as recorded in the Cemetery Record. 3

Early town meetings were held in various homes until the year 1810 at which time it was voted to hold town meetings in the school building in the Middle School District. 4 The first mention of a Town Meeting House appears in the warning for the March meeting of 1821, "to see if the town will vote to buy the old school house of the second school district for a Town house in said town and move it to some central place."5 However nothing developed from this suggestion. In 1837 the townspeople voted to hold future town meetings in the Union Meeting House in Brookline.6 This evidently proved unsatisfactory, since in 1841 the warning read in part, "to see if the Town will agree upon some suitable place to hold Town Meeting,"7 and in 1844 the townspeople voted that the selectmen appoint a place for holding town meetings.8 Meetings were held either in the Union Meeting House or the third school district until, in the year 1886, it was decided to obtain legal title to the Union Meeting House and make necessary repairs. However, until 1894, meetings were held in private homes. From 1894 to date they have been held in the Round School House, variously designated in warnings as the North School House, the Round School House, and North Meeting House, 9

From the time of the early settlement until 1837, Brookline received no postal service and the people were sometimes troubled

to find their mail at Athens, Putney, and Newfane, 1 Through the efforts of Braxilla Stickney and Alvin Royden of Brookline, aided by General Martin Field of Newfane, a daily star mail route from Bellows Falls by way of Saxtons River, Cambridgeport, Westminster, Brookline, Fayettsville, and Williamsville to Dover was started August 29, 1837. This service was discontinued from 1870 to 1880. Then in 1908 the Rural Free Delivery replaced the Star Route. 2

Numerous boundary changes have taken place in Brookline and the phraseology of the old statutes does not make a clear picture. The act of 1788, establishing the South Parish gives its lines in part as follows: "beginning of the southeasterly corner of Athens and extending westerly on the north line of Putney to the southewesterly corner of Athens aforesaid, thence extending northerly, to be bounded on the east and west line of said town." The extent of territory occupied was to embrace twenty-one property shares, the north and south lines to be parallel. 3

The act of 1794 incorporating the town added to this tract that part of Putney lying "west of a line beginning in the south line of Westminster, at the northwest corner of lot number one, in the thirteenth range of the lots laid out in the town of Putney, thence running a straight line to the southwest corner of lot number eight in the fourteenth range and thence to the northwest corner of Samuel Bennett, Junior's lot, and the west line of Ezekial Wilson's lot, to the Dummerston line." This extended Brookline considerably farther south than is now the case. 4

Lines between Brookline and Putney were established jurisdictionally by an act of 1804 as follows "beginning at a certain stake and stones, forty-four rods west of Westminster south-west corner; thence running south seventeen degrees west, three hundred and twenty-four rods, thence south forty-seven degrees west, thirty-two rods; thence twenty-seven west, fifty-seven rods, thence south twenty degrees west to the north line of the eighth lot in the fourteenth range (thence westward on the line of said lot, to the town line heretofore established between said Brookline, and Putney; thence on said line, to the south line of said towns)."5

A part of the town of Newfane was annexed to Brookline in 1820. The act reads in part, "a part of the town of Newfane... bounded southerly by a line, extending straight with the south line of said Brookline, from the southwest corner thereof, to the easterly bank of the said river (West River), at low water marks; thence up the northerly and easterly bank of said river, at low water mark, to the north line of said Nowfane; thence on said

mentioned line, to the west line of Brookline, "1

The selectmen of Putney were named as a committee for that town in 1829 to establish the line between Putney and Brookline. The selectmen of Brookline likewise were appointed a committee and June 19 was fixed as the date for a survey by the county surveyor. The survey, which fixed the south and southwest bounds as they now stand, is recorded in the records of the two towns. 3



HOUSING, CARE, AND ACCESSIBILITY OF THE RECORDS

All the extant rocords in the inventory of the town of Brookline, except a few of the records of the selectmen, road commissioner, school directors, overseer of poor, and cemetery commissioners, are located in the office of the town clerk, Mr. Arthur C. Wellman, who is also town treasurer. The selectmen's records are at the residence of Mr. Lester Rink; also the records of the overseer of the poor are kept by Mr. Rink. Some of the records of the road commissioner are located at the residence of H. E. Bush, road commissioner. The school directors records are kept at the residence of G. Allbee, a member of the school board. Mr. Allbee is also one of the cemetery commissioners and the order book stubs for this office are kept by him. Unless otherwise specified in the inventory all records are kept in the safe.

The office of the town clerk and treasurer is located at the residence of Mr. Arthur C. Wellman. The house is a wooden frame building built about 1843 and is located on a cross road running from the valley road in Brookline to Route 30, Newfane. The living room is used as an office and the safe is kept in the adjoining hall. Approximately a fifth of the records are kept in the safe, others being located in a desk in the living room, in a desk in a bedroom, on top of the safe, and in the attic. The house is not fire proof and is located several miles from any fire station; also in case of fire the safe would be subject to a drop of several feet and would be likely to spring open.

The living room is heated by a small stove and is well lighted by three windows; there is no electricity. A card table may be set up in the living room which makes the working conditions very favorable; and if this room is too crowded a table in the kitchen can be used. The town clerk is willing to have the records inspected during reasonable hours and is always very helpful and courteous.

TOWN OFFICES AND THEIR RECORDS

I. TOWN CLERK

A town clerk was elected at the first annual town meeting held March 7, 1795 to serve for a term of one year. Since 1796 a town clerk has been elected annually, except for the year 1797 when the town meeting was not recorded. An assistant town clerk was appointed in the years 1843, 1846-49, 1865, 1867, 1897, 1924, 1927-33. The town clerk is a member of the board for abatement of taxes, and in 1892 this officer was added as a member of the board of civil authority.

A treasurer was elected annually with the exception of the years 1800, 1827, 1833, 1860, 1927-28 and 1934, when the election of a person to perform the duties of this office was not recorded, and the town meeting was not recorded for the year 1797. In 1892-93 the treasurer was designated collector of taxes, and for the years 1911 to date the

One trustee has been elected annually since 1846 with the exception of the years 1849, 1869 and 1883 when no mention of the election of this official is made in the records. In 1929 the selectmen served as trustees of public money. The title of this office has varied slightly.

A tax collector was elected at the annual town meeting held March 7, 1796, to serve for a term of one year. 3 A tax collector was elected for the years 1798, 1803, 1811, 1815-16, 1822, 1835, 1844 and 1894. 4 The constable served as collector for the years 1795, 1800-1802, 1804-10, 1812-14, 1817-21, 1823-34, 1837-40, 1842-43, 1843-50, 1853-54, 1856-57, 1862-73, 1875-87, 1869, 1895 and 1897-1906. 5 In 1892-93 the treasurer was designated collector of taxes; 6 and for the years 1911 to date the treasurer has received the current taxes and the constable has collected the delinquent taxes. 7 For the years not shown no information could be found regarding the election of this officer. VIII. BOARD FOR ABATEMENT OF TAXES

The board for abatement of taxes, consisting of the selectmen, town clerk, listers, and justices of the peace, was created by an act of the legislature in 1860. In 1929 the treasurer was added as a member of this board. During the years 1839 to 1860 the duties of this office were performed by the board of civil authority. IX. BOAFD OF CIVIL AUTHORITY

The board of civil authority, consisting of the selectmen and justices of the peace, was constituted by an act of the legislature in 1839. In 1892 the law was revised and the town clerk was added as a member. Prior to 1839 the duties were performed by the selectmen and justices of the peace but no specific name was given to the office. During the years 1839-60 the duties of the office of the board for abatement of taxes were performed by this board. For records of minutes of meetings of the board, see entry 1-v; for check lists as revised by this board, see entry 4.

X. SCHOOL DIRECTORS

Three school trustees were elected at a special town meeting held April 21, 1796. The election of these officers does not again appear in the records until 1819 and 1820 when two end three persons, respectively, were elected to serve as a school committee; 6 in the years 1828-33, three persons to serve as a superintending school committee were elected. 7 For the years not shown above no record was found of the election of these officers. At the annual town meeting held March 2, 1846, a superintendent of common schools were elected. 8 From 1850 to 1892, with the exception of the years 1884 and 1889-90 when no record appears, one superintendent of common schools was elected annually.9 At the annual town meeting held March 7, 1893, three school commissioners were elected as follows: one for a term of one year, one for a term of two years end one for a term of three years. 10 Since 1894, one has been elected annually for a term of three years. 11 The title "School Commissioners" was changed in 1918 to "School Directors," which has contimed to be the title since that date. 12 In 1890, one person was elected as a member of the county board of education. 13 For printed copy of financial report for voters, see entry 3-xi; for minutes of meetings as recorded by town clerk, see entry 1-xxvi.

At the annual town meeting held March 3, 1885 three road commissioners were elected to serve for a term of one year. Three road commissioners were elected in the years 1886 and 1888. In the years 1887 and 1889, the selectmen performed the duties of this office. In 1892, three street commissioners were elected for a term of one year. From 1893 to date, one road commissioner has been elected annually to serve for a term of one year. For the years 1890-91 no mention was made of the election of this officer. At the annual town meeting held March 4, 1844, one overseer of poor was elected to serve for a term of one year. From 1844-1921, 1932-34, one overseer of poor has been elected annually with the exception of the above years and in 1862 when no mention was made of the election of this officer. For the years 1922-31 and 1935 to date, one selectmen has been chosen as overseer of the poor. The records show that in 1811-13, 1817, 1820-24, 1827-28, 1830, 1832-39 there was a committee elected to settle with the treasurer and overseer and in 1814, 1816, 1829, 1831, 1840 there was a committee elected to settle with the selectmen and overseer. Although the records do not state that an overseer of poor was elected in these years, it is possible that the selectmen served as overseers. March 7, 1795 to serve for a term of one year. One constable was elected for the years 1796, 1798-1840, 1842-1906, 1909-23, 1925 to date. In the years 1841 and 1907-8, two constables were elected, and the year 1924 one constable was appointed. For the years 1795, 1800-1802, 1804-10, 1812-14, 1817-21, 1823-34, 1837-40, 1842-43, 1846-50, 1853-54, 1856-57, 1862-73, 1875-87, 1889, 1895, 1897-1906, the constable performed the duties of tax collector. In the years 1892-93 and 1911 to date, it has been understood that the constable was collector of delinquent taxes.

XVII. TOWN AGENT

Two town agents were elected at a special town meeting held March 16, 1826 to serve for a period of one year. In 1827 the selectmen performed these duties. In 1828 a town agent was elected at a special meeting held September 2. One town agent has been elected annually since 1829, except for the years 1925, 1927—30, when one selectmen performed the duties; 10 and for the years 1829, 1836, 1855 and 1860-61 when no record was found of the election of this officer. This office keeps no records.

XVIII. GRAND JURORS

At the first annual town meeting held March 7, 1795 one grand juror was elected to serve for a term of one year. 11 One or two grand jurors have been elected for the years 1796, 1798 to date. 12 This office keeps no records.

XIX. BOARD OF HEALTH

An act of the legislature in 1892 required the commissioner of the State Board of Health to appoint a health officer in each town. 14

At present the State Board of Health upon recommendation of the selectmen of the town appoints a health officer to serve for a three year term and until his successor is appointed. The selectmen of the town and the health officer constitute the local board of health and the health officer is the secretary and executive officer of this board. 2 For printed copy of health officer's report for voters, see entry 3-vi.

XX. FENCE VIEWERS

Three fence viewers were elected at the first annual town meeting held March 7. 1795 to serve for a term of one year. 3 Fence viewers were elected annually for the years 1796, 1798-1906 the number elected varying from two to four. 4 From 1907 to date, three fence viewers have been appointed annually by the selectmen. 5

XXII. SEALER OF WEIGHTS AND MEASURES

One sealer of weights and measures was elected to serve for a term of one year at the first town meeting held March 7, 1795. One officer was elected annually for the years 1796, 1798-1881, except for the year 1845 when two were elected, and the years 1813, 1836-37, 1865, 1872-74, 1876-77, 1879, when no election of this officer was found recorded. In the years 1806-8, 1811, 1819, 1821-22, 1829, 1835, 1838-39, 1855 the duties of this office were combined with those of the inspector of leather. In 1821, the duties were performed by the poundkeeper. This non-record keeping office was discontinued after 1881.

XXIII. SURVEYOR OF WOOD, LUMBER AND SHINGLES

On March 31, 1841 four wood measurers to serve for a term of one year were appointed by the selectmen following the request of seven legal voters. One inspector of lumber was elected at the annual town meeting held March 1, 1870. One was elected annually in the years 1873-76, 1878-80, 1882-1906. Since 1907, one or two have been appointed annually to perform the duties of this office. In the year 1892 the title was changed to measurer of wood and lumber. and in 1918, to surveyor of wood, lumber and shingles. For the years not shown above no record was found of the election or appointment of this officer. This office keeps no records.

XXIV. INSPECTOR OF LEATHER

A leather sealer was elected at the first annual town meeting held March 7, 1795 to serve for a term of one year. 11 One leather sealer or inspector of leather was elected annually for the years 1796, 1798-1906, with the exception of the years 1813, 1827-28, 1836-37, 1854, 1857, 1877, when no election to this office was found recorded. 12 The duties of inspector of leather were combined with the

One tree warden was elected at the annual meeting held March 5. 1907, to serve for a term of one year. No mention of any other election to this office is made until 1913, when one tree warden was elected. In the years 1916-18, 1920, 1923 and 1925-33, one was elected to serve for a term of one year and one has been appointed annually since 1934. For the years not shown above no record of the election or appointment of this officer was found. This office keeps no records.

XXVI. TYTHING EN

Two tythingmen were elected at the first town meeting held March 7, 1795 to serve for a term of one year. From one to four were elected annually for the years 1796, 1798-1840, with the exception of the years 1809 and 1836 when no election to this office was recorded. This non-record keeping office was discontinued in 1841.

XXVII. HAYWARDS

One hayward was elected at the first town meeting held March 7, 1795 to serve for a term of one year. 8 For the years 1796-1840 from one to nine were elected annually, 9 with the exception of the year 1819 when no election to this office was recorded, and in 1797 when the minutes of the annual town meeting apparently were not recorded. In 1841 this office was discontinued. For the year 1833 the six haywards elected were called hog constables. 10 This office kept no records.

XXVIII. COFFIN COMMITTEE

Two persons to comprise a coffin committee were elected at the
